From Out of the Shadows

There is a wealth of articles trumpeting the inauguration of the new European Jewish Parliament in news sources which are produced for Jews, such as the [European Jewish Press](#), [Arutz Sheva](#), [Europe-Israel.org](#), [Chabad](#), the [European Jewish Union](#) website, and many other outlets, however little is known of this new parliament outside of Jewish circles. While it has been planned for quite some time, and the Jewish outlet [Ynetnews](#) reported on its formation as early as August of 2011, there is nothing about it in any major media produced for the general European public. Of course, it is already vaunted on the pages of the world's largest pro-Jewish propaganda outlet, Wikipedia, but only on a page concerning the [European Jewish](#)



[Union](#) (EJU). The article states that “The EJU hopes to establish a European Jewish Parliament, comprising 120 members modeled on the Israeli Knesset This group would then represent the concerns of the Jewish community to the European Union.” Of course, there has been a [European Jewish Congress](#) for several decades, which has long been careful to downplay itself as a civic association while at the same time exerting an influence over European governments which far exceeds the proportions of the Jewish population. However this new Jewish Parliament is no civic association. Its meeting place is the very same as that of the regular European Union Parliament in Brussels, and its members are calling themselves “MEJPs”, or Members of the European Jewish Parliament.

This is not merely a civic association.

European: get your head out of your Jewish-owned newspapers and study your history! The Jews have had an active plan to destroy Christianity and White European civilization, and the product is proof of the development. Before the French Revolution, they executed their plan through secret societies, through the corruption of the nobility, through bribery or murder. Now since their emancipation they have been implementing that plan more and more openly for over 200 years, until now when they have totally emerged from the shadows. Any resistance to the Jewish plan of complete global domination is called “anti-semitism”, as if wanting to maintain one's own religion, culture and values were inherently evil.

The inherent evil of the Jews in history goes far beyond the crucifixion of Christ. The Jews have been crucifying Christ every day ever since the crucifixion! Christ Himself said at Matthew 25:40 that “Truly I say to you, for whomever of the least of My brethren have you done one of these things, you have done them for Me!” The Book of Acts, as well as the early Christian apologists Tertullian and Minucius Felix, all blame the Jews for the persecutions of Christians. These persecutions endured over three hundred years and resulted in the horrible executions of thousands of innocent Christian men and women. When the Jews were virtually excluded from Christendom by the Byzantine emperors, it was they who brought the Arabs against Spain, France and Italy in the West, and it was they who were behind the Mongol conquest of the great ancient cities of Eastern Europe. It was the Jews who were behind the Turkic invasion and destruction of Byzantine Greece, the Balkans and once-Christian Anatolia (modern Turkey). It can even be established, that [Jews were behind the actual founding of Islam](#), which has long been used as a tool to destroy Christianity, and that Jews are behind all of the Muslim immigration into Europe today can be

easily discovered by anyone who investigates.

The Jews were behind much of the oppression of Christendom by the Medieval Roman Church, and the Jesuits, an order founded by Jews, were the impetus of the 30 Years' War and the complete destruction of over half of Germany and Bohemia. Following that horrible war, it was the Jewish Jesuits and the Freemasons who conspired with them who were behind all of the wars and revolutions in Europe, right up to the First World War. Whatever Bible-believing Christians think about priests and nuns, the Jews are nevertheless proven to be forever the enemies of Christ and of White European civilization. These are only some of the major crimes perpetrated by the Jews throughout history, where the full list is endless.

Now the Jews control all of Europe. The Jews control all of Europe, and they are not being challenged. The proof that the Jews control all of Europe is now obviously clear: for they have established their own separate parliament, and it meets in the same building as the European Union parliament! This is, to use one of their own words, real *chutzpah*. This is not a civic association, but rather it is a control commission. With their first meeting, they have already demanded that David Cameron fire an appointed British official simply because she vociferated support for the cause of Palestinians in Gaza. The Jewish parliament has labeled that as "anti-semitism", a crime punishable by death in Soviet Russia, which itself was a Jewish monster. The new Jewish parliament is really the new Pan-European Knesset – and a continental Soviet government in everything but name!

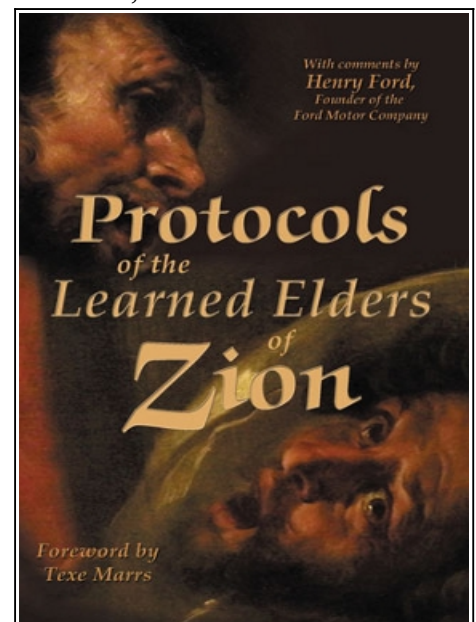

Thus the promise of the Talmud will be fulfilled, that is, the promise that the Jews, at the arrival of the Messiah, will possess the key to the wealth of all the peoples of the earth."

- Baruch Levy, in a letter to Karl Marx, published in the Rothschild controlled *La Revue de Paris*, p.54, June 1, 1928.

The foregoing quote from Levy is often-cited in articles available on the internet, and was dismissed as spurious in a book, written by a Jew, titled *The Hoaxers: Plain Liars, Fancy Liars and Damned Liars* by [Morris Kominsky](#), published by Branden Press in 1970, which is also frequently cited in articles on the internet. However more importantly, Kominsky admitted that the quote did appear in [La Revue de Paris](#) in 1928.

If the quote was a fraud, as Kominsky insists, then how do we see its fruition? If, as Kominsky and so many Jews along with him are right in stating that the *Protocols of the Learned Elders of Zion* were a hoax, then how do we see their fulfillment? If the [Communist Manifesto](#) is not a plot of the Jews in general against all Christendom, then how have all European states, Australia, Canada, New Zealand and America, come to adopt its provisions, at the consistent political agitation of the Jews?

Marx, Lenin, Trotsky, and nearly all of the major figures of Bolshevism and European and American Communism were Jews.



The Jews have had an active plan to destroy Christianity and White European civilization, and they have been implementing that plan openly for over 200 years now. Any resistance to that plan is called “anti-Semitism”, as if wanting to maintain one’s own culture and values were inherently evil. The Jews themselves have come to define “anti-Semitism”, by the way that they use the word, as anti-Jewish-supremacy! In that sense, I am proud to be an anti-Semite, even if by race, White Europeans are the world’s only true Semites. An investigation of the Bible and history proves that all Semites were originally White. There is nothing that the Jews do not lie about.

Among the earliest articles on the internet which concern this new Jewish European parliament are from August, 2011. One is from the Jewish news agency, Ynetnews, which is [Europe’s Jews to have own parliament](#):

“The idea of the creation of a European Jewish Parliament was envisioned by Shimon Peres, the president of the State of Israel, when several years ago he called for the establishment of such an organization.”

The Israeli news outlet Arutz Sheva announced after its first meeting that the [New Jewish Parliament Fights Anti-Semitism](#). However in reality, the audacity of the Jews in their belief that they have a right to control every non-Jewish nation is the **cause** of anti-Semitism! And they have asserted that right throughout their history from Roman times! Again, “anti-Semitism” is in reality anti-Jewish-Supremacism. For a White man to be what the Jews call an “anti-Semite”, is to be a true Christian.

So the Jews planned long in advance to found their own European parliament and to house it in the same government building that the constitutional European Union conducts its business. Then they have no obstacles in putting such a nefarious plan into effect. Could any other self-appointed religious association have such clout and put it into practice so easily? Is it not obvious that the Jews are controlling all of Europe? They claim this is a “non-governmental organization”. Yet the Jews have a proven track record of turning non-governmental organizations into quasi-governmental organizations. In the United States, the ADL and AIPAC are certainly proof of that.



In its first order of business, the European Jewish Parliament has already issued a decree demanding the removal, as soon as possible, of Catherine Ashton. Now we are not by any means supporters of Ashton, who has been hob-nobbing with and whoring for the British branch of the global elite for over 30 years. Never having been elected to anything, she was made a life peer by the Labour party and is now the First Vice President of the European Union and its [High Representative of the Union for Foreign Affairs and Security Policy](#), a position she will hold for two more

years. However after her term expires, her career may soon be cut short, since a few weeks ago she raised the ire of Jewry by comparing the shootings of four Jews in France to the carnage of Palestinians in Gaza. The Jews will not endure any political opposition at all in Europe or anywhere. All who stand against Jewish world supremacy are demonized in the popular press, and labeled with the death knell accusation of being “anti-Semitic”.

One excellent example of the arrogance of Jews and their insistence on commanding non-Jewish nations how they must live is found in the Jewess Barbara Spectre [aka Spector]. She has been a delegate of the [International Jewish Leadership Delegation to the United Nations](#) and calls herself the “Founding Director, European Institute For Jewish Studies in Sweden”, and she has gone on the record as promoting the destruction of Christian Europe. Spectre is tied to the [The International Raoul Wallenberg Foundation](#). The Wallenbergs are a family of bankers and corporate raiders who have come to control most all of Sweden’s major corporations over the past 50 or so years. This is from a television news program which promoted

her filth (the video is hosted at Christogenea.org in an article titled *The Effrontery of Judaism*):

(Reporter:) “As we heard, there are people in Sweden who support Israel, and have a deep sense of the injustice of the present situation. It’s these people who give hope to those who still believe that things will get better here. One of them is Barbara Lerner Spectre, a former American who made ‘*aliyah*’ [meaning migration to the spurious Israeli state in Palestine – ed.] and then ten years ago, with the help of the government of Sweden, set up a non-denominational institute of Jewish learning with the Greek name of ‘*Paideia*’ [which she also calls ‘*The European Institute for Jewish Studies in Sweden*’ – ed.] here in Stockholm. She believes that the current wave of anti-Semitism in Sweden will pass, and that Jews have an important role to play in a country undergoing profound change.” [Anti-Semitism exists in Sweden because Jews are forcing change upon Sweden! - ed.] (Spectre, agreeing with the program host, says): “I think there is a resurgence of anti-Semitism because, at this point in time, Europe has not yet learned how to be multicultural [meaning racially-mixed – ed.]. And I think we [meaning the Jews – ed.] are going to be part of the throes of that transformation, which must take place. Europe [meaning all the countries of Europe – ed.] is not going to be the monolithic societies [meaning racially pure-blooded nations – ed.] that they once were in the last century. Jews are going to be at the center of that. It’s a huge transformation for Europe to make. They are now going into a multicultural mode, and Jews will be resented because of our leading role. But without that leading role, and without that transformation, Europe will not survive.” [Brackets added for clarification.]



So has this Jewess unilaterally decided for the Swedish people that they must become race-mixed in order to survive, and that she will lead the way with that race mixing? That is what she inferred in this interview. And she herself admits the cause of anti-Semitism. Yet her Wallenberg connections demonstrate that her plot against Christendom has large and powerfully wealthy backers. Now Europe has a parliamentary control commission full of Jews who think just like she does. Jewish antipathy towards Christians over 40 generations proves that this problem is genetic. White men everywhere must awaken to the Jewish peril, because it is already too late!

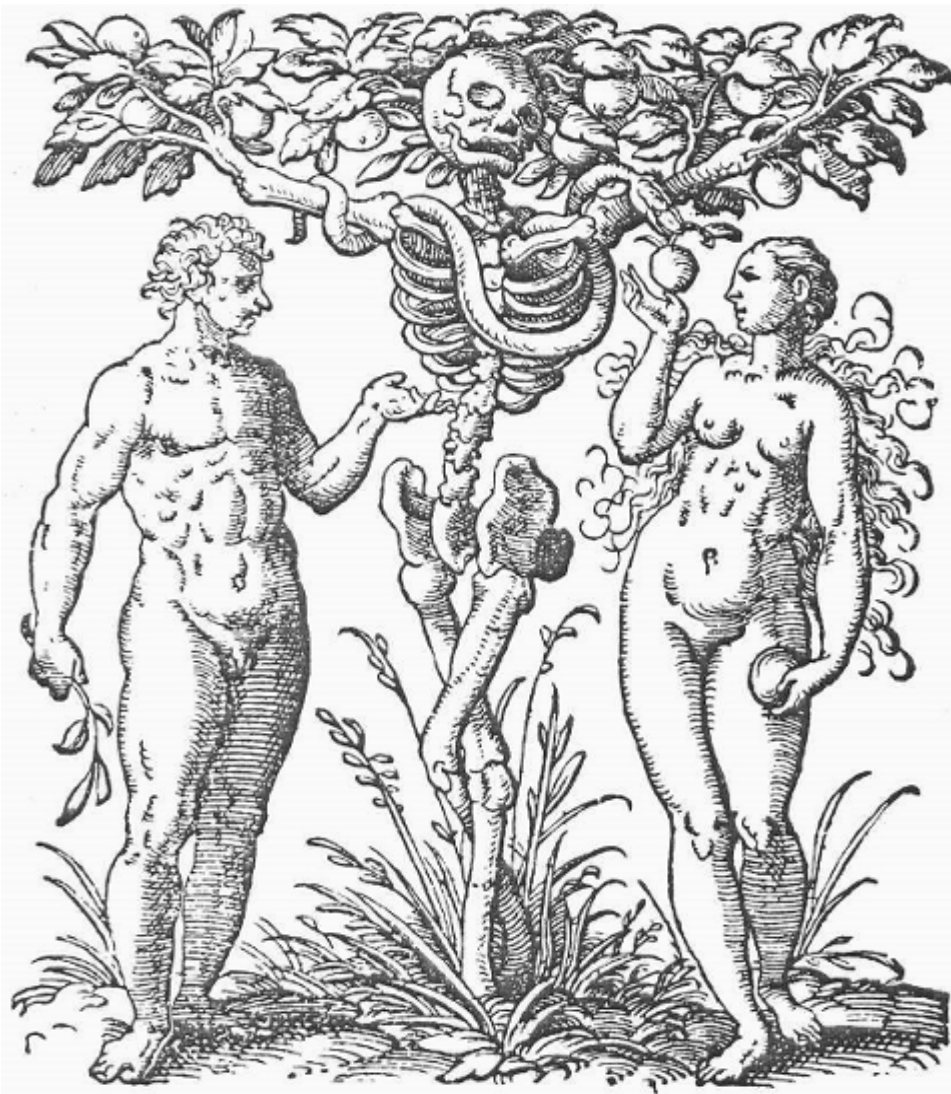

My name is “NoOne” Ulysses told the Cyclops, Polyphemos when asked his name. The ogre, his one eye poked out by Ulysses, and his companions, stumbled out of his cave crying, "NoOne has blinded me, NoOne wants to kill me." The neighboring ogres shouted back, "If no one has blinded you, and no one wants to kill you, why are you making such a commotion disturbing our sleep?" Help for Polyphemos was not forthcoming, which allowed Ulysses and his crew to reach the safety of their ship.

The Jews use a similar ruse with this variation. They do not call themselves NoOne but AnyOne. Let me explain. The history books call the 1917 November Revolution in Russia either the Russian Revolution, or The Communist revolution when it should be named the Judeo/Communist Revolution. Without Jews the Russians would have been spared the Jewish Communist takeover of their country.

After World War II the Jews who had not perished in the German "Holocaust" were still there sitting in the camps waiting to go to Palestine. However they no longer went under the name Jews but DPs (displaced persons).

The Jews, Icahn, Miliken, Boesky, Goldsmith, Jacobs, etc. who plundered American corporations (their tools were junk bonds) were called raiders. Hollywood showed a noble raider in *Pretty Woman*. After having been deregulated (deregulation pushed by the Jew, Milton Friedman) the Savings and Loan companies were "persuaded" to replace sound investments with junk bonds, The junk bonds went belly up, so did the Savings and Loan companies. Since the savings were government guaranteed, the taxpayers, you and me,

were out \$500 billions. The Jews who plundered Russia, impoverishing the man in the street, found for themselves a ridiculous Oligarch (oligo - few, arch - rule).

Why are we in the war against Iraq? The Jews who put us there use the AnyOne name, Neoconservatives (neos – new, conservare - preserve). What a misnomer. The Neoconservatives do not preserve, they destroy. I have yet to see a Perle, Golde or Silverstein name when I watch the news stories

concerning Americans killed in Iraq.

That brings me to the book by M. Stanton Evans *Blacklisted by History: The Untold Story of Senator Joe McCarthy*. Evans' dedication reads: *For my mother Josephine Stanton Evans who knew it all along*. What did Evans' mother know all along? She knew that McCarthy was right, namely that there was a Communist conspiracy permeating the whole American government. In

the 1950s Jewish world dominance was still achievable through international Communism of which the Soviet Union was the flagship. The Jewish attempt at world dominance now goes under the name of Globalism. The Jews easily shifted their alliance to their present flagship, the United States.

In the index of Evans' book there are plenty of Jewish sounding names but the words Jew or Jewish do not appear. Again the Jews are NoOne. *Blacklisted By History* is the title of the book. But history does not blacklist, people blacklist, in this case people who control the media, the Jews. The Jewish media has managed to make McCarthyism synonymous with "witch hunt". The men, women and children accused of being witches were innocent. Horses and cows did

not die on account of their evil spells. People did not sicken and the harvest did not fail on account of them. Similarly the men and women accused by McCarthy of harboring communist sympathies and working for the communist cause were innocent, patriotic Americans unjustly accused. The analogy is false. The witches were innocent but the people accused by McCarthy were not.

That which Evans' mother knew all along my educated friends in Boston did not. When husband and wife badmouthed McCarthy I asked them to listen to what I knew about the man.

The Case Malmedy. During the last German offensive, the "Ardennenoffensive" (December, 1944), 71 American soldiers were killed. The American government accused the Germans of having killed these soldiers after they had surrendered. No corpse however showed a head wound delivered at close range as was claimed.

After the war members of the SS unit commanded by Jochen Peiper were tortured, a lieutenant Pearl being especially eager to extract confessions. A number of tortured German soldiers committed suicide. On July 16, 1946, 43 of the accused were condemned to death, 22 received life sentences and eight long prison sentences. The death sentences

were not carried out, but for years these German soldiers were under the threat that every Friday they

might have to face the gallows at Landsberg. As time passed the death sentences were changed to imprisonment. On Christmas Day in 1956 the last, Peiper, was released.

I quote from *Blacklisted by History* (footnote, p. 33) "*Malmedy*" was an atrocity case from World War II in which American soldiers were slaughtered by the Nazis. Later numerous German soldiers were interrogated, put on trial, and convicted in a U.S. military court for complicity in the murders. There were allegations that the defendants had been subject to torture and inhumane treatment to extract confessions. The issue was somewhat similar to the Abu Ghraib episode in the war against Iraq. McCarthy became the main Senate spokesman questioning the methods of interrogation of the German prisoners. That was new to my friends.

In *Blacklisted by History* I met two old acquaintances, the German Jew and Communist, Wilhelm Muenzenberg, and his fellow Jew and coworker, Leo Katz. After World War I both were active in the attempted subjugation of Germany to Communist rule. When Hitler came to power in January of 1933 they took abode in France from where they directed atrocity propaganda against Nazi Germany. In the Spanish Civil War they supported the Red Republic with their propaganda machine. I quote from *Blacklisted by History* (p. 491): *Matthew told the House committee, naïve and busy people could be hoodwinked into lending their names to the Red causes that looked good on the surface but were something else on close inspection. He cited the fancy Communist newspaper Ce Soir in France (a Willie Munzenberg production), which on approach of its first anniversary solicited and received greetings from some big Hollywood names – Clark Gable, Robert Taylor, James Cagney, and even Shirley Temple.*

Let us call a spade a spade and a Jew a Jew.

The Revelation of Yahshua Christ

VIII 1 And when He opened the seventh seal, there was silence in heaven for about half an hour. 2 And I saw seven messengers who stood before Yahweh, and they had given to them seven trumpets. 3 And another messenger having a golden censor came and stood upon the altar, and much incense had been given to him, that he may offer it with the prayers of all the saints upon the golden altar before the throne. 4 And the smoke of the incense with the prayers of the saints ascended from the hand of the messenger before Yahweh. 5 And the messenger took the censor and filled it from of the fire of the altar and cast it into the earth, and there were thunders and noises and lightnings and an earthquake. 6 And the seven messengers who having the seven trumpets prepared them in order that they may sound.

7 And the first sounded the trumpet, and there came hailstones and fire mixed with blood and it had been cast into the earth, and a third of the earth had been burnt, and a third of the trees had been burnt, and all the green grass had been burnt.

The Roman Empire had been threatened by the Germanic tribes for quite some time, and even Julius Caesar in his own description of the Gallic Wars complained that the Germanic tribes were forever pushing west of the Rhine. Throughout the centuries of the Empire there were emperors who attempted to buy off the invading Germanic tribes. The examples are numerous. Augustus offered many tribes land, or bribed their chieftains, in order to gain them as allies. In the third century Caracalla fought against and then bought off the Alamanni with a large sum. In the fourth century Constantine bribed the Vandals with the land of Pannonia, which they inhabited for quite some time before becoming restless once again. Discussing Chapter 6 and the invasions of Rome by the Goths and Vandals, the following was mentioned, and here I will elaborate a little further: With the anarchy of the mid-third century, the city of Rome itself began to lose its lustre, and with Constantine in the early 4th century the capital was moved eastward. In 364 AD the empire

was divided east and west, and this represents the beginning of the dissolution of the ten toes: the splitting of the original provinces of the empire as it existed under the first Caesars. The eastern portion would last another thousand years, however the west fell quickly. Later in the fourth century the Visigoths, after defeating the Romans in a large battle, were given leave to cross into the lands of the Empire. Eventually they were mistreated by Rome, and rebelled against the empire. Around 406 AD tribes from out of the Vandals, Alans and Suebi crossed the Rhine into Gaul and began to loot and pillage the empire, and take much of its lands in Gaul and Iberia, which were never recovered. The Visigoths at this same time raided Greece, and then invaded Italy. At first the western empire attempted to buy off the Goths with a large sum of gold. Rome was then sacked by the Goths under Alaric in 410 AD. The years from 433-453 AD saw the Hunnic Empire under Attila and Bleda, who raided the Balkans, Gaul, and Italy, threatening both Constantinople and Rome.

The Vandals then sacked Rome in 455 AD. The Huns were bought off in the east with a large grant of land which eventually became Hungary. But looting and bribes were eventually not enough for the Goths, who really wanted the fertile soil of Italy and the treasures

of the empire for themselves, and so finally in 476 AD they took it, when the Gothic chieftain Odoacer declared himself ruler of Italy. Rome could no longer defend herself first because the empire was completely corrupt and decadent, but more importantly, as Daniel 2:43 attests, because there was little unity in the citizenry, which was now made up of people of diverse and mixed races.

8 And the second messenger sounded the trumpet, and thus a great mountain burning with fire had been cast into the sea, and a third of the sea became blood 9 and a third of those creatures having souls of those in the sea died, and a third of the ships had been destroyed.

The Vandals, along with the Goths were indeed descended from the Israelites of the Assyrian deportations, yet it had been quite a long time in their history since they had ever been sailors or had any sort of maritime tradition. Upon the invasion of Spain, the Vandals had taken the Balearic Islands off of the Spanish coast. From there, along with many of the Alans, they crossed to Africa, and Procopius states that there were no Vandals left in Europe – or at least in those parts of Europe which he was acquainted with - in his time, which was about a hundred years later. In Africa the Vandals eventually made a treaty with Rome, in 435 AD, dividing the coastline. Yet the Vandals still did not cease from their looting and pillaging of the coasts of Africa and Sicily. In October of 439 AD, the Vandals under Gaiseric made a successful surprise attack on Carthage. He had his designs on both the city and the large port. They took the city and found a large Roman fleet laying in the harbor waiting for them. This was a devastating strategic mistake on the part of the Romans, to allow such a large supply of ships to fall into the hands of their enemies.

The fall of Carthage to the Vandals greatly disturbed both the western and the eastern empire, as there was a large number of galleys and a great shipyard in Carthage, creating a Vandal fleet as great as the joint navies of both empires. That the Romans allowed for so many ships to be left in Carthage's port while the Vandals were so close by, must be one of the greatest

errors of Roman history. The very next Spring, that of 440 AD, a vast fleet manned by Vandals and their allies (Alans, Goths, Romanized Libyans, and even Moors) set out from Carthage for Sicily, which at the time was the principal supplier of oil and grain to Italy after the loss of North Africa. All the coastal towns were looted and Palermo was besieged. Ships heavily laden with plunder returned to Carthage. The powerful eastern imperial fleet responded by sailing into Sicilian waters in 441 AD, taking the Vandals by surprise. This was under the command of the Romano-Goth Areobindus, but a major invasion of the Balkans by the Huns and the threat of a Persian attack, forced him to take his fleet back home. After this Gaiseric allowed his fleets to continue plundering throughout the western Mediterranean Sea. The Vandals then plundered Rome itself in 455 AD.

That the Romans allowed for so many ships to be left in Carthage's port while the Vandals were so close by, must be one of the greatest errors of Roman history.

The Western emperor Majorian was the last to try to hold onto the old Roman Empire against the invading barbarians. Gibbon said of Marjorian that he “presents the welcome discovery of a great and heroic character, such as sometimes arise, in a degenerate age, to vindicate the honor of the human species.” Marjorian planned a naval campaign against the Vandals to reconquer northern Africa in 461, but word of the preparations got out to the Vandals, who took the Roman fleet by surprise and destroyed it. A second naval expedition against the Vandals, sent by emperors Leo I and Anthemius, was also defeated, in 468.

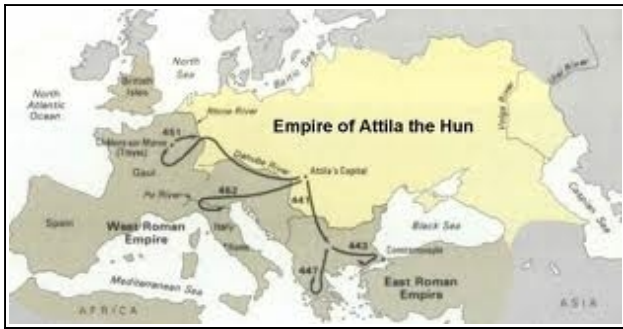
10 And the third messenger sounded the trumpet, and a great star fell from heaven, burning as a lamp, and it fell upon a third of the rivers and upon the springs of waters, 11 and the name of the star is called Wormwood, and a third of the waters came to be wormwood and many of the men died from the waters because they had been made bitter.

Bertrand Comparet in his own Revelation sermons identified this star with Attila the Hun. That is based on the idea that somehow the Huns were not White, and that is wrong on both counts. The Huns were indeed White, and this is not referencing Attila. When Clifton Emahiser had put together his transcriptions of Comparet's Revelation series along with a lot of my notes, I disputed the identification of this passage with

Attila. Now I can do so much more effectively.

First, this passage is after the one which describes the invasions of the empire by the Goths and Vandals, and yes, the Huns. Yet the Huns had already come to relative peace with the eastern empire, and were no longer a threat to the west, when the Vandals had their maritime escapades, which we have seen described before this. Secondly, Procopius describes the Huns as tall and very fair. Procopius also equates the Massagetae and the Kimmeroi to the Huns on several occasions, therefore esteeming them to be of Germanic stock.

Now the depictions of Attila as a short Asiatic runt come from Jordanes, the Gothic historian, but he wrote in the seventh century – a hundred years after Procopius – and his main source was the Gothic



propagandist Cassiodorus, whose work has hardly survived. Cassiodorus, a Roman Senator under Gothic rule, wrote his history in a manner very flattering to the Goths, who were once ruled over by and therefore despised the Huns. The depictions of Attila by Cassiodorus and Jordanes are clearly little but propaganda. However other records of Attila exist, where he is often mentioned in Germanic writings such as the Edda and the Nibelungenlied. In Germanic poetry, Attila is depicted as a much more noble character, and in the Nibelungenlied he even receives the widow Kriemhild – the wife of the slain Burgundian prince Siegfried, as a wife.

So with Attila discounted, let me repeat the passage:

10 And the third messenger sounded the trumpet, and a great star fell from heaven, burning as a lamp, and it fell upon a third of the rivers and upon the springs of waters, 11 and the name of the star is called Wormwood, and a third of the waters came to be wormwood and many of the men died from the waters because they had been made bitter.

It can be told from Daniel Chapter 7 that upon dissolution of the toes, from one of them would arise ten horns, and then an eleventh which would subdue three kings. This describes Justinian, the eleventh emperor of the eastern empire, during whose reign the Vandal King Gelimer was defeated in Carthage and the Gothic kings Witiges and Totila were defeated in Italy. During the wars of this period, much of Italy and Sicily were laid bare, the Vandal kingdom of North Africa was wasted and many of the Vandal soldiers were forcibly relocated to the east in the service of the conquering Byzantines. The city of Rome was practically deserted for an extended period of time. This, it can be ascertained, is the wounding of the head in another vision – that of the beast of Revelation Chapter 13. The empire is dead, but the beast and the dragon which gives its power to the beast still live to rise again – as the Roman Catholic Church! When we get to Revelation Chapter 13, the correlations with Daniel 7 will be discussed at great length. This star which fell from heaven made a third of the waters bitter because Justinian would prevail over the Germanic peoples in Italy and Africa, and this in turn would also pave the way for Catholicism in Western Europe. Therefore, it is evidenced that this passage in the Revelation also refers to Justinian, just as the little horn of Daniel Chapter 7 does.

12 And the fourth messenger sounded the trumpet, and a third of the sun had been struck, and a third of the moon and a third of the stars, that a third of them had become darkened, and the day did not shine for a third part of it, and likewise the night.

While it is not esteemed that the symbolic language of the Revelation should always be interpreted literally, here we do have a physical proof of the veracity of the interpretations of the Revelation which we have seen thus far. And while the references to the sun, moon and stars are not to the mere objects in heaven, but rather they are symbols of organized government and people, there is still an absolutely striking occurrence which happened in 536-537 AD, which points to a certain and literal fulfillment of this passage. Of the very time when the great general Belisarius had defeated the Vandals and taken Carthage for the Byzantines. Procopius writes thus: “For the sun gave forth its light without brightness, like the moon, during this whole year, and it seemed exceedingly like the sun in eclipse, for the beams it shed were not clear

nor such as it is accustomed to shed. And from the time when this happened men were neither free from war nor pestilence nor any other thing leading to death. And it was the time when Justinian was in the tenth year of his reign.” This is found in the Loeb Classical Library edition of Procopius, Book 4 Chapter 14 Section 5. By this we also know that the interpretation of these passages as having to do with the wars which destroyed the old Roman empire, but also brought great harm to the people of God who brought that empire down, is absolutely certain. Yet the dulling of the Sun during this year only represents and reflects the events as they were happening upon the earth, for after the passing of Rome, much of Europe also fell into the so-called Dark Ages.

13 And I saw and heard one eagle flying in mid-air saying with a great voice: “Woe, woe, woe for those dwelling upon the earth from the rest of the sounds of the trumpets of the three messengers who are about to sound!”

Thus ends Revelation Chapter 8, and from this I hope that it is made evident, that the historical view of this prophecy is the only legitimate view. The Chapter that follows should make this even more evident, for it describes perfectly the Arab and Turkic invasions of the Adamic oikoumenê. Here we see that three woes announced.

Chapter 9

IX 1 And the fifth angel sounded the trumpet, and I saw a star from heaven fallen to earth, and to him had been given the Key of the bottomless pit. 2 And he opened the bottomless pit, and smoke ascended from the pit like the smoke of a great furnace, and the sun and the air had become darkened from the smoke of the pit. 3 And from the smoke locusts came out into the earth, and authority had been given to them like the scorpions of the earth have authority. 4 And it had been spoken to them in order that they do not injure the grass of the earth nor any green thing nor any tree, except those men who do not have the seal of Yahweh upon their

foreheads. 5 And it had been given to them that they should not kill them, but that they shall be tested for five months, and their torment is as the torment of a scorpion when it strikes a man. 6 And in those days men shall seek death yet they shall not find it, and they shall desire to die yet death flees from them.

Howard Rand and Bertrand Comparet have both identified this passage as a depiction of the rise of Mohammedism and the Arab conquests of the formerly White regions of Mesopotamia, the Levant, and the northern coast of Africa. I believe that they were absolutely correct. As an aside, it is also evident that Mohammed is the “little horn” of Daniel Chapter 8, This little horn is not to be confused with the little horn of Daniel Chapter 7, which we shall see when we get to Revelation Chapter 13 refers to the Emperor

Justinian. So it may be seen that just as Daniel in Chapters 7 and 8 prophesied of Justinian, and then of Mohammed, so does the Revelation in Chapters 8 and 9. At Daniel 8 this is what it says in part, which I believe correlates with this passage in the Revelation:

Daniel 8:9-12, 21-25: “9 And out of one of them came forth a little horn, which waxed exceeding great, toward the south, and toward the east, and toward the pleasant land. 10 And it waxed great, even to the host of heaven [meaning the Children of Israel]; and it cast down some of the host and of the stars to the ground, and stamped upon them [the Mohammedan conquests]. 11 Yea, he magnified himself even to the prince of the host, and by him the daily sacrifice was taken away, and the place of his sanctuary was cast down. 12 And an host was given him against the daily sacrifice by reason of transgression, and it cast down the truth to the ground; and it practised, and prospered. [The taking away of the “daily sacrifice”, I believe, represents a change in religion described in Daniel's own terms – in this case from Christianity to Mohammedism. Now to skip to verse 21:] 21 And the rough goat is the king of Grecia: and the great horn that is between his eyes is the first king. 22 Now that being broken, whereas four stood up for it, four kingdoms shall stand up out of the nation, but not in his power. [As we have seen it

prophesied elsewhere in Daniel, and as happened in history, Alexander's kingdom was split into four pieces upon his death.] 23 And in the latter time of their kingdom, when the transgressors are come to the full, a king of fierce countenance, and understanding dark sentences, shall stand up. [The Arabs of Islam were conquerors under the guise of religion, and used by Yahweh as a scourge against our race.] 24 And his power shall be mighty, but not by his own power: and he shall destroy wonderfully, and shall prosper, and practise, and shall destroy the mighty and the holy people. 25 And through his policy also he shall cause craft to prosper in his hand; and he shall magnify himself in his heart, and by peace shall destroy many: he shall also stand up against the Prince of princes [Mohammed claimed to be greater than Christ – and muslims still make that claim.]; but he shall be broken without hand.” [Something we wait for the fulfillment of even today.]

“2 And he opened the bottomless pit, and smoke ascended from the pit like the smoke of a great furnace, and the sun and the air had become darkened from the smoke of the pit. 3 And from the smoke locusts came out into the earth, and authority had been given to them like the scorpions of the earth have authority.”

Arabia is renowned as a land of locusts. The locust eggs stay under the desert soil until it rains, and then they begin to hatch and swarm. ([See the Earth Observatory website hosted by NASA which has much information concerning this.](#)) This helps us identify who these people are and where they come from. Egypt and Arabia were one of the four portions of Alexander's empire, from where the Ptolemy's ruled until Roman times. The “latter time of their kingdom” is just as well a reference to the Greek rulers in general as it is to the Ptolemy's themselves, and the Greeks are still the rulers of the east in the Byzantine period.

The scorpions of the earth are a reference to the Canaanite Jews. This can be seen at Luke 10:18-19 where Yahshua Christ said “I beheld the Adversary falling as lightning from heaven! Behold! I have given to you authority to tread upon serpents and scorpions, and upon all the power of the enemy, and no one shall by any means do you injustice.” The serpents and scorpions were not to be taken literally in that passage,

but as metaphors for certain people, which we see are of the Adversary, or Satan.

“4 And it had been spoken to them in order that they do not injure the grass of the earth nor any green thing nor any tree, except those men who do not have the seal of Yahweh upon their foreheads. 5 And it had been given to them that they should not kill them, but that they shall be tested for five months, and their torment is as the torment of a scorpion when it strikes a man. 6 And in those days men shall seek death yet they shall not find it, and they shall desire to die yet death flees from them.”

That a day in prophecy can represent a year is evident in many places in Scripture. Here are a few evidences of the validity of such an interpretation:

Numbers 14:34: “After the number of the days in which ye searched the land, even forty days, each day for a year, shall ye bear your iniquities, even forty years, and ye shall know my breach of promise.”

Ezekiel 4:5-6: “For I have laid upon thee the years of their iniquity, according to the number of the days, three hundred and ninety days: so shalt thou bear the iniquity of the house of Israel. 6 And when thou hast accomplished them, lie again on thy right side, and thou shalt bear the iniquity of the house of Judah forty days: I have appointed thee each day for a year.”

The 5 month period of the locusts seems to represent the approximate 150-year period of Islamic conquest over the Byzantine lands. This period began around 622 AD when Mecca was entered by Mohammed and was eventually conquered, process which ended in 632 AD. Within two years of Mohammed's death, his followers began their conquests outside of Arabia, first taking Syria, Persia and Palestine. In 652 AD they already began attacking Sicily, and Arabs occupied parts of the island then for an extended period. By 670 they controlled the entire Middle East and began attacking even Constantinople itself. From this time they began conquering Northern Africa, and by 711 they are crossing into Spain. In 726 and again in 740 they captured Syracuse on Sicily, but never took the entire island until the 9th century. In 736 the Arabs took Georgia north of the Caucasus Mountains. In 751 they even defeated Chinese forces in a battle near the

Talas River in modern-day Kyrgyzstan. By 762 Baghdad was created as the capital of the Abbasid caliphs, and Islamic conquests are virtually finished. Yet it is evident that the main period of Islamic conquest lasted about 5 prophetic months, or nearly 150 years. Until 1060 AD, when the Turks began to take Anatolia from the Byzantines, Arabs competed mostly among themselves, in lands they had already occupied to some extent, such as the taking of Crete and southern Italy – portions of which some Arabs had long occupied - in 820 and 827 AD.

7 And the likenesses of the locusts are like horses having been prepared for war, and upon their heads as crowns like gold, and their faces as faces of men, 8 and they had hair as hair of women, and their teeth were as of lions', 9 and they had breastplates as breastplates of iron, and the sound of their wings as a sound of many chariot-teams of horses running into battle, 10 and they had tails and stingers like scorpions, and their power is in their tails to injure men for five months. 11 They have over them a king: the messenger of the bottomless pit, whose name in Hebrew is Abaddon but in Greek he has a name, Destroyer. 12 One woe has departed. Behold, there come yet two woes after these things!

This is a poetic description of the Arab hordes. Apollyon is a Greek word which means *destroyer*. This is how we should view Mohammedism, even to this very day – as a destructive force to our Christian Civilization.

13 And the sixth messenger sounded the trumpet, and I heard one voice from the four horns of the golden altar before Yahweh, 14 saying to the sixth messenger, he having the trumpet: "Release the four messengers who are bound by the great river Euphrates!" 15 And the four messengers had been released, who had been prepared for that hour and day and month and year, that they should kill a third of the men. 16 And the number of the armies of the horsemen is two hundred million. I heard the number of them. 17 And thus I saw the horses in the vision, and those sitting upon them, having fiery-red and hyacinth and yellow breastplates, and the heads of the horses as heads of lions, and from their mouths came out fire and smoke and sulfur. 18 From these three plagues a third of the men had

been killed, from the fire and from the smoke and from the sulfur coming out from their mouths. 19 For the power of the horses is in their mouths and in their tails, and their tails like serpents, having heads and with them they injure.



Again, both Howard Rand and Bertrand Comparet correctly identified this second woe as a description of the Turkic invasions of Byzantine lands. This is the release of those bound by the Euphrates, which is metaphorical and not a literal reference, so that the Turkic hordes – already converted to Mohammedism by the Arabs in the 7th and 8th centuries - can begin to cross from the east. This process began in 1055 AD, when the Seljuk Turks captured Baghdad. Eventually they came to control nearly all of the formerly Arab lands, under the Ottoman Empire, but that is not our concern here. They began to move on Christian lands around 1064 AD when they began to clash with Byzantine troops in Asia Minor. In 1067 they attacked Caesarea and then Iconium in central Asia Minor. Although initially repulsed, within thirty years they controlled all of Anatolia. This ushered in the period of the Crusades, but wherever the European nations were able to recapture lands for Christendom, the results were only temporary. Furthermore, the Norman raids of the Balkans and southern Italy and their sacking of Constantinople in 1204 weakened efforts, rather than helping them. By the 14th century the Turks occupied the Balkans, and occupied or subjected many of the Black Sea nations. In 1453 Constantinople, surrounded by lands already fallen to the Turks, finally also fell to them. Looking at Byzantine resources in this period, compared to Turkic resources, it is amazing that the city held out as long as it did.


Going back to the text of the passage being discussed here, verse 15 from the King James Version reads in part “for an hour and day and month and year”, rather than “that hour and day and month and year”. The Greek may read either way, yet the interpretation need not change. If we interpret this time period by the prophetic time scale of a year for a day, this would add up to around 391 years and 15 days. The Turkic conquests of Anatolia began around 1067 AD, and their conquest of the of Eastern Roman Empire ended with the taking of Constantinople in 1453 AD, a that is a total of 393 years, very close to the 391 years of this prophecy. The army of two hundred million men in verse 16 need only represent the number of invaders over this nearly 400-year period.

Even more interesting, and a clear identifier of the fulfillment of this prophecy, where at verse 17 it says “And thus I saw the horses in the vision, and those sitting upon them, having fiery-red and hyacinth and yellow breastplates, and the heads of the horses as heads of lions, and from their mouths came out fire and smoke and sulfur”, this seems to be a poetic description of cannon. Constantinople was the first major city in history to have been taken with the help of cannon. Sadly, it was a Christian gun-maker, Urban of Hungary, whom the Turks hired to build the cannons, 70 of them. In his book, *Marvels of Prophecy*, Howard Rand has a picture of one of these cannon which sat as a war souvenir on the banks of the Thames in Britain. [I do have an image of one of these which I will post along with this document on [Christogenea](#).]

This particular cannon is shaped just like a lion, including its limbs, and the mouth of the lion is the mouth – or muzzle - of the cannon, while its tail looks like a long serpent up its back, where the fuse was lit, just as John described.

20 And the rest of the men, those who had not been killed by these plagues, did not even repent from the works of their hands, that they do not worship demons and idols, things of gold and things of silver and things of copper and things of stone and things of wood, things which are able neither to see nor to hear nor to walk. 21 And they did not repent from their murders nor from their drugs nor from their fornication nor from thefts.

When the Catholic religion – by which the true Christian religion is not meant - is compared to the ancient Greco-Roman paganism, we see that there is not much difference. The Catholics paganized Christianity, by transferring the ancient pagan gods and goddesses into the false conception of “saints”, thereby actually worshipping demons, and by their idolatry in the making of statues representing these things. The anti-Christian practices of pharmakeia – the use of drugs, and fornication – which is race-mixing, were also prevalent in Byzantium and Rome. They still are today, and we who remain of our race will never understand these things until we study our bibles and understand our history.

To All Those Who Deny Two Seedline

Again, I cannot emphasize enough how important it is to understand the formidable enemy with whom we have to contend! In order to fathom our present **world problems**, it is imperative we grasp two things: (1) That the White Europeans and their kin worldwide are the true racial Israelites

of the Bible, and (2) Who Israel's real enemies are. To know one without the other is insufficient. To improperly identify Biblical Israel's enemy is a criminal offense, for it can mean the difference between life and death to our people. Death is not always so obvious to the eye. When a white marries a member of another race, it brings about death of the Spirit which was breathed into our forefather Adam. If you are ever invited to attend a wedding of a White and a non-white, you are not attending a wedding, but a funeral. When the 23 chromosomes of the male sperm of a non-white unites with the 23 chromosomes of the egg of a White, it brings death to the 23 chromosomes of the egg of the White (and the other way around)! This process is now happening in White countries every few minutes. In the Bible it is called a "plague", Numbers 25:1-9 (especially verse 9). In that chapter, having intercourse with non-Israelites was considered the same as "death." If you think the bombing of the Twin Trade Towers in New York was terrible, consider the death being brought about by miscegenation. This should give you some idea of what kind of WAR we are in, and who the players are. Now the key to understanding this WAR is found in Genesis 3:15. The anti-seedliners, by denying the truth of that passage, are aiding and abetting Israel's worst enemy. Actually, the anti-seedliners are doing more damage than the "Jews"

themselves. They call us Two Seedliners 'seedliners', so the only thing we can dub them is 'anti-seedliners'.

MY FATHER versus YOUR FATHER

John 8:38 is one of the main supporting passages for Genesis 3:15:

"I speak that which I have seen with my Father: and ye do that which ye have seen with your father."

You will first notice, as properly applied by the translators, the one "father" is capitalized and the other one isn't. From this, it should be quite evident that the Father of the Messiah was not the same father as that of those so-called "Jews." Therefore, Scripture is talking about two separate genetic family trees! You might argue, "this is speaking in a 'spiritual' sense." Yet, take a look at the next verse where it says: "*Abraham is our father.*" That hardly sounds "spiritual", does it? It is not "spiritual" here, nor is it "spiritual" in John 8:44 where Messiah tells certain Judeans, later called "Jews", who their father really was and is.

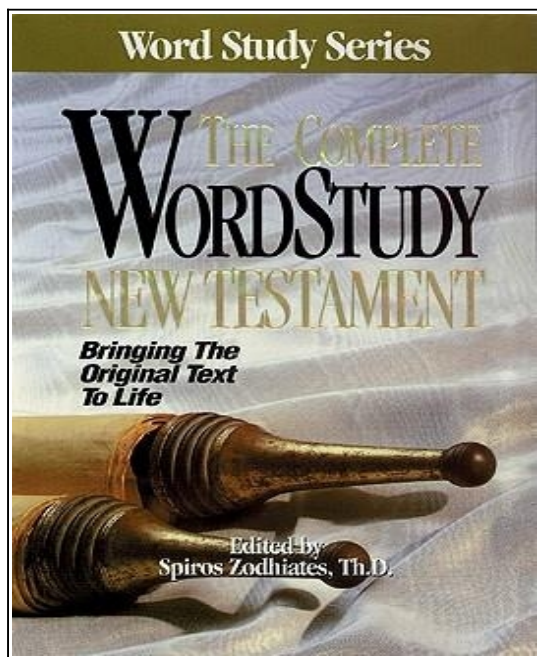
Further, it is stated "my Father" and "your father" indicating that our Savior had a different genetic Father than did the so-called "Jews." The Greek word for "my" is #3450, while the word for "your" is #5216. Surely, this language should be clear enough to understand the "Pharisee" and "Sadducee" alleged "Jews" were, for the most part, definitely not of the same lineage as our Messiah. Yet, in spite of that evidence, this is what the anti-seedliners falsely maintain. Weiland and Weisman both made this assertion as I have already shown you in other *Special Notices*. What is it that we don't understand about the difference in the meanings of "my" and "your"? Jeffrey A. Weakley also says it's all "spiritual."

'IF'

In John 8 verse 39 it says: "**IF** ye were Abraham's children, ye would do the works of Abraham." In

verse 42 it says: “**IF** God were your Father, ye would love me.” Questions: (1) Did the so-called “Jews” ever do the works of Abraham? (2) Did these same “Jews” ever love Him? In order to understand what these passages mean, it will be necessary to qualify the Greek word “**IF**.” Actually, there are two Greek words translated “**IF**” in our English versions, and they are quite different! As a matter of fact, unless we investigate the true meanings of these words in the Greek, we cannot comprehend what is being said in the entire 8th chapter of John.

The one word “**IF**” is #1487, and the other word “**IF**” is #1437 in the *Strong’s Concordance*. We are particularly interested in #1487 in this case. W. E. Vine does not deal with either of these. *Strong’s* explanations do little to make these understandable either. After



searching through several Greek reference books, I found Dr. Spiros Zodhiates in his *The Complete New Testament Word Study Dictionary* had the best general definitions for these two meanings. On pages 504 & 493 he says this of these two Bible words rendered ‘**IF**’:

“1487 ... *ei*: conditional conjunctive. If. As such it expresses a condition which is merely hypothetical and separate from all experience in indicating a mere subjective possibility and differing from *ean* (1437), if, which implies a condition which experience must determine, i.e., an objective possibility referring always to something future ...”

“1437 ... *ean* ... It differs from *ei* in that *ei* expresses a condition which is merely hypothetical, a subjective possibility; *ean* implies a condition which experience must determine, an objective possibility, and thus refers always to something future ...”

From this we can see in the Greek, for these two words, it is either a “hypothetical” **IF** or a “future” **IF**. For an example of a “future” **IF**, one might say: **IF** you will turn on the ignition, you might be able to start the engine. But the **IF** in our passages above is #1487, a “hypothetical” **IF** in nature. Thus, these verses might read something like this:

Verse 39 saying: “**IF** [hypothetically] ye were Abraham’s children, ye would do the works of Abraham.” And verse 42 saying: “**IF** [hypothetically] God [Yahweh] were your Father, ye would love me.”

Surely, this very strongly suggests that the greater part of the Pharisees and Sadducees were NOT true children of Abraham of **pure genetic seed**! When faced with these statements of our Redeemer, the so-called “Jews” said, verse 41: “**We be not born of fornication; we have one Father, even God.**”

Those so-called “Jews” wouldn’t have made such a statement if it hadn’t been implied in the discourse by our Savior in John chapter 8, for “fornication” means to race-mix. Yes, they understood His words very well, and they knew what the word “*ei*” (**IF**) meant, even though the anti-seedliners don’t seem to comprehend it today. Not only did the “Jews” understand the impetus of Messiah’s words, but they understood well the sarcasm in which they were said. There used to be a bumper sticker that read: “*If you’re so smart, why aren’t you rich!*” Messiah said: “**If ye were Abraham’s children, ye would do the works of Abraham.**”

How much more evidence is needed to convince the anti-seedliners that those so-called “Jews” were not true pure-blooded descendants of Abraham? I recognize that verse 37 says: “*I know that ye are Abraham’s seed*”, but it doesn’t say “*pure seed*”, and “*never in bondage*” confirms it in John 8:33! The Hebrew word “*arab*”, #6154, means “a *mixture* or *mongrel* race” The Esau-Edomite-“Jews”, and the Arabs all have one thing in common; they are all “*mamzers*” (bastards). All mixed people are “Arabs.”

'OF'

In John 8:47, Messiah tells the so-called “Jews”: **“He that is [genetically] OF God heareth God’s words: ye therefore hear them not; because you are not [genetically] OF God.”** In *Special Notice #1*, we considered the word **“OF”** such as used in this verse. It is *Strong’s* #1537 in the Greek. To refresh our memory, I will repeat it here:

“The *Complete Word Study Dictionary, New Testament* by Dr. Spiros Zodhiates devotes five pages to define and expound the word **“OF”** as used in the Greek, pages 529-534. Obviously, I cannot quote this entire document here, but cite only that which is relevant to John 8:44:

“1537. ... Preposition governing the genitive, primarily meaning out of, from, of, as spoken of such objects which were before another ... Of the origin or source of anything, i.e., the primary, direct, immediate source ... Of persons, of the place, stock, family, condition, meaning out of which one is derived or to which he belongs ... Of the source, i.e., the person or thing, out of or from which anything proceeds, is derived, or to which it pertains ...”

“The *New Testament Greek Study Aids*, by Walter Jerry Clark, says, on page 230, about the Greek word ἐκ: ‘out of ... with the genitive: by means of, out of.’ The *Intermediate New Testament Greek* by Richard A. Young, page 95 says the following: ‘ἐκ often conveys special extensions ‘out of’ or ‘from.’ For example, the prophet said that God would call His Son out of Egypt (Matthew 2:15)” From the *Greek to English Interlinear* by George Ricker Berry, page 31 of his “Greek-English New Testament Lexicon”, we have this: “ἐκ, or before a vowel, ἐξ, a preposition governing genitive, from, out of.” The *Thayer Greek-English Lexicon of the New Testament*, page 189 expresses ἐκ this way: “... out of, as separation from, something with which there has been close connection ...” John 8:47 has the same connotation as John 8:44. It means a chip off the old block. When it says the so-called “Jews” are not **“OF”** God [Yah], it means it in a genetic way. But only those of us who are genetically **“OF”** God (Yahweh) can hear and comprehend His

Word.

John chapter 10 warns us of this very thing! In John 10:26-27 Messiah says the same thing to the “Jews”, but puts it a little differently: “26 But ye believe not, because ye are not my sheep, as I said unto you. 27 My sheep hear my voice, and I know them, and they follow me.”

You may be wondering why I am so adamant concerning the Two Seedline doctrine. The reason I am so insistent is because, without properly identifying the enemy, the Identity message is neutralized. It also tends to open the door for the enemy to worm his way into our midst. Once the enemy has established a beachhead among us, he can spread all kinds of misleading information and false doctrine (“leaven”). The “Jews” who are in the Herbert Armstrong camp are a good example of this. It should be obvious that the “Jews” would have the most to gain from an anti-seedline message. If the enemy can directly or indirectly influence those in Israel Identity to the fraud that there is no “seed of the serpent”, he has them right where he wants them. Once the enemy has convinced Identity minded people there is no “seed (children) of the serpent”, the

Messiah says the same thing to the Jews, 'But ye believe not, because ye are not my sheep, as I said unto you. My sheep hear my voice, and I know them, and they follow me'

“no-devil doctrine” invariably follows. Once this erroneous premise is established, the next step is usually to identify the “devil” as the “flesh.” While it is true we do have a war with the flesh, this is not the same WAR as that which is being waged against “the seed (children) of the serpent!” To identify the flesh as the Satanic enemy is to grossly misdirect our energy. While the anti-seedline people are trying to analyze their own individual, personal, fleshly problems, the real enemy is bulldozing along their agenda to destroy the White Race! You can’t get any more neutralized than that!!! Paul speaks of it as: “one that beateth the air.” David said the following about the enemy, Psalm 139:21-22, of which I am sure he wasn’t talking about his “flesh”:

“21 Do not I hate them, O YAHWEH, that hate thee? and am not I grieved with those that rise up against thee? 22 I hate them with perfect hatred: I count them mine enemies.”

Surely, the “devil” and the “flesh” can’t be the same thing! Yet this is what Ted R. Weiland maintained on one of his ten audio cassette tape series entitled *Eve, Did She Or Didn’t She?* He tried to claim that the two seeds of Genesis 3:15 were the “seeds of the spirit against the seeds of the flesh.” Ted R. Weiland was saying, in effect, that the “tree of knowledge” was the law, and when Eve ate of it, it brought on death and that the “enmity” between “thy seed and her seed” of Genesis 3:15 is the enmity between the “flesh and the spirit.” In other words, the flesh represents a seed line. In doing this, Ted R. Weiland was separating verse 15 from 14 as if it didn’t exist. Yahweh was directing His dialogue to the “serpent”, not the “flesh.” Let’s read the whole passage, Mr. Weiland:

“14 And Yahweh said to the serpent, Because thou hast done this, thou *art* cursed above all cattle, and above every beast of the field; upon thy belly shalt thou go, and dust shalt thou eat all the days of thy life: 15 And I will put enmity between thee and the woman, and between thy seed and her seed; it shall bruise thy head, and thou shalt bruise his heel.”



Now if it is a war between the “spirit” and the “flesh”, it would have to read as follows. (So let’s now read it as Ted R. Weiland would have us to read it):

“And the LORD God said to Eve’s flesh, Because thou hast done this, thy flesh is cursed above all cattle, and above every beast of the field; and thy flesh shall go upon its belly, and dust shalt thy belly eat all the days of thy life: And I will put enmity between the flesh of the woman and the spirit of the woman, and between the offspring of her flesh and the offspring of her spirit, and the offspring of her spirit shall bruise the head of the offspring of her flesh, and the offspring of her flesh will bruise the heel of the offspring of her spirit.” (The Gospel according to Ted R. Weiland.)

THE 'LAW TREE' HYPOTHESIS

Although Weiland does not say it in terms of a “law tree”, he highly suggests that this is what the “tree of

the knowledge of good and evil” was which Eve partook of in the garden. I will quote some excerpts from his book by the same title as his ten audio cassette series, pages 40-44, and I am sure you will have to agree with my analysis of what he, in essence, is saying:

“There are no scriptures that categorically tell us what the tree of the knowledge of good and evil was ... Genesis 3:22 clearly reveals that the knowledge of good and evil resides not with some demon of darkness, but rather with our omniscient God, Yahweh ... God’s law itself is good because it reflects Yahweh’s nature. Consequently, Yahweh uses it as the vehicle through which the knowledge of good is commuted to man. The knowledge of evil is imparted by means of the law as well ... Furthermore, Genesis 3:6 describes the tree of the knowledge of good and evil as being able *to make one wise, being pleasant to the eyes and good for food*. These qualities also describe the law of God ... At this point someone is likely to inquire ‘If the tree of the knowledge of good and evil was the law of God, would not that

have made God’s law evil because God did not want Adam and Eve to partake of it?’ ... There may be Christians, especially those who understand the vital goodness and importance of God’s law for us today, who may still have difficulty reconciling in their minds that Yahweh would ban His law from Adam and Eve. Such Christians should consider that when God prohibited Adam and Eve from partaking of the tree of life, that prohibition did not make the tree of life evil ... So why would Yahweh want to keep Adam and Eve from His law? ... Perhaps God initially forbade Adam and Eve the knowledge of good and evil by way of His law because He knew He would have to hold them accountable to it, and He knew the heartache and death that would ensue as a result ... On the other hand, if the eating of the tree of knowledge of good and evil was an unlawful partaking of God’s law, then there is a connection between Adam and Eve’s sin and all other sin.”

Let's now sort out all this gibberish. What are the consequences of what Weiland is saying? Weiland is inferring that Yahweh deliberately withheld His Law from Adam and Eve so they wouldn't be condemned by their sin — that as long as they didn't know the Law, they were innocent - that by partaking of the Law, it brought about death. If Weiland is correct (Yahweh forbid), and Adam and Eve had never partaken of the "law-tree" (as Stephen E. Jones calls it), we could conceivably be living in innocence today, partaking of every kind of immorality, and it would not be considered by Yahweh as sin because we never ate of the so-called "law-tree." Wouldn't all the homosexuals of today love that situation?

THEORY OF EATING OF THE LAW TREE NOT ORIGINAL WITH WEILAND

This idea is not original with Weiland. Stephen E. Jones, in his book *The Babylonian Connection*, pages 60-61, says this in part:

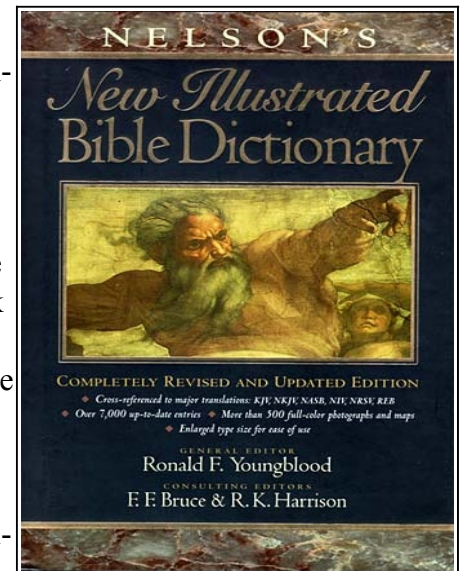
"The tree of life (Grace) and the tree of knowledge (Law) both were planted in the same garden by God. They grew together. The Law-tree provided the righteous standard; the Grace-tree provided the means by which the standard could be met ... First they disobeyed God by eating from the Law-tree, and for that act they were made mortal. Then their eyes were opened to know both good and evil, and they *recognized* their mortality in contrast to God's immortality ... Because they had broken His Law, they stood naked (mortal) and without excuse." [*Bull manure!*]

All this is absolutely preposterous, for there is positively no Scriptural backing for such ideas as a "law tree", or a "grace tree", or that the two seeds of Genesis 3:15 are representative of the "seeds of the flesh" and "seeds of the spirit." The term for seed in both the case of the woman and the serpent is #2233 *zera*, and is the same word used in Genesis 13:16 where Abram is promised by the Almighty that his "seed" would become "as the dust of the earth." If in fact Abraham had literal "seed", so also must the serpent of Genesis 3:15 have literal "seed!" So where are the serpent's "seed" then? You talk about "taking away", "adding to" or "twisting"; this is the ultimate zenith of absurdity. It is obvious then, that the "woman", the "serpent" and "Abraham" were all to have literal "seed" (children).

Thus, to state that the "woman" was to have only one "seed" is also outrageously irrational for it does not literally follow! She was to have a single variety (species; like kind) of "seed" via Seth, of which one "seed" was to bruise the head of the serpent! All this makes one wonder who will be next in line to parrot this same spurious argument! Stop and think: Without the "seed" of the serpent, Messiah's heel could not be bruised; and without the bruising of His heel, we have no Redemption. Maybe we should be a tad more careful how we interpret Genesis 3:15! Repeating: If there was not a literal genetic offspring of the "serpent" to bruise the "heel" of our Savior, then, WE HAVE NO REDEMPTION!!! It would appear the anti-seedliners have talked themselves into a corner from which there is no escape!

'A MURDERER FROM THE BEGINNING'

This phrase is found in John 8:44, and the anti-seedliners make the claim that it has a "spiritual" connotation. For the life of me, I don't know where they find a case of "spiritual murder" in the Bible. Then again, maybe they have a different Bible from mine. I wish they would quote book, chapter and verse showing a single occurrence where someone was "murdered spiritually." The word "murderer" in John 8:44 is #443, *anthropoktonos*, in the Greek and means "a manslayer." It would seem if it had "spiritual" connotations, it would be defined as "spirit slayer." But, try as I may, I can find no place where this word has any such meaning. Many of the commentaries attempt to point out that this doesn't mean Cain, but the devil. Lt. Col. Jack Mohr makes this same claim on page 23 of his *Seed of Satan, Literal or Figurative?* But thankfully, all commentaries do not agree on this. The *Nelson's Illustrated Bible Dictionary* says this on page 733:



“**MURDER** — the unlawful killing of one person by another, especially with premeditated malice. After the Fall in the Garden of Eden (Gen. 3:1-24), it was not long before the first murder occurred (Gen. 4:8), as Cain killed Abel his brother.”

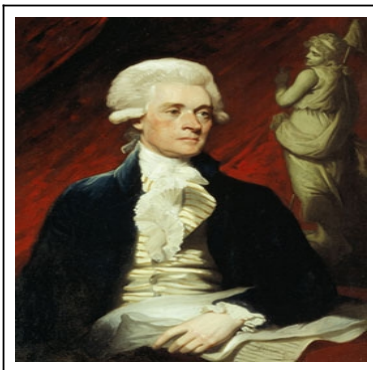
It would appear from this that the killing of Abel by Cain is the first recorded murder in the Bible. While it is true that Satan’s beguiling brought on “death”, nowhere is it recorded as a “murder” as implied in the meaning of this Greek word. *The Complete New Testament Word Study* by Spiros Zodhiates makes this observation on the Greek word #443 on page 179: “*anthropoktonos* ... Homicidal, used substantively [not imaginary; real rather than apparent; actual] manslayer, one who commits homicide (John 8:44; 1 John 3:15) ... to kill, put to death.”

As you can see, Zodhiates includes both John 8:44 and 1 John 3:15 in this definition. And, if you will check 1 John 3:15, you will see that it is speaking of Cain as recorded in 1 John 3:12, just three verses before it! Where do these anti-seedliners come up with all of this hocus-pocus about some kind of “spiritual murder”?

Stephen E. Jones implied this in his *The Babylonian Connection* on pages 70-71 where he said this:

“Remembering John’s definition that ‘he that committeth sin is of the devil’, Jesus was simply saying that the Pharisees were doing the devil’s works. Since we have already seen that the devil could not have physically fathered Cain, nor any other human, the Pharisees were ‘of the devil’ idiomatically, not genealogically.”

words it a little more cleverly, when on page 90 he says:

“However, any well-versed Bible student knows that the Word of God is not always intended to be taken literally.” Then, on page 84 he asks this question: “However, is it a foregone conclusion that the word ‘father’ used in John 8 has to be understood in a literal, physical sense? The seedliners declare: ‘Absolutely!’”

Well, if the word “murderer” is literal, as we have just seen, then the word “father” would have to be literal also, would it not? Matthew 23:29-35 cites the murdered victims.

Jeffrey A. Weakley, in his *The Satanic Seedline, Its Doctrine and History*, parrots the same contention in a “question and answer” discussion conducted solely by himself on page 24:

“**ARGUMENT** [of the Two Seedliners]: John 8:44 says: ‘Ye are of your father the devil ...’ This shows that the devil is their physical father.” **ANSWER** [by Weakley]: “Wrong. This once again shows that the devil is their spiritual father (the one that they serve).”

Lt. Col. Jack Mohr in his *Seed of Satan, Literal or Figurative?*, page 26, put it this way:

“Figuratively, I believe they are the special children of Satan and that as the Apostle Paul said: ‘They please not God, and are contrary to all men’ (Thess. 2:15). But let us use care when we call them the literal, physical children of Satan, for we cannot prove this from the Word.”

How wrong Mohr was in that assessment - WRF

Valley Forgery Rewriting History

Last July we wrote in *Philthadelphia* about the corrupted revising of American history in order to wrongly give credit for the making of this society to those groups who have as of late come to dominate the city, especially Negroes and Jews. We said that “Today it is their monuments which are quickly coming to dominate Philadelphia, and they are rewriting our history in order for them to make it even easier to corrupt and destroy our nation.” A display of this same phenomenon was made in our February Saxon Messenger editorial, [Worshipping the Beast](#), where it was explained that at the National Constitution Center in Philadelphia, American History up to the Civil War is portrayed as little more than a debate over the issue of slavery and the plight of Negroes, when in fact that debate was only an incidental part of both the history of that era and the causes of the war itself. We also attempted to illustrate how other facets of American history, such as the nature of the American air forces in World War Two Europe, were being distorted by those same groups for that very same purpose.

On another recent trip to the Philadelphia area, we now notice that the same people are up to the same shenanigans, and that they are forging history at Valley Forge. Amidst the monuments commemorating those White men who left the comfort of their homes and farms and kin in order to fight for a cause they believed in, there is now at least one large monument - relatively new compared to the others, and also quite different from all of the others - which clearly has no part with the others. While most of the roadside monuments encircling the Valley Forge grounds have

the names of real men, mostly of the rank of Colonel, who had been among the officers of the regiments which camped through that historic winter during the Revolution, this one large granite monument has emblazoned in bronze on its front “Patriots of African Descent”, below a large relief of a male Negro in the regular military dress of the period. Actually, his uniform looks fairly rich compared to the accounts of the tattered condition of the troops who actually lived through that winter encampment.

On the back side of the monument it has engraved “In honor of patriots of African descent who served suffered and sacrificed during the Valley Forge encampment”. This assertion is then propped up by the claims of a modern Negro and supposed historian named Charles L. Blockson, who is quoted as saying

that “Throughout these historic and hallowed campsites were courageous black patriots who participated in our nation's bitter fight for independence”. The monument then has a notice, that it was dedicated by the Valley Forge chapter of some sorority, and there is a bronze placard on its back presumably containing the names of all of the Negroes and others involved in getting the monument erected. Of course, there is very little real history of any Negroes who fought in combat for the cause, or who were encamped at Valley Forge along with those non-imaginary White men who actually did participate in the struggle.

One website for the National Park Service makes the assertion that enlisted Negroes participated in the Revolutionary War in significant numbers, and were among those at Valley Forge (See the online article [Valley Forge Encampment Diversity](#)

[of the Revolutionary Soldiers](#)). However the revising of history by the Park Service is so sloppy that it claims Washington himself issued an order which “authorized the enlistment of free African Americans on December 30, 1775.” The *Valley Forge Muster Roll Project* makes the claim that “Promises of freedom motivated thousands of enslaved African Americans to join Continental and British forces. In the Continental Army, bound individuals yearning for liberty and wages served alongside freemen in search of a better life. The Continental Army was integrated and included many patriots of African descent.”

Yet another revisionist article advancing the role of Negroes in the Revolutionary War, *The Revolution's Black Soldiers* by Robert Selig, more accurately states that Washington did not permit free blacks to enlist in the Continental Army until

January 1777. Selig is certainly not biased against any thoughts of Negro involvement in the war. Many blacks were said to have enlisted hoping to gain freedom from slavery, and there were, as he claims, 700 blacks on the American side in the Battle of Monmouth, where the total force was approximately 11,000. A proportionately equivalent number, 5%, of the American side at Bunker Hill are

frequently said to have been black. Yet Selig also says that there were only 755 blacks in the entire Continental Army according to an official army report issued eight weeks after the Battle of Monmouth. Most of these Negroes who did serve, served in positions without arms, as in Virginia free blacks admitted to the militia during the war when manpower was short were only permitted to serve without arms, and even in northern States blacks permitted to serve in state militias were often forbidden arms, although there were apparently a couple of small black regiments – with White officers – formed in Rhode Island and Connecticut later in the war. After the war, Selig says of Virginia that “eight slaves are known to have been granted freedom by the legislature for service in the Revolutionary War.”

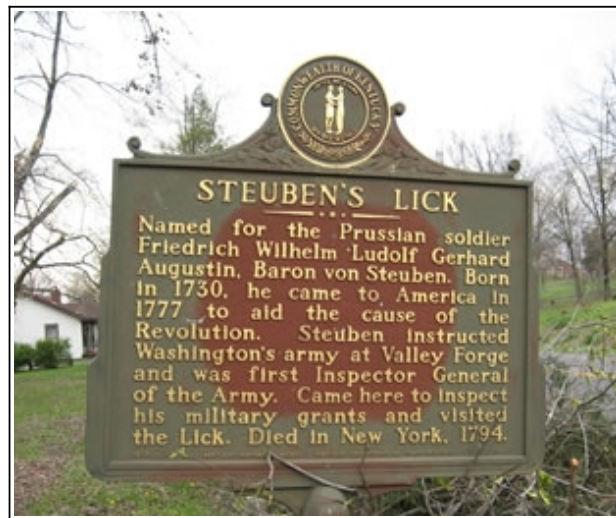
Often misquoted on the internet is a supposed

comment from the papers of one Baron von Closen, a member of Rochambeau's French army at Yorktown, who purportedly wrote of the American army that in July 1781, "A quarter of them are Negroes, merry, confident and sturdy." That is the way it is presented in many internet articles, which leaves readers with the impression that von Closen was describing the entire Continental army. However a closer inspection of some sources, such as the aforementioned article by Selig, reveals the context of the quote, where von Closen was only discussing the American forces gathered at White Plains, New York, at a particular instance in June, 1781, and estimated that there were 1,200 to 1,500 blacks among them. While the Von Closen papers were known to American historians since at least 1890, according to [an article published that very year in The New York Times](#), the earliest

citation for the Closen quote as it appears in many internet articles is from *The Revolutionary Journal of Baron Ludwig von Closen, 1780-1783* by Evelyn M. Acomb, translator and editor, which was published in 1958 by the University of North Carolina Press. Just in time for the civil rights movement.

There are many claims that as many as 5,000 Negroes “served” on the American side in the Revolutionary war.

According to [Wikipedia](#), there were 757,208 Negroes in the United States in 1790, that first census reflecting the highest recorded point that the Negro population ever reached as a percentage of the overall population. According to that same source only 60,000 were free, and the rest were slaves. Most of these free Negroes lived in the urban centers of the north, and those who did serve in the military did so for pay. Some in southern states were manumitted, and functioned as slaves in a support capacity in one of the various state militias. While Maryland allowed blacks to enlist in their Continental Army regiments in 1779, the other southern states forbid them totally. Selig's article even admits that in the face of an imminent British invasion, Virginia nevertheless refused to arm slaves. Therefore any Negroes who did serve in the state militia under manumission were not placed into



armed positions.

However the 755 Negroes mentioned by Selig as being in the Continental Army, out of an approximate free black population of 60,000 means that a considerably low number of blacks served in the American regular army as a percentage of the free black population – not even one-and-a-half percent. And even if 5000 Negroes served in all forces, which would include state militias, that would represent only a tiny percentage of the 230,000 men who are estimated to have served in the Continental Army alone over the course of the war, for which see the article describing [The Continental Army](#) at [sonsofthesouth.net](#). Others estimate that number to be as high as 250,000, as stated in the article [Valley Forge FAQs](#) at the [USHistory.org](#) website. Not counting Whites in state militias which were not part of the Continental Army, the lower of these figures places blacks at just 2.1% of the armed forces while they are said to have been 19.3% of the population.

Yet if the figures in the article [The American Revolution: How were the colonies able to win independence?](#) at the Digital History website are correct, the disparity may be even greater yet. Here it is explained that over 400,000 Americans took part in the fighting over the course of the war, and that of these there were “at least 5000 blacks”, a ratio of perhaps 79:1, even greater once it is realized that far fewer blacks were actually armed:

The growth of popular participation in politics began even before the Revolution. In the years preceding the war, thousands of ordinary Americans began to participate in politics--in non-importation and non-exportation campaigns, in anti-Tory mobs, and in committees of correspondence linking inland villages and seaports. Many men joined groups like the Sons of Liberty to protest British encroachments on American liberties. Many women took the lead in boycotts of British goods; they also took up the spinning wheel to produce homespun clothes. During the Revolution itself, some 400,000 Americans, including at least 5,000 African Americans, served in the fighting for at least some time.

The British, however, had a much larger success rate at mobilizing Negroes. The same sources that credit the black race with supplying 5,000 “patriots” to the

American side of the war, also admit that as many as 20,000 contributed to the British war effort. While Selig records that General Howe himself refused to have blacks enlisted as soldiers in his army, not all British generals had that attitude. In an article at another Park Service website which discusses the American Revolution, entitled [Stories From the Revolution](#), the following is found:

When the British launched their southern campaign in 1780, one of their aims was to scare Americans back to the crown by raising the fear of massive slave revolts. The British encouraged slaves to flee to their strongholds, promising ultimate freedom. The strategy backfired, as slave owners rallied to the patriot cause as the best way to maintain order and the plantation system. Tens of thousands of African Americans sought refuge with the British, but fewer than 1,000 served as soldiers. The British made heavy use of the escapees as teamsters, cooks, nurses, and laborers. At the war's conclusion, some 20,000 blacks left with the British, preferring an uncertain future elsewhere to a return to their old masters. American blacks ended up in Canada, Britain, the West Indies, and Europe. Some were sold back into slavery. In 1792, 1,200 black loyalists who had settled in Nova Scotia left for Sierra Leone, a colony on the west coast of Africa established by Britain specifically for former slaves.

On the [African American Heritage](#) page at the [ValleyForge.org](#) tourist site, only two Negroes are actually named, one called a soldier and the other said to be a freed female slave. That may be representative of reality, but it certainly does not merit a special monument for “African American Patriots” situated in a way that insinuates that they are somehow the unsung heroes of a dominant White society. While any role that certain blacks may have had in helping the American cause need not be disparaged, the overall role of Negroes is instead being exhibited in a manner which leaves visitors and readers with the impression that black efforts for the Americans far exceeds their actual contribution. The actual numbers, when examined in the context of the entire war, clearly demonstrate that the black contribution to the war effort was negligible. They also show that blacks as a group actually had a negative impact on the efforts of

Americans to gain their independence, since many more fought for the British than those who helped the American cause. History is indeed being rewritten in order to please the false gods of diversity and multiculturalism. That is Valley Forgery.

There are several reasons why the Patriots of African Descent monument should be considered heretical, and even removed. Here are a few:

- The monument represents a general corruption of history to favor the interests of a particular ethnic group, something which should never be tolerated or supported by the public at large.
- All of the monuments at Valley Forge are dedicated to the great leaders of the war, and to the regiments which those men led – regardless of who served in those regiments. Therefore the other monuments represent all

ethnic groups.

- There are no other monuments for any other ethnic group, such as the Germans, the Irish, the Swedes, the French etc., all of whom – along with other European ethnic groups – were much better represented among the ranks of the soldiers than Negroes, but none of whom have their own special monument. Therefore, the monument hypocritically makes a distinction of Africans which were only one ethnicity among many which participated in the war.
- **At least four times as many Negroes fought against the fledgling American nation as those who fought for it,** and therefore any claim which blacks may have as having contributed as a group to the founding of the nation is negated four times by their own kind. Therefore they do not deserve any special commemoration as a group, since they clearly acted only as individuals in their own interests.

The general trend in historical studies and commemorations in the entire Philadelphia area is aimed at unjustly enfranchising minority ethnic groups which did not contribute in any significant manner to the founding of the American nation, at the expense of those Whites who did found the nation. While it is not possible to reverse this trend under the present-day political climate, it must be noted by Whites everywhere, that certain other groups are purposely trying to diminish the White stake in American society, and in that way make it easier to displace Whites themselves from their own society.

One journal, Race Traitor, edited by [Jewish academic] Noel Ignatiev and subtitled "Treason to Whiteness is Loyalty to Humanity," openly declares its conviction that the only way to solve the social problems of the age is to abolish the White race. Its admitted aim is not "multiculturalism" or "multiracialism," but biological unity and racelessness.

Lithuania

The Latest Jewish Extortion Victim

As reported by the Jewish news outlet [Ynetnews](#), the Lithuanian government has recently entered into an extortion agreement with European Jewry, according to Reuters. The article states that “Lithuania's government on Wednesday approved a foundation to allocate 128 million litas (\$49.45 million) in compensation for Jewish communal property appropriated during Nazi and Soviet times. The step follows last year's decision by the parliament to pass a special law after years of negotiations and calls from Lithuania's Western allies, including the United States, to reach the settlement.”

It is Lithuania which should be collecting from the Jews, and not the Jews from Lithuania. The tiny Baltic state was first attacked by the Bolsheviks attempting to keep it from independence at the end of 1918. The Bolsheviks only failed because of the help of the German Freikorps. Over the immediately subsequent years Lithuania was forced to fight wars against the Bermontians (a mix of German and Russian anti-Bolshevik military forces who sought to maintain power in the region in the aftermath of the First World War), the Poles and the Latvians, where Lithuania was never the aggressor. Before 1919, Lithuania did not even have an army of its own.

Lithuania fought hard, and against all odds, to maintain its independence during the inter-war period of the 1920's and 1930's. During this period, the Jews in Lithuania were unmolested, and they evidently thrived. The government of Lithuania, due to territorial and other disputes, opposed National Socialist Germany at an early time, and Germany even imposed an embargo against Lithuania. As Europe once again neared war, Lithuania was only a pawn on the map between Germany and the Soviets, until the Soviets annexed the Baltic states in 1940. In 1941



Germany invaded and occupied Lithuania. Many Lithuanians cheered Germany as a deliverer from the Soviet oppression. Many Lithuanians were compelled to assist the war effort by Germany. But on the other hand, many Lithuanians resisted the German occupation, and

some even formed a pro-Soviet armed resistance, in league with minority Russians and Jews. The Lithuanian people as a whole, therefore, who were always imposed upon by the much larger powers, can by no means be seen as aggressors or as being responsible for anything which happened to non-Lithuanians during the war.

After the war, Lithuania was returned to Soviet rule until 1988. The Lithuanian people were every bit as much victims of circumstances as the Jews claim to be, and even to a greater extent, for they were victims of the Jews: it is common knowledge that Bolshevism itself was Jewish, the Bolshevik leaders were nearly all Jewish, and Bolshevism was the primary cause of the Second World War in the east in the first place.

The [Ynetnews](#) article also cites the chairman of the Lithuanian Jewish Community as saying that there are “about 4,000 Jews left in Lithuania”. According to a [Wikipedia article on Lithuania](#), only about 2,000–3,000 Lithuanian Jews were liberated from German camps. How many of the 4,000 Jews in Lithuania today could actually have been survivors of any supposed “Holocaust” which allegedly took place there 70 years ago?

Warning for Americans: A Message from a South African

People used to say that South Africa was 20 years behind the rest of the Western world. Television, for example, came late to South Africa (but so did pornography and the gay* rights movement).

Today, however, South Africa may be the grim model of the future Western world, for events in America reveals trends chillingly similar to those that destroyed our country.

America's structures are Western. Your Congress, your lobbying groups, your free speech, and the way ordinary Americans either get involved or ignore politics are peculiarly Western, not the way most of the! world operates. But the fact that only about a third of Americans deem it important to vote is horrifying in light of how close you are to losing your Western character.

Writing letters to the press, manning stands at county fairs, hosting fund-raising dinners, attending rallies, setting up conferences, writing your Congressman -- that is what you know, and what you are comfortable with. Those are the political methods you've created for yourselves to keep your country on track and to ensure political accountability.

But woe to you if -- or more likely, when -- the rules change. White Americans may soon find themselves unable or unwilling to stand up to challenge the new political methods that will be the inevitable result of the ethnic metamorphosis now taking place in America.

Unable to cope with the new rules of the game -- violence, mob riots, intimidation through accusations of racism, demands for proportionality based on racial numbers, and all the other social and political weapons used by the have-nots to bludgeon treasure and power from the haves -- Americans, like others before them, will no doubt cave in. They will compromise away their independence and ultimately their way of life.

That is exactly what happened in South Africa. I know, because I was there and I saw it happen.

America; yet ultimately South Africans voted for their own suicide. We are not so very different from you.

We lost our country through skillful propaganda, pressure from abroad (not least from the U.S.A.), unrelenting charges of "oppression" and "racism," and the shrewd assessment by African tyrants that the white man has many Achilles' heels, the most significant of which are his compassion, his belief in the "equality of man," and his "love your neighbor" philosophy -- none of which are part of the Third World's history.

The mainline churches played a big role in the demise of Western influence throughout Africa, too; especially in South Africa. Today's tyrants were yesterday's mission-school protégés. Many dictators in Africa were men of the cloth. They knew their clerical collars would deflect criticism and obfuscate their real aims, which had nothing whatever to do with the "brotherhood of man."

Other tyrants, like the infamous Idi Amin, were trained and schooled by the whites themselves, at Oxford, Cambridge, and Harvard. After receiving the best from the West, they unleashed a resentful blood-lust against their benefactors.

From what I have seen and read thus far, I fear Americans will capitulate just as we did. Americans are, generally, a soft lot. They don't want to quarrel or obstruct the claims of those who believe they were wronged. They like peace and quiet, and they want to compromise and be nice.

A television program aired in South Africa showed a town meeting in Southern California where people met to complain about falling standards in the schools. Whites who politely spoke at the meeting clearly resented the influx of Mexican immigrants into their community. When a handful of Chicanos at the back

of the hall shouted and waved their hands at them, the whites simply shrunk back into their seats rather than tell the noise-makers to shut up. They didn't want to quarrel.

In America, the courts are still the final arbiters of society's laws. But what will happen when your future majority refuses to abide by court rulings -- as in Zimbabwe? What will happen when the courts are filled with their people, or their sympathizers? In California, Proposition 187 has already been overturned.

What will you do when the future non-white majority decides to change the names of streets and cities? What will you do when they no longer want to use money that carries the portraits of old, dead white "racists" and slave owners? Will you cave in, like you did on flying the Confederate flag? What about the national anthem? Your official language?

Don't laugh. When the "majority" took over in South Africa, the first targets were our national symbols.

In another generation, America may well face what Africa is now experiencing -- invasions of private land by the "have-nots;" the decline in health care quality; roads and buildings in disrepair; the banishment of your history from the education of the young; the revolutionization of your justice system.

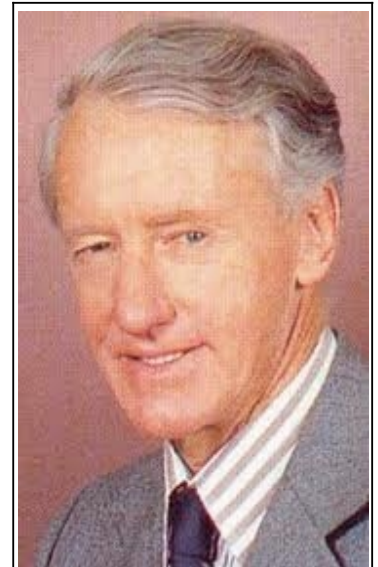
In South Africa today, only 9 percent of murderers end up in jail. Court dockets are regularly purchased and simply disappear. Magistrates can be bribed as can the prison authorities, making escapes commonplace. Vehicle and airplane licenses are regularly purchased, and forged school and university certificates are routine.

What would you think of the ritual slaughter of animals in your neighbor's backyard? How do you clean up the blood and entrails that litter your suburban streets? How do you feel about the practice of witchcraft, in which the parts of young girls and boys are needed for "medicinal" purposes? How do you react to the burning of witches?

Don't laugh. All that is quite common in South Africa today.

Don't imagine that government officials caught with their fingers in the till will be punished. Excuses -- like the need to overcome generations of white racism -- will be found to exonerate the guilty.

In fact, known criminals will be voted into office because of a racial solidarity among the majority that doesn't exist among the whites. When Ian Smith of the old Rhodesia tried to stand up to the world, white South African politicians were among the Westerners pressuring him to surrender.

When Robert Mugabe of Zimbabwe murders his political opponents, ignores unfavorable court decisions, terrorizes the population and siphons off millions from the state treasury for himself and his friend, South Africa's new President Thabo Mbeki holds his hand and declares his support. That just happened a few weeks ago.

Your tax dollars will go to those who don't earn and don't pay. In South Africa, organizations that used to have access to state funds such as old age homes, the arts, and veterans' services, are simply abandoned.

What will happen is that Western structures in America will be either destroyed from without, or transformed from within, used to suit the goals of the new rulers. And they will reign either through terror, as in Zimbabwe today, or exert other corrupt pressures to obtain, or buy votes. Petition Lodged at the International Criminal Court in The Hague Afrikaner Claims of Genocide



Mr Paul Kruger, the convenor of the Boer-Afrikaner Nation's Volksraadsverkiesingskomitee (VVK), walked into the International Criminal Court in The Hague and handed in a formal genocide-complaint against the Government of the Republic of South Africa and the African National Congress Party on behalf of the non-political, non-profit cultural 'Verkenner' movement.

The legal complaint, lodged by the cultural Verkenner movement, was formally accepted and signed into the registers of the ICC.

Mr Kruger said the formal request was lodged on behalf of the entire Boer Afrikaner Nation by a non-political, non-profit cultural organisation – the Verkenner Movement of SA. (contact: president Ben Geldenhuys, ben@bravoland.co.za)

The cultural organisation asks the ICC in its petition to formally launch a thorough investigation into a charge of genocide against the ruling African National Congress party and the Government of South Africa.

Earlier that day, Mr Kruger had also held a press conference at the Unrepresented Nations' and Peoples' Organisation (UNPO) nearby, highlighting the growing plight of his people. The ICC-complaint provided several hundred pages of exploratory documentation for the ICC to peruse. It noted that 'specific experts amongst the international community have already acknowledged and warned that a genocide is being conducted against the complainants – namely the Boer-Afrikaner nation.

"Both accused parties (the ANC and the SA government) are not only creating a climate of violence in which such a racism-driven genocide can take place, but we also allege that the accused two parties also support it; and moreover are undertaking no specific steps to end the genocide against the complaint-nation."

International Criminal Court in the Hague was asked to investigate genocide-charges against the ruling African National Congress and the SA government - targeting the Boer-Afrikaner nation:

The Boer-Afrikaner nation is universally recognised as an individual nation with a unique ethnic-cultural culture, which is based on European origin but is rooted in Africa, and primarily live within the legal borders of the Republic of South Africa, it was noted.

One-million Boer-Afrikaners already fled from the genocide being conducted:

The document submits that more than one-million of the Boer-Afrikaners have already fled from the country of their birth to many other foreign states to flee from the genocide being conducted against them.

The petition noted:

'The political party which currently rules South Africa – the African National Congress – gained hegemony 17 years ago, in 1994. And while the international community describes it as a 'de jure democracy' because elections are held every five years, the ANC-rule rather is a 'de facto dictatorship' which due to the overwhelming race-driven black-majority block-voting, disallows any meaningful participation or influence on the electoral process by the Boer-Afrikaner nation.'

'In the past four decades the now ruling party of South Africa and its front-organisations carried out and/or approved of acts of murder, torture, arson and terrorism and thus created an insane 'culture of violence across the entire spectrum of society.'

'In the international area, the ruling ANC's gruesome reign of terrorism has been largely ignored while it was being supported as a 'freedom movement'. Such double-standards currently allow the ANC to maintain its culture of violence and its terrorism against the population of South Africa, in the apparent belief that the international community will continue to ignore such violence.'

'The Boer-Afrikaner has for the past decades, become a marginalised population-group which is being demonized in every possible way, through the government-controlled public news media (SABC); through its educational curriculum, and through every other possible means, including all employers and business-owners being forced to hire blacks, while at the same time denying Boer-Afrikaners every opportunity to survive economically – thus forcing hundreds-of-thousands of Boer-Afrikaners into

squatter-camps, and also forcing them to leave the country of their birth in search of a better environment.'

The document submits many examples of 'the ANC-regime's willful, methodical and systematic physical elimination of the Boer-Afrikaner nation including through violent means'. The document also submits that the 'overwhelming number of murderers of whites in South Africa are blacks; that very few whites are killed by other whites; and that very few whites kill blacks except in self-defence.'

'The cumulative effect of all these policies and laws and activities by the Government of South Africa and by the ruling African National Congress party are having 'the cumulative effect of a genocide' being perpetuated against the Boer-Afrikaner nation'.

The document points out that the ruling party and the government of South Africa have not only failed in their 'duty of care for the protection of the Boer-

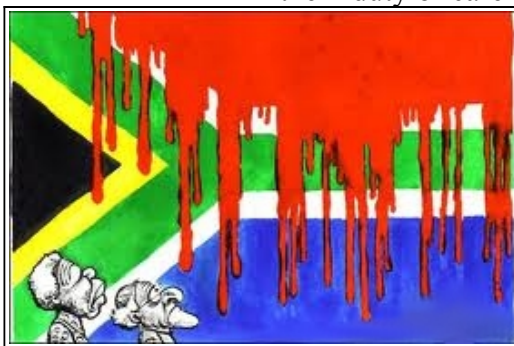
Afrikaner nation but that their demonization campaign of the Boer-Afrikaner nation also uses hate-speech slogans and music which deliberately incites Blacks in South Africa to kill members of the Boer-Afrikaner nation.'

Study Finds Highest-Ever Rate of Autism in US

One in 88 American children has autism or one of its variants according to a new study, marking the highest-ever rate of prevalence and prompting calls for a stronger government response to the "national emergency"

It is believed by a growing body of people that a direct correlation exists between the number of vaccines given to children and the increasing numbers of autism diagnosed. That is not to say there are not other factors involved but that the destructive assault upon the immune system from toxic overload lowers the resistance to other adverse environmental factors such as mercury toxicity from dental amalgams, electro magnetic fields, phthalates, poor nutrition and Vitamin D deficiency amongst other factors.

The Center for Disease Control (CDC) has announced that 1 in 88 children in the U.S. are now diagnosed with an autism spectrum disorder (ASD). Broken down, the numbers equate to 1 in 54 boys with ASDs, and 1 in 252 girls. The updated estimates are based on data collected in 14 American communities during 2008. [Five years on, it is thought present day figures are much higher]

These communities comprised over eight percent of all American 8 year-olds that year. Interestingly, the number of children with ASDs varied widely from site to site. The highest prevalence was found in Utah, where a staggering 1 in 47 eight-year-olds were identified with some form of ASD. New Jersey was also far higher than the average, with 1 in 49.

So what's really going on here? In a normal, healthy environment, that just shouldn't happen. And the fact that it is happening should demand our immediate attention individually and nationally.

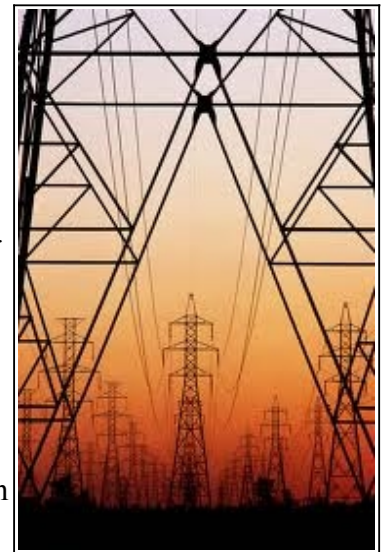
Autism was first described as a unique disorder in the 1940s. In the early 1990s, autism diagnoses began to soar. In the 10 years between 1993 and 2003, the number of American school-children with autism diagnoses increased by over 800%. As the number of vaccines administered to children increased so did the incidence of autism. However, that is only part of an extremely complex narrative.

Electromagnetic fields

Work by Dr. Dietrich Klinghardt suggests there are distinct correlations between a woman's exposure to electromagnetic fields during pregnancy and her child's neurological functioning. He found that if you sleep in strong electromagnetic fields during pregnancy, your child will likely begin to exhibit neurological abnormalities within the first two years of life, such as neurological dysfunction, hyperactivity, and learning disorders.

In 2007, this theory received additional support from a study published in the Journal of the Australasian College of Nutritional & Environmental Medicine. It presented the theory that electromagnetic radiation (EMR) from cell phones, cell towers, Wi-Fi devices and other similar wireless technologies may work in conjunction with genetic and environmental factors, becoming an accelerating factor in autism.



After more than five years of research on children with autism they found that EMR negatively affects cell membranes, allowing heavy metal toxins, which are associated with autism, to build up.

Mercury toxicity: It is already an established fact that exposure to mercury can cause immune, sensory, neurological, motor, and behavioral dysfunctions -- all similar to traits defining, or associated with autism. Mercury pollution is widespread from the burning of fossil fuels, but the

use of thimerosal-containing vaccines and dental amalgams—both of which contain mercury—also cannot be overlooked as major sources of individual exposure to this neurotoxin.

Phthalates

Research from 2009 discovered that infants who lived in homes with vinyl floors were twice as likely to have autism five years later, compared to those with wood or linoleum flooring. Vinyl floors can emit chemicals called phthalates, which are widely used plastic softeners found in much more than just vinyl flooring. Hairsprays, perfumes, cosmetics, toys, shower curtains, wood finishers, lubricants, certain medical devices and more all contain phthalates. Researchers have suggested the chemicals may contribute to autism by disrupting hormones not only in small children but also in the womb.

Vitamin D Deficiency

There is also a link between rampant vitamin D deficiency in pregnant women and the proportionate jump in autism, which has been highlighted by Dr. John Cannell. The vitamin D receptor appears in a wide variety of brain tissue early in the fetal development, and activated vitamin D receptors increase nerve growth in your brain.

As children's brains are being eaten by vaccines, parents urged to ignore the symptoms and 'soothe' their babies

A recent study published in the journal *Pediatrics* suggests that administering one or more of the five "Ss" -- swaddling, side/stomach position, shushing, swinging, and sucking -- to babies in conjunction with their childhood vaccine regimens can help alleviate the physical and emotional stress typically brought about by this highly-invasive medical tradition.

Swaddling babies, or wrapping them in a warm blanket after they are vaccinated, as well as placing them in certain positions can help reduce their levels of anxiety, say researchers. Gently shushing them while rocking them or giving them a pacifier can also help to make the vaccination process move along much more smoothly and less painfully.

Though these measures do absolutely nothing to address the potential neurological damage caused by vaccines, researchers say they can "soothe" babies and help them to stop crying. According to Dr. John W. Harrington from *Eastern Virginia Medical School* and *Children's Hospital of the King's Daughters* in Norfolk, the methods serve as a "distraction" from the pain caused by the needles.

For their study, Harrington and his colleagues divided 234 two- and four-month-old babies into four study groups, two of which received the five Ss after their vaccinations. They found that those who received these interventions experienced less visible pain, grimacing, and frowning, according to *Reuters*, and they cried less.

But as good as it might be to effectively comfort a child who has just been bombarded with dozens of vaccine injections, no amount of physical comfort will mitigate the damage being done to babies' brains by vaccines. The combination

diphtheria, pertussis and tetanus shot, also known as DPT, for instance, is known to cause severe and permanent brain damage in some children (http://www.naturalnews.com/031469_vaccine_brain_seizures.html).

All vaccines, in fact, come with the potential to cause permanent nerve damage, particularly in the brain. Going back as far as 1855, when Massachusetts passed the first law in the United States requiring vaccinations for schoolchildren, it was known that vaccines carried with them the risk of encephalitis, also known as inflammation of the brain (http://www.naturalnews.com/031476_vaccines_nerve_damage.html).

Brachial neuritis, chronic inflammatory demyelinating polyneuropathy (CIDP), complex regional pain syndrome (CRPS), Guillain-Barre syndrome (GBS), multiple sclerosis, narcolepsy, Opsoclonus-Myoclonus syndrome (OMS), trigeminal neuralgia, and transverse myelitis are among the many neurological side effects that can be caused by vaccines. And none of these conditions, of course, can be mitigated with a pacifier or a blanket.

Colloidal Silver the perfect mouthwash?

Scientists find rinsing mouth with silver treats infections

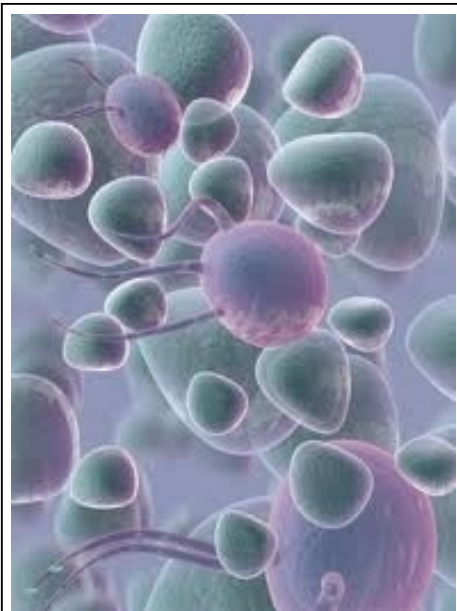

The amazing infection-treating properties of silver seem to be flooding the pages of scientific journals these days, as researchers, scientists, and medical experts are finally conceding that this unique element possesses healing properties far superior to pharmaceutical antibiotics and drugs. A new study published in the *Society for Applied Microbiology* journal *Letters in Applied Microbiology* reveals that silver is fully capable of killing yeast-based mouth infections caused by *Candida albicans* and *Candida glabrata*.

Professor Mariana Henriques and her colleagues from the University of Minho in Portugal evaluated the effects of a silver nanoparticle solution on oral thrush, dental stomatitis, and various other mouth infections caused by the two aforementioned strains of yeast. They came to the conclusion that, in all cases, the silver solution was effective at combating these infection-causing yeast strains, even when the size of the silver particles used varied dramatically.

"With the emergence of *Candida* infections which are frequently resistant to the traditional antifungal therapies, there is an increasing need for alternative approaches," commented Henriques about her findings. "So, silver nanoparticles appear to be a new potential strategy to combat these infections. As the nanoparticles are relatively stable in liquid medium they could be developed into a mouthwash solution in the near future."

To many in the natural health community, these findings may not necessarily be all that revolutionary as thousands of people have been using ionic and

colloidal silver solutions internally to fight off disease and infection, and externally on wounds to boost healing and prevent infection. For centuries, in fact, silver has been used for medicinal purposes, that is until the *U.S. Food and Drug Administration* (FDA) began marginalizing it in favor of pharmaceutical drugs in the 1940s (http://www.naturalnews.com/027235_silver_colloidal_antibacterial.html).

In 2000, researchers from China and Korea found that silver is also an effective treatment against *Escherichia coli* (*E. coli*) and *Staphylococcus aureus* (staph infection). Tests

revealed that silver effectively unhinges the cytoplasmic membranes from bacterial cell walls, and prevents the DNA of these bacterial mechanisms from replicating. In essence, silver was found to demobilize deadly bacteria and prevent it from spreading (<http://www.sovereignsilver.info/pdf/3.pdf>).

"Colloidal silver has a long history in medicine as a natural antibiotic," writes Walter Last in his book *The Natural Way to Heal: 65 Ways to Create Superior Health*. "It is very effective in killing bacteria, viruses, fungi, parasites, and the cancer microbe, and no serious side effects from overdosing have been reported."

Colloidal Silver is effective against more than 650 different disease-causing pathogens. Unlike antibiotics, resistant strains have never been known to develop. (Antibiotics are only effective against about a dozen forms of bacteria and fungi, and never viruses!)
