## Olympic Disenfranchisement

If White people ever needed a clear sign of ongoing disenfranchisement from their own society, it would be the 2012 London Olympics. And as for the English, not only did they suffer the immediate insult of seeing French designated as the official language of the games, but far worse, the games' ceremonies were committed to the care of marginal-Irish-Catholic-Englishman-turned-atheist-Hollywood-filmmaker Danny Boyle.

A panorama of English history being the theme of the games' opening ceremony, it was a typical Hollywood-style presentation, replete with images tailored to elevate the aliens who are currently being empowered to overrun White society everywhere. The fact that the Hollywood agenda is the same as that which is found in media, ecclesiastic and government offices from Westminster to Washington should be proof enough that filmmaker, pundit, priest and politician all have the same hidden master.

As we discussed here several months ago while presenting another topic, in an editorial entitled *Lambs to the Slaughter*, filmmakers and psychologists know well that people - especially children - "learn" through play-acting, whether they are participating or even merely watching. The impressions made through theatre, television, and play-acting of any sort imprint indelibly on the young child's mind, and even on the minds of older children and many susceptible adults. Here the objective is clear: to make it look as if the negro was an important part of a developing English society, and to move that idea into the minds of the general population, when nothing could be further from the truth. This represents the rewriting of English history, and the history of Western society in general, for the advantage of those aliens who are more recently being forcefully introduced into every Western nation as if they belonged. It bestows on these aliens an ownership role that they never earned and are not capable of earning. In reality non-Whites had no active part in the creation of modern society. Modern society was created in spite of non-Whites. But the aliens are now reaping all of the benefits of modern society as if they had such a role, and the history of White nations is being rewritten to accommodate them.

The opening scene of the Olympics opening ceremony presented a stone marking the sources of the Thames, and then a winding trip downstream towards London, with several bucolic scenes along the way. Early on there is a scene of a cricket match which is apparently set in the early days of the Industrial Revolution. However one glaring incongruity with British history is that in the cricket game as it is presented, the pitcher is a negro youth. Hardly an accurate scene in the middle or even in the latest parts of



the nineteenth century, where the English countryside was completely devoid of negroes.

Presenting the transition from a pastoral to an industrial England, images of the Industrial Revolution feature black men quite prominently as nineteenth-century British businessmen, as well as the inclusion of significant numbers of black men and women among the factory workforce. Yet the presence of negroes in 19<sup>th</sup> century England was rather insignificant compared to the population as a whole. The role which negroes played in the industrial revolution in Britain, in any capacity, was absolutely negligible, and they certainly weren't the overlords of British business. So insignificant was their contribution, in fact, that a black character cannot be found in Dickens, many of whose stories were centered around the dregs of London society, nor in Austen, whose realistic writings accurately portrayed the upper classes. There are no black British counterparts to Huck Finn's Jim or to Robinson Crusoe's Friday.



The gods of diversity are perverting history to the disadvantage of Whites, and they are also perverting justice for that same cause. Even the most innocuous display of racial consciousness is punished swiftly and harshly, but only if those who make such displays are White. Voula Papachristou, A White female long jumper from Greece, was expelled from the Olympics for posting on Twitter a

rather harmless joke about Africans in Greece: "With so many Africans in Greece, at least the West Nile mosquitoes will eat home made food!" White Swiss soccer player Michel Morganello was expelled from the Olympics for posting a Tweet in which he referred to South Korean soccer players as "a bunch of Mongoloids". One White Lithuanian basketball spectator was arrested for making monkey noises at Nigeria's basketball players, and another White Lithuanian was arrested for making a straight-armed "Nazi" style salute during a game. Most troubling was the story of Nadja Drygalla, the German female rower who was forced to leave the Olympics after it was revealed that her boyfriend belongs to a "far right" political party, although she herself had not expressed any political sentiments. The Drygalla story shows that Whites in the public eye are not permitted to think independently, or even to associate in any way with those who do.

Following the Drygalla affair, a very Orwellian headline appeared in Reuters which read "[Germany may demand democracy pledges after rower quit Olympics](#)". What happened to Drygalla was an affront which outrages the concept of democracy even as it is trumpeted by the gods of diversity. The word democracy is Greek for *rule by the people*. If the people rule, then the individual must be allowed free expression, because the voices of the people must be heard whether any given majority may agree with them or not. Since not one European government ever held a referendum for diversity or mass immigration of non-Whites, Europe is clearly not a democracy, and the word is merely



tossed around by the media to serve as a smokescreen for tyranny. Whites still getting everything that they think they know from the media, they have not yet noticed the problem of their own disenfranchisement because the media does not present it as a problem: the media presents it as a solution. When will Whites realize that the disenfranchisement of Whites is considered a solution only because Jews and other aliens consider Whites themselves to be the problem?



In the meantime, during the games themselves a non-White female Columbian soccer player assaulted White American player Amy Wambach on the field and went unpunished. A black Cuban women's judo contestant bit her White Greek opponent, Ioulietta Boukouvala on the hand and was never punished, and unnerving Boukouvala the cheating Cuban went on to win the match and was actually rewarded. White British handball player Marie Berbron was choked by a black player from Angola, and in a different contest another black Angolan placed a choke-hold on a White player from Montenegro, Milena Knezevic, who subsequently left the match on a stretcher. The Angolans apparently went unpunished, however this was difficult to determine since their animalistic behaviour was virtually ignored by the media.

More repulsive than any of these displays of black savagery, however, was the act put on by the “woman” tennis player called Serena Williams, who seems to be for tennis what Lance Armstrong has turned out to be for cycling. After winning the final match of the Olympics, Williams broke into a performance of a dance called the “Crip walk”, a dance which even MTV has refused to broadcast. The dance is a signature of the violent black racist street gang called the *Crips*, and Williams performed it with markedly proud effrontery. If a White athlete had put on a similar display with some markedly White symbolism after a victory on the court there would have been a public lynching.

There was one lengthy presentation at the end of the opening ceremony which precisely revealed the political agenda which the London Games endeavored to express. It was entitled "Frankie and June say ... Thanks Tim" and was applauded in the Telegraph and other media as “Danny Boyle's masterpiece”. The Tim in the title was Timothy Berners-Lee, developer of the protocol which drives the World Wide Web, or what people commonly call the Internet (of which the web is really only a part). It portrayed a modern English family with a White woman, a Black man, and several mulatto children. One of these children is June, a teenager who meets Frankie over a lost cell phone and from the moment of its return the romance is on, with thousands of both White and alien teenagers portrayed in its celebration.



The real story which Boyle's “masterpiece” presents has nothing to do with Tim Berners-Lee or with the other amazing technological accomplishments of the English people. The real story is the ongoing replacement of the White race in

Western culture with something rather different. Therefore the projection of a mixed-race family as the ideal family is prominent, its results are celebrated, and nobody seems to even notice since all Whites have apparently been deracinated, cleansed of any sense of ethnicity. The inevitable result is the disappearance of Whites through miscegenation, and the gods of diversity are already celebrating its achievement. If they have their way, England, and all of the formerly White portions of the world, will soon come to look like the Sudan.

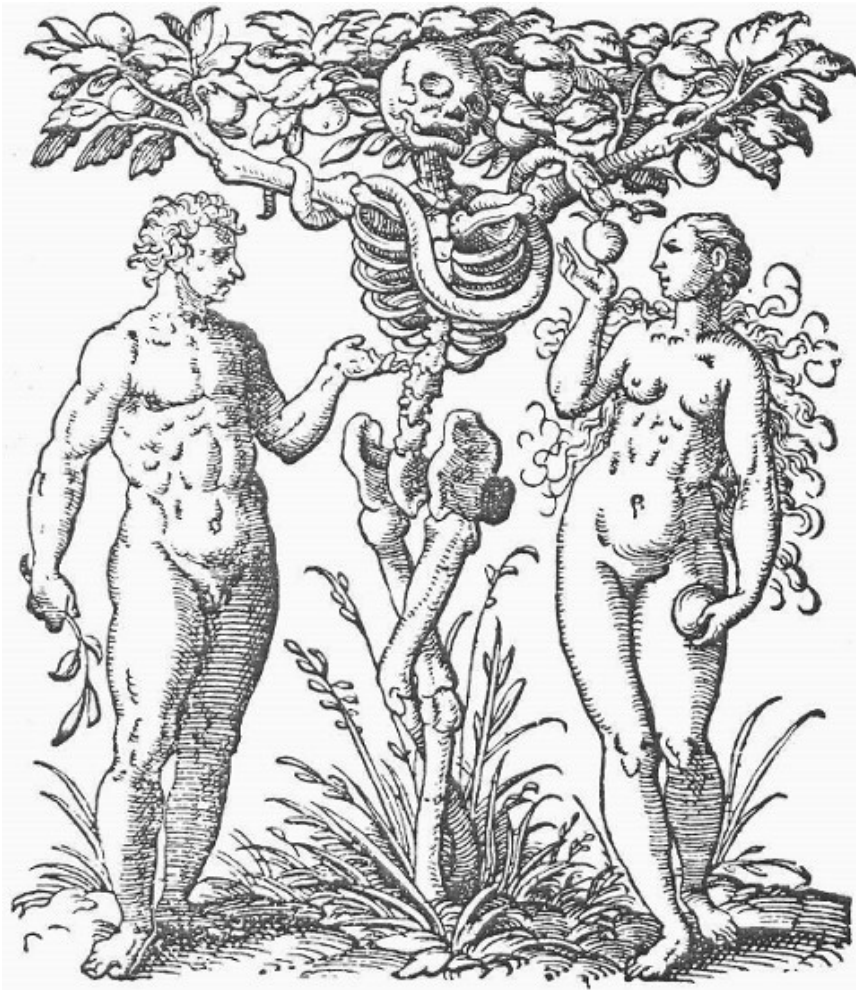
The closing ceremonies of the London Olympics followed suit, filled with such Marxist propaganda as a choir of young children singing “Imagine”, which among many other anti-Christian sentiments also expresses the desire that “the world will be as one”, the embodiment of communist globalist propaganda. In the end, a stadium filled mostly of White people were asked to stand and idolize three black athletes. Sebastian Coe, the British former track athlete turned politician and chairman of the London Organising Committee for the Olympic Games, could not be outdone fawning over black athletes such as Mohamed Farah or the mulatto Jessica Ennis. Coe smothered Farah with superlatives for his medals in the 5,000 and 10,000-meter races, although what Farah did had already been done by many others and was therefore no really special accomplishment. Coe called Farah “the greatest runner we've produced in this country” in spite of the fact that Farah is a Somali native who was not at all produced in Britain.

If indeed Coe had spoken so ebulliently of greater achievements among the British, the media must have missed it. Chris Hoy's record 6<sup>th</sup> gold medal made him the Brit with the most gold medals ever. Alistair Brownlee became Britains first-ever triathlon champion, and in the same event his brother Jonny won the bronze. Ben Ainslie became the most successful sailor in Olympic history. A host of other White and actually British athletes brought glory to the nation, yet news of their accomplishments were eclipsed in the media by all of the plaudits being piled upon a Somalian immigrant and a mulatto born of a Jamaican immigrant and a wayward White social worker.

White people are the last to know that they don't belong. They don't belong anywhere. Unless of course they happen to be groveling before some Negro or other alien and then they belong only temporarily: so long as they are useful to the media and the agenda of the policymakers, those who lurk behind the corporations, churchmen and politicians who are all dancing the same destructive waltz. Or perhaps it's now a “Crip walk”.

## The Revelation of Yahshua Christ

### Chapter 14

W R Finck

**XIV** 1 And I looked, and behold! The Lamb stood upon Mount Zion, and with Him a hundred forty-four thousand having His Name and the Name of His Father written upon their foreheads. 2 And I heard a sound from out of heaven like a sound of many waters and like a sound of great thunder, and the sound which I heard like lyre-players playing on their lyres. 3 And they sang a new song before the throne and before the four living creatures and the elders, and no one was able to learn the song except the hundred forty-four thousand, those having been purchased from the earth. 4 These are they who have not been defiled with women, for they are virgins. These are they who follow the Lamb wherever He should go. These have been purchased from among men, a first-fruit for Yahweh and for the Lamb, 5 and in their mouths a lie is not found: they are blameless.



Here we see a vision of the 144,000 that were first mentioned in Revelation Chapter 7. These were those men who were sealed by Yahweh – kept from the troubles and pollutions of this world and from the wrath that was to come upon the Roman empire, which was the context of Chapter 7, and we see them again here. Some commentators have claimed that these will be the government of the Kingdom of God, however that idea is not found in the text. Others have claimed that these are the Kingdom of God, however it is clear in the text that these are only the first-fruits of those whom He has purchased – the first-fruits of the children Israel and, as it is evident in Chapter 7 at verse 9, they are followed by an innumerable multitude who were clothed in white garments. The

promise to Abraham was that his descendants would be an innumerable multitude, as the stars of heaven and as the sand of the seashore, and not a mere hundred and forty-four thousand (Genesis 22:17, 32:12 et al).

In the Book of Job, at 19:25, Job is said to have proclaimed “For I know that my redeemer liveth, and that he shall stand at the latter day upon the earth”.

Psalm 74:2 is a plea to Yahweh to “Remember thy congregation, which thou hast purchased of old; the rod of thine inheritance, which thou hast redeemed; this mount Zion, wherein thou hast dwelt.” Yahweh is described as the Redeemer of the children of Israel quite often in the prophecy of Isaiah, and also at Psalms 25:22, 49:15, 78:35 and at Jeremiah 50:34 and elsewhere. It is explained in Isaiah Chapter 50 that the Children of Israel, the “peculiar treasure” of God and His possession since the days of the Exodus, had sold themselves into sin, where it says “for your iniquities have ye sold yourselves, and for your transgressions is your mother [meaning the nation as a whole – the wife of Yahweh] put away”.

The meaning of redemption in the New Testament is that God – through Christ – would purchase His people back from their transgression, for which He had long ago put them away Therefore at Luke 1:68 Zacharias is recorded as having said: “Blessed is Yahweh the God of Israel, that He has visited and brought about redemption for His people.” This is the fulfillment of the law of the Kinsman Redeemer, found at Leviticus 25:48-49 and elsewhere in the Old Testament. At Galatians 4:5 Paul states that Yahshua's purpose was “that he would redeem those subject to

law, that we would recover the position of sons”, we, meaning the children of Israel, from whom the Galatians were indeed descended. Here in the Revelation, although the Greek word used is *purchased* and not *redeemed*, that same purpose of the New Covenant is stated once more. In this same manner, Paul told the Corinthians – descendants of Dorian Greeks, the Dorians having also emigrated from ancient Israel – that “ye are bought with a price”, at 1 Corinthians 6:20 and 7:23.

**6 And I saw another messenger flying in mid-air, having an eternal good message [or gospel] to announce before those sitting upon the earth and before every nation and tribe and tongue and people, 7 saying with a great voice: “You must fear Yahweh and you must give honor to Him, because the hour of His judgment has come, and you must worship Him who has made the heaven and the earth and the sea and springs of water!”**

Revelation chapters 14 and 15 are a warning for our present time, this era of self-government and the loosing of Satan from the pit, which we have endured since the French Revolution. This shall be discussed at length with Revelation chapter 20. The Reformation, the diminishing of the papacy, and the decentralization of power in Europe invited all of the social revolutions of the nineteenth century, from the first French Revolution to the Bolshevik, and even into America the social revolutions of more recent decades were orchestrated by the same peoples, the anti-Christ jews, who have been at the root of every single one of them, and conceal as much through the media which they have come to control.

Chapter 14 begins to set the stage for the time of Jacob's trouble, that last period of world history before the Kingdom of Yahweh is finally established. Ever since the missionaries of the post-Reformation period, where there was witnessed the return to the Word of God by a significant number of His people, has the eternal gospel gone out into the entire world, chastising people to repent and to return to the God of the Bible. The time of great trouble which this passage introduces is mentioned in Jeremiah chapter 30,

especially verse 7 which says “Alas! for that day is great, so that none is like it: it is even the time of Jacob's trouble; but he shall be saved out of it.”, and again in Daniel chapter 12:1 where it says: “And at that time shall Michael stand up, the great prince which standeth for the children of thy people: and there shall be a time of trouble, such as never was since there was a nation even to that same time: and at that time thy people shall be delivered, every one that shall be found written in the book.” This is the day of judgement, it has already been going on for many decades now, and true Israel shall be delivered. In the 19<sup>th</sup> and 20<sup>th</sup> centuries there were several Michaels, among whom were Tsar Nicholas II and Adolf Hitler, and their taking a stand against the beast and against the international merchants of world jewry did indeed cause such a time of trouble.



**8 And another, second messenger followed saying: “Babylon the great has fallen, has fallen! She who has made all the nations drink from the wine of the passion of her fornication!”**

One message that the original protestants professed, that men must serve God and not mammon, has been distorted. Now many of the protestant denominations, in their gospel of personal enrichment, encourage people to pursue mammon and consider it godly. Here it is announced that Babylon has fallen, and in discussing chapters 17 through 19 it shall be evident that Babylon is multifaceted, a world system centered upon international trade and the political, social and religious systems which facilitate that trade. While Babylon has not yet fallen, here it is announced that Babylon is indeed fallen, as the Scriptures often announce things prophetically, as having already happened even though it is long before the actual events transpire. In this sense Paul said of Yahweh God at Romans 4:17, that He “calls things not existing as existing”, because they shall indeed exist. It is fully evident in our recent history – that of the past century especially, that the global commercial system – particularly the international banks of London and New York – have “made all the nations drink from the wine of the passion of her fornication” by making war



with all of those nations which do not join their system of central banks. All of those nations which have resisted the Rothschild-controlled central banking system have either been made to succumb over time, or outright destroyed – such as Tsarist Russia and Nazi Germany. Unto this day, even the arab nations and all the so-called “third world” nations are being forced into this jewish banking system.

**9 And another, third messenger followed them saying with a great voice: “If one worships the beast and its image and receives an engraved mark upon his forehead or upon his hand, 10 then he shall drink from the wine of the wrath of Yahweh which is poured unmixed into the cup of His anger, and he shall be tormented in fire and sulfur before the holy messengers and before the Lamb. 11 And the smoke of their torment ascends for eternal ages, and they who worship the beast and its image and one who receives the engraved mark of its name shall not have rest day and night. 12 Thus is the patience of the saints, they keeping the commandments of Yahweh and the faith of Yahshua!”**

The “mark” of the beast is not necessarily a physical mark. The people described in Revelation chapter 13, those who were trapped under the power of the papacy – which describes nearly all of the Children of Israel through the later Medieval period – they had no practical choice but to worship the beast, the papacy at that time, in order that they may survive in their communities. However now the power of the papacy has eclipsed, and the nations of Europe have for the most part entered into a period of self-rule, the monarchical powers being diminished, the ancient feudal system being broken, and the parliamentary democracies being established. As the Scripture says in Jeremiah chapter 31, the children of Israel now choose their governors from among themselves. The new god of the nineteenth century is capitalism. The people are no longer compelled to worship the beast, but rather they have every opportunity to seek the Kingdom of Heaven – to seek to live by the Word of God. For those who choose the beast system over Yahweh God, they shall be punished and the smoke of their torment is everlasting. However that does not necessarily mean that they themselves are going to be eternally tormented. The smoke may only serve as an eternal *remembrance* of the torment, their lack of rest

being attributed to their great feelings of guilt.



Revelation chapters 17 through 19 fully elucidate that the beast is related to the world mercantile system, which is controlled by jews. Likewise, bankers, merchants and criminals (such as the Borgias and the de Medicis) rose to the power of the papacy, and many of them were also jews. Therefore those worshipping the beast can only be those who have forgotten God and who have forsaken His commandments in order that they may worship and pursue the rewards of the mercantile system – the rewards of mammon - in the political, social and religious systems which facilitate the conduct of the beast system. And even more so, worship of the beast may have a greater literal meaning. Here it must be mentioned, that the demise of the papacy as an empirical authority over Europe took place in concert with the French Revolution. The French Revolution saw the jew gain an equal citizenship with the Christian in the polity of France, and with Napoleon that circumstance had been exported to the rest of Western Europe. This is referred to as the [Jewish Emancipation](#). This is the final release of Satan from the pit, a process which had actually started three centuries sooner. With this period, a strange new religion began to gain a foothold in Europe: that which is called Secular Humanism.

Secular Humanism is a rejection of the supernatural or any spiritual authority, and therefore it seems to be a revival of the ancient religion of the Sadducees. The Sadducees, not the Pharisees, were the high priests who crucified the Christ (Acts 5:17). Secular Humanism arose from the deism and anti-clericalism

of the Enlightenment, the various so-called secular movements of the 19th century, and the acceptance of science as a discipline which may explain existence, as if that idea could possibly have any merit. Secular Humanism is therefore the rejection of God and the ideal guiding philosophy for the international merchant – and it glorifies man, who without God is little but a beast, and promotes him into the position of being his own god. It is truly the worship of the beast. The word *secular* is from the Latin *saecularis*, meaning *of an age*, and therefore it means *worldly*. The Christian is told to reject the world (i.e. James 4:4; Romans 12:1-2; 1 Corinthians 2:6, 12; 10:11; 11:32) because the whole world lies under the power of the evil one (1 John 5:19). Therefore Secular Humanism is an anti-Christ religion, a religion for satan, and it is also the worship of the beast.

This view of Secular Humanism is not new. The Oxford English Dictionary records the use of the word “humanism” by an English clergyman in 1812 to indicate those who believe in the “mere humanity” (as opposed to the divine nature) of Christ (The Oxford English Dictionary. VII [2nd ed.]. Oxford: Clarendon Press. 1989. pp. 474–475). According to Wikipedia, “After the French Revolution, the idea that human virtue could be created by human reason alone independently from traditional religious institutions, attributed by opponents of the Revolution to Enlightenment philosophies such as Rousseau, was violently attacked by influential religious and political conservatives, such as Edmund Burke and Joseph de Maistre, as a deification or idolatry of man.” So we see the rise of the religion which deifies man, right at the same time that we see the diminishing of the tyrannical institutions of Europe – by which is meant the papacy and the monarchies – and also the emancipation of the Jew. This is indeed the age of Satan.

Also according to Wikipedia, the anarchist Proudhon (best known for declaring that “property is theft” and a leading figure in revolutionary France) used the word “humanism” to describe a “culte, déification de

l’humanité” (“cult, deification of humanity”) and Ernest Renan in *L’avenir de la science: pensées de 1848* (“The Future of Knowledge: Thoughts on 1848”) (1848–49), states: “It is my deep conviction that pure humanism will be the religion of the future, that is, the cult of all that pertains to man — all of life, sanctified and raised to the level of a moral value.”

**13 And I heard a voice from out of heaven, saying: “Write: ‘Blessed are those dead among the number of the Prince who are dying from now on! Yeah’, says the Spirit, that ‘they shall have rest from their labors, for their works follow with them!’”**

The use of the phrase “from now on” indicates that there is still a lot of history left in this last age, and it also supports the statement made in these comments

above at verses 6 and 7, that this chapter is setting the stage for the last period in the history of this present age. If one dies a Christian in this time, one will indeed be rewarded for one’s faith – and rewarded whether one is conscious of it or not, since Christianity is much more than a simple profession. It is a way of life which many of us live regardless of our confession – since the laws of our God are written on our hearts. Many of the children of God behave like perfectly good Christians, but

turned off from judaized churchianity, they do not profess to be Christians.

**14 And I looked, and behold, a white cloud! And he sitting upon the cloud like a son of man, having upon his head a gold crown and in his hand a sharp scythe. 15 And another messenger came out from the temple crying out with a great voice to him sitting upon the cloud: “Swing your scythe and reap, because the hour to reap has come, because parched is the harvest of the earth!” 16 And he sitting upon the cloud cast his scythe upon the earth and harvested the earth.**

The King James Version has the exclamation at verse 15 as “for the harvest of the earth is ripe”, just like the second harvest which follows at verses 17-20. Yet there the Greek word for *ripe* is ἄκμαζω, which does

indeed mean ripe when used of growing fruit. But here in verse 15 it is ἐξηράνθη, a Passive form of the verb ξηραίνω which means *to be parched*. Something that is parched, cannot be considered ripe, but rather describes something which is withered.

The parched grapes seem to represent those same allegorical tares, from the parable of the wheat and the tares told by Yahshua Christ at Matthew chapter 13. The ripe grapes of the harvest which follows seem to represent the wheat. In the parable of the wheat and the tares, the wheat represent the children of God – the true seed of the woman (Genesis 3:15) who are the descendants of Adam. The tares represent the seed of the serpent - children of the devil – who were planted by the enemy and descended through Cain from the serpent.

**17 And another messenger came out from the temple which is in heaven, he also having a sharp scythe. 18 And another messenger came out from**

**the altar, he having authority over the fire, and uttered with a great voice to him having the sharp scythe, saying: “Swing your sharp scythe and gather the clusters of the vine of the earth, because ripe are her grapes!” 19 And the messenger cast his scythe to the earth and gathered the vine of the earth and cast it into the great wine-vat of the wrath of Yahweh. 20 And the wine-vat was trampled outside of the city and blood came out from the wine-vat, as high as the bridles of horses for a thousand six hundred stades.**

The ripe grapes represent the harvest of the wheat. As it also does in the harvest of the parched grapes described above, the swinging of the scythe represents the wrath of Yahweh which is manifested in the wars and tumults of this age – which have been far greater than those of previous ages. Christians are promised that they will not suffer greatly in these wars and other disasters, so long as they do not worship the beast.

Once more, I will reiterate We are at WAR, and I am not referring to the war between the “spirit and the flesh” as the anti-seedliners do. Yes, there is a war between the spirit and the flesh, and I wouldn’t discredit it in the least, but the WAR I am speaking of is an entirely different conflict.

The WAR I’m addressing is the WAR between the “seed of the serpent” and the “seed of the woman.” How can anyone deny there are two seeds mentioned in Genesis 3:15? But deny it they do! They use some of the most fantastic arguments in an attempt to disprove that fact. Most anti-seedliners trace the bad fig “Jews” back to Esau, with which I do not disagree. But, if one will notice the various wives whom Esau married, one will discover they were mainly from the ten Canaanite nations of which the Kenites were a part (Genesis 15:19). If one will check the *Strong’s* number for Kenite, one will see that it is #7017 and 7014 which will be found to mean Cain, the one who murdered Abel. Now whether you believe that Satan or Adam was Cain’s father, Scripture definitely proves that Esau’s children had Cain’s blood flowing in their veins. This fact is confirmed by Messiah Himself, (Matthew 23:35). The very nature of Cain displayed itself in Doeg the Edomite killing 85 of Yahweh’s priests of the “linen ephod” at king Saul’s command, 1 Samuel 22:17-18. This leaves the whole matter dependent on Genesis 4:1 for which both the *Masoretic* and *Septuagint* texts are ambiguously obscure. Thankfully, we have a witness which is much clearer than the usual, accepted rendering of that verse, and which is contextually in agreement with the rest of Scripture. Let’s take a look at it:

*Targum of Jonathan* on Genesis 4:1: “And Adam knew his wife Eve, who was pregnant by the Angel Sammael, and she conceived and bare Cain; and he was like the heavenly beings, and not like earthly beings, and she said, I have acquired a man, the Angel of the Lord.”

Whether or not we agree with this rendering depends on how badly we want to correlate this passage to correspond with, and measure up to the rest of THE WORD. If the anti-seedliners don’t accept this rendering, one would think they would at least recognize that the “Jews” are the descendants of Cain! They simply don’t believe their Bible. They, therefore, demand that the Almighty accept their personally contrived dogmas and opinions on Scripture. One such passage of Scripture the anti-seedliners take vehement exception to as proving Two Seedline doctrine is Matthew 13:24-30, 37-43 about the “wheat and the tares.” While Stephen E. Jones and Jeffrey A. Weakley avoid comment on this topic, Lt. Col. Jack Mohr and Ted R. Weiland jump right in where angels fear to tread.

Before examining Matthew 13:24-30, 37-43, it would be advisable to read it: **“24 Another parable put he forth unto them saying, The kingdom of heaven is likened unto a man which sowed good seed in his field: 25 But while men slept, his enemy came and sowed tares among the wheat, and went his way. 26 But when the blade was sprung up, and brought forth fruit, then appeared the tares also. 27 So the servants of the householder came and said unto him, Sir, didst not thou sow good seed in thy field? from whence then hath it tares? 28 He said unto them, An enemy hath done this. The servants said unto him, Wilt thou then that we go and gather them up? 29 But he said, Nay; lest while ye gather up the tares, ye root up also the wheat with them. 30 Let both grow together until the harvest: and in the time of harvest I will say to the**

reapers, Gather ye together first the tares, and bind them in bundles to burn them: but gather the wheat into my barn ... 37 He answered and said unto them, He that soweth the good seed is the Son of Man; 38 The field is the world; the good seed are the children of the kingdom; but the tares are the children of the wicked one; 39 The enemy that sowed them is the devil; the harvest is the end of the world; and the reapers are the angels. 40 As therefore the tares are gathered and burned in the fire; so shall it be in the end of this world. 41 The Son of man shall send forth his angels, and they shall gather out of his kingdom all things that offend, and them which do iniquity; 42 And shall cast them into a furnace of fire; there shall be wailing and gnashing of teeth. 43 Then shall the righteous shine forth as the sun in the kingdom of their Father. Who hath ears to hear, let him hear.”

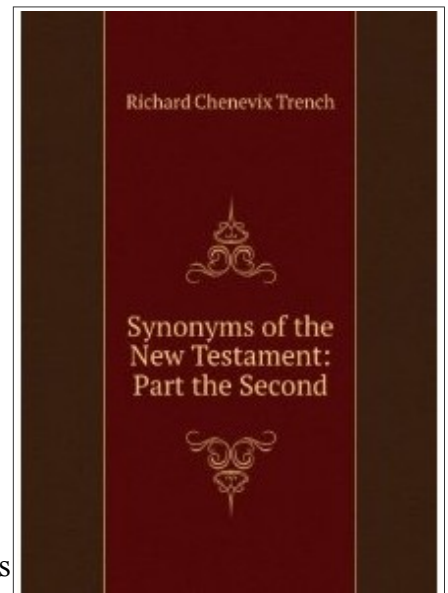
The anti-seedliners have put many different interpretations on this passage, most of which they have brought with them out of Jew-deo-unchristian churches and seminaries. Lt. Col. Jack Mohr, a vehement anti-seedliner, comments in his *Seed of Satan, Literal or Figurative?*, page 15, concerning the words “tares” and “children” on this segment of Scripture in Matthew 13: “Apparently the disciples were intrigued by this parable, but could not understand its meaning. So Jesus explained it to them and told them that the ‘tares’ (#2215 — ‘zizanon’, a false grain called ‘darnel’, which looks like wheat), were the ‘children of the wicked one.’ The word ‘children’ in Greek is (#5207 — ‘huios’ and means ‘immediate, remote or figurative kinship.’ So if the word can refer to ‘figurative kinship’, why are the seedliners so adamant in stating it means ‘literal kinship?’”

Had Lt. Col. Jack Mohr checked with the *Thayer Greek-English Lexicon*; *The Complete Word Study Dictionary NT* by Spiros Zodhiates; or *An Expository Dictionary of NT Words* by W. E. Vine, instead of the limited definition found in *Strong’s*, he would have found the primary meaning for the word “children” #5207, means: “(A) A male offspring ... (B) In a wider sense a descendant, pl. descendants, posterity.” (This definition is from Zodhiates, and the others agree.) There is a secondary figurative sense

which can apply and I will give you an example: The disciples were called “sons of thunder.” Had Mohr read *Strong’s* more carefully, he would have noticed that it mentioned “immediate kinship” first. One’s immediate kinship would be one’s own son. *Strong’s* gave Mohr three choices, and he rejected the first two and implied that “figurative kinship” was the only one mentioned. Such a maneuver is hardly honest! It is apparent, Mohr already had his mind made up what he thought it should be.

Secondly, Mohr forgets that Messiah Himself said “seed are ... children.” Therefore, “seed” and “children” cannot be separated. Consequently, it is highly essential to find out what the word “seed” means. The Greek word for “seed” is #4690, and is *sperma*. This is where we get the English word “sperm.” According to Zodhiates, page 1304, “*sperma* ... Also figuratively used of living beings as the seed of man; i.e., of posterity or descendants.” In this case “figuratively” means comparing man’s seed to agricultural seed, and that is exactly what this parable is doing in comparing Satan’s offspring to tares (darnel).

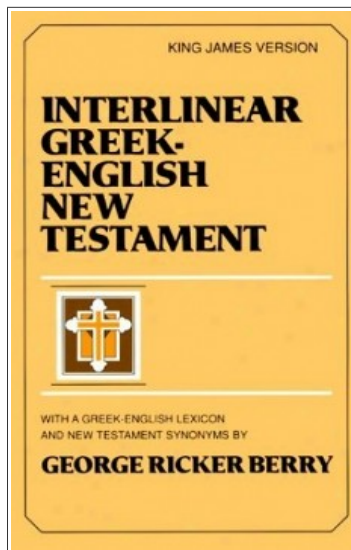
Thirdly, we must check out the one responsible for planting the darnel-like genetic people. In the parable of the wheat and tares the word “wicked” is #4190, and is used with the **definite article “ho”** in Matt. 13:19; Eph. 6:16; 1 John 1:13, 14; 3:12; 5:18, and means “Satan.” Thus in 1 John 3:12 where it says: “Not as Cain, *who* was of that wicked one ...”, it means exactly what it says, “Satan”. Further, the word “wicked”, #4190, in that same verse, according to Zodhiates, page 1198, is used with the definite article “*ho*”, and means: “... the evil one, Satan ...” The book *Synonyms of the New Testament* by Richard Trench confirms what Zodhiates says about the word



“wicked” (Greek #4190) on page 330: “Satan is emphatically *ho poneros* as the first author of all the mischief in the world.” In his *Greek-English NT Lexicon*, George Ricker Berry, page 82 describes *ho poneros* as “... the wicked one. i.e., Satan ...” W. E. Vine in his *An Expository Dictionary of NT Words* under “wicked” on Matthew 13:38 states: “... and in the following [verse just cited], where Satan is mentioned as ‘the (or that) evil one’ ...” (Don’t waste your time with *Strong’s* on this one.) Another way to verify the “wicked” of Matthew 13:38 is speaking of Satan is to go to Matthew 13:19 where the same Greek word #4190 is used saying: “... then cometh the wicked one ...” Then compare the parallel passage in Luke 8:12 which says: “... then cometh the devil ...” Conclusion: the “seed” or “children” in Matthew 13:38 planted by the “wicked” one are the genetic offspring of Satan!

In his attempt to spiritualize and take a figurative view of the “tares” in Matthew 13, Ted R. Weiland in his *Eve, Did She Or Didn’t She?* in a rebuff of a quotation by James E Wise, makes this statement: “Furthermore, if the seedliners’ interpretation of the wheat and tares parable is accurate, and if the tares in Matthew 13 represent *all the seed line of Satan through Cain*, then there is no alternative but to accept that the wheat represents *all the physical seed line of Eve through Seth*. The wheat in this parable depicts the sons of the kingdom, and by this interpretation, the wheat would automatically be sons of the kingdom by their heritage, that is, they would be saved by their race or lineage. If this is true, then Yahshua’s death, burial and resurrection were wholly unnecessary. Of course, this hypothesis flies in the face of the entire Bible ...”

Well, what do you know, except for the last two sentences, Weiland got something right! After all, Hebrews 12:8 says we are either “sons” or “bastards”, and there isn’t anything in-between. And all this bull manure about being “born again”, (John 3:3), is totally an incorrect translation and interpretation. That verse is not saying “born again” but “born from above.” Actually if one will check that verse out, it is saying



one must be “born of the correct race.” To show you this, we will investigate the meaning of the word “born” as used in John 3:3 which has the *Strong’s* number 1080 in the Greek. *The Complete Word Study Dictionary NT* by Spiros Zodhiates, page 364. Zodhiates tells us this word means “generation, kind, offspring” ... and the primary definition is: “Spoken of men, to beget” ... “Spoken of women, to bear, bring forth” ... “To be begotten” ... “To be born as used generally ...” In other words, when an Adamic White person is born in the flesh, he is also born of the Spirit. Other races are not “born” of that Spirit, nor can they ever be. Zodhiates points out that “born” as used here (#1080) *gennao*, is from #1085, *genos*, which in turn means “offspring, posterity ... family, lineage, stock ...” Check this with *Strong’s*, but follow-through to #1085 to get the entire meaning. If you should check only the word #1080, *gennao*, you will not

understand the full implications, for it is speaking of race. John 3:31 makes it clear there are “heavenly” people from above and people “that are of the earth ... earthly ...” Our Redeemer told the Jews, John 8:23: “Ye are from beneath; I am from above: ye are of this world, I am not of this world.” Thus, like us, He was also born from above; i.e., of the White race.

I don’t want to leave the impression that we should not be converted though. It’s not a matter, as the Babylonian prostitute preachers imply, that one should “accept the Lord Jesus Christ as our personal Savior.” It’s not a question of whether we accept Yahshua, but whether or not He accepts us. Inasmuch as He died two thousand years ago for our Redemption, He has already accepted us. To be truly converted, we must accept His Redemption, which brings about communion! Conversion does not consist of being “regenerated by the Spirit”, but of being “turned around” (an about-face). Where in the past we were “sinners” (breakers of Yahweh’s Law), we do a 180 and start, to the best of our ability, to keep His Laws.

I know that many who are reading this have experienced conversion. Whatever kind of prayer we

made at that time, it was necessary for the Spirit to intercede on our behalf, (Romans 8:26). It's only conjecture what kind of "groanings" the Spirit might have "uttered", but perhaps it might have gone something like this: "*Here is an Israelite under the Covenant of Abraham who has come to the realization that he/she is a Lawbreaker and wishes to plead the blood of Redemption on his/her behalf. He/she promises hereafter, based upon the light of the written Word, do his/her best to reject the leaven of the Pharisees, and to return to the faith of the Patriarchs.*" Don't worry about the exact words you might have prayed at your conversion, for the Spirit interceded and presented them before the Throne in an appropriate manner! Also, don't distress yourself about all the members of your family kin who were never converted. If they were not converted in this life, they will be in the next, for it is written: "... every [Adamic] knee shall bow to me, and every [Adamic] tongue shall confess to God", (Romans 14:11). Some of us Adamite-Israelites send our sins ahead to the Judgment, while for other Adamite-Israelites, their sins will follow them to the Judgment, (1 Timothy 5:24). And that is no sign the latter are going to be assigned to a burning hell. They will be in the kingdom too. But aren't you glad you settled the account ahead of time?

To show you Ted. R. Weiland is still holding the position on the parable of the wheat and the tares which he learned at his Christian Leadership College in Denver, Colorado, I will quote a ludicrous statement he made in his *Eve, Did She Or Didn't She?*, page 72: "Instead, this parable [of the wheat and the tares] is simply contrasting righteous Israelites with wicked Israelites ..."

To believe such a thing, Weiland is implying that agriculturally wheat has the same genetics as darnel. If, as he contends, the only difference between wheat and darnel are "righteous" and "wicked" Israelites, in essence he is claiming wheat and darnel are genetically identical. It would seem, with this conclusion, that Messiah is somewhat incompetent in presenting His teachings by way of parables. Or rather, could it be that Weiland is the one who is incompetent in understanding them?!?! The truth is, the wheat and tares are **NOT** genetically identical, and

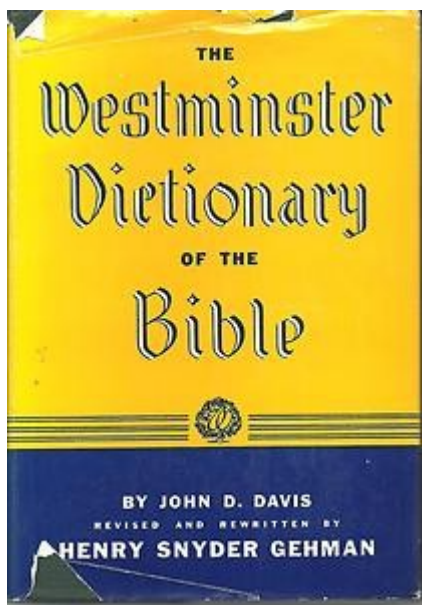
neither are the seed of the serpent and the seed of the woman whom the wheat and tares represent. They may have had the same mother, but they surely had different fathers! By such spurious teachings as this, Weiland is doing more damage to Israel Identity than he is doing good! [which might be intentional]

Jack Mohr gets his two cents worth in by saying in his *Seed of Satan, Literal or Figurative?*, page 15: "In no way does this Parable [of the wheat and the tares] point to specific people by race, who are literal descendants of Satan, coming from his union with Mother Eve." Moreover, on pages 15-16, Mohr has his own convoluted idea of what he thinks the parable of the wheat and tares is all about: "The 'tares', those who disobey God's law and refuse to be reconciled to Him, will be gathered at this time by the reapers, who will be 'angels', not 'white Israelites, bent on vengeance' ... This is one of the biggest problems with the SEEDLINE people. They are more concerned with 'pulling up the tares', whom they say are the Jewish people, then [sic. probably than] in getting their own house in order and their own Israelite people in a right relationship with God, so that He can do the 'rooting out work.' As a result, we find the SEEDLINERS doing exactly what Jesus warned them not to do, 'rooting up the wheat along with the tares' ... I can assure you from the Word of God, that when the 'rooting up' process takes place, there are going to be 'white Israelites' among the 'tares' who will be rooted up along with God's other enemies'."

I have two questions: Where in the Bible does Mohr get his evidence to substantiate these claims? Where is his verification this parable of the wheat and the tares is not racial in nature? As already documented in this *Special Notice* both the words #4690, "seed" and #5207, "children", mean "kinship" and "posterity." How much more racial can it be?!?! Furthermore, if one will read some of Jack Mohr's other publications, one will find that he has a very **peculiar** position on race and talks out of both sides of his mouth on that subject. Remember, Scripture says: "A double minded man *is* unstable in all his ways", (James 1:8).

Further evidence concerning the meaning of the term "seed" is found in *The Zondervan Pictorial*

*Encyclopedia of the Bible*, volume Q-Z, pages 328-329: “SEED ... is used to indicate both agricultural and human seed, the latter both in a narrow physical sense and as a description of the descendants of a common ancestor ... the Israelite was commanded not to mix his seed in any field or vineyard, but to plant only one crop (Lev. 19:19; Deut. 22:9), a stricture [critical remark] parallel to that regarding the mixture of human seed by intermarriage with other nations.” In the parable of the wheat and the tares, the common ancestor to the “wheat” is Seth, the son of Adam. The common ancestor of the tares is Cain, the son of Satan through Eve.



While many commentaries address the topic of “tares”, a very good description for the term is given by *The Westminster Dictionary Of The Bible* by Henry Gehman, page 591: “**Tares.** The rendering of Gr. *zizanon* in Matt. 13:25-27, 29, 30; R.V. marg. darnel. The tare (*Vicia*

*sativa*), a vetch, with pinnate and purple-blue or red papillionaceous flowers, would be easily distinguished from the wheat. The Gr. word *zizanon*, which is probably of Semitic origin, corresponds to Arab. *zuwan*., which denotes *Lolium*, and to Talmudic *zonin*. The bearded darnel (*Lolium temulentum*) is a poisonous grass almost indistinguishable from wheat while the two are only in blade, but which can be separated without difficulty when they come into ear (cf. vs. 29, 30).”

The poison from the “tares” is caused by a fungus. “The darnel is host to an ergot-like smut fungus which infects the seeds. The fungus is a serious poison if eaten by animals or man.” (*Pictorial Bible Dictionary* by Merrill C. Tinney, page 668.)

From this description, we can easily apply the term “tares” to the “Jews.” You will notice that when

the darnel comes into flower the colors are “purple-blue or red.” Because the “Jews” represent a few members of the Tribe of Judah who didn’t keep their bloodline pure, they would naturally appear as a counterfeit royal-blue, which in turn, serves to identify them with the tares. But the color red is even more significant, as it can represent Communism, for which the “Jews” are the inventors. Not only that, but it is the color of Esau from whom they also descend. It is also the color of the “red dragon” of Revelation 12:3 which represents Herod, the “Jewish” Edomite-racial proselyte who attempted to murder the Emmanuel-child shortly after His birth. (For Herod’s father’s and mother’s lineage, check *Josephus’ Wars* 1:6:2; 1:12:3; *Antiq.* 14:1:3; 14:8:1; 14:7:3; 14:12:1.) Furthermore, the poison from the darnel seed would be representative of the poison; “leaven of the Pharisees” which churchianity today is so infected with. Who says the “tares” don’t represent the “Jewish” people?!?!

Della Stanley in her book *Adam’s Tree*, (1975) pages 170-173, puts it very nicely about the parable of the wheat and the tares at the end of chapter 34 and the beginning of chapter 35, entitled “Pharisees and Scribes — a Generation of Vipers.” I will quote excerpts from these few pages as a critical review in order to counter the anti-seedliners’ arguments:

“... Jesus gave the people another parable concerning wheat and tares. He compared the kingdom of heaven to a man that sowed productive seed in his field. But while his men or servants slept, an enemy came and sowed tares among the wheat. When the plants came up and brought forth fruit, the tares came up also. The servants wanted to go and gather out the tares, but the man said wait until harvest time. Then he instructed the reapers to gather the tares first, and bind them in bundles to burn them; and gather the wheat into his barn. (Matthew 13:24-30) ...

“... When Cain killed Able he was cursed and banished from the presence of God, and the curse was never lifted. And at this time the seed of man was divided into two groups: the descendants of Seth that replaced Abel which were the children of God; and the descendants of Cain which became the children of the devil.

“Generations later, Canaan, the son of Ham,



was cursed. And the curse was never lifted, therefore his descendants became the children of the devil [by admixture with Kenites, Gen. 15:19].

“Nimrod was another descendant of Ham; and he built cities, among them Babylon. When the Israelites under Joshua pushed a portion of the Canaanites out of the land of Canaan, they dispersed and some went to Babylon. Later still, there were the Shelanites, descendants of Shelah the son of Judah of the house of Jacob, whose mother was a Canaanite ... neither were they allowed to rule through the house of Judah.

“The people that returned to Jerusalem from the sixth century B.C. captivity were not of the house of Israel, but were a remnant of the house of Judah. But it was the royal house of Zedekiah and his followers that God said, ‘I will deliver them to be removed into all kingdoms of the earth for their hurt, to be a proverb, a reproach, a taunt, and a curse ...’ it was mostly the members of Zedekiah’s house and his followers that intermarried with the cursed descendants of Canaan [which had also mixed with the Kenites, the descendants of Cain].

“After the return of the Jews to Jerusalem, there emerged a number of sects called the Pharisees, the Sadducees, the Herodians, and the Scribes ... John the Baptist called these people a generation [race] of vipers. Jesus called them hypocrites and children of the devil; and cautioned His disciples to beware of their doctrine. He speaks of Satan and his kingdom in Luke 11:18 ... And everywhere He went the Scribes and Pharisees followed and opposed everything that He did.

“There was quite a division among the Jews for the sayings of Jesus. Some believed and some did not. They came to Him and said, ‘How long dost thou make us to doubt? It thou be the Christ, tell us plainly.’

Jesus replied, ‘I have told you, but you believe not ... because ye are not of my sheep. My sheep hear my voice ... and follow me. And I give them eternal life ... and I and my Father are one’ (John 10:24-30) And the Jews took up stones to stone him ... But Jesus said, ‘If God were your Father, then ye would love me: for I came from God ... ye are of your father the devil, and the lust of your father ye will do ...’” [*Comments in brackets mine.*]

What Della Stanley failed to explain was: Of the two factions (one favoring diplomacy with Babylon; the other with Egypt), the house of Zedekiah favored the latter. After Nebuchadnezzar captured Zedekiah, and killing his seventy sons and gouging out his eyes, the remainder of his surviving household forced Jeremiah to accompany them to Egypt for which he had forewarned them against. After Jeremiah sailed to Britain with Tea Tephi, the remainder fell under the judgment of a third dying by the sword, a third by pestilence, and a third being captured and taken to Babylon. Actually, one small group ended up in Elephantine in Egypt where they built a temple after the fashion of Solomon’s Temple (check Elephantine Papyri), and intermixing with African Cushite types (i.e., Sammy Davis Jr.) they became half-breed Falasha (black) “Jews.” You can’t find a more rotten “bad fig” than that! How foolish then is Ted R. Weiland’s remark, already quoted from his *Eve Did She Or Didn’t She?*, page 72, but this time I will finish it: “Instead, this parable [of the wheat and the tares] is simply contrasting righteous Israelites with wicked Israelites, much the same as the good and evil figs of Jeremiah 24.” You can see from this, Weiland hasn’t the slightest clue why the house of Zedekiah was considered “naughty figs.” While Della Stanley did quite well, she should rather have linked the “bad figs” primarily with Elephantine in Egypt.

**“Wherever the body is, there also shall the eagles be gathered together.”**This is similar to a statement found in Matthew chapter 24: “28 Wherever the corpse may be, there the eagles shall be gathered!” The body, or the *corpse* or *carcass* as it is in Matthew 24:28, from the word which Christ used there, the corpse at which the eagles are gathered must be the body of the woman who joined herself to the beast, Mystery Babylon, and there is where the vultures and parasites, or “every unclean and hated bird”, are found, which is described in Revelation chapter 18. Find those nations which are being devoured by the anti-Christ jews and overrun with “every unclean and hated bird”, and you have found the people of God, true Israel. Of course, the description can apply only to the White race.

# The Living Hell of Utopia

I admire those people who grow their own food and eat what they grow, but I am not that self-sufficient. I still must depend on the grocery stores for my food. And it is mostly at the grocery stores that I get to rub shoulders with the white hoi polloi. The other day I listened to two white female checkout clerks (both mid-fortyish) going on about a black rapper named Snoop Dogg. They and their children just love Snoop Dogg. And both women were also professed born again Christians. Has it come to this? Is Christianity synonymous with the worship of black rappers? Do all Europeans feel an uncontrollable desire to abase themselves before their black gods? The answer to both questions is, unfortunately, yes. Those two women were mothers. They were what would be called ordinary white people, which is what makes it all the more tragic. We know how debased and satanic academics are, but if the black worshipping faith has spread to run-of-the-mill working class whites, which it most certainly has, there is a greater need in Europe than ever before for hearts of fire who will oppose negro worshipping liberalism. ### 3. DEHUMANIZATION

*One group denies the humanity of the other group. Members of it are equated with animals, vermin, insects or diseases. Dehumanization overcomes the normal human revulsion against murder.*

When faced with what is being done to our people, this revulsion clearly doesn't exist anymore! Babies are being shot at point blank range! Elderly women are being raped and tortured by burning them with clothing irons and shoving anything from broomsticks to smashed bottles into their vaginas! People are being hacked to death with pangas, their heads smashed with bricks and stones, their throats slit with blunt knives... ### 4. ORGANIZATION

*Genocide is always organized, usually by the state, though sometimes informally or by terrorist groups. Special army units or militias are often trained and armed. Plans are made for genocidal killings.*

In South Africa, the Government is simply turning a blind eye to this and calling it "Normal Crime" at worst! These murders are by no means random nor are they disorganized! The killers/murderers always work in groups – mostly 4-5 . They steal very little and what they do take is considered "loot" or "reward" for a job well done. In many cases they arrive on foot and steal a vehicle as a means of getting away. These vehicles are then simply discarded along the way and often burnt. The process of "organizing" a complete wipeout of the Boer people was very well thought through.

Firstly the South African Government ordered that firearm owners should surrender all their firearms though a hugely unconstitutional and completely illegal campaign. Most of the law abiding citizens complied for fear of prosecution. These weapons were to be destroyed, but there is NO evidence of this ever having been done. To make matters worse, over 20,000 weapons have gone "missing" from the Police Force's arsenal, with no reports as to what happened to these guns and in addition nobody was ever

prosecuted for negligence regarding the disappearance of these firearms!

Secondly, all the Commandos (volunteers with army training operating under strict governance of our Defense Force) that used to keep our farming communities safe, were disbanded by our current Government, thus leaving our Farmers defenseless against these attacks. Despite promises from the Government that police officials and Defense Force units will replace the Commandos, nothing has transpired ever since!

Thirdly, much is being made by the SA Government of "redistributing" farmland. They have created the impression that most of our arid land is still in the hands of the "Boers" and that they are bluntly refusing to sell land to the Government who will in turn distribute this land to Black people to farm on. This is a lie, as most of the land in South Africa already belongs to the Government and up till now, no audit has been done to establish how much agricultural land is owned by the black people and how much land is being registered in the names of Foreign owners. Some of these farms previously developed by white farmers, have been given to Black communities to farm on, but without significant success. These farms have become barren, costing thousands of people their jobs and livelihood and seriously threatening our food supply in SA. All of these factors are creating an environment where the hatred for the Boer is being aggravated and these farmers are considered the enemy of the "People" ...and our leaders then singing songs about killing or shooting the "Boer", is certainly not helping!

### 5. POLARIZATION

*Extremists drive the groups apart. Hate groups broadcast polarizing propaganda. Laws are passed*

*with racial criteria that further oppresses the already marginalized group...in this case the White Boer People!*

South Africa is currently the only country in the world that has laws in place to “Protect” a 60 Million Majority against a 4.5 Million Minority! The most obvious ones being:

**\*Affirmative Action (AA)** – in terms of which businesses are forced to employ workers in accordance to the percentage of the population in the country – thus meaning that 92% of the work force HAS to be black whether they have the necessary qualifications or not!

**\*Black Economic Empowerment (BEE)** – This law forces businesses with a certain turnover P/A to give 35% of their shares to a Black Business Partner. Businesses are audited and prosecuted if they are not BEE compliant. Since capability and skills left the Government sector at the time when the white employees were dismissed, the Government had to contract consultants to fulfill the duties of those qualified and competent white people who were dismissed. Once more, the Government is now compelled by law to only award all Government contracts to those private companies who are in possession of a BEE-certificate. This certificate is issued by the Government on completion of a thorough investigation by the Government to confirm that a private company has sufficient Black shareholders and employees on all levels of their work force.

**\*Quota System** – All Sport Unions are forced to apply a quota system when choosing players for Provincial and National teams and the percentages have to again be representative of the population, thus leaving capable sportsmen and –women with no way to participate unless they are black. In practice, this means that sportsmen and –woman are elected to represent their province/country on the basis of the colour of their skin and not on merit at all.

**\*\*\*All of this whilst our Highly Praised Constitution states very clearly that:**

**Section 9: The right to equality before the law and freedom from discrimination. Prohibited grounds of discrimination include race, gender, sex, pregnancy, marital status, ethnic or social origin, colour, sexual orientation, age, disability, religion, conscience, belief, culture, language and birth.**

Polarizing propaganda is openly preached from public stages at political gatherings and white people are being called “Thieves and Murderers” to the delight of cheering crowds. Due to large scale corruption, the current Government is hardly able to deliver any of the promised services to the poorest of the poor, but instead of owning up to the fact that BILLIONS are lost or stolen from our annual budget, white people are simply blamed for the horrendous conditions in which more than 25% of the population is currently living. ## **6. PREPARATION**

We have now entered this phase in South Africa. We need not wear symbols as we are identified simply because we are White! In less than 10 years, more than 600 000 White people have ended up in Squatter Camps (ghettos) mostly because they have been forced to resign due to the Affirmative Action Legislation (i.e. due to the colour of their skin). These people live in horrifying circumstances with absolutely NO hope of receiving any help from the Government to acquire shelter and food!

There are only two levels left before my people, the ones that are left, will literally have to “run for their lives”! ## **7. EXTERMINATION**

Johannesburg - Axed ANC Youth League leader Julius Malema believes bloodshed will help him get South Africa's land and mineral resources. Malema was in Harare to address Zanu-PF youth, the Zimbabwe Herald reported. He said the youths in South Africa were calling for whites to surrender land and minerals resources they hold because "when they came from Europe they did not carry any land into South Africa". # Chemtrails

Those long, white streams of persistent, cloudy haze commonly blasted into blue skies by unmarked airplanes are not your typical contrails, says Swedish Green Party leader Pernilla Hagberg. As reported by the Swedish paper *Katrineholms Kuriren*, Hagberg, the first major political leader to come forward on the issue, has openly admitted that these unusual cloud trails, which fail to dissipate like normal contrails, are actually a toxic mix of chemicals, viruses and metals which have been collectively referred to as "chemtrails."



According to Hagberg, the sprayings are a joint endeavor by the U.S. *Central Intelligence Agency* (CIA) and the U.S. *National Security Agency* (NSA), as well as the Swedish government in her own country, to modify atmospheric conditions via deliberate aerosol spraying efforts. admission. "Unfortunately, this is a political problem that requires many non-political solutions."

### **Spraying the skies to save the planet?**

Interestingly, the United Nations (UN) and various Bill & Melinda Gates Foundation-backed groups have recently been forced to admit that such

sprayings are taking place, and that the emitted particles are not normal contrails. But their excuse for why chemtrail sprayings are being done is that they will somehow save the planet from the devastating effects of so-called "global warming," that ever-present, pseudoscientific environmental theory that is often used as justification for all sorts of outlandish policy proposals. Dr. Lucija Tomljenovic gave a full description of these devastating side effects, including encephalitis, bilateral deafness and meningitis, in her paper *The vaccination policy and the Code of Practice of the Joint Committee on Vaccination and Immunisation (JCVI): Are They at Odds?* Appalled at the committee's behavior, she exposed exactly what was being said behind the closed doors of UK's JCVI. She wrote:

*"Thus, instead of re-evaluating the vaccination policy, at least until safety concerns were fully evaluated, the JCVI choose to support the existing policy based on incomplete evidence that was available at that time."* [2]

One child who became profoundly deaf in one ear after she received the now banned vaccination, Katie Stephen, is still fighting for compensation to this day. Her mother, Wendy Stephen, is furious at her daughter's treatment and told *The Telegraph* in a



recent article:

*"She wasn't born this way. This was done to her by the Department of Health. They distributed pamphlets arguing that this was the right thing to do for your child, and not just that, but the right thing to do for herd immunity in the UK against these three illnesses."* [3]

## Second Banned Vaccine Gets Revamp

Obviously not learning from the error of their ways, the UK government has once again potentially put thousands of lives at risk by re-introducing a banned, this time **unlicensed** vaccine onto the UK market.

In June 2012, the single mumps vaccine Medi-Mumps cultured on dog kidney cells was advertised for use at a number of private clinics as an alternative option to the MMR. It has since been discovered however, that Medi-Mumps is in fact the banned, unlicensed vaccine Pavivac. To cover this up, just like the MMR vaccine Pluserix, the vaccine was repackaged and given a new name.

## A SHOCKING DISCOVERY

Through intensive research, we have learned that on September 13, 2012, the UK's MHRA (Medicines and Healthcare Products Regulatory Agency) wrote a press release titled *Advertising Investigations*. The MHRA wrote:

*"13 September 2012*

*The MHRA was made aware of information presented on the Children's Immunisation Centre (CIC) website about Medi-Mumps and a related press release. The MHRA was concerned that the information provided an unbalanced view of the safety and efficacy of the*

vaccine because it did not mention the MHRA's concerns and previous CSM advice **or that the product was unlicensed.** (emphasis added)

**We understood that the Medi-Mumps vaccine is manufactured from the same stock and processed in the same way as Pavivac mumps vaccine.**

(emphasis added) The MHRA, acting on advice from an independent advisory committee, the Committee on Safety of Medicines (CSM), has for a number of years objected to the importation of the Pavivac product because there is insufficient information available to assure its safety, quality and efficacy. CIC amended the websites to remove the information about Medi-Mumps.

Date case raised: 3 April 2012

Date action agreed: 2 May 2012

Date of publication: 13 September 2012" [4] **DON'T SAY WE DIDN'T WARN YOU**



Amazingly in May of this year on this very site, I wrote an article titled *New Vaccine Made From Dog Cells May Trigger Allergy to Dogs*. [5] My article highlighted the fact that a new single mumps vaccine had been slipped into private clinics in the UK through the back door.

I highlighted that the Medi-Mumps vaccine had been advertised as being available from June 2012 in two private clinics, The Children's Immunization Centre, who have now removed the vaccine in question from their listings [6] and The Early Onset Clinic who, at the time of this writing, are still advertising it as available today. [7]

I queried whether or not the new vaccine could possibly be the banned vaccine Pavivac repackaged and re introduced as a new product:

*"Interestingly Medi-Mumps is extremely similar to the banned vaccine Pavivac. The Pavivac vaccine was also manufactured in the Czech Republic and cultured on canine kidney cells but this vaccine was rejected by the CSM (Committee on the Safety of Medicines) in 2002 because of safety concerns."* [8]

My research was spot on and once again, vactruth.com can be proven to promote child health safety.

## CONCLUSION

I would like to know just how these private clinics managed to get this so wrong. Did they not realize that they were and still are, in some cases, advertising and injecting very young children with an unlicensed, previously banned product? Do they also not realize that it has been illegal to advertise unlicensed products to the public since 2010? [9]

How can we, as healthcare consumers, ever trust our governments if they continue to sanction dangerous, banned and unlicensed products for use on our children? These are only two products that we now know about. How many other banned, unlicensed drugs, vaccines and healthcare products are being recommended for use that are repackaged and renamed?

## **FDA Approved Vaccine with Autism and SIDS Listed as Adverse Events, Vaccine Safety Website Removes Information**

**S**ome very disturbing news recently came across my desk from a fellow activist.

The Tripedia vaccine product insert was removed from the Johns Hopkins Institute for Vaccine Safety website. [1] I also discovered that it is now missing from the Centers for Disease Control Vaccine Price List. The “official” reason is likely Sanofi Pasteur’s discontinuing the production of the vaccine. [2]

**However, closer inspection of the Tripedia product**

**insert reveals another smoking-gun relationship between vaccines and autism.**

### **THE SECRET MEETING YOU WERE NEVER SUPPOSED TO KNOW ABOUT**

Information can disappear for many reasons. For example, perhaps a webmaster accidentally removes the hyperlink to the Tripedia vaccine product insert. But if it was removed intentionally, we obviously have a situation where “The Authorities” want to limit the

exposure of very damaging information. Before you can appreciate *what* disappeared, you need to know *why* this information is so important.

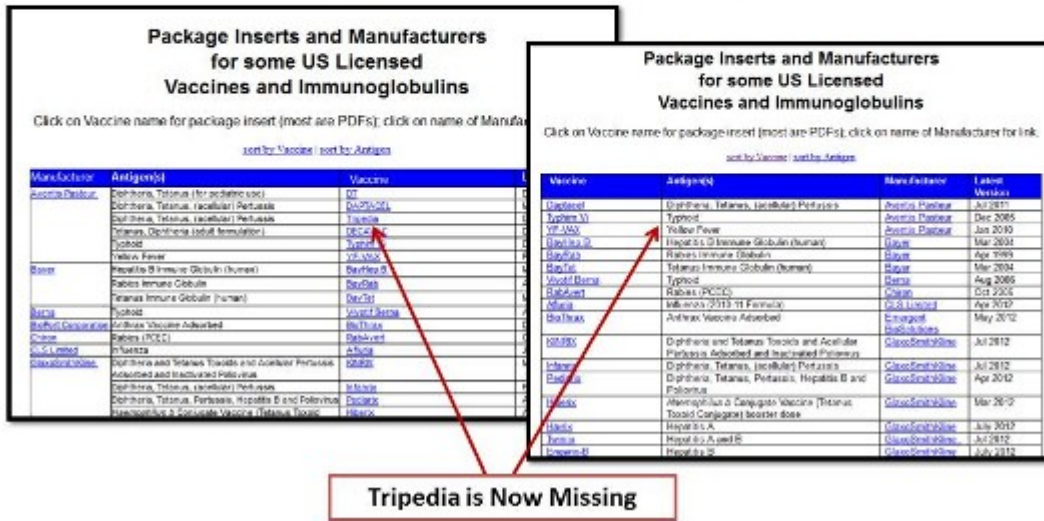
Let’s get right to it. Some vaccines contain a particularly nasty ingredient called thimerosal. The purpose of this organic mercury preservative in

vaccines, as stated on the FDA’s website, is to prevent the growth of harmful microorganisms. [3] However, there are major concerns from parents regarding the mercurial compound being neurotoxic to children.

In June of 2000, members from the Centers for Disease Control, the Food and Drug Administration, and pharmaceutical companies, met in a secret meeting held in Simpsonwood, GA. The topic of discussion was the relationship between thimerosal and autism.

We know what was said at the meeting because parents obtained the transcripts through the Freedom of Information Act. The conversations are chilling. [5]

Here are three important quotes from the Simpsonwood Document:

“...the number of dose related relationships [between mercury and autism] are linear and

statistically significant. You can play with this all you want. They are linear. They are statistically significant.” – Dr. William Weil, American Academy of Pediatrics. Simpsonwood, GA, June 7, 2000

“Forgive this personal comment, but I got called out at eight o’clock for an emergency call and my daughter-in-law delivered a son by c-section. Our first male in the line of the next generation and I do not want that grandson to get a Thimerosal containing vaccine until we know better what is going on. It will probably take a long time. In the meantime, and I know there are probably implications for this internationally, but in the meanwhile I think I want that grandson to only be given Thimerosal-free

**vaccines.”** – Dr. Robert Johnson, Immunologist, University of Colorado, Simpsonwood, GA, June 7, 2000

**“But there is now the point at which the research results have to be handled, and even if this committee decides that there is no association and that information gets out, the work has been done and through the freedom of information that will be taken by others and will be used in other ways beyond the control of this group. And I am very concerned about that as I suspect that it is already too late to do anything regardless of any professional body and what they say...My mandate as I sit here in this group is to make sure at the end of the day that 100,000,000 are immunized with DTP, Hepatitis B and if possible Hib, this year, next year and for many years to come, and that will have to be with thimerosal containing vaccines unless a miracle occurs and an alternative is found quickly and is tried and found to be safe.”** – Dr. John Clements, World Health Organization, Simpsonwood, GA, June 7, 2000

The last quote by Dr. John Clements is important and revealing, because here is what happened next.

### BIG PHARMA IS QUICK TO RESPOND

Recall that the spotlight of this story is on the Tripedia vaccine.

Tripedia is an FDA approved diphtheria, tetanus, acellular pertussis (DTaP) vaccine and the Centers for Disease Control recommends that infants be injected at 2, 4, and 6 months of age. [6]

It contains thimerosal.

Nine short months AFTER the Simpsonwood meeting mentioned above, the Food and Drug Administration approved a “thimerosal free” Tripedia vaccine. [7] Do

you think the FDA might have been a bit concerned about the findings discussed at the Simpsonwood meeting?

I personally think so.

You can now see the importance of the following passage on the FDA’s website:

*“Much progress has been made to date in removing or reducing thimerosal in vaccines...In March 2001 the FDA approved a second DTaP vaccine formulated without thimerosal as a preservative (Aventis Pasteur’s Tripedia, trace thimerosal).”* [3] (emphasis mine)

In my opinion, it couldn’t be any clearer. The pharmaceutical companies are being shielded from a landslide of litigation. But here’s the smoking gun I promised to show you.

### EXTREME ADVERSE EVENTS (AUTISM & SIDS) REPORTED

The smoking gun comes in the form of the Tripedia vaccine product insert dated December 2005. This places the insert four years on the timeline after being approved for a “thimerosal free” alternative.

Keep in mind, no massive recall was made for the vaccines already containing thimerosal. The vaccines stayed on the shelves and were injected into your children. The reason you didn’t hear about any major recalls of the vaccines is because doing so would have jeopardized the public’s confidence in the entire vaccine program.

With that, I’m going to suggest that this information may radically change the way you look at vaccines forever. Page 11 of the Tripedia product insert states:

*“Adverse events reported during post-approval use of Tripedia vaccine include idiopathic thrombocytopenic purpura, SIDS [Sudden Infant Death Syndrome], anaphylactic reaction, cellulitis, autism, convulsion/grand mal convulsion, encephalopathy, hypotonia, neuropathy, somnolence and apnea.”* [8] (emphasis mine)

SIDS is most likely to occur between 2 and 4 months of age. [9] DTaP is given at 2,4, and 6 months. [6]

Strange coincidence, is it not?

The insert continues to say it is not possible to establish a “causal relationship” between the reactions



and the components in the vaccine. In other words, the language is saying you can't blame the vaccine for these conditions, even though they were reported.

The FDA has a large problem on their hands, and they know it. They approved vaccines with thimerosal and are trying to keep the situation quiet, especially when it comes to parents. As shown in this article, this information is coming up missing. But, the missing information did shine a HUGE spotlight on the information in the vaccine product insert.

With all the controversy surrounding vaccines and autism, why even mention it in a vaccine product insert for an FDA-approved vaccine?!? We may never know the true answer, but consider this question for a moment.

How many times have you heard a doctor or health worker hysterically say there is ZERO chance that vaccines cause autism?

My hope is for health professionals to take the time and independently research vaccines. However, researching vaccines and putting the pieces together can be difficult, especially when information disappears.

## CONCLUSION

The secret Simpsonwood meeting points to a direct causal relationship between vaccines and autism. This information prompted vaccine manufacturers to rapidly and very quietly manufacture a thimerosal-free

vaccine with the FDAs full cooperation. I think parents need to keep that in mind.

Four years after a "thimerosal free" vaccine became available, a cryptic paragraph referencing autism and SIDS appeared in a vaccine product insert. Now that information is being scrubbed from government and vaccine safety websites. Shame on them!

And by the way, Mom and Dad, as of May 2, 2012, the Johns Hopkins Institute for Vaccine Safety knows Tripedia has trace amounts of thimerosal. [10]

You need to know that if your child is injured by a vaccine, your doctor is not held responsible. Read the vaccine product inserts. Research the information for yourself. Don't take for granted that your doctor has done it for you.

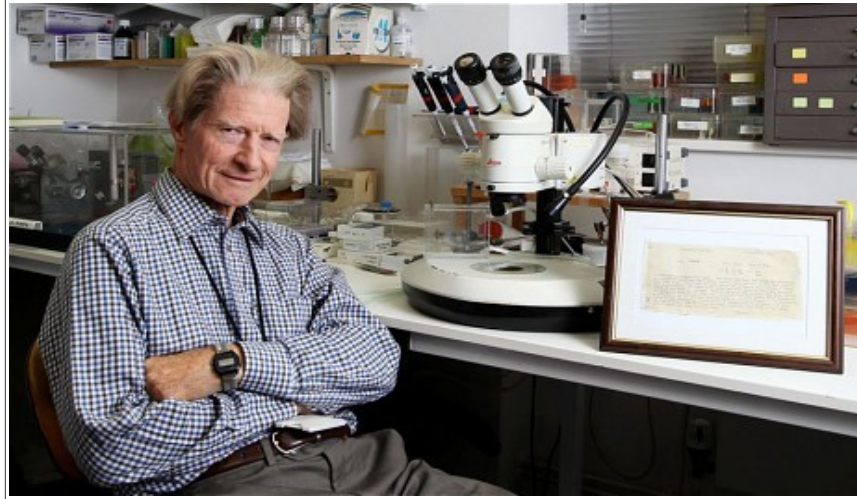

# Sir John Gurdon, Nobel Prize Winner 2012 was 'too stupid' for science at school UK contributor

A British scientist whose schoolmasters told him he was too stupid to study the subject has been awarded the Nobel Prize in medicine for his pioneering work on cloning. Ranking last out of 250 pupils in his peer group at Eton in biology, John Gurdon's prospects looked rather dim, added to which he was consistently in the bottom set in every other science subject.



Sixty-four years later he has been recognised as one of the finest minds of his generation after being awarded the £750,000 annual prize, which he shares with Japanese stem cell researcher Shinya Yamanaka.

Delighted at hearing this news, Sir John revealed that his old framed school report, stating that to study science at University would be a "sheer waste of time" still sits above his desk at the Gurdon Institute in Cambridge, which is named in his honour.

The master, a Mr Gaddum, was in fact by profession a museum curator hired to teach the lowest-achieving pupils and had no vocational calling.

He said: "The main gist of it was that he had heard Gurdon was interested in doing science and that this was a completely ridiculous idea because there was no hope whatever of my doing science.

After receiving the report Sir John said he switched his attention to classics and was offered a place to study at Christ Church, Oxford, but was allowed to switch courses and read zoology instead because of a mix-up in the admissions office.

It was at Oxford as a postgraduate student that he published his ground breaking research on genetics and proved for the first time that every cell in the body contains the same genes.

He did so by taking a cell from an adult frog's intestine, removing its genes

and implanting them into an egg cell, which grew into a clone of the adult frog.

The idea was controversial at the time because it contradicted previous studies by much more senior scientists, and it was a decade before the then-graduate student's work became widely accepted.

But it later led to the subsequent discovery by Prof Yamanaka that adult cells can be "reprogrammed" into stem cells for use in medicine. So any cell in the body can be made into stem cells which in turn can turn into any type of tissue in the body, thus they can replace diseased or damaged tissue in patients. He joined the university in 1971 following spells at the California Institute of Technology and Oxford, and in 1989 was a founding member of the Wellcome/CRC Institute for Cell Biology and Cancer - later renamed the Gurdon Institute - where he still works full-time at the age of 79.

The first Sir John knew of his prize was when telephoned at 7.30 am in his lab by a journalist asking for his reaction but dismissed their information as speculation. An hour later he received a call from the Swedish Academy telling him he had won the prize, but admitted he was initially suspicious that the call was a hoax by a friend or colleague speaking in a Swedish accent.

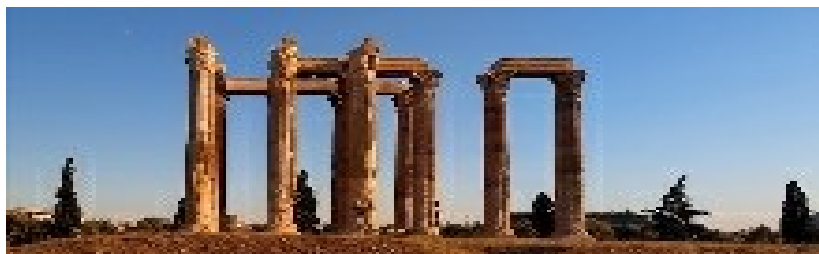
