Bolshevism After 95 Years

This October marks the 95th year since the West witnessed the Bolshevik Revolution in Russia, which precipitated one of the most horrendously murderous eras in the history of the world. If one day we could sit in heaven and watch God's Official Version of the History of Man as recorded by His omnipotent omniscience, perhaps in exquisitely vivid holographs, then we would learn that Bolshevism has really been with us for perhaps 9,500 years, if not longer. We would also learn that Bolshevism is still with us, and that the radical Bolshevism witnessed in the last days of old Russia can break out again at any time, wherever its carriers happen to reside.

Indeed, Bolshevism has carriers, people infected with its tendencies who spread it from region to region and epoch to epoch. These carriers have called themselves by diverse names over the centuries, and are therefore difficult to trace. In the Hebrew Bible, they first appear as Kenites. The careful student of the Bible and the Classics can then trace them down through Biblical and ancient history to where they are today, and now they are known for the most part as Jews.

That Jews were behind the Bolshevik Revolution is a very well-documented and indisputable fact of history. But every revolution requires funding. A lesser known fact is that New York bankers, Jewish bankers with names such as Schiff and Warburg, had financed the Bolshevik Revolution. This matter has been known since at least June 15, 1934, when [Congressman Louis T. McFadden read a detailed explanation into the Congressional Record](#). But it never made the mainstream media, because the same Jewish bankers and their Jewish fellows control the media as well. Another observation which must be made is that while one Warburg, Max, was in Germany ensuring the success of the Bolsheviks, another Warburg, Paul, was in America setting up the fledgling Federal Reserve banking system. McFadden said, in part:

“From the date of Trotzky's return to Russia the course of Russian history has, indeed, been greatly affected by the operations of international bankers. They have acted through German and English institutions and have kept Russia in bondage to themselves. Their relatives in Germany have drawn immense sums of money from the United States and have in turn financed their agents in Russia at a handsome profit. The Soviet Government has been given United States Treasury funds by the Federal Reserve banks acting through the Chase Bank and the Guaranty Trust Co. and other banks in New York City.”

Shortly thereafter several attempts were made on the Congressman's life, and he was finally killed in October, 1936.

Something else that McFadden had entered into that same Congressional Record, was an explanation of the flooding of Jews into America in the late 19th century, again at the instigation of the Jewish banker Jacob Schiff. While Jews always had a presence in America, which can be traced back to colonial times, it was never a presence which allowed them any political impact at the polls. By the dawn of the 20th century that had changed. McFadden said:



"This country was then [in the 1890's] a debtor nation, paying a high yearly tribute to Schiff and his principals. Schiff accordingly took it upon himself to create a prejudice in the United States against Russia. He did this by presenting the supposed wrongs of the Russian Jews to the American public. Unpleasant tales began to appear in print. School children in this country were told the Jewish children were crippled for life by Russian soldiers wielding the knout. By unfair means a wedge was driven between Russia and the United States.

"One of Schiff's schemes was a sort of wholesale importation of Russian Jews into the United States. He drew up divers and sundry regulations for the temporary transplantation of these Jewish emigrants. He would not, he said, have them enter this country through the port of New York, because they might like New York too well to leave it for the outposts he had selected for them. He said it would be best to have them come in at New Orleans and to have them stay there two weeks, 'so that they could pick up a few words of English and get a little money' before setting off for what he called the 'American hinterland.'

"How they were to get the money he did not say. Aided by Schiff and his associates, many Russian Jews came to this country about that time and were naturalized here. A number of these naturalized Jews then returned to Russia. Upon their return to that country, they immediately claimed exemption there from the regulations of domicile imposed on Jews; that is, they claimed the right to live on purely Russian soil because they were American citizens, or 'Yankee' Jews.

"Disorders occurred and were exploited in the American press. Riots and bombings and assassinations, for which somebody furnished money, took place. The perpetrators of these outrages appear to have been shielded by powerful financial interests. While this was going on in Russia, a shameless campaign of lying was conducted here, and large sums of money were spent to make the general American public believe that the Jews in Russia were a simple and guileless folk ground down by the Russians and needing the protection of the great benefactor, of all the world—Uncle Sam. "

The Jewish takeover of the old Russian Empire was an investment which paid off handsomely for world Jewry. With it came the destruction of the last White nation to ever openly resist Satan: National Socialist Germany. After the war, Soviet Russia was propped up by those same Jews as a tremendous threat to the West. From that time, all the while distracted by impending doom from the East, a cultural battle was being fought in Western Europe and especially in America, which would presume to destroy Christendom forever.

This cultural battle represented a different type of Jewish warfare against the West, one fought without traditional armies and weapons. It has rightly been called Cultural Bolshevism. After the First World War in Germany, Jewish Communists attempted to establish Soviet Republics in Bavaria and other diverse places. However due to the resistance of the Freikorps, Germany's militia, the Jews failed miserably. However under the Weimar Republic, Cultural Bolshevism blossomed in Germany. Its hallmarks include the open promotion of narcotics use, sexual deviancy, pornography and every other sort of decadence. Such lifestyles are promoted in Jewish art, literature, cinema and theater, which are in turn given the foremost exposure wherever Jews are able to control mass media. The same things were being promoted in the United States, however the profligacy of the Roaring Twenties was curtailed by the Great Depression. This promotion of decadence was one major evil which Adolf Hitler and his National Socialist party fought their political battles against. When Hitler won Germany democratically, the Jews rallied outside nations to ensure that Germany, and perhaps the rest of Europe, would not be lost to their cause.

After the defeat of Germany, Jewish-owned political administrations in London and Washington would ensure that Eastern Europe was placed under the control of Soviet Jews, as the West was delivered to Capitalist Jews. Churchill's hypocritical Iron Curtain speech ironically, and most likely purposely, stole the phrase and the idea behind it's most famous line from Goebbels. In a 1945 speech, Goebbels warned that "An iron curtain would fall over this enormous territory controlled by the Soviet Union, behind which nations would be slaughtered." In the subsequent decades the false Capitalist vs. Communist dichotomy would be used to mold public perception and control public fears by the Jewish media for the remainder of the century, but it was the same Jews controlling both sides all along.

"The Bolshevist revolution in Russia was the work of Jewish brains, of Jewish dissatisfaction, of Jewish planning, whose goal is to create a New Order In the World. What was performed in so excellent a way in Russia, thanks to Jewish brains, and because of Jewish dissatisfaction, and by Jewish planning, shall also, through the same Jewish mental and physical forces, become a reality all over the world."

The American Hebrew Magazine – September 10, 1920

America had no Hitler, and left Europe devoid of one. After the Second World War, the bankers, the media, and various Jewish agents inside the courts and the government along with their fellow idealists had ensured that America would be captured by Cultural Bolshevism, all while the Marxists hid themselves behind the more innocuous label of *Liberal*. As America feared the Communist Soviet and Communist Chinese bogeymen, America succumbed to the program outlined in the Communist Manifesto through a corrupted political process, and few people even noticed that all of its planks were rapidly being enacted into American law. Now America is a Communist nation, and still people do not notice. They won't notice, because in today's Orwellian world few people ever look at the substance residing behind the label.

All of the other nations of the West have fallen to Communism in like manner. The European Union is merely a new Soviet through which Marxist ideals become law. The Berlin Wall did not come down because old Russia recovered its freedom. Rather, it came down because the West had finally become equally yoked in slavery under the Jewish bankers. Therefore the wall was no longer necessary, and the public show with which it was dismantled helped to continue the illusion of freedom in the minds of the slaves.

In the October Saxon Messenger Clifton Emahiser takes a look at two facets of the cultural war against America. The first is the [Jewish program of forced racial integration](#), a program which has been carried on in America for over a hundred years now. The second is the Statue of Liberty, which was indeed a [Jewish \(Edomite\) Trojan Horse](#). What's Behind the Edomite-jewish Agenda?

To hit the road running on this subject, I will quote the audio portion from a YouTube video on my website: **THE JEWESS BARBARA LERNER SPECTRE CALLS FOR THE GENOCIDE OF THE ENTIRE WHITE EUROPEAN RACE** (that the jews are Edomites, check Josephus' *Antiquities*, bk. 13, ch. 9, par. 1):

An unidentified jewess introduces Spectre:

“As we heard, there are people in Sweden who support Israel, and have a deep sense of the injustice of the present situation. It's these people who give hope to those who still believe that things will get better here. One of them is Barbara Lerner Spectre, a former American who made 'aliyah' [meaning migration to the spurious Israeli state in Palestine] and then ten years ago, with the help of the government of Sweden, set up a non-denominational institute of Jewish learning with the Greek name 'Paideia' [which she also calls 'The European Institute for Jewish Studies in Sweden'] here in Stockholm. She believes that the current wave of anti-semitism in Sweden will pass, and that jews have an important role to play in a country undergoing profound change.”

Then Spectre, agreeing with her introducer:

“I think there is a resurgence of anti-semitism because, at this point in time, Europe has not yet learned how to be multicultural [meaning racially-mixed]. And I think we [meaning the jews] are going to be part of the throes of that transformation, which must take place. Europe [meaning all the countries of Europe] is not going to be the monolithic societies [meaning racially pureblooded nations] that they once were in the last century. Jews are going to be at the center of that. It's a huge transformation for Europe to make. They are now going into a multicultural mode, and Jews will be resented because of our leading role.

But without that leading role, and without that transformation, Europe will not survive.” [Brackets added so the reader can better understand the motivation of the speakers.] **What in hell is Spectre threatening we pureblooded Whites with?** We will go next to the Internet at The Jewish Magazine website:

“BROADWAY PLAYS & HOLLYWOOD MOVIES, “SHOWBOAT”:

“Jewish Bravery Shows Up in ‘Showboat’ [Jewish Promotion Of Miscegenation] by Walter J. Klein:

“The heart and soul of ‘Showboat’ was and always will be Jewish.

“Edna Ferber wrote the timeless novel in 1926. Jerome Kern and Oscar Hammerstein II created the huge, beloved score and Florenz Ziegfeld produced the Broadway musical in 1927. George Sidney II produced the third motion picture in 1951. Harold Prince produced the Broadway revival in 1994.

“All were Jewish. And all made America a better place.

“What makes ‘Showboat’ a source of pride for the Jewish faith wasn't those great Jewish names of literature and entertainment. It was their Jewish ethics, human spirit, bravery and sense of social justice they imbedded in ‘Showboat.’

“It was unimaginable in the 1920s for Broadway to mount a musical strongly based on the dangerous concept of miscegenation. Who would invest in such suicidal controversy? Who would rent a theater to troublemakers? Who would buy tickets to witness two leader characters agonizing over their mixed-race love affair? [underlining mine]

“Well, just about everyone in America!

“Once the initial shock was over, audiences fell in love with the depth of the characters, the delicious score, the epic plot development, the charming locations, the brilliant staging and the exquisite mix of heartbreak and humor. America took to its heart both the ‘only make-believe’ romance of Magnolia and Gaylord and the brutal reality of Julie’s lover sucking blood from her hand so he could tell the sheriff ‘black blood’ flowed in his veins. The Jewish people of today would do well to thank God for those of their faith who risked their careers to deliver ‘Showboat’ to the world uncensored.

“Consider their risk. Ferber, Kern, Hammerstein and Ziegfeld were already enormously successful in their professions before ‘Showboat.’ (Ferber had already won a Pulitzer and an Oscar.) Turning Ferber’s profound story into a Broadway musical was a professional risk per se. Putting their reputations on the line by dramatizing the ethical confrontation of miscegenation could have brought threats of violence to all the Jews responsible.

“Anti-semitism was rampant in America. Show business depended on its light, sprightly, fun-filled successes patterned on the past. Vaudeville and parlor banter sold the tickets. That was years before *Gone with the Wind* made it to the screen with the words, ‘Frankly, my dear, I don’t give a damn’ intact, long before the word pregnant could be uttered in a movie. Taking chances with social issues was dangerous business. And what kind of craziness was it to go to the heart of black-white sex relations on a musical Mississippi river boat?

“‘Showboat’ was without precedent. It was much more than a toe-in-the-water experiment in the sticks. The Edna Ferber story was a powerful statement nobly published. Its unabashed adaptation to the stage and screen was asking for trouble and perhaps ruin for its creative team. Indeed, the first movie stumbled. The famous miscegenation sequence was stricken from the 1929 film because miscegenation was banned as a film subject. When the 1936 version was produced, special permission had to be granted from Hollywood’s Hays Office. Otherwise the superb performance of Helen Morgan as Julie LaVerne would have been eliminated. Irene Dunne’s Magnolia Hawks character would have lost depth without her close mixed-race friend at her side. The racial undercurrent was much more than a sub-plot. The bond between Magnolia and Julie permeated ‘Showboat’ from stem to stern.

“Did those Jews have doubts? Certainly. Flo Ziegfeld was terrified that ‘Showboat’ would die at the box office because of its complex and troubling storyline. But he stuck with his instincts and he stuck with Ferber, Hammerstein and Kern. An opening night eyewitness said the audience barely applauded. They liked the show immensely, but it shook and shocked them.

“After Ziegfeld lost badly in the market crash, he staged a ‘Showboat’ revival in 1932. It was the biggest ticket on Broadway. ‘Showboat’ kept rolling along, like Old Man River, to become America’s longest-running musical for decades.”

We will now consider more maneuverings of those who want to destroy our families and children:

At a “Jewish” conference, January 12, 1952, in Budapest, a “Jew”, Rabbi Emanuel Rabinovich, spoke before the Emergency Council of European Rabbis. The following is part of that speech which can be found in William Guy Carr’s book, *Pawns In The Game* on pages 105-106:

“... I can state with assurance that the last generation of white children is now being born. Our Control Commissions will in the interest of peace, and wiping out interracial tensions, forbid the whites to mate with whites. The white women must cohabit with members of the dark races, the white men with black women. Thus the white race will disappear, for mixing the dark with the white means the end of the white man, and our most dangerous enemy will become only a memory. We shall embark upon an era of ten thousand years of peace and plenty, the Pax Judaica, and our race will rule undisputed over the world. Our superior intelligence will easily enable us to retain mastery over a world of dark peoples.” The “Jews” went on to brag: “... We are about to reach our goal. World War II furthered our plans greatly. We succeeded in having many millions of Christians kill each other and returning other millions in such conditions that they can do us no harm. There remains little to be done to complete our control of the stupid goyim.” [“ ” around jew, means I reject the term] **“A RACIAL PLAN FOR THE 20TH CENTURY”**

The following declaration of intent was given in 1912 by a British top-level Communist theoretician, Israel Cohen, as recorded in the booklet *Who’s Who In The World Zionist Conspiracy* by James Combs, page 40:

“The ‘Race-Mixing’ program: We must realize that our party’s most powerful weapon is racial tension ... In America we will aim for subtle victory. While inflaming the negro minority against the whites, we will endeavor to instill in the whites a guilt complex for their exploitation of the negroes. We will aid the negroes to rise in prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige, the negro will be able to intermarry with the whites and begin a process which will deliver America to our cause.”

In Myron C. Fagan’s booklet *UN Is Spawn Of the Illuminati*, published October-November, 1966, he elaborates somewhat more in depth concerning this matter on pages 16-18:

“Around 1910, one Israel Zangwill wrote a play which he called ‘*The Melting Pot*.’ The central figure in the play was a very young Jewish boy, who *ostensibly* was a violinist of wonderful talent. *According to the plot in the play*, certain people were eager to reveal his great talents to the world and they tried to lease the Carnegie Music Hall for a concert, but the management of the Carnegie refused, *ostensibly* because the boy was a Jew. However, very great pressures were brought to bear on the management, and they consented to the engagement. Then – and this was still part of the play – it was discovered that the young violinist insisted upon a young Negro pianist being his accompanist. Again the management exploded – they had a rigid rule against Negroes performing in their Music Hall. But, again tremendous pressure was brought to bear on them – and they finally surrendered.

“All that was part of the play. Now, I come to the point of establishing that ‘*The Melting Pot*’ was sheer propaganda, embodied in a good evening’s entertainment. The idea in the play was that the United States should be a ‘*Melting Pot*’ for the Minority Groups, but especially for the Jews and Negroes. And that was the way the Critics viewed it – and the way the audiences accepted it. As a result of the reviews, the play was a sensational success. Nobody who saw the play recognized the propaganda in it – not even I. Well, as far

back as 1910, [in 1966] 56 years ago, there was no reason to suspect [propaganda]. We all accepted what Zangwill said – that it was all a case of ‘*humanitarianism*’ – they used that word that far back ... Now, get the following!

“George Bernard Shaw, Israel Zangwill and another English (Jewish) writer, named Israel Cohen, composed the triumvirate that launched ‘*Fabian Socialism*’ in England. And all three were zealous supporters of Marxism.

“Both Shaw and Cohen came to America to attend the opening of the Zangwill play. Following the performance,

Diamond Jim Brady, a famous character of those days, threw a banquet at Delmonico’s for the Cast and the author – and invited many Broadway celebrities to attend. I was one of the invited. There, for the first time, I met Israel Cohen – I had previously known Shaw in England. During the evening, Cohen mentioned that he was writing a book, which was to be titled: ‘*A Racial Program For The 20th Century*.’ Cohen described it as a ‘*humanitarian*’ follow-up in book form of ‘*The Melting Pot*.’

“At that time that meant nothing to me. When the book was published I did not get a copy of it – I wasn’t that interested in it.

“It first came to my attention

shortly after [Earl] Warren issued his infamous ‘Desegregation Decision’, and it was brought to my attention by an article published by the *Washington Star*, in which they quoted the following passage from Cohen’s ‘*A Racial Program Of The 20th Century*’ ... the following is the quote:

“We must realize that our most powerful weapon is racial tension. By propounding into the consciousness of the dark races that for centuries they have been oppressed by the whites, we can mould them to the program of the Communist Party. In America, we will aim for subtle victory. While inflaming the Negro Minority against the Whites, we will instill in the Whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige the Negro will be



able to intermarry with the Whites and begin a process which will deliver America to our Cause.

“Following the publication of that story, Congress- man Abernathy, after checking the ‘*Star*’, and himself reading the book, published the same quote in the ‘*Congressional Record*.’ That [book] was published in 1913 ... the NAACP and the ADL were created almost simul-taneously to carry out those directives. *That was more than a half-century ago. Can there be any doubt that that was intended to launch our present Negro upheaval for a Black Revolution?*”

“If that isn’t enough evidence, in 1935, the Communist Party’s ‘*Workers Library Publishers*’ issued a pamphlet entitled ‘*The Negroes In A Soviet America*.’ It urged the Negroes to rise up, especially in the South, and form a Soviet State in the South, and apply for admission into the Soviet Union ... it contained implicit assurance that the ‘*revolt*’ would be supported by all American Reds, and on page 38 it promised that a Soviet government would confer greater benefits on Negroes than on Whites and that ‘*Any act of discrimination or prejudice against a Negro will become a crime under the Revolutionary law*’ ...

“And the Warren ‘Desegregation Decision’ transformed all those Communist directives into rigid law of the land. Furthermore, *by his own admission*, [Earl] Warren ignored our Constitution when he wrote that ‘Decision’ – admitted that he based it on the ‘*modern scientific authority*’ of one Gunnar Myrdal, a Swedish Socialist, whose book publicly proclaimed contempt for our Constitution and hatred for our form of government. Can there be any doubt that that ‘Decision’ was framed to conform with these Communist Directives? ...

“... When Abernathy published that Israel Cohen excerpt in the Congressional Record, we (Cinema Educational Guild, Inc.) promptly issued a ‘*News-Bulletin*’ in which we published the entire story – and warned of the coming Negro uprisings ...

“Two years went by and nobody even tried to deny the matter, but, suddenly, after two years, during which the ADL and similar groups had ferreted out ALL copies of the book and destroyed them, they announced that the whole thing was a fraud, that there never had been such a book, or an ‘*Israel Cohen*’ ... Why did they wait two years? and how could they deny the existence of a writer named Israel Cohen in the face of all the books he had written? *copies of*

which I have. More important, bear in mind that Israel Cohen had been a prime mover in all ‘*Fabian Socialist*’ and Communist movements in England – also that I had met him in person when he actually discussed the book at that banquet.”

MORE SERIOUS DOCUMENTATION

In or about 1980, a book was published by Bantam Books entitled *The Jewish Almanac*, and is described as “A Celebration Of Jewish Life And The Jewish People. A Fact-filled Book Of Information and Entertainment. Traditions, History, Religion, Wisdom, Achievements. Compiled And Edited By Richard Siegel And Carl Rheins With Extensive Illustrations, Maps And Charts.” On page 3 of this over 200 page book, under the heading “Identity Crisis; A Brief History Of The Terms For ‘Jew’”, it says:

“Strictly speaking, it is incorrect to call an ancient Israelite a ‘Jew’ or to call a contemporary Jew an ‘Israelite’ or a ‘Hebrew.’ The first Hebrews may not have been Jews at all, and contemporary Palestinians, by their own definition of the term ‘Palestinian’, have to include Jews among their own people – although in choosing the name ‘Palestine’ for their homeland signified the opposite: an enclave of foreigners.”

From this, it should be quite obvious the “Jews” know who **they** are! Don’t you think it is about time the “Christians” know this too? Don’t you think it is about time we stop repeating the **LIE** that “the ‘Jews’ are ‘God’s’ chosen people”? The pastors of today have everything just the opposite to the way things really are. The White people of Western Europe and their offshoots are the true Israelites; not the “Jews”!

In the publication *Liberal Judaism*, January, 1949, there was an article entitled “*Liberal Judaism and Israel*” written by one of their greatest and most renowned Rabbis, Dr. Abba Hillel Silver. Dr. Silver, writing about the then new State of Israel, says:

“... the Jewish Nation is thus an accomplished fact. The State of Israel exists. As a result the concept of the wandering Jew is bound eventually to disappear along with the term (galut) exile. All nations send forth immigrants to all parts of the world. People are continually moving from one country to another, and change their citizenship, but they are not regarded as exiles. This fact alone – the end of national exile for the Jewish people ... is destined to affect favorably the psyche of the Jew throughout the world. It will endow the Jew, wherever he lives, with a self respect and a sense of security, a normal tone, long-wanting in

Jewish experience. For the curse of Cain, the curse of being an outcast and a 'wanderer' over the face of the earth has been removed ... [cf. Gen. 4:12]

I would like to cite another Communist by the name of Ernest Fremont Tittle, a onetime minister at the M.E. Church at Evanston, Illinois. Elizabeth Dilling in her monumental work *The Red Network*, speaks of an incident which happened at his church back in the 1930's, page 37:

"The time was, when Methodism, in its zeal for personal purity, frowned upon dancing. Some Methodists nowadays who are little opposed to dancing, even in a church were a bit surprised, however, when several colored men were introduced into circle dances at a dance given in the parish house of Tittle's church and were thus forced upon the young white girls as partners. An M.E. Guide member whose daughter attended this dance reported that when she phoned the assistant pastor about this he said that these colored men had been invited by Dr. Tittle himself (one of them being the son of a classmate of his at college), who felt that it was now time that the young people learned to mingle with other races. (God created separate races, but Communism insists upon racial inter-mixture and inter-marriage.)"

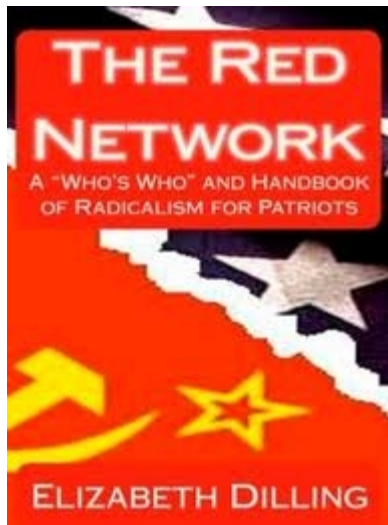
Elizabeth Dilling went on in her book *The Red Network*, written in the 1930's, saying this on page 36:

"The negroes are made to believe that the Communists practiced complete racial and social equality and that only when a communist Government is set up in the United States will the negroes obtain equality and freedom from exploitation by the 'white bosses', and in order to attract and impress the negro, the Communists make a point of encouraging mixed

social functions where white women Communists dance with negro men, and white men Communists dance with negro women. It is openly advocated that there must be complete social and racial equality between the whites and negroes even to the extent of intermarriage." (As this was written in the mid 1930's; we have come a long way.)

This is not the only background on the "Jews." Not only are the "Jews" **NOT** the "chosen people", but by their own words, we can know who they really are. While they have a multi-racial background, it may surprise many of you that they are essentially descendants of **Cain** and **Canaan** and **Esau-Edom**.

Are you one of those who have swallowed the vicious **LIE** about the "melting pot"? The Statue of Liberty

An Edomite Trojan Horse?

“... Homer relates that Troy reached its greatest splendor in the reign of King Priam. Its destruction was caused by Paris, a son of Priam, who abducted Helen, the wife of Menelaus, King of Sparta, and carried her off to the Trojan capital. The Greeks spent 10 years in collecting an army to avenge this outrage, and, under the

leadership of Agamemnon, who had 1,186 ships and 100,000 men drove the Trojans within the walls of Troy ... It is related that the Greeks were unable to capture the city by direct assault. Hence, they constructed a huge wooden horse, within which they concealed a band of the bravest Greek heroes” (*World Scope Encyclopedia*, vol. 10). To make a long story short, the Trojans lost the war to the Greeks. Like the “huge wooden horse” of the Greeks, the “Statue of Liberty” planted on Bedloe Island in New York Harbor is serving a similar purpose, and there are few who comprehend the significance!

I will quote from *Who's Who in Jewish History*, by Joan Comay, p. 128:

“**LAZARUS, Emma** 1849-1887. US poetess. Emma Lazarus is remembered principally as the author of the sonnet ‘The New Colossus’ which is engraved upon the Statue of Liberty in New York harbour. The poem expresses her vision of America as a sanctuary for the ‘huddled masses’ of Europe, victims of religious and economic persecution.

“The daughter of a New York Sephardi family, she began writing poems and novels in her teens. Ralph Waldo Emerson took an interest in her work, and she developed a correspondence with Henry Longfellow that was to continue over the years. The pogroms in Russia in 1881-1882 gave her a passionate interest in

Jewish problems. She learned Hebrew and translated Judah **halevi** and other medieval Spanish-Jewish poets. Her volumes of poetry, such as *Songs of a Semite* (1882) and *By the Waters of Babylon* (1887), are filled with prophetic Zionist sentiment, and she urged her views in essays that appeared in contemporary American periodicals. It is ironical that at the request of her assimilated family, works with a Jewish content were omitted from a collected edition published two years after her death.”

To understand the terminology surrounding immigrant-jews during the late 1800's, one must grasp that the Sephardim-jews were misleadingly dubbed “German-jews” while the Ashkenazi-jews were erroneously dubbed “Russian-jews”. To show that the Statue of Liberty was basically bought and paid for with Jewish lucre is evident in the book *Our Crowd*, pp. 127-128:

“In the gaslit New York of 1876, the hand torch of the Statue of Liberty, the gift from France, sprouted surrealistically from a street corner at Fifth Avenue and Twenty-sixth Street – part of a campaign to raise money to get the rest of the statue assembled on an island in the harbor, where it would welcome immigrants to the New World. (France had contributed \$450,000 toward the erection of the statue, but expected the United States to contribute an additional \$350,000 for the construction of a pedestal. For several years, while Americans bickered over who should pay this bill, the rest of Bertholdi's 225-ton lady reposed in a warehouse.) Emma Lazarus had written her lines, ‘Give me your tired, your poor ...’ to be inscribed upon the base of the controversial gift. Miss Lazarus' lines had a majestic ring. But – or so it seemed at the time – they also conveyed a somewhat condescending tone. Seligmans, Lehmans, and Goldmans may have arrived tired and poor, but did not enjoy being called ‘the wretched refuse’ of some teeming European shore. Many German Jews in the 1870's, perhaps overquick to sense a slight where none was intended, interpreted Miss Lazarus' words as

a snide comment on their own humble immigrant beginnings. Subscribing funds for the statue's erection on Bedloe's Island became largely a Sephardic project, eschewed by Germans. Such forces served to draw the Germans even closer to one another, into their own 'Hebrew Select,' with their own exclusive standards."

The fact that the Russian-jews became offended at Emma Lazarus' lines, "Give me your tired, your poor etc. ..."

is prima facie evidence that the whole project of the Statue of Liberty was a Jewish contrivance from its beginning! It is obvious that it was nothing more than a Jewish sleight-of-hand trick to get the White American's minds off the Preamble of the U.S. Constitution, where it expressly states, "to us and our posterity", and substitute "your tired", "your poor", "your huddled masses", "the wretched refuse", "homeless, tempest-tost" in its place. Then to connect these spurious terms to the U.S.

Constitution, the statue's right arm holds a great torch raised high in the air, while the left arm grasps a tablet bearing the date of the Declaration of Independence. What an outrage of blasphemy! This was nothing more than an attempt by the cursed descendants of Cain to rewrite the intent of U.S. Constitution. If this isn't enough of an insult, the original name of the Statue of Liberty was *Liberty Enlightening the World*, or as Scripture proclaims, 2 Cor. 11:14: "And no marvel; for Satan himself is transformed into an angel of light." It's tantamount to saying, "up with Satan, and down with your Christian forefathers' form of government!" What is even more provoking is the fact that the right arm is the strong arm, but the Statue of Liberty places the Declaration of Independence in the weak left arm! Only traitors would do such a damnable thing. In effect, it places the Declaration of Independence subsidiary to Satan's false light!

However, this is not the end of the story concerning Emma Lazarus and her infamous activities. I will now quote from *A Century of Jewish Life*, by Ismar Elbogen, pp. 332-333 in part:



"... Schiff's interest in Jewish matters began early, and he was always distinguished by the reverential regard he showed to Jewish scholarship and Jewish scholars. During the forty years of his active career there was scarcely a worthy Jewish movement in the United States in which he was not to be found at the forefront. He was a recognized leader of American Jewry during the critical period in which that Jewry attained world importance.

"When the overwhelming stream of immigrants made necessary the erection of temporary barracks to shelter them, it was Jacob Schiff who financed the undertaking. The plight of her fellow Jews turned the gifted poetess, Emma Lazarus (1849-1887), into an enthusiastic Jewess who recalled the Jews to a realization of their own dignity and worth. It was on her numerous visits to the barracks which Schiff had built that she realized the need of giving their inmates work in order to guard them from the crippling consequences of idleness. In the columns of the *American Hebrew*,

which quickly grew to be an outstanding Jewish periodical, she kindled the ardor of the larger community for the task of training the refugees, and more especially their children, in the technical arts and in trades. Due to her efforts the Hebrew Technical Institute was established in New York and similar schools were set up in Boston, Philadelphia and Chicago ...

"It was no light task to make such great masses employable. But the situation was much more favorable than in England, for America was hungry for workers. The first newcomers were far from accumulating riches, but they did find a livelihood. None of them became a public charge. Those who were needy were helped by the United Hebrew Charities, which came into being after the dissolution of the Emigrants Societies. The newcomers lived in overcrowded and unhealthy dwellings in the most wretched fashion; whenever they could do so they would actually deny themselves food in order to be able to bring their relatives from abroad. Nevertheless, as was shown by an inquiry, the state of their health

was not bad; their children flourished and developed properly”

To validate this account even further, I will quote from the book *The Story of the Jew*, by Rabbi Lee J. Levinger and his wife Ema Ehrlich Levinger in 1928, and later edited by Green, Bial, & Long, pp. 161-162:

The First Jews in America

“In the first century after the discovery, hundreds of Jews and Marranos came to the New World. Some came seeking the gold of El Dorado; most came seeking freedom. But they did not find it immediately. The ships that planted the Spanish flag from Florida to Peru also carried the cross of the Inquisition. Thirty-six years after the first European stepped foot in the New World, a Jew was burned at the stake in Mexico. The persecutions reached their peak in 1639 when sixty-three Marranos were condemned in Peru in one mass trial.

“When the Dutch took Brazil, Jews built substantial colonies at Recife and Surinam. But the respite was short. The Portuguese took back Brazil in 1654 and the Jews scattered northward through the West Indies. The history of the Jews of the United States begins with that scattering. Twenty-four refugees from the Portuguese Inquisition limped into the harbor of New Amsterdam aboard the tiny brig *St. Charles*.

“Peter Stuyvesant, Governor of New Amsterdam, was not pleased to see the Jews, some of whom were penniless. He tried to bar them, but the colony belonged to the Dutch West India Company, whose Jewish stockholders made him accept the Jews. The refugees were admitted with one restriction, ‘providing that they shall not become a charge upon the community.’ The Jews gladly accepted this condition. It was to have a profound effect upon the development of the American Jewish community.

“The Jewish colony in North America grew slowly, mostly from Sephardic Jews who came by way of England. By the time of the Revolution they numbered about twenty-five hundred traders, merchants, and shipowners. They were scattered up and down the coast, centering on five congregations, Newport, New York, Philadelphia, Charleston, and Savannah. They lived in peace and security with their

neighbors, but they did not have full civil rights. Yet, even as second-class citizens, the Jews of America truly lived in a golden land.”

The following is what I covered in my *Watch man’s Teaching Letter #39*:



This is not the only erroneous information Ted R. Weiland advances. Weiland has very little to say of the Sephardic Jews, and what he does say is mostly in error. In his book “*God’s Covenant People, Yesterday, Today And Forever*”, Weiland quotes (page 68) a Jewish source, James Gaffe, from his book *The American Jews*, which says this:

“... the early Sephardic settlers for example, left practically no

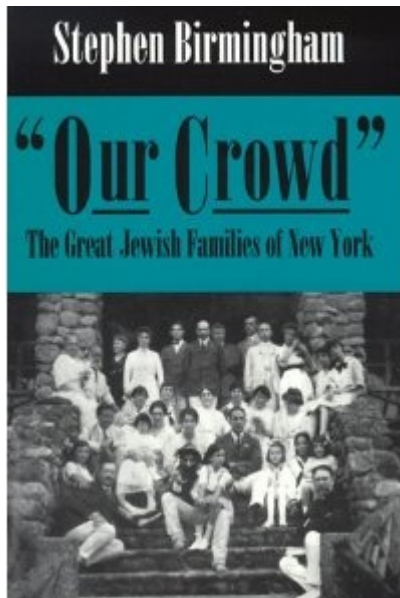
descendants who are still Jewish ... they disappeared not because they intermarried but because they refused to intermarry – and so, without sufficient choice among their own, they remained unmarried and died out. ... choosing extinction rather than assimilation.”

Now, I will back up to a note by Weiland: “**Note that he (Gaffe) considers the Sephardic Jew extinct.**” At this point, one must understand Weiland’s motive for quoting this “Jew.” Weiland is attempting to prove that the “Jews” of today are only “Jews” by religion. By doing this, he tries to avoid any connection whatsoever with a genetic Satanic seedline. But, in so doing, he backs himself into a corner. Weiland also tries to trace the “Jews” lineage back to Esau in order to discredit any idea that they are descendants of Cain. By Weiland’s endeavor to prove the Sephardic extinct, he is also implying the Esau-Edomite-Jews are extinct. If the Sephardic-Esau-Edomite-Jews are extinct, why does Ted R. Weiland even make an issue out of it? I will now present evidence that the Sephardic “Jews” still exist. The following is a review of what I have written before concerning this:

THE SEPHARDIM ARE STILL AROUND!

In the book *OUR CROWD*, ‘The Great Jewish Families of New York’, pages 29-30, and I will have to paraphrase the story: Sometime in the 1650’s a ship (“bark”, 3 masted sailing ship, *St. Charles*) dubbed the “*Jewish Mayflower*” brought twenty-three Sephardic

Jews (Rabbi Lee J. Levinger says twenty-four) from the culture of medieval Spain and some of the great Sephardic families of New York descended from the “*St. Charles*” arrivals which included the Hendrickses, Cardozos, Baruchs, Lazaruses, Nathans, Solises, Gomezes, Lopezes, Lindos, Lombrosos & Seixases. Check these names and you can know, without any reservations, the Sephardic “Jews” are still around.



On page 31, it tells how the German-Sephardic and (Ashkenazi) Jews of New York began to “intermarry.” It was the Sephardic that were the old Canaanite-Jews that came from Palestine They had the blood of Cain, Esau and the race of Rephaim (fallen angels). **If the Sephardic Jews are extinct, as Ted**

R. Weiland implies, there is no longer an Esau-Edom! Why, then, even make an issue of Esau-Edom if this is the case? This is just one example of the many spurious statements people such as Weiland, Jones, Bruggeman and Weisman make in their presentations to mislead and confuse the issues. UNABLE TO OVERCOME THE CURSE OF CAIN

At Gen. 4:12, it is recorded: **“When thou tillest the ground, it shall not henceforth yield unto thee her strength, a fugitive and a vagabond shalt thou be in the earth.”** Now returning to *A Century of Jewish Life*, by Ismar Elbogen, pp. 333-335

“Michael Heilprin was an enthusiastic partisan of the back-to-the-land movement and was happy to find that many immigrants expressed a strong desire to devote themselves to agricultural pursuits. He made it his business to raise funds for this purpose. Settlements were attempted in several states, but unfortunately all of them miscarried. One time it was the water that was at fault, another time it was a crop failure; once

drought, again frost and hail spoiled flourishing crops that were almost ready to harvest. Always it was complete lack of experience and consequently ill-chosen ground which was to blame for the failure. The settlers worked with all their might and contented themselves with the barest minimum, but none of the settlements survived its difficulties longer than four years. Individual farmers could set their teeth and outface failure until their soil rendered a return, and indeed many did so. But for closed colonies the requisite experience and capital were never available. Most of the enthusiasts were forced to return to the city disillusioned. A few colonies in southern New Jersey, like Alliance, Carmel, Rosenhayn, maintained themselves because their proximity to large cities provided them a favorable market and because the Baron de Hirsch Fund stood behind them.

“Heilprin’s influence in the creation of this Fund was considerable. In Constantinople Maurice de Hirsch was in contact with Oscar S. Straus (1840-1926), the United States ambassador to Turkey. Straus informed de Hirsch of the miserable condition of the immigrants in America. Prepared, as always, to give productive help, de Hirsch asked for a plan, and one was prepared by Michael Heilprin and met with de Hirsch’s approval. He made the income, and later the principal sum, of ten million francs (\$2,400,000) available, and left the disposition of these moneys to the judgment of an American committee. Upon this committee sat men most experienced in such affairs, among others Schiff, Straus and Judge Mayer Sulzberger. In addition to temporary help immediately upon landing, such as providing shelter, distributing immigrants in the interior of the country and the purchase of tools for artisans, measures were taken for providing permanent help by making the immigrants self-sustaining. There was much difference of opinion in matters of detail, but eventually unity was achieved. In 1890 the Fund began to operate, and the American administration was given broad powers”

Here it must be asked, If Michael Heilprin, Maurice de Hirsch and Oscar S. Straus were able to conjure up ten million francs (\$2,400,000) for the failed “back-to-the-land movement” of the Edomite-jews, how much might they have contributed to the fund for the Statue of Liberty, or as they called it at that time, *Liberty Enlightening the World*? And the jews tried the same so-called “back-to-the-land movement” in Canada, which also failed.

Ibid. p. 323: “Canada, too, had a considerable share of immigration. The proximity of the United States, the extent and fertility of the country, and the sparsity of its population were inducements to immigration but prevented a firm and independent development. The reception of the first refugees was very cordial. All charitable work was on a voluntary basis, and the personal interest and warmth with which they were met encouraged the immigrants and made it easy for them to settle down, so that they could soon help others to settle. When immigration became particularly heavy, in 1888, the Young Men’s Hebrew Benevolent Society of Montreal, which had always felt responsible for the immigrants, approached Baron de Hirsch and solicited the same interest on behalf of immigrants to Canada as he showed in those to the United States. The petition was promptly heeded; permanent assistance was promised and given. In 1891 the Baron de Hirsch Institute was opened. This provided shelter for newcomers and also secular education, with evening classes for adults. The Institute became more important as immigration grew after the turn of the century. Not content with this work, Baron de Hirsch and later the Jewish Colonization Association, which established a separate Canadian Committee, promoted the settlement of Jews as farmers. The government favored these efforts by putting land at their disposal gratis. As in almost all other countries these settlements began with a very difficult period of trial. Their success was retarded by unfavorable location and failure of crops. According to a census of 1920 there were 3,500 Jewish persons in Canada living by agriculture, and the annual value

of their products was a million dollars.” That would be \$285.71 per year per Jewish farmer, hardly a living wage even back then! That would amount to about \$23.80 per month to meet the needs of one Jewish family!

Ibid. p. 324: “These figures signify little in view of the greatly increased immigration which took place, especially in the bad decade between the pogrom of Kishinev and the World War. Whereas there were only something more than 16,000 Jews in Canada in 1901, in 1911 the number was 50,000, or 1.03% of the total population, and in 1921 it had grown to 126,196, or 1.44%. This enormous absolute increase was received into the cities, of which some, like Winnipeg and Vancouver, were founded during this period and grew at an astounding rate. The Jews wandered from east to west along the railroad, and many settled at the stations fixed by the railroad. Their small stores became central points for the agricultural regions round about. There farmers not only found their necessities, but frequently an interpreter for the various languages spoken in the country, someone to read and write their letters, and sympathetic understanding for their human problems. At these railroad stops villages came into existence, and also Jewish congregations. They are to be found strewn over the whole broad dominion. But the main body of the Jews settled in a few large cities. Montreal, Toronto, and Winnipeg contain about three-fourths of the total Jewish population. The character of the congregations was determined by the character of the immigrants, who brought a conservative attitude into an essentially conservative country. It is significant that, as late as 1921, 87% of the Jewish population recorded their mother tongue as Yiddish. Proximity to the United States determined the character of charitable institutions, hospitals, orphanages and the like; all such establishments followed the pattern set in the United States. The relief organizations for the victims of pogroms and for work in Palestine found ready support in Canada”

Question: Who’s Statue of Liberty, or Who’s Trojan horse? An “Edomite-horse” of course!

The Revelation of Yahshua Christ
Chapters 15 & 16

XV 1 And I saw another sign in heaven, great and wondrous, seven messengers having the seven last plagues, that in them the wrath of Yahweh is fulfilled. 2 And I saw like a glass sea mixed with fire, and those prevailing from the beast and from his image and from the number of his name standing upon the glass sea holding lyres from Yahweh.



The glass sea mixed with fire represents the trials of this life, the “fire” which each of us must pass through. That this fire represents these earthly trials which we endure is evident at 1 Peter 1:3-10, which states (from the KJV): “3 Blessed be the God and Father of our Lord Jesus Christ, which according to his abundant mercy hath begotten us again unto a lively hope by the resurrection of Jesus Christ from the dead, 4 To an inheritance incorruptible, and undefiled, and that fadeth not away, reserved in heaven for you, 5 Who are kept by the power of God through faith unto salvation ready to be revealed in the last time. 6 Wherein ye greatly rejoice, though now for a season, if need be, ye are in heaviness through manifold temptations: 7 That the trial of your faith, being much more precious than of gold that perisheth, though it be tried with fire, might be found unto praise and honour and glory at the appearing of Jesus Christ: 8 Whom having not seen, ye love; in whom, though now ye see him not, yet believing, ye rejoice with joy unspeakable and full of glory: 9 Receiving the end of your faith, even the salvation of your souls. 10 Of which salvation the prophets have enquired and searched diligently, who prophesied of the grace that should come unto you [here it is evident that Peter is

speaking only to the children of Israel, the subjects of all of these prophecies exclusively]: 11 Searching what, or what manner of time the Spirit of Christ which was in them did signify, when it testified beforehand the sufferings of Christ, and the glory that should follow.” So we see that the trials of this world are indeed the fires which we must pass through. This is also evident in 1

Corinthians chapter 3 where we find: “11 For other foundation can no man lay than that is laid, which is Jesus Christ. 12 Now if any man build upon this foundation gold, silver, precious stones, wood, hay, stubble; 13 Every man's work shall be made manifest: for the day shall declare it, because it shall be revealed by fire; and the fire shall try every man's work of what sort it is. 14 If any man's work abide which he hath built thereupon, he shall receive a reward. 15 If any man's work shall be burned, he shall suffer loss: but he himself shall be saved; yet so as by fire.”

3 And they sing the song of Moses, the servant of Yahweh, and the song of the Lamb, saying: “Your works are great and wonderful, Prince Yahweh Almighty! Your ways are righteous and true, King of the Nations! 4 Who should not be afraid, Prince, and honor Your Name? Because You are the only Holy One, because all the nations shall come and they shall worship before You, because Your judgments have been made manifest!”

These people are not the one hundred and forty-four thousand of chapters 7 and 14. Neither are they the innumerable multitude of chapter 7. Rather, they are a new multitude – those Israelites from among the Nations who in these last days have prevailed over the beast by not worshipping the beast. All of the Nations

which worship Yahweh are, in the Biblical context, all of those nations of people which are written in the book of life – since all others shall go into the Lake of Fire. The distinction must remain between the sheep nations and the goat nations of Matthew chapter 25. The sheep nations go onto eternal reward, and the goat nations go on to eternal punishment – the Lake of Fire, which in this case is different from the trials of fire. The Lake of Fire represents permanent destruction, since the beast, the false prophet, Hell and Death also face that same fate.

5 And after these things I looked, and the temple of the tabernacle of testimony opened in heaven, 6 and the seven messengers having the seven plagues came out from the temple, clothed in clean bright linen and girt about the chest with gold belts. 7 And one from among the four living creatures had given to the seven messengers seven gold bowls filled with the wrath of Yahweh who lives for the eternal ages. 8 And the temple filled with smoke from the effulgence of Yahweh and from His power, and no one was able to enter into the temple until the seven plagues of the seven messengers are completed.

The tabernacle of testimony must be related to the “ark of His testament” mentioned at the end of Chapter 11. There it was remarked that the Word of God is the true ark of His testament, since it holds all of the promises made to Israel, and in that section of the Revelation we saw the opening of the Little Book – the Reformation and the deliverance of the Scripture into the hands of men, and the Two Witnesses, Israel and Judah, who fulfilled their testimony by fulfilling the prophecies concerning them: that they would indeed turn back to Yahweh and His Word through Christ. Their adoption of Christianity and their embrace of the Word of God in the Reformation was indeed the fulfillment of such prophecies. One example is found at Hosea 2:7, speaking of the deported Israelites: “And she shall follow after her lovers, but she shall not overtake them; and she shall seek them, but shall not find them: then shall she say, I will go and return to my first husband [Yahweh]; for then was it better with me than now.”

In Chapter 16, with the seven vials, we return to the last portions of the historical prophecies in the Revelation, which have already been accomplished, and which cover the last age leading up to the fall of

Babylon.

Chapter 16

XVI 1 And I heard a great voice from out of the temple saying to the seven messengers: “Go, and pour out the seven bowls of the wrath of Yahweh into the earth!”

Here will be discussed not definite and detailed historic events, as were witnessed in chapters 4 through 13, but an overall picture of Christian society, because it may be discerned that these prophecies are indeed a premonition of the overall state of the Christian society as it exists after the passing of the two beasts which we saw portrayed in Revelation chapter 13.

2 And the first went out and poured his bowl out into the earth, and there came a bad and grievous sore upon the men who have the engraved mark of the beast and who worship its image.

With the French Revolution and the age of Napoleon, the end of the old feudal order had come for certain. The end of ecclesiastical control over the morals and behavior of the people, a power which was often abused under the Romish catholic church system anyway, had also come. The people would now generally be left to their own devices, under the guise of the so-called free and modern society. Yet with the introduction of mass-produced Bibles into the average home, the common person was also given a choice: to follow the Word of God, or succumb to the devices of the society. The jew – satan let out of the pit - as we shall see in Revelation chapter 20 – is now an equal in European society, and will use his new status to promote all sorts of vice and corruption, modern versions of the Canaanite idols his fathers had once used to allure the children of Israel into sin. Furthermore, free enterprise is endangered and shall succumb to an entirely usury-based economy, organized under capitalism and orchestrated by the jewish banking families of Europe, notably the Rothschilds. Under a usury-based capitalist economy, the enemies of Christ would gain more and more power and influence, enabling them to finance ever-stronger attacks against Christendom, and from within rather than from without.

In order to help understand what is being described here, a reading from Ezekiel chapter 18 shall be presented, along with a reading of part of Jeremiah

chapter 31 and then a reading from the Book of Joshua. Ezekiel is writing at a time when practically all of the Israelites along with most of Judah were taken off into captivity by the Assyrians. Ezekiel is among the captives who were relocated and settled in a part of northern Syria. Those taken captive by the Assyrians would never return to Palestine. Instead, they would for the most part eventually migrate through the Caucasus mountains and eventually emerge as the [Sakans and Kimmerians, forerunners of the modern Germanic peoples](#).

Ezekiel 18: “1 The word of the LORD came unto me again, saying, 2 What mean ye, that ye use this proverb concerning the land of Israel, saying, The fathers have eaten sour grapes, and the children's teeth are set on edge? 3 As I live, saith the Lord GOD, ye shall not have occasion any more to use this proverb in Israel. 4 Behold, all souls are mine; as the soul of the father, so also the soul of the son is mine: the soul that sinneth, it shall die. 5 But if a man be just, and do that which is lawful and right, 6 And hath not eaten upon the mountains, neither hath lifted up his eyes to the idols of the house of Israel, neither hath defiled his neighbour's wife, neither hath come near to a menstruous woman, 7 And hath not oppressed any, but hath restored to the debtor his pledge, hath spoiled none by violence, hath given his bread to the hungry, and hath covered the naked with a garment; 8 He that hath not given forth upon usury, neither hath taken any increase, that hath withdrawn his hand from iniquity, hath executed true judgment between man and man, 9 Hath walked in my statutes, and hath kept my judgments, to deal truly; he is just, he shall surely live, saith the Lord GOD.”

Among the sins which men will die for are idolatry, fornication, adultery and usury, which is what the language here is describing, along with a lack of brotherly love – here depicted as a fair treatment of the debtor, and provision for the needy.

This admonition in Ezekiel 18 is then repeated for a son who does engage in such behavior, and for a son's

son who does not, in order to demonstrate that the same family may have members who sin in this manner, and members who do not. But from this time only the sinners will be punished, and not the entire family. That at one time entire families were punished for the sins of a man is evident in Scripture, and because it also helps to explain other aspects which are being discussed here, a passage from the story of Achan, found at Joshua 7:20-26, shall be read: “20 And Achan answered Joshua, and said, Indeed I have sinned against the LORD God of Israel, and thus and

thus have I done: 21 When I saw among the spoils a goodly Babylonish garment, and two hundred shekels of silver, and a wedge of gold of fifty shekels weight, then I coveted them, and took them; and, behold, they are hid in the earth in the midst of my tent, and the silver under it. 22 So Joshua sent messengers, and they ran unto the tent; and, behold, it was hid in his tent, and the silver under it. 23 And they took them out of the midst of the tent, and brought them unto Joshua, and unto all the children of Israel, and laid them out before the LORD. 24 And Joshua, and all Israel with him, took Achan the son of Zerah, and the silver, and the garment, and the wedge of gold, and his sons, and his daughters, and his oxen, and his asses, and his sheep, and his tent, and all that he had: and they brought them unto the valley of Achor. 25 And Joshua said, Why

hast thou troubled us? the LORD shall trouble thee this day. And all Israel stoned him with stones, and burned them with fire, after they had stoned them with stones. 26 And they raised over him a great heap of stones unto this day. So the LORD turned from the fierceness of his anger. Wherefore the name of that place was called, The valley of Achor, unto this day.”

So it is evident that Achan's entire family was destroyed for his transgression. If Achan were to keep his gold and his silver, and his “Babylonish garment”, it was inevitable that he was to become a banker – for that was the only use that those things would have had. In ancient Babylon, the temples of the pagan idols also served as banks, among other things. The



priests of those temples would loan out the offerings which they received at usury. Achan would have had no other purpose if he kept these things.

Another passage which lends insight to this passage of the Revelation is found in Jeremiah Chapter 31, verses 27 through 30: “27 Behold, the days come, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast. 28 And it shall come to pass, that like as I have watched over them, to pluck up, and to break down, and to throw down, and to destroy, and to afflict; so will I watch over them, to build, and to plant, saith the LORD. 29 In those days they shall say no more, The fathers have eaten a sour grape, and the children’s teeth are set on edge. 30 But every one shall die for his own iniquity: every man that eateth the sour grape, his teeth shall be set on edge.” This passage in Jeremiah precedes a passage beginning at verse 31 which promises the consummation of the New Covenant. Therefore it is a prophecy for this very time. Sour grapes are associated with the sins of Sodom and Gomorrah at Deuteronomy 32:32: “For their vine is of the vine of Sodom, and of the fields of Gomorrah: their grapes are grapes of gall, their clusters are bitter”. Here it is evident that the sour grapes represent the fornication and other sins which were prominent at Sodom and Gomorrah.

The day would come when Yahweh would sow the house of Israel and the house of Judah with the seed of man and the seed of beast, and that day began when the Jew was emancipated and allowed into the community of the European nations as citizens equal to Christians. Satan was loosed from the pit, or the ghettos of Europe, in order that he may deceive the entire world. In Revelation chapter 13, we saw that it was the dragon which gave his power to the beast. This dragon is also identified with Satan in Revelation chapter 12. For many centuries the Jew remained in the background, as court physician or private banker or in some other panderous capacity, attempting to compromise the nobility of Europe and often succeeding. Through the usurpation of organizations such as the Jesuits and Masonry, now the Jew could overthrow and supplant the nobility of Europe, which began with the French Revolution. The capitalist system requires usury, considered to be a great evil to Yahweh God. The capitalist system has brought with it international commerce – globalism, multiculturalism, and all of the other devices of the Jew used to weaken

Christendom and flood the Christian nations with godless aliens, the “beasts” of Jeremiah chapter 31. It will be seen below that these ideas, along with the idea of a society without God, were first broadcast and promoted throughout the Christian world beginning with the French Revolution. The result is the modernist and mixed-race society in which we live today. Worship of the beast, and the taking of the mark of the beast, is therefore the worship of this system of man brought upon the Christian world by the enemies of God. Unlike the mark of the beast placed upon man during the period of the papacy, this time it is voluntary, and man takes it upon himself. Christians are told to despise the world, and today most of them fully embrace the world, even believing that to be Christian.

3 And the second poured his bowl out into the sea, and it became blood as if dead, and every soul of life died which was in the sea.

This represents the death of spiritual life in the Christian nations – as people began to worship the beast the aspirations of Christianity were replaced with the Jewish ideals of consumerism and humanism.

4 And the third poured his bowl out into the rivers and the springs of the waters, and they became blood. 5 And I heard the messenger of the waters saying “You are righteous, He who is and who was, the Holy One, because You have judged these things! 6 Because they poured out the blood of the saints and prophets, You also gave them blood to drink. They are deserving!” 7 And I heard the altar saying “Yeah, Prince Yahweh Almighty, true and righteous are Your judgments!”

This represents all of the resulting wars stemming from humanism and the Jewish influence over Christianity.

8 And the fourth poured his bowl out upon the sun, and had given to it to burn men with fire. 9 And the men had been burned by great heat and they blasphemed the Name of Yahweh who has authority over these plagues, and they did not repent to give honor to Him.

The sun in the Revelation often seems to represent the powers of worldly governments as ordained by God, who has authority over these plagues. In this age the governments of Adam-kind have become tyrannies.

People curse, blaspheme and deny God when they are affected by these plagues, although they are affected by them because they worship the beast system, and not God Himself.

10 And the fifth poured his bowl out upon the throne of the beast, and his kingdom became darkened, and their tongues strove from the toil, 11 and they blasphemed the God of heaven from their toils and their sores yet they did not repent from their works.

How often do we hear “why does God permit things to be so?” Or “what kind of God would allow such a thing?” Humanism has replaced God because God is considered to be unfair. No longer do the governments of the world act as Christian governments. Because we as a people have worshipped the beast, - as we shall see in chapter 17 - our kingdom has been handed over to the beast.

Remember the trial of Job. Satan challenged Yahweh, that if Job were to be touched by adversity, he would curse Yahweh. Yahweh therefore allowed Job to be denuded of all which he had by Satan, and Job suffered greatly, but he never cursed God. In the end Job was rewarded many times over. This should continue to serve as our model today, whenever we are tried or suffer damage from this beast system.

12 And the sixth poured his bowl out upon the great river Euphrates, and its waters dried, in order that the way of the kings from the rising of the sun should be prepared.

The industrialization of Asia which began in the 19th century prepared the way of the kings of the east to gain power over Christendom. Today, through the industrialization of China and Japan and the other Asian states, they hold a great amount of power and influence over Christendom. They have also become militarized at the expense of Christendom. These peoples of Asia would never have been able to rise to the level where they could be any plausible threat against us if it were not for internationalist capitalism, for the jew knows no boundaries and has no allegiances to any other people. It is only natural that eventually the parasite will destroy the host.

13 And I saw from out of the mouth of the dragon

and from out of the mouth of the beast and from out of the mouth of the False Prophet three unclean spirits like frogs.

[*Yahweh God does indeed have a sense of humor.*] Frogs have no prior allegorical use in Scripture. They are one of the plagues in Egypt, however it is certain that the reference to frogs in the Book of Exodus must be taken literally. However one clue to the use of the word here cannot be overlooked. While it is not an intention here to continually insult the French people, and they were as much victims of circumstance in the French Revolution as were the Germans, the English and the Americans in the torments to follow, the use of the term frog to describe a Frenchman has been extant throughout the English-speaking world for over 200 years. This may be an indication as to the nature of the unclean spirits which emanate from the mouth of the false prophet.



A lot of argument, rational or emotional, can be made concerning which isms or which philosophies these three unclean frogs represent. However all of the philosophies promoted and forced into our Christian society by our enemies can be summarized in and have been cloaked by the supposed ideals of the French Revolution found in the slogan, Liberté, égalité, fraternité, which is still the national motto of France today. Through these ideals have gone out all of the jewish ideas into the world, the ideas of liberty and freedom and equality and brotherhood which are contrary to the covenant relationship which Christians have with their God. Christians are not supposed to be free. They are supposed to be servants of Christ, and keep His commandments. Christians do not have equality. Wives and children are supposed to be subject to their husbands and fathers (Ephesians 5:21-33, 1 Peter 3:1-5), and each of us has an unequal portion in the diverse gifts of God (1 Corinthians 12, Matthew 25:15). Christians are supposed to have brotherhood only with those of their kin who are Christians, and are to have no community or fellowship whatsoever with non-Christians (2 John 9-11). The jewish ideals of liberty, equality and fraternity are ideals which lead to the decline of Christian society into the cesspool of human licentiousness. All of the cries for diversity, racial equality, sexual liberation, and every other philosophy

detrimental to sound Christian society which has been made these past 200 years have been based upon these Jewish ideals, and Jews have been their chief instigators and promoters.

14 For they are the spirits of demons making signs, which go out to the kings of the whole inhabited earth to gather them to the battle of the great day of Yahweh the Almighty. 15 “Behold! I come as a thief! Blessed is he being alert and keeping his garments, that he would not walk naked and they would see his shame!” 16 And He gathered them into the place called in Hebrew “Harmagedon”.

An *ar*, or *har*, is a mountain, and Megiddo means *place of crowds*. The events described here can be paralleled to the events described in Ezekiel chapter 38. All of the alien nations of the world are gathered to battle against the people of God. While an actual military invasion cannot be precluded, this situation has been transpiring for at least 50 years now, since the Christian nations have begun to be overrun with massive non-European immigration by all of the world's other races, the beasts of Jeremiah 31:27, and also of Isaiah 56:9. This situation is described as culminating in Revelation chapter 19 and will be discussed at length there.

As for those keeping their garments, Christians should

be covered with the blood of the Lamb. The references to shame and nakedness are a reference to Genesis chapter 3, and after the transgression in the garden, which was certainly sexual in nature, Adam and Eve realized that they were naked, and became ashamed.

17 And the seventh poured his bowl out upon the air, and a great voice came from out of the temple from the throne saying “It has happened!” 18 And there were lightnings and noises and thunders and there was a great earthquake, such as had not happened from when man had come to be upon the earth was such an earthquake so great! 19 And the great city broke into three parts and the cities of the nations fell. And the great Babylon had been remembered before Yahweh, to give to her the cup of the wine of the wrath of His anger. 20 And every island fled, and the mountains were not found. 21 And a great hailstorm like boulders descends from out of heaven upon men, and the men blasphemed Yahweh from the plague of the hailstorm, because the plague of it is exceedingly great.

These last verses describe the fall of Babylon. It cannot be commented upon yet, because it has not yet happened. Chapters 17 and 18 which follow will discuss this same thing – the fall of Mystery Babylon – in greater detail, and also offer a poetic portrayal of Mystery Babylon itself.

The Afrikaner: Black Africa's Last Hope A Boer Perspective

The transformation of our fundamental values have brought with them unique problems requiring unique solutions. What we have today is a miscellany of people demanding and receiving equality on all human levels. It also has a name: "humanism". How to extricate ourselves from this hotchpotch of humanity is the problem, because we are under command to come out from among them and "be separate".

This incongruous mixture of mankind is today's version of ancient Babel, which brought about divine intervention. And because we know that God "changes not" we can be certain that it won't be long before divine displeasure will once again be manifest in the affairs of man. It has never made sense to mix milk with ink, light with darkness, nor the races of man. It makes no sense except to people of ill-will and vested-interests in controlling freedom that comes with independence. Why should anyone wish to deprive people of this freedom who choose to live apart from racial admixture? What other motive could there be other than political control? After two world wars, fought in the name of "freedom", it became clear, from the chaos that followed, that those wars were not fought *for* freedom but to *deny* freedom.

After Germany's independence was lost to the united Judaic-Christian/Communist Alliance, the same political gangsters directed their united wrath against South Africa, another independent Christian people. The bossy, nosey-parkers who lived in the White haven of European environment, decided to teach us how to live in Africa. Well, let's go back a little into history because South African history is like none other.

South African history shows that the Dutch got here first, as early as the sixteen hundreds. Then the British came. Those early centuries bristled with clashes as British, French, Dutch and Spanish forces contested supremacy of sea and land for empire and trade. The British came out on top and established an Empire

upon which the sun never set.

The British soon demonstrated a highly developed sense of entitlement. No 'United Nations' there to curb her ambitions. British occupation expanded domestic trade, but it also brought many benefits to her colonies. They were taught good manners, good government, how to write letters and use the red pillar-box and other civilized things, but all was done allegedly for King and country. What the British African occupations appeared to lack was a sense of African "savvy" for want of a better word. They saw nothing wrong with allowing Kenyatta, who ate raw human parts, to dance with their Queen. Whereas Professor Albert Sweitzer, who spent his life attempting to civilize Africa, warned against treating them as equals, saying they would "destroy you, devour you".

The Boer had a different world-view. He came to settle.

Africa was his "Home". His roots went deep into African soil. The wild, angry character of the land offered the challenge that suited his tough, rugged nature. His conviction that he was in Africa by divine appointment was as powerful as was Britain's quest for Empire,

When the British came, unreconcilable political views led eventually to two wars and endless political bad blood. The two world wars that followed the two Boer wars did not improve the situation because the liberal spirit of Empire had now saturated the entire British way of thinking. The establishment from church to government to sport was riddled with liberalism, while the South African nation had moved in the opposite direction with the national policy stabilizing her society on Separate Development.

Under the post-war Afrikaner Nationalist government the White language population balance was approximately 60/40 percent. English speakers became known as the 'forty percenters'. It is

interesting to note that despite the international prejudice against the Apartheid. policy, in the 1966 General Election, Dr. Hendrik Verwoerd's last election before his assassination, his party registered its biggest English support ever. English South Africans, despite the fire-eating ravings of the Jew Helen Suzman, the idealistic Alan Patons, and the Anglican pests, they voted together with their Afrikaans fellow citizens, wide awake to the rising tide of Black unrest. People who stopped to think saw sense in the policy of separating peoples as diverse as Africans from the creative Caucasian peoples. But by then universalism closed its ears to all but its humanistic program. Washington's vision, which predicted the collapse of Africa from north to south happened as he had been shown it, as British, French, Belgium and Portuguese colonies gained their independence and became voting members of the UNO.

No Black state however, has ever achieved stability and prosperity, because the Black race is non-creative, and without help, guidance and support from a civilized society, chaos, wars and fightings become the norm.

One of the commandments our Lord left His people was to: "Occupy till I come." After World War Two, General Montgomery laid before his Labour Government a plan whereby the British forces would have occupied and controlled the African states, which would have fulfilled that order, but his government had already decided upon their participation in the New World Order, and the first post War boat load of immigrants were brought in and dumped on sacred British soil.

The other option for Black Africa was the Afrikaner. He was the better option because he did not wish to dominate or steal land from the Blacks. He did not want to colonize them but he had a plan whereby both peoples could live side by side as good neighbours. The Afrikaner with his skills and know how would assist with their infrastructure, business methods, animal husbandry, technology and so on.

Apart from their individual participation on the side of the Allies in the two world wars, the Afrikaner's African military engagements were limited to defensive action. The Afrikaner is a God-fearing people with a love for the land. His farmers are

among the best in the world, but he has skills in many directions. An Afrikaner performed the first successful heart transplant operation. Much of his military weaponry for the Border war was unique and highly technically sophisticated. Out of the soil he loves, was born a new Aryan language: Afrikaans, a beautiful, flowing, rhythmic sound when spoken by her people.

In the early 1800s the British ruled in the Cape. Their liberalism, a colonial offshoot, divided the Cape Afrikaner community resulting in large numbers moving North in "The Great Trek" that has been likened to Israel's Exodus out of Egypt. The risks of this enterprise were many: the angry wilderness, high, craggy mountains, primitive tribesmen, all were overcome. Women and children - including 12 year-old Paul Kruger - did their bit along the way that led to the founding of the Transvaal and the Orange Free State. The glorious adventure that brought them from the oppressive dictats of the English, to their new world produced a generation of Christian men and women of a caliber unexcelled from then till now. The Boer is not a stolid, humourless, work-machine. His rugby, his braaivleis, boerewors and boere-musiek provided by his lively concertina and banjo, accompanied by his stories told as only the Boer knows how to tell them, is what made South Africa the unique paradise it became, when he ruled.

But paradise was lost when gold was found in her ground.

The friendly hand offered to the African has been slapped away. They wanted what the White man had created, and England helped them to get it. Today the Black barbarian murders, rapes, robs, with near impunity, and looks forward, after the death of Mandela, to intensify their reign of terror against South Africans to whom this land, "beyond the rivers of Ethiopia" was given by divine decree of Almighty God

Even as we see African states refusing to take action to restore something resembling civilization in Zimbabwe, the begging bowl for Ethiopia is being passed around to us yet again. It is nearly 25 years since Ethiopia's (and Bob Geldof's) famous Feed The World campaign, and in that time Ethiopia's population has grown from 33,5 million to 78 million today. So, why on earth should I do anything to encourage further catastrophic demographic growth in that country? Where is the logic? There is none ... Sorry. My conscience has toured this territory on foot and financially. Unlike most of you, I have been to Ethiopia, like most of you I have stumped up the loot to charities to stop starvation there.

In around fifteen years (for the second time in a few decades) it built an economic wonder' - today, fast becoming a global leader in almost every aspect. [A Reminder: a lineage very strongly associated with White Afrikaans speaking people.]

On the 'flip side' Zimbabwe was handed one of the

wealthiest countries in the world. For example, her currency was worth more than the USA Dollar. What is it today? Competing with Ethiopia to be the most desolate hell-hole on the planet? Please explain?

You cannot take something from somebody who never had it! In fact what is it that White people, specifically White men, are supposed to give back to the Black people? What exactly was it that White men took from Blacks?

Money, Capital and the pivotal mechanisms of the wealth that allows you to breathe, eat, have children, live a rather healthy, productive and fulfilling life, but also allowed the cognitive development ... it is all of Western origin. In fact, the key advancements in modern finance and economics were made by the Dutch. Why do you think it is called Wall Street? It was initially "Wal Straat". Yes, the Dutch took their

proper. If the policies of the Golden Dawn were actualized, they would benefit Greeks themselves but also substantially benefit other Europeans. Its policies would spell an end to the flooding of Greece but also stymie the further influx of aliens into the nations of Europe.

Therefore, if seen from a broader perspective, there are positive racial ramifications to supporting the Golden Dawn, and concrete benefits to Europeans of all nationalities.

The Golden Dawn as a movement has potential ramifications not only for the Greek people but for all people of European descent. In this post I desire to draw out these ramifications.

The immediate benefit of the Golden Dawn is to the Greek people themselves. As is widely reported, though with a negative angle, the Golden Dawn proposes forcible repatriation of illegal immigrants and the laying of mines along Greece's borders. It is the only Greek party to place at the forefront Greek ethnic interests, and perforce is the only legitimate Greek party, because *a true political entity exists as a mechanism for the preservation of a unique people*.

I submit that there are other ramifications, equally as positive, to not only the Greeks, for whom this party is intended, but indirectly to other peoples of Europe saddled with alien elements.

It has also been widely reported and known that since Europe has tightened other transits, Greece has been, of late, *the primary transit route for illegal immigrants attempting to make their way into Europe*

Lastly, the Golden Dawn is somewhat a novelty [among the] so-called *far right* parties in Europe by not only adopting a revisionist perspective on certain aspects of World War II history, but also refusing to co-opt Jewry. EU FIDDLES ILLEGAL NOBEL PRIZE

The award of the Nobel Prize to the European Union is crass, immoral and illegal under Nobel rules. The award follows a trail of disgraceful awards to sundry bigots and bombers. The Peace Prize has been awarded to bombers like Gerry Adams, Yasser Arafat and Menachem Begin - consistent perhaps with the source of the fortune made by Alfred Nobel from guns and ammunition!

Thorbjorn Jagland, the chairman of the Nobel Committee, is also Secretary General of the Council of Europe, which dubiously shares the blue and yellow flag with the EU and works hand-in-glove with the EU. Jagland is a former Prime Minister of

Norway and one of that country's more fanatically supporters of the European Union - membership of which his wise countrymen have repeatedly rejected.

This award follows a pattern in recent times of one institution awarding prizes (originally meant for individuals) to other corporate bodies. A recent example was the award of an honorary degree by Newcastle University to the Jean Monnet Foundation (which promotes pro EU Chairs of learning at Universities). These collective unaccountable awards are pure corporatism - out of democratic control. No institution is more corporatist and out of democratic control than the European Union.

BUT SUCH AWARDS TO CORPORATE BODIES ARE ILLEGAL UNDER NOBEL PRIZE RULES.

The Norwegian Nobel Committee, in accordance with the Will of Alfred Bernhard Nobel, (Paris, 27 November, 1895) has a specific responsibility to determine "the eligibility of candidates" before any award is made. Here is the relevant extract from the Nobel Will (for which I am grateful to the researches

of Professor Michel Chossudovsky of the Centre for Research on Globalisation):

"The whole of my remaining realizable estate shall be dealt with in the following way: the capital, invested in safe securities by my executors, shall constitute a fund, the interest on which shall be annually

distributed in the form of prizes to those who, **during the preceding year**, shall have conferred the **greatest benefit to mankind....**

The said interest shall be divided into five equal parts, which shall be apportioned as follows: one part **to the person** who shall have made the most important discovery or invention within the field of physics; one part **to the person** who shall have made the

most important chemical discovery or improvement; one part **to the person** who shall have made the most important discovery within the domain of physiology or medicine; one part **to the person** who shall have produced in the field of literature the most outstanding work in an ideal direction; and one part to the person who shall have done the most or the best work for fraternity between nations, for the **abolition or reduction of standing armies** and for the holding and promotion of peace congresses. ... (The latter being the Peace Prize awarded to the European Union.

Needless to say the European Union does not qualify either under the definition of "a person" nor under their track record "during the previous year" which has seen violent upheaval, mass unemployment, a massive rise in suicides, the further destruction of national democracies and unrepayable indebtedness of member states. Nor does the EU qualify as having "done the most or best work for fraternity between nations" since it has been behind the destruction of Yugoslavia and Czechoslovakia and daily seeks the "regionalisation"



of nation states as a means of bypassing their national Governments. Throughout the EU mutual national hatreds rise, not least in Greece where Germans are justifiably [*wrongly - Editor*] associated with the destruction wrought by Nazis in the 1940s and the traditional alliance between France and Germany daily falls apart. With many EU member states engaged in war in Afghanistan and EU forces engaged in various parts of the world, they can hardly have done much for "the abolition or reduction in national armies".

The European Union is responsible for the abolition of 27 national constitutions, 27 parliaments, 17

currencies and 17 Central Banks and a record decline in the share of world trade and wealth creation attributable to its members. There are over 25 million unemployed in the European Union and it has never been so detested by those who "benefit" from its institutions.

The award of the Nobel Prize is a sick joke - but all too typical of the decadence of the supranational anti-democratic establishments which brought the EU into being.

There is much public talk in the UK about leaving the EU and speculation as to how this can best be achieved without incurring massive financial penalties. The following timely comment relates to the plan drawn up by Roger Bootle, an economist whose team won the £250,000 Wolfson Economics prize for producing the best plan for dealing with member states leaving the eurozone, and which had been written about by Patrick O'Flynn and Ambrose Evans-Pritchard, leading national journalists.



From this report it seems that the Irish, Patrick O'Flynn and the Welsh, Ambrose Evans-Pritchard think we should leave the EU. It would seem they have no understanding of our Constitution which is perhaps understandable, but presumably Roger Bootle is English and he clearly has no understanding of it either.

What they all fail to grasp is that we are not and never have been lawfully members of the EU simply because constitutional constraint forbids the surrender of our national sovereignty and to act in contravention of constitutional constraint is Treason. A referendum on whether or not we should leave would be inviting the people to act with complicity in an act of treason against themselves.

It is simply amazing just how ignorant and naive people of the media are. He alleges: "*In fact, we joined the EU willingly, but with our eyes shut,*" Just who is Mr Bootle referring to as "we"? If he is referring to the British people on what does he base his statement? 'We' were never asked or consulted because the government knew full well what the answer would have been.

The treacherous Conservatives took us into the then

EEC, (the Europaisch Wirtschafts Gemeinschaft) on a 'might is right' basis and lied to the people in Parliament (perjury) to cover the Treason and get the unlawful and consequently *ultra viros* ECA 1972 passed.

" *It is one thing to give up sovereignty to a body which is honest, efficient and prosperous;*" No mention or recognition you notice that surrendering our sovereignty was an act of Treason, or that by so doing it ended the monarchy as there can be no sovereign head of state in a country that is not sovereign. Or that it surrendered the supremacy of the Crown that is supreme or it is but nothing and as Parliament drew its legitimacy from the Crown it ended the legitimacy of Parliament rendering it an unlawful assembly. Perhaps due to ancestry and disposition Mr Bootle only sees the situation from the

standpoint of economics and no one can deny the importance of that aspect, but the self autonomy of the nation relies not on economics and politics but on the laws which protect and sustain national sovereignty, laws which were broken and totally ignored by acts of treason which were not only sanctioned by the person of the monarch whom the

people had elected in 1953 to ensure their protection but who subsequently honoured the traitors. In short, national sovereignty means complete self autonomy, to surrender that sovereignty in an act of national capitulation is to surrender the national purse which is not in the gift of any government without the specific and express permission of the people. Never the less, this is what the Queen and her Conservative government did in 1972 and that was plain theft.

We do not need and according to law may not have a referendum to further compound the existing Treason. All that is needed is an honest body to recognise and uphold our laws and lawful sovereignty. It is here that our greatest difficulty lies, for this is a duty entrusted to the Monarch but clearly that trust has been broken. There can be no doubt that our system of constitutional monarchy has totally failed. If we are to



survive as a nation state we must now either dismiss the Monarch and elect another, or find a different system which in view of recent events is long overdue.

Changing our system might not be as radical or difficult as it might initially seem. In principle this nation has always been a republic, a republic being a country in which the people hold the supreme power over their governors. This principle was clearly asserted in the Magna Carta and again in the Declaration of Right and Bill of Rights 1688/9 in which the concept of the monarch's rule by divine right was ended once and for all and the role of the monarch established as that of official Governor of the nation (ref. Coronation Oath Act 1688) and to whom the government would be subordinate by oath. In effect the monarch became what is now known as a president. In order to keep usurpers from muscling in

on the office they retained the practice of the nations leader having the role for life and the eligibility of that role being restricted to one family.

All that is fine but it depends very much on personal integrity and sense of honour. In those times all people were religious and were more God fearing than they are today and sacred

oaths were more respected. This has changed with social evolution and therefore such concepts cannot be relied upon. It is essential therefore that other means must now be devised to ensure the integrity of those in whom we place our trust and better means introduced to remove from office any who fail in their statutory and lawful obligations of office; just as did our ancestors the Celts many centuries ago. As it happens no one would have to be charged with the removal of the Queen as she abdicated her office when she was a willing party to the surrender of the supremacy of the Crown. It should be well remembered that this nation is not the Monarch, nor its government or parliament, it is the British people and their historic common law constitution, as it has so been down through the many centuries regardless of monarchs, dictators and pretenders.

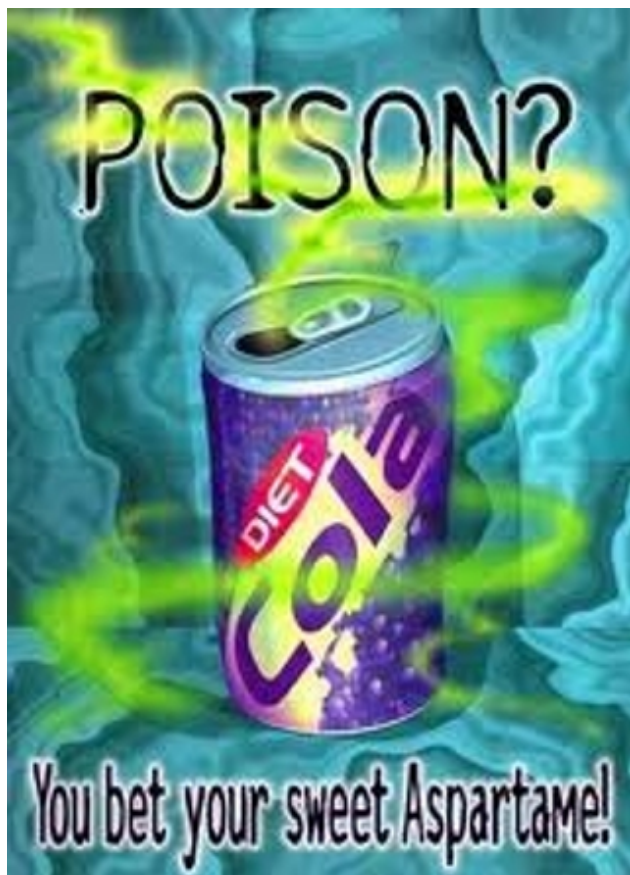
While Science Sleeps: The Toxicities of Methanol as it Relates to Aspartame

Aspartame is the technical name for the brand names NutraSweet, Equal, Spoonful, and Equal-Measure. While it's one of the most commonly used artificial sweeteners in the world, it's also one of, if not THE most dangerous food additive on the market today.

Aspartame accounts for over 75 percent of the adverse reactions to food additives reported to the FDA. Many of these reactions are very serious, including seizures and death.

In this interview, Dr. Woody Monte, professor emeritus at Arizona State University in food and chemistry, sheds light on what makes aspartame so hazardous to human health.



Dr. Monte, who also authored the book *While Science Sleeps: A Sweetener Kills*, is well-known as a world expert on the toxicities of methanol as it relates to aspartame, having studied it for the last three decades.

"I was asked by the soft drink beverage industry to look at aspartame [in 1983]... Basically, the summer of '81 is when aspartame first came out, but it first came out in powdered drinks only, and for good reason. Crystal Light, that kind of thing. They didn't want to put it into liquid form because they knew in the liquid form it would break down. It breaks down into methyl alcohol and what's left of the molecule. They didn't want to start doing that."

Methyl Alcohol – The Root of the Problem with Aspartame

Aspartame is made up of aspartic acid and phenylalanine. But the phenylalanine has been synthetically modified to carry a methyl group as that provides the majority of the sweetness. That phenylalanine methyl bond, called a methyl ester and is very weak.

If the methyl alcohol is removed from aspartame as easily happens when drinks sweetened with it are exposed to higher temperatures, it no longer tastes sweet. This is precisely what happened to most of the diet soda sent to the Middle East for US troops. They received non sweet sodas that were loaded with dangerous levels of methanol which is more or less like drinking straight poison when it's in this already broken down state.

Dr. Monte explains the history of how methanol found its way into our food supply:

"Methyl alcohol is made from wood alcohol. Wood alcohol and methyl alcohol are two different names for the same thing. Methanol is called wood alcohol because if you take wood and heat

it in a closed cylinder, the smoke that's evolved from that contains a large amount of methyl alcohol.

Methanol is the smallest molecule of alcohol there is. It's one carbon... ethanol has two carbons... They are similar in many ways. So, if you want to make a really, really good tasting vanilla extract, you would use methanol to do it. You could, because you would get more of the flavor essence out of it.

The food industry decided, 'We've got to test the methanol to see how safe it is.' They went to the laboratory and they tested animals. Back in those days, believe it or not, they did actually better laboratory testing than we did when it comes to toxicology. They would take a whole range of animals. They would take rabbits, dogs, guinea pigs, various kinds of ruminants besides rats and monkeys – different varieties of monkeys – and test them all.

When you test all of these animals to see how dangerous methanol is compared to ethanol, ethanol comes out to be more dangerous by a factor of about 30 percent, depending on the animal. Right away they decided this is important because... methanol is cheap to make. We can make it taste good, and there is no tax on it..."

Methyl Alcohol Metabolizes Differently in Humans Compared to Other Animals

Food and drug companies decided to use methyl alcohol (wood alcohol) to make a variety of flavor extracts and other accoutrements that they'd previously used ethanol for. They also began using methyl alcohol for cough syrup. As Dr. Monte says, all hell broke loose after that. Starting around 1904, and for the next 40 years, doctors wrote extensive articles detailing the health problems suffered by their patients, including blindness and death, pleading with the food and drug industry to re-evaluate their products.

"Here is the story: there is a major biochemical problem here," Dr. Monte says. "Methyl alcohol is known now, and has been known since 1940, to be metabolized differently by humans from every other animal."

Both animals and humans have small structures called peroxisomes in each cell. There are a couple of hun-

dred in every cell of your body, which are designed to detoxify a variety of chemicals. Peroxisome contains catalase, which help detoxify methanol once it is to formaldehyde. Other chemicals in the peroxisome then convert the formaldehyde to formic acid, which is harmless, but this last step occurs only in animals.

When methanol enters the peroxisome of every animal except humans, it gets into that mechanism. Humans do have the same number of peroxisomes in comparable cells as animals, but human peroxisomes cannot convert the toxic formaldehyde into harmless formic acid.



"The methanol bounces off the catalase or bounces off something there," Dr. Monte says. "What happens then is every cell in your body cannot metabolize methanol. Wherein the animal body, every cell can metabolize and turn it to formic acid, which is safe.

What happens to the methyl alcohol?

That's the key. In humans, methyl alcohol could just as easily not be metabolized at all. That would be the ultimate and best outcome, and you could urinate it away or sweat it out and you would be fine. Unfortunately, there are some locations in the human body, particularly in the lining of the vessels of your body... especially in your brain that are loaded with alcohol dehydrogenase (ADH) that converts methanol to formaldehyde and there is no catalase present to enormous amounts of damage are created in the tissues."

Formaldehyde May Be a Significant Contributor to Chronic Disease

According to Dr. Monte, there are about 11 areas of the human body where you find alcohol dehydrogenase, which is capable of converting methanol into formaldehyde. He discusses the details of this in his book. Unfortunately, the areas where formaldehyde

tends to be created are some of the most sensitive areas in terms of creating serious, chronic disease, such as multiple sclerosis (MS), and Alzheimer's disease.

"If you look in the cell, you say, in what part of the cell is this happening? That's the key. That enzyme, the alcohol dehydrogenase, is not associated with any organelle that can handle formaldehyde. It's just floating around in the cell. That means that you can convert methanol into formaldehyde right next to your nucleus. You could do it next to the cell membrane. You could do it next to an important organelle. And when that happens, when methanol turns into formaldehyde, you have a methylating monster inside of your cell. It's very difficult, if not impossible, to get formaldehyde into the cell otherwise. When you breathe formaldehyde, it's so extremely reactive – it reacts with the tissue it first makes contact with. It's considered a carcinogen in that case."



This cellular methylation alters DNA functioning. It turns off the DNA by preventing it from producing protein. The damage from methylation is not necessarily permanent, but if not controlled, it will definitely have a negative impact. It could possibly be reversed, and ubiquinol and optimizing leptin and insulin signaling are likely very helpful for this as they upregulate repair processes. This becomes crucial if we ever hope to address the methylation damage which is a major concern in cancer and autism. Interestingly enough, tobacco smoke also causes methylation, similar to that of aspartame. Dr. Monte explains:

"Tobacco is fermented. When you ferment tobacco in the field, [it creates] spoilage bacteria that liberates the methanol from the pectin, which normally we couldn't liberate. That's what really makes the methanol content high. It's not just the smoking process itself, but

it's the way cigarettes are produced... Basically, the methanol produced by one pack of cigarettes would be equivalent to the methanol liberated from a liter of diet Coke."

How Can You Prevent Methanol from Turning into Formaldehyde?

Curiously, ethanol prevents methanol from turning into formaldehyde. If you look up methanol toxicity in the medical literature, you will find that most of it points to formic acid as the cause of the problems associated with methanol poisoning in humans. "The literature will also point to the fact that small amounts of methyl alcohol that are consumed, that are breathed in or consumed during the day, will all be processed by your liver. This is not true," Dr. Monte says.

"Scientists have shown that most people, not all the time, but most people have a little bit of ethanol in their bloodstream. If that's the case, then the small amount of ethanol that comes from aspartame or whatever will not be metabolized in the liver, because there is just that little bit of ethanol... So what happens is – and this is not good – the methanol gets through your liver completely... and gets into your circulatory system."

The methanol will continue to circulate through your body until there's no ethanol left in your body, and at that point, any alcohol dehydrogenase available will get converted to formaldehyde... According to Dr. Monte, this in part explains why small amounts of alcohol each day seem to have a protective effect against many diseases, including atherosclerosis and Alzheimer's.

Dr. Monte believes the major benefit of consuming alcohol that is widely known to lengthen lifespan, is related to it being safely excreted before methanol is converted to formaldehyde. A far safer and likely just as effective strategy however would be to optimize your gut flora as one of the byproducts of healthy gut flora is ethanol that could provide the same methanol sparing formaldehyde conversion benefit.

What about Methanol in Fruits and Veggies?

The manufacturers of aspartame counter the claims of methanol being a harmful aspect of aspartame by

pointing out that it also occurs naturally in fruits and vegetables. So why would it cause a problem in aspartame?

First, methyl alcohol, while present in significant quantities in plants and vegetables is typically safely bound to pectin and since we do not have any enzymes capable of breaking that bond, once the methanol in fresh vegetables or fruits is eaten, it is safely eliminated in the stool.

However the methyl alcohol can be liberated by putrefying bacteria that spoil fruits and vegetables and in fact methanol is an indication of spoilage in fruits and vegetables. Dr. Monte recommends cutting off all spoiled parts before eating your fruits and veggies. I believe most people avoid eating spoiled produce. If not, it would be a wise move. It's the putrefaction that liberates the methyl alcohol.

"If you have a good whole fruit and vegetable, unspoiled, fresh off the field, the amount of methyl alcohol in that is extremely low," he says. "There is methyl alcohol exuded by leaves and this sort of thing. It's part of their process of growing and all that. But the mechanism to get rid of it is there."



Remember when you consume methanol in soda, it easily breaks off from the phenylalanine in aspartame in your duodenum, and this is a major difference between consuming methanol in the form of aspartame versus getting it from fresh fruits and vegetables. Contrary to the bond between pectin and

methanol, which is very strong, the bond holding the methanol in aspartame is extremely weak.

"It's the weakest methyl ester [bond] I've ever seen," Dr. Monte says. "Chemically, it doesn't want to be there and it wants to liberate methanol. But pectin binds extremely tightly – the methanol that is bound to pectin gets through your digestive system and comes out with the fiber."

Processed Foods High in Methanol

Processed foods are another matter, however. When fruits and vegetables are canned, the methanol becomes liberated from the pectin. At room temperature, it only takes one month for 10 percent of the methanol to be released. After about six months, virtually all of the methanol is liberated. Dr. Monte is convinced that methanol and the subsequent conversion to formaldehyde from certain processed foods and foods containing aspartame is a major culprit in a variety of diseases, especially MS.

"Multiple sclerosis behaves sort of a like an autoimmune disease. How can methanol cause this? The formaldehyde is what causes it," he says.

Methyl alcohol can slip through your blood brain barrier, and your brain is one of the areas where you find alcohol dehydrogenase, which converts methyl alcohol to formaldehyde. This causes the destruction of myelin basic protein, which is one of the triggers for MS. *[There are other known causes of myelin destruction including vaccinations – Editor]*

"We know that methyl alcohol is known to be a demyelinating agent," Dr. Monte says. "We don't know why. In general, it's accepted as a demyelinating agent. You have the symptoms associated with the demyelination, and they're identical between multiple sclerosis and methanol poisoning, and people who consume aspartame."

Dr. Monte believes many diseases such as MS can be prevented if we start avoiding methanol, and he offers a methanol-free diet on his website.

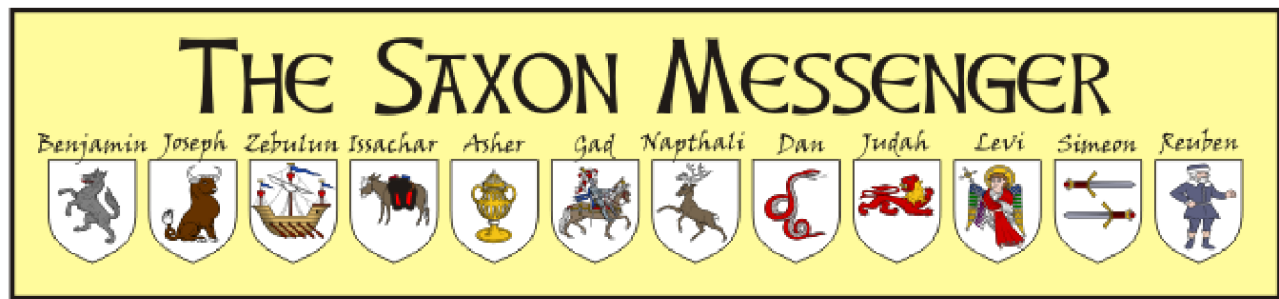
Christian Identity, also sometimes called Israel Identity, is the only true conservative Christianity. It is true because it seeks to maintain the understanding - in accordance with Scripture - that the New Covenant was made only with those same people with whom the Old Covenant was made: the House (family) of Israel and the House (family) of Judah. These Israelite people are traceable through time to the Keltic and Germanic tribes of today. None of these people are Jews. The Jews are descended from a mere remnant of the old Kingdom of Judah along with assorted Edomite and other Arab who were mixed into the Roman province of Judaea during the Hellenic period. There are - at last count - at least sixteen detailed essays on this website which demonstrate this, and which are replete with Biblical, archaeological and historical citations.

Christian Identity is the belief that the Covenants of God are real and consistent. It professes that the people of the Old Testament were every bit as much Christian as the people of the New Testament. They were simply looking forward to the first advent of the Christ, while we today await His Second Advent. As the famous Christian bishop Ignatius said nineteen hundred years ago, Christianity did not come from Judaism: rather, Judaism is a perversion of Christianity.

Christian Identity is the belief that there is no disparity between the Word of God, His Creation, His prophecy, and world history. It is also the understanding that while Scripture was inspired by God when it was transmitted, men have certainly mistreated it since that time, and so every passage and every doctrine must be fully investigated from all of the most ancient sources possible. As it reads in the King James Version: Study to show thyself approved.
