Anti-Christian Materialism *or Christian Socialism, Part Two*

Back in the 1980's someone, ostensibly some Jew, was selling bumper stickers that read “The man who dies with the most toys wins.” This statement seems to be one of the more popular new-age mantras of Western materialism. The luxury sedan, the second SUV, the third Xbox, the large flat-screen television in every room, the abundance of what the merchants call *consumer goods*: today the stock-piling of all of these things far beyond necessity gives the individual a false sense of value, and keeps oiled the gears of the artificially constructed global economy. With this, the international Jewish bankers are happy, although they are never satiated.

Once upon a time economies were centered around the extended family, or tribe. A man's sense of self-worth came from what he could contribute to his tribe, which was his community. By making extraordinary contributions to his community, a man advanced his own status and value. In time of need all men were builders, soldiers, hunters, herders or farmers. When a man did well, the community benefited, and when the community thrived the man did well. The community could not exist without a collection of noble men, and the man could not survive without the protection of the community. If left to himself, he may well starve to death, or be robbed and enslaved, or even destroyed by outsiders from other tribal communities. The man served the interests of the community, and the shelter provided by the community protected the man. The community was governed by the tribal elders, the patriarchy, and those who were most capable among them. This was all a part of the natural order recognized by our fathers – and our mothers - as they wandered the Eurasian steppe and the forests of the north.

As those tribes began to grow and prosper, the tasks of men became specialized. While in necessity every man remained a soldier, only some men were builders, others herders, yet other farmers. But the patriarchal family and tribe remained the primary components with which Western civilization was formed. Thus was the case in Rome and Athens as well as in Hamburg and London. Pride in one's heritage meant pride in the deeds of one's fathers, those men whose sacrifices benefited their communities so that those communities could build the great cities, principalities and nations which the tribal units had eventually become. That pride is true patriotism, an idea which cannot be authentically separated from patriarchy. Two men cannot be commonly patriotic, if they do not have common patriarchs.

In the natural order, with the specialization of labor within a community, a man's sense of worth still remained in the value of his service to his community, and when men did great things, the community as a whole benefited. Paul of Tarsus would ask, “If the whole body were an eye, where were the hearing?” However in an economic context speaking of the same community it may be asked, “If the whole body were engineers, who will grow grain for bread and cattle for meat?” If we do not transfer our Christian understanding to our everyday practices, then we are not good Christians. The man comes into being through the tribal community. The man is a creation of the community and is obligated to serve the community just as the hand or eye are a part of the body and are obligated to serve the body. If the hand or

eye offended the body, it would be cut off so that the body may live, and so it is also with the man. Thus is the essence of Christian Socialism, which is the fulfillment of the obligation of a Christian to his community, in concert with the community's obligation to protect its members.

Not all members of the body can be scientists, not all can be engineers. But scientists and engineers are raised up, nurtured, and receive their basic educations in the communities that shelter them. And a scientist or engineer cannot exist without the patriotic soldiers who defended both him and his ancestors that bore him. Neither can the engineer even do his engineering without the butcher, the baker and the farmer that feed him. The community organism is healthy only when it has all of its parts. When the soldier is a hero, the entire community shares the benefit of his heroism. Likewise, when the scientist or engineer makes some great new development, the community has a rightful expectation to share in the fruits of that development along with its inventor. In a sense, the development belongs to the entire community, since the community produced the man who made it, and the community sheltered that man and provided him with the opportunity to make it. Without such a principle, communities cannot thrive, but can only decay.

The Capitalist system takes the devices of men and sells them to the highest bidder, most often to be removed from the communities that made them, and frequently even to alien lands. For this reason, the once-great industrial communities of the West are in a state of decay at this very moment. The Capitalist moved their inventions and their factories to Japan, India, and China. Now people benefit from them who most probably never could have developed them on their own. The disease which has caused this is materialism.

Materialism is the religion of the new world order, a Jewish world order, and it has been promoted since the advent of Jewish Capitalism. However Christ told us that *the man who dies with the most toys loses* when He said that Christians should “Lay not up for yourselves treasures upon earth, where moth and rust doth corrupt, and where thieves break through and steal: but lay up for yourselves treasures in heaven, where neither moth nor rust doth corrupt, and where thieves do not break through nor steal: for where your treasure is, there will your heart be also. The light of the body is the eye: if therefore thine eye be single, thy whole body shall be full of light. But if thine eye be evil, thy whole body shall be full of darkness. If therefore the light that is in thee be darkness, how great is that darkness! No man can serve two masters: for either he will hate the one, and love the other; or else he will hold to the one, and despise the other. Ye cannot serve God and mammon(Matthew 6:19-24).”

Christians collect that treasure in heaven by demonstrating their love for their Christian kindred. The apostle John encapsulated the teachings of Christ when he said “Marvel not, my brethren, if the world hate you. We know that we have passed from death unto life, because we love the brethren. He that loveth not his brother abideth in death. Whosoever hateth his brother is a murderer: and ye know that no murderer hath eternal life abiding in him. Hereby perceive we the love of God, because he laid down his life for us: and we ought to lay down our lives for the brethren. But whoso hath this world's good, and seeth his brother have need, and shutteth up his bowels of compassion from him, how dwelleth the love of God in him? My little children, let us not love in word, neither in tongue; but in deed and in truth (1 John 3:13-18).” As Christ said, “If any man will come after me, let him deny himself, and take up his cross, and follow me.” He gave up His life on behalf of His brethren, and Christians should devote their lives to their kindred communities in turn. As He also told us, “Greater love hath no man than this, that a man lay down his life for his friends (John 15:13).”

The Capitalist system reduces man from the status of being a contributing member of a supportive community to a mere individual competing for material reward against other individuals in an incoherent cluster of dwellings which continues to exist only under compulsion by the force of the State, and which can hardly be called a community. Capitalism and its religion of materialism force man to compete with his neighbor for his rewards, and it no longer matters who his neighbor is since any individual can fulfill the roles of consumer and commodity laborer. Rather than loving one's brother, a man becomes the opponent of his brother because he labors for mere currency credits gained from within the community so that he may obtain material objects from outside of the community for his reward. The Christian body becomes a

collection of diseased egos working against one another. The end result is the eventual imposition of the Marxist system, which should be evident to anyone with eyes to see the world around them today. Marxism is the other side of the Capitalist coin, a coin which was minted by world Jewry.

The Marxist system, like Jewish Capitalism, reduces all men to mere consumers, and the labor of man becomes a commodity. Man himself is therefore reduced to the status of an object, and loses his value and his rightful place in the community. His sense of value which was once found in his contribution to his community is then compensated with the artificial value of temporal materialistic rewards. In order to maintain their control of society, the entire Christian body is ultimately reduced to the status of the foot, and only the Jews themselves are the hands, eyes and ears.

In modern capitalist churchianity, a materialistic religion sometimes called Prosperity Doctrine is being taught. Prosperity Doctrine is based upon materialism, self-righteousness egotism and helps to feed the Jewish global mercantile system. Prosperity Doctrine entices people to gamble, going into debt while they hope to be imminently rewarded for simply professing an empty belief in Jesus, while ignoring everything that Jesus actually said.

True national socialism, the essence of socialism as it was originally perceived, and as it was implemented by National Socialist Germany, is predicated upon service to one's community and love of one's brother, things which are purely Christian principles. Therefore true socialism is the practice of Christianity within the community, as witnessed in the opening chapters of the Book of Acts and in many other places in Scripture. True Christian Socialism is not Marxism. It is not the so-called "social doctrine" of the Marxist-infiltrated churches. Marxism is forced communism and collectivism. Marxism, like Capitalism, reduces men to mere economic units and the works of men to commodity status, with all things valued by the least common denominator.

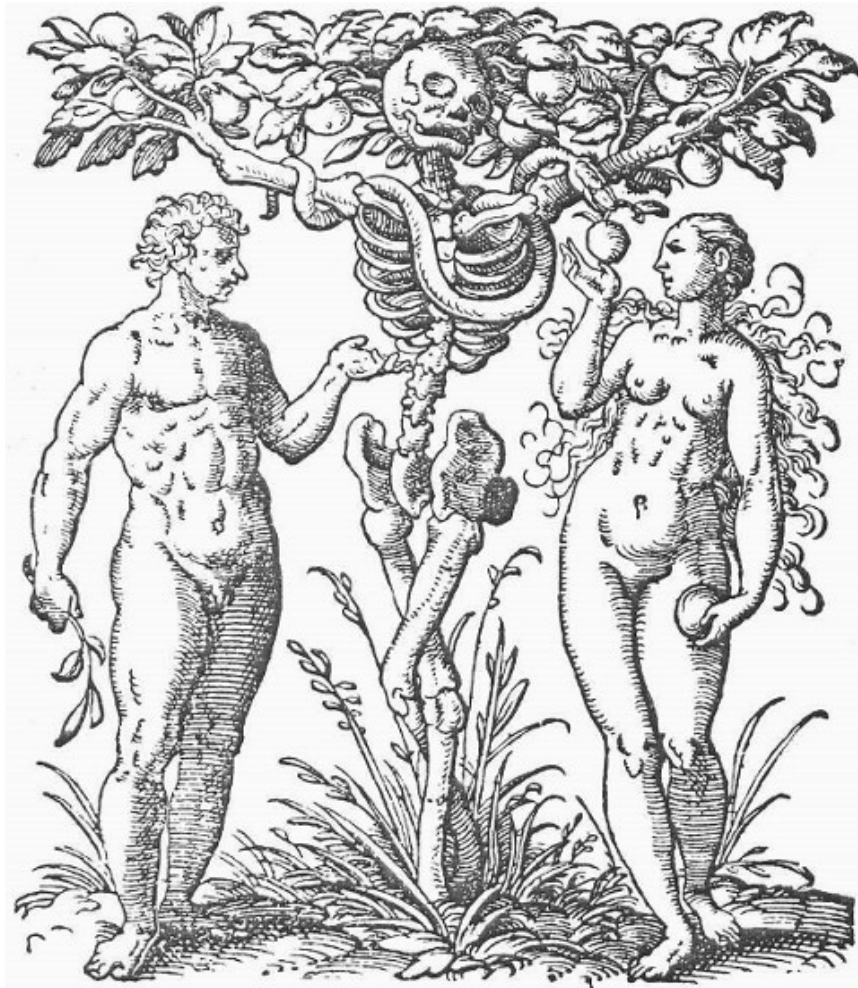
Christian Socialism is the antithesis of Marxism, where man cares not for himself but for his community, and the man thrives in concert with his community. The community has as much a stake as the man in the fruits of his labor and intellect. Only the State and those who control it can benefit in the Marxist system, because the man has no reward for the true value of his labor. The man cannot advance himself by better benefiting his community through his labor. Marxist ideas are destructive to any community which embraces them.

Capitalist ideas are equally destructive, and an economy based upon usury enslaves Christians and is anathema to godliness. Under Marxism, the State seizes the fruits of one's labor and intellect, and gives them to whomever it desires. Capitalism securitizes the intellectual property that should belong to the community which developed it, and sells it to the highest bidder, stripping the community of the fruits of its culture.

Just as well, the Capitalist system leads to the same ends as the Marxist system led Soviet Russia: under Jewish Capitalism as well as Jewish Communism, all Christians are fated to be the slaves of the Jews. National Socialist Germany understood all of this, implemented a Christian economy, and because of this it was demonized by World Jewry and destroyed by its willing Capitalist slaves.

The Revelation of Yahshua Christ

Chapter 18

W R Finck

XVIII After these things I saw another messenger descending from heaven having great authority, and the earth is illuminated from his effulgence

And he cried out with a mighty voice saying: “Babylon the great has fallen, has fallen! And it has become a dwelling-place for demons and a prison for every unclean spirit, and a cage for every unclean and hated bird, 3 because from of the wine of the passion of her fornication fell all the nations, and the kings of the earth fornicated with her, and the merchants of the earth are enriched from the power of her wantonness!”

While Babylon has not fallen yet, here it is pronounced as sure a declaration, by Yahweh who “calls things not existing as existing” (Romans 4:17). It is indeed fully evident, however, that the cities of the formerly White Christian nations have indeed “become a dwelling-place for demons and a prison for every unclean spirit, and a cage for every unclean and hated bird”. They are filled with jews, and with every sort of beast which has been admitted into those nations as the fruits of imperialism and international commerce. This is the fulfillment of Jeremiah chapter 31, where it says in verse:27. “Behold, the days come, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast”.

4 And I heard another voice from out of heaven, saying: “You come out from her, My people, that you should not partake in her errors, and that you would not receive from of her wounds, 5 because her errors have built up as far as heaven and



Yahweh has called to mind her injustices!

This may be interpreted several ways. It may be opined that the people of God cannot come out of the beast – cannot separate themselves entirely from this evil world system – until Babylon does fall.

Another way to interpret it, is that once sufficient of the people of God do separate themselves from the evil world system, it will fall. Yet we cannot expect the provenance of God to require the assistance of the hand of man. It is evident, that the current world system, the illusion of security in consumerism, humanism, and global mercantilism, will come crashing down upon those who worship the beast. Those people of God who do not worship the beast system, should attempt to separate themselves from it so that when it does crash, they do not suffer its punishments. That crash may be sudden, as verses 10, 17 and 19 seem to indicate, however “one hour” is not so definite a period in Greek as the English expression infers, and in prophecy it may describe a longer interval, months or even a couple of years, for which see Revelation 11:13, 14:7 and 17:12.

Even without fear of judgement, Christians should always seek to separate themselves from evil deeds and from wicked people anyway, and in every aspect of life, avoid getting caught up in the beast system. Paul warned at 2 Corinthians 6:14-18 thus: “14 Do not become yoked together with untrustworthy aliens; for what participation has justice and lawlessness? And what fellowship has light towards darkness? 15 And what accord has Christ with Beliar? Or what share the faithful with the faithless? 16 And what agreement has a temple of Yahweh with idols? For you are a temple of the living Yahweh; just as Yahweh has said, 'I will dwell among them, and I will walk about; and I will

be their God, and they will be my people.' 17 On which account 'Come out from the midst of them and be separated,' says the Prince, and 'do not be joined to the impure, and I will admit you'. 18 'And I will be to you for a father, and you will be mine for sons and daughters, says the almighty Prince.'" Verse 17 quotes Isaiah 52:11, which says "Depart ye, depart ye, go ye out from thence, touch no unclean *thing*; go ye out of the midst of her; be ye clean, that bear the vessels of the LORD." All of the translations I have seen add the word *thing* to the text in one way or another. Yet it is really saying only "touch not the unclean", and refers to people, not to inanimate object. The "vessels of Yahweh" are those children of Adam who bear the spirit which Yahweh breathed into Adam. The other and mixed races, and especially the Canaanite-Edomite jews, do not have this spirit.

6 You return to her as she also had rendered, and you double twice the things according to her works. In the cup which she had mixed, you mix double for her! 7 As much as she had magnified herself and lived wantonly, so much you give torment and grief to her! Because in her heart she says that 'I sit a queen and I am not a widow and I have not seen grief', 8 for this reason in one day shall her plagues come: death and grief and famine, and she shall be burned with fire, because mighty is Prince Yahweh who judges her!

The vengeance of the people of God shall be discussed in detail with Revelation chapter 19, which describes the Wedding Supper of the Lamb – which is the destruction of all of the enemies of God who are here on this earth. Here in reference to this, Micah chapter 4 will be quoted. When discussing Revelation chapter 12, it was posited here that the text of that chapter is not only a vision of the circumstances surrounding the coming of Christ, but that it was also a vision of the circumstances surrounding the creation of the United States. Micah chapter 4 was a large part of the evidence supporting that contention. The United States is the first and only nation ever founded as a Christian nation. Micah 4:13 states "Arise and thresh, O daughter of Zion: for I will make thine horn iron, and I will make thy hoofs brass: and thou shalt beat in

pieces many people: and I will consecrate their gain unto the LORD, and their substance unto the Lord of the whole earth." The children of Yahweh have yet to look forward to the fulfillment of these passages.

The exclamation by the woman, the whore sitting upon the beast, that "I sit a queen and I am not a widow and I have not seen grief", sounds exactly like the attitude being taught in the judaized sects of Christianity today, where the gospel of personal enrichment is preached. That is probably the best doctrine that could have been formulated for the benefit of the international commerce of the jew. It is also an absolute deception, contrary to all sound Christian teaching.

"9 And the kings of the earth who had fornicated and lived wantonly with her shall weep and shall mourn over her, when they see the smoke of her burning, standing from afar on account of the fear of her torment, saying 'Woe! Woe! The great city! Babylon the mighty city! For in one hour your judgment has come!'



"So He said to them: 'Wherever the body is, there also shall the eagles be gathered together.'" - Luke 17:37

Mystery Babylon, the international mercantile system of debt, credit, and free trade set up by the internationalist jew. The kings of the earth have compromised the stability of their own nations in order to commit fornication – or open their borders – so that the beast may thrive, hoping to enjoy the benefits of its false prosperity.

"11 And the merchants of the earth weep and lament over her, because no one buys their cargo any longer, 12 cargo of gold and of silver and of precious stone and of pearl and of linen and of cloths of purple and of silk and of scarlet, and every cedar timber and every ivory vessel and every vessel from of precious wood and of copper and of iron and of marble, 13 and cinnamon and incense and ointment and frankincense and wine and olive oil and flour and grain and herds and flocks, and of horses and of carriages and of

bodies, and souls of men.

“14 And your maturity of youth, that of the desire of the soul, has departed from you, and all the rich things and the lustrous things have vanished from you, and no longer shall these things be found!

A parallel can be found in ancient history. Ancient Tyre was a city of Israel, as both Josephus and the Septuagint manuscripts profess, and history proves, and it too was a great city of international commercial, complete with cosmopolitan attitudes and Canaanite merchants. Ezekiel chapter 27 is a lamentation for Tyre, and it begins “2 Now, thou son of man, take up a lamentation for Tyrus; 3 And say unto Tyrus, O thou that art situate at the entry of the sea, which art a merchant of the people for many isles, Thus saith the Lord GOD; O Tyrus, thou hast said, I am of perfect beauty. 4 Thy borders are in the midst of the seas, thy builders have perfected thy beauty.” The merchant traffic of Tyre was then described by Ezekiel at length, and the lamentation ends thus “34 In the time when thou

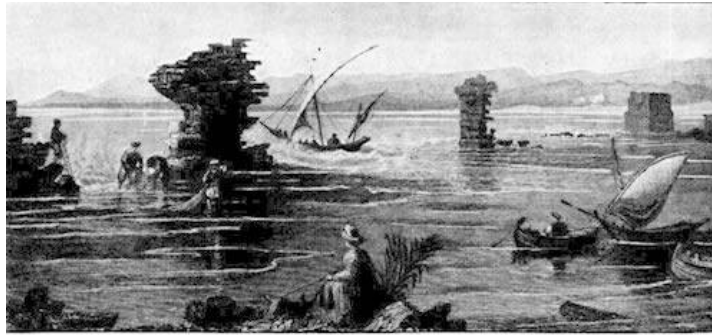
shalt be broken by the seas in the depths of the waters thy merchandise and all thy company in the midst of thee shall fall. 35 All the inhabitants of the isles shall be astonished at thee, and their kings shall be sore afraid, they shall be troubled in their countenance. 36 The merchants among the people shall hiss at thee; thou shalt be a terror, and never shalt be any more.” Ezekiel's words were of course fulfilled, however the children of Israel did not learn by the example.

“15 The merchants of these things who are enriched from her shall stand from afar on account of the fear of her torment weeping, and lamenting 16 they say ‘Woe! Woe! The great city, wrapped in linen and purple and scarlet and gilt with gold and with precious stone and with pearl, for in one hour such wealth is made desolate!’ 17 And every pilot and all who are sailing by the place, and sailors and as many as are working the sea stood from afar 18 and cried out, seeing the smoke of her burning, saying ‘What is like the great city?’ 19 And they cast dirt upon their heads and cried out weeping

and lamenting, saying ‘Woe! Woe! The great city! In which all those having ships in the sea have been enriched from her value! For in one hour she is made desolate!’

There is not much that can be added to make this picture any clearer than it is. Global commerce will come to an end. It has served only to enrich the enemies of Yahweh and to destroy His people. The articles of commerce are described in the terms of luxury available to John in his own time, but represent all of the goods of international trade today, even though of course now they are more modern, electronic goods and vehicles and all of the other modern amenities.

Just as the whore of Mystery Babylon said “I sit a queen and I am not a widow and I have not seen grief”, the King of Tyre is depicted where he is lamented in Ezekiel chapter 28 as saying “I am a God, I sit in the seat of God, in the midst of the seas”. All of the rewards of this world are vanity. Seeking after them is idolatry. The gain of great wealth here on earth first

convinces men to forsake God, and then tempts men to think that they are God. Yahshua Christ said to the wealthy young man who kept all of the commandments “Yet lackest thou one thing: sell all that thou hast, and distribute unto the poor, and thou shalt have treasure in heaven: and come, follow me” (Matt. 19:21, Mark 10:21, Luke 18:22).

“20 Rejoice over her, O heaven and saints and ambassadors and prophets, because Yahweh has passed the judgment of your condemnation of her!”

The people of God have already condemned international commerce in this modern version of the beast system. Now they await the moment of its destruction.

21 And the one mighty messenger took up a stone like a great millstone and cast it into the sea, saying: “Thus with violence Babylon the great city is cast down, and she shall not be found hereafter!

22 And the sound of lyristis and poets and flutists and trumpeters shall not be heard in you hereafter! And every craftsman of every craft shall not be found in you hereafter! And the sound of a mill shall not be heard in you hereafter! 23 And the light of a lamp shall not shine in you hereafter! And the voice of the bridegroom and a bride shall not be heard in you hereafter! Because your merchants were the great men of the earth! Because by your pharmaceuticals have all the nations been deceived!” 24 And in her is found the blood of the prophets and saints and all those

having been slaughtered upon the earth.

The jewish world of sorcery and multiculturalism and fornication and race-mixing and deviancy and godlessness and everything else which the beast system represents shall fail, and it shall all be destroyed, supplanted by the Kingdom of God. Exactly how or when this is going to happen, cannot be known beyond what the Scripture tells us, and the children of Israel are powerless to act out this judgement by themselves. Vengeance belongs to God, as is evident here in verse 20, that “Yahweh has passed the judgment of your condemnation of her”.

The Jewish doctrine of Marxism repudiates the aristocratic principle of Nature and substitutes for it the eternal privilege of force and energy, numerical mass and its dead weight. Thus it denies the individual worth of the human personality, impugns the teaching that nationhood and race have a primary significance, and by doing this it takes away the very foundations of human existence and human civilization. Special Notice to All Who Deny Two-Seedline More to Jeremiah 24 than Ted Weiland Claims

Because many incorrectly interpret Genesis 3:15 to mean a personal private war between one's spirit and one's flesh, I make it clear that the "enmity" spoken of in the passage is a "hate" WAR to the death between two different walking, talking, breathing genetic family seedlines; and that

"hate" was placed there by the Almighty Himself! Since the anti-seedliners willfully and arrogantly refuse to identify our enemy, they categorize themselves with those who "serve HIM not." Their message is an invitation for disaster. Genesis 3:15 says "I will put", and our Maker never put "enmity" between our spirit and our flesh. Before making such an assertion, they should stop and think what they are accusing HIM of, for that makes HIM responsible for every sin man has committed and continues to commit. Furthermore, if the enemy can get us all wrapped up in ourselves, and convince us that the only war we are fighting is a "spiritual war" between the spirit and the flesh, we won't be of any use to the Almighty or to ourselves.

With this paper we will expand on *Special Notice #16*, where Ted R. Weiland foolishly tried to make it appear that the only difference between the "wheat and tares" of Matthew 13 were "righteous Israelites" and "wicked Israelites", remarking in his *Eve, Did She Or Didn't She?*, page 72: "Instead, this parable [of the wheat and the tares] is simply contrasting righteous Israelites with wicked Israelites, much the same as the good and evil figs of Jeremiah 24." It is evident that Weiland hasn't the slightest clue why Zedekiah and company were listed among the "naughty figs."

We noted there were two factions at Jerusalem: one

favoring diplomacy with Babylon; the other with Egypt, the house of Zedekiah advocating the latter. After Nebuchadnezzar captured Zedekiah, killing all his sons and gouging out his eyes, the remainder of that group forced Jeremiah, against his warning, to accompany them to Egypt. Upon Jeremiah sailing to Ireland with Tea Tephi, they fell under the judgment of the sword, famine & pestilence.

Had Weiland read and studied Jeremiah 24:8-9 thoroughly, he might have grasped the prophet's true message regarding the "evil figs", which says: **"8 And as the evil figs, which cannot be eaten, they are so evil; surely thus saith Yahweh, So will I give Zedekiah the king of Judah, and his princes, and the residue of Jerusalem, that remain in the land, and them that dwell in the land of Egypt. 9 And I will deliver them to be removed into all the kingdoms of the earth for their hurt, to be a reproach and a proverb, a taunt and a curse, in all places wither I shall drive them."**

In analyzing this passage, we see Jeremiah's prophecy was directed at four categories: (1) Zedekiah and some of his household, (2) His "princes" (better rendered "rulers") under him, (3) The residue of Jerusalem, which included Hittites and Amorites, (Ezek. 16:3-4) who had "confusion of face" (Ezra 9:1,7) and were referred to as "wild grapes" (Isa. 5:2), and (4) Them that dwell in Egypt. Weiland and his *anti-seedline, antichrist, fellow travelers* refuse to address these four categories in their proper context. Zedekiah was 32 years old when Nebuchadnezzar killed all his sons and gouged out his eyes, leaving him only daughters (the tender twigs of Ezek. 17:22). Other than Tea Tephi and her sister, we are not told how many. The "princes" were simply the political and religious leaders under Zedekiah, not necessarily royal family members. After the campaigns of 605 and 597 B.C. by Nebuchadnezzar, and removal of the royal family of Jehoiachin along with 7,000 soldiers of Judah and their best craftsmen, only the poorest quality of people

remained in Jerusalem; among them many non-Israelites. Such was the “residue of Jerusalem, 2 Kings 24.”

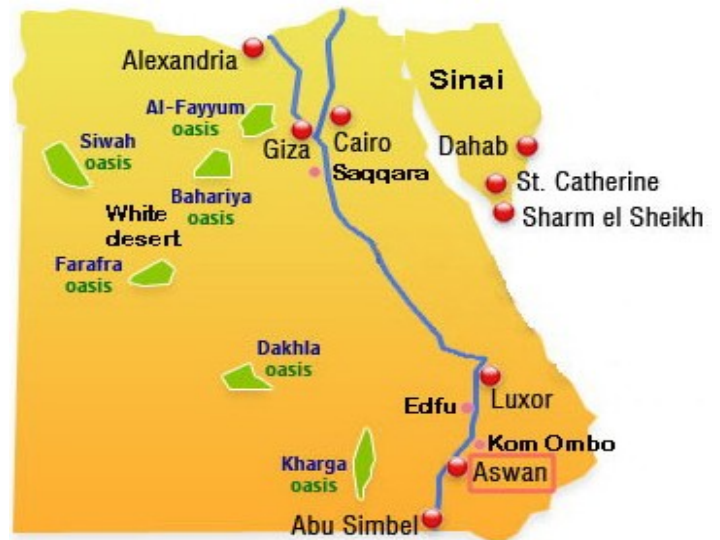
Additionally, after Jerusalem was depleted of most of its population, nearby peoples moved into their empty homes as a refuge from Babylon thinking it safe after Zedekiah was appointed king by Nebuchadnezzar. Even during the kingship of Jehoiakim, after Nebuchadnezzar’s first campaign of 605 B.C., there were the Rechabites of Jeremiah 35:11, who moved into Jerusalem; descendants of the Kenites of 1 Chr. 2:55 and Gen. 15:19, or “Cain’s bloodline.” In Joshua 15:63; Judges 1:19 and 2:2-3 we are told that Judah would not drive out the “inhabitants of the land” (Jebusites and others), and these would remain as thorns and snares among them. Surely, they must have been part of the “residue” making up the “evil figs.” Then, we must remember the descendants of Shelah, the son of Judah by Shuah, the Canaanite. In addition, we must recall Solomon’s affairs with non-Israelite wives, 1 Kings 11:1-9. Undoubtedly he had descendants by those wives living in Jerusalem during Jeremiah’s time (Neh. 13:26). The idolatry which manifested itself under all of Judah’s evil kings originated with Solomon’s wives. Therefore, to believe that Jerusalem, as the Weilandites proclaim, was made up of only pure blooded Israelites (“righteous” and “wicked”) is only a childlike, fairyland pipe-dream on the level of Alice in Wonderland or the Wizard of Oz. The fourth category classified as “evil figs” (Jer. 24:8) included “them that dwell in Egypt.”

[Note that while Clifton does very well in the passages which follow, the commentaries which he cites rather consistently confuse Jews with Judaeans and Judahites. Concerning the colony at Elephantine first established in the Persian period, the word Judahites is more fitting than Jews, since the Jews of today are only partially, and marginally, descended from those tribes of Judah, Benjamin and Levi which made up the original kingdom. Elephantine was never a Jewish colony, in the sense in which the word is used today. Rather, it was originally an Judahite colony. Concerning the people of Judaea around and after the time of Christ and since the middle of the 2nd century BC, the Edomites and Canaanites had already been

fully subsumed into the citizenry, and therefore the word Judaeans is more fitting than Jews because it may describe either a pure Israelite of Judah, Benjamin or Levi. or any one of those Canaanite tribes absorbed into Judaeans polity during this period. Please bear these differences in mind while reading the material which Clifton is quoting. - William Finck]

TWO ELEMENTS IN JEREMIAH’S PROPHECY

While both Jeremiah 24:8-10 & 44:7, 12, 14, 26-30 seem to indicate that all the “evil figs” would die by the “sword”, “famine” and “pestilence” at that time; on the other hand, both passages contain a clause that the “evil figs” would be driven into all the “nations” and “kingdoms” of the earth as a “proverb”, “taunt” and a “curse” (Jer. 24:9; 34:17; 44:8). Therefore, it is evident these prophecies have both short and long-term fulfillment’s. *Matthew Henry’s Commentary*, volume 4, pages 564-565 comments on Jer. 24:9-10 thus: “Doubtless this prophecy had its accomplishment in the men of that *generation*; yet, because we read not of any such remarkable difference between those of Jeconiah’s captivity and those of Zedekiah’s, it is probable that this has a typical reference to the last destruction of the Jews by the Romans, in which those of them that believed were taken care of, but those that continued obstinate in unbelief were driven into all countries for *a taunt and a curse*, and so they remain to this day.” Rather, it was sifting-out of the racially impure.

THE “EVIL FIGS” OF EGYPT

When first researching this topic, I was convinced that the party that forced Jeremiah to accompany them to Tahpanhes, Egypt were those who eventually arrived and established a “Jewish” colony at Elephantine in Egypt. I no longer hold that opinion. Some Bible references such as the *Pictorial Bible Dictionary*, published by the Southwestern Company in 1966, on page 239, also holds that position. Rather, it was mainly the “Jews” who “returned from all nations” to Jerusalem and attempting to go to Egypt, who worshipped the “queen of heaven”, who fell under the curse of the sword, famine and pestilence. *The Penguin Pictorial Historical Atlas Of Ancient Egypt* says this on page 120, under the topic “The Saite Monarchy”: “... There is evidence of Greek commercial activity at Naukratis as early as c. 615 BC and during the reign of Amasis (570-526 BC) it was officially instated as the centre of Graeco-Egyptian trade (partly, of course, to keep within direct royal control). Other Greek communities settled at Memphis and elsewhere, alongside immigrant Phoenicians and Jews.” In his *The Bible Is History*, page 168, Ian Wilson places some of the “Jewish” immigrants in Egypt contemporary with Judah’s evil king Manasseh. I will now present various documentation for this period:

From the *EERDMANS Dictionary Of The Bible* (2000), page 391, we get the following: “**ELEPHANTINE ... PAPYRI**, A large number of papyrus documents and fragments, written in Aramaic during the 5th century B.C.E., discovered at Elephantine, an island in the Nile River opposite Aswan (biblical Syene) which became an asylum for Judean refugees after the Babylonian conquest of Jerusalem (cf. Jer. 43-44).”

From the *Tyndale Bible Dictionary* by Elwell and Comfort (2001), under the same topic, pages 419-420: “**ELEPHANTINE PAPYRI**, Aramaic documents from the fifth century BC discovered at Elephantine, an island in the Nile River. At the time of the documents’ writing, Elephantine was a Persian military outpost, manned in part by a group of Jewish mercenaries with their families. The documents numbering over 100, belong primarily to three archives — two familial and one communal. The

archives contained many complete scrolls that were still tied and sealed at the time of their discovery, along with numerous broken papyri and fragments.

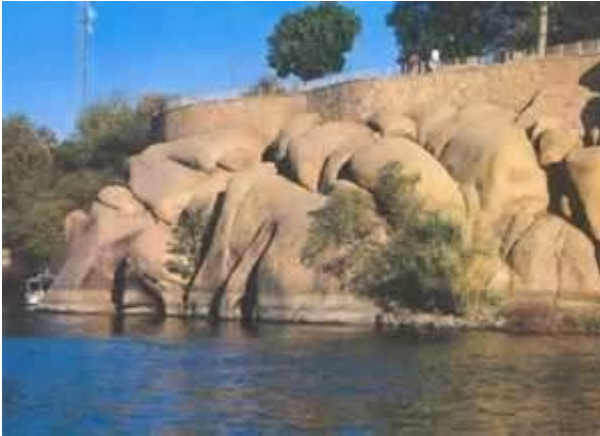
“The manuscripts are of considerable archaeological importance. Several centuries older than most of the Dead Sea Scrolls, they portray the social, political, and religious life of a Jewish community outside Palestine. Several points of contact are made with the books of Ezra and Nehemiah ...

“**Ancient Elephantine**, Elephantine was located on the southern tip of a small island in the Nile River a few kilometers north of the first cataract, opposite its twin city, ancient Syene (modern Aswan). The Bible probably includes the twin cities of Elephantine and Syene in two occurrences of the phrase ‘from Migdol to Syene’ (Ezek. 29:10; 30:6 [RSV]), that is, from Egypt’s northern border to its southern border. The city’s name was an Aramaic version of an Egyptian name meaning ‘city of ivories’ and was translated into Greek as *Elephantine*. Because of its strategic importance on Egypt’s southern boundary with **Nubia** ... and figured repeatedly in Egypt’s military history ...

“**Discovery of the Papyri** Elephantine came into archaeological prominence with the discoveries of the papyri. The discoveries were made in three stages. The first group to be published (in 1906) had been gathered by purchases from antiquities dealers and was housed in the Cairo Museum. That first publication stimulated German and French excavations at Elephantine in the hope of discovering more papyri. The Berlin Museum was rewarded for its efforts with a second group of papyri, published in 1911. Ironically, a group of papyri discovered in the late 19th century was the last to be studied and published. American scholar C. E. Wilbour purchased papyri in 1893 from some Arab woman at Aswan. In storage until Wilbour’s daughter bequeathed them to the Brooklyn Museum, they were finally published in 1953. Since 1912, other excavations have been mounted by the pontifical Biblical Institute of Rome and the Egyptian government, but no further papyri were found ... [or so they say]

“**Jewish Colony** ... The Elephantine Jews worshipped in their own temple, which was dedicated to the Hebrew God, whom they called Yahu (a variation of

Yahweh). Political and religious leaders at Elephantine were in correspondence with officials in Jerusalem and Samaria.



“... One document from Elephantine claims that the Jewish temple there was built during a period of native Egyptian rule before the Persian conquest under Cambyses (reigned 529-522 BC). That would give a date for the construction of the Elephantine temple by the mid-sixth century at the latest.

“Elephantine Judaism In spite of the law of a single sanctuary (Dt. 12:1-11), and in spite of the recent reforms of kings Hezekiah and Josiah in the seventh and eighth centuries BC that centralized worship in Jerusalem, the Elephantine Jews seem to have felt no wrong in having a temple in Egypt. Neither the German, French, Italian, nor Egyptian excavations located the Jewish temple, but the documents record that the temple was oriented toward Jerusalem.

“The Elephantine Jews may have recognized Jerusalem’s primacy in religious affairs. When the temple at Elephantine was destroyed by priests of the Hahnium temple in 410 BC, an appeal was sent to Johanan the high priest (cf. Neh 12:22; 13:28) and Bagoas the governor of Judah, seeking their permission and influence for its restoration. The appeal produced no response, perhaps because of the Jerusalem leadership’s disapproval of the temple in Egypt. A second appeal, sent years later to Bagoas, governor of Judah, and to Delaiah and Shelemiah, sons of Sanballat, governor of Samaria, produced an oral reply, recorded in a memorandum. The reply ordered the temple’s rebuilding and the resumption of meal and incense offerings. Permission to reinstitute the burnt offering, however, was not given, perhaps as

a concession to Egyptian or Persian religious convictions. A deed for a piece of property, dated 402 BC, mentions the temple of Yahu, implying that it was in fact rebuilt ...

“Moreover, intermarriage with surrounding peoples, forbidden in the OT because it would lead to religious apostasy (Ex 34:11-16; Dt 7:1-5), **had become a common practice at Elephantine.** It was a contemporary problem in Israel as well under Ezra and Nehemiah (Ezr 9:1-10:44; Neh 13:23-28). **Children of mixed marriages in Elephantine** often had Egyptian names ...” *[emphasis mine]*

If you read this very carefully, you will notice that Elephantine was located near Nubia, an area inhabited by many blacks. Therefore, we should not be surprised that many blacks today are claiming they are “Jews.” In view of this, let’s return to Weiland’s statement about the “bad figs”: “Instead, this parable [of the wheat and the tares] is simply contrasting righteous Israelites with wicked Israelites, much the same as the good and evil figs of Jeremiah 24.” So much for his credibility!

Another witness to this is the *Collier’s Encyclopedia* (1980), volume 13, page 575, under the topic “The Early Jews”: “... Documents discovered at Elephantine in Upper Egypt have revealed the existence here in the fifth century B.C. of a military colony of **half-assimilated** Jews in the Persian service, with their own temple, looking, however, to the authorities in Palestine for guidance.” *[emphasis mine]*

The events which happened in the time of Ezra, Nehemiah and at Elephantine are good examples of what happens under the influence of such false teachers. As I have pointed out before, the anti-seedliners like Weiland and company are contributing as much toward multiculturalism as the “Jews.” Substituting their kind of “spiritual hocus-pocus” for racial discipline opens the door to all kinds of miscegenation. One shouldn’t be surprised, then, by supporting the teachings of the anti-seedliners, if he ends up with a half-breed offspring. The bottom line is, the anti-seedliners are trying, wittingly or unwittingly, to lead the rest of us down the path of race-mixing similar to that of Elephantine in Egypt.

As the residue of Jerusalem was made up partly from the ten Canaanite nations (later designated seven), we really need to go back and review Genesis 15:19-21 again: “**19 The Kenites, and the Kenizzites, and the Kadmonites, 20 And the Hittites, and the Perizzites, and the Rephaim, 21 And the Amorites, and the Canaanites, and the Girgashites, and the Jebusites.**”

In Genesis 15:19-21 are listed ten nations who then race-mixed so much that in Deuteronomy 7:1-2 there were left only seven. The Kenites, Kenizzites and Rephaim were completely absorbed by the other nations of this group from which the “Jews” are extracted. The Adam Clarke’s *Commentary on the Bible*, abridged by Ralph Earle, page 38, has this to say: “**The Kenites.** Here are ten nations mentioned, though afterwards reckoned but seven; see Deut. vii. 1; Acts xiii. 19. Probably some of them which existed in Abram’s time had been **blended** with others before the time of Moses, so that seven only out of the ten then remained ...”

In the Peake’s *Commentary on the Bible*, page 116 we find this about that mixed group of nations spoken of in Genesis 15:19-21: “When the Israelites entered Canaan they found there a **very mixed** population generally designated by the term Amorite or Canaanite.”

We can see from this that the line of Cain was assimilated into all those peoples. Therefore, when any one of the ten (later designated as seven) nations are mentioned, it automatically includes the line of Cain, as in Acts 13:19. Although continuing to be designated as seven nations, as the race-mixing persisted, many more were added to the list, such as the “Egyptians” at Ezra 9:1.

AN ODD TWIST TO THE STORY

A most unusual aspect to this story is the fact that the modern-day “Jews”, for the most part, were not aware of the Elephantine connection until the beginning of the 20th Century. This can be seen in the seven volume set of books the, *History Of The Jews*, by Heinrich Graetz. The set I have was copyrighted in the year 1898. The first six volumes are the original set of history books. They then added a seventh volume to bring their history up-to-date; copyrighted 1944. In the

index for the first six volumes, no mention is made of the black Falasha Jews of Ethiopia. In the additional volume entitled *A Century Of Jewish Life*, (an update by Ismar Elbogen) pages 419-420, it says the following:

“Joseph Halévi (1827-1917), the well-known Parisian Semitist, had been sent to Abyssinia by the *Alliance Israélite Universelle* in 1868 to study the Falashas. He brought important personal impressions from his travels, but he lost his materials in consequence of the Franco-German War. The contact which had been made was not followed up. The Falashas had for centuries manfully resisted the attempt of Christian missionaries to convert them, and their courage was now strengthened by contact with Jews. The reports of missionaries that there was a community of Jews who believed in Christ was proven false. Halévi never gave up hope for renewed contact, and his pupil, Jacques Faitlovitch, undertook an expedition to the Falashas equipped by Baron Edmond de Rothschild (1904). His report of the loyalty and persistence of the Falashas in their faith was stirring and called for immediate attention to the problem. But the *Alliance* refused its help. It was Margulies who then aroused the interest of the Jews of Italy and Germany, and later those of the United States to undertake missionary work among the Falashas. Young Falashas were educated in Europe, became teachers in the model schools founded with the assistance of the Italian government in Addis Ababa (Abyssinia), and were enabled to send teachers educated there into the interior of the country.”
Question: Why don’t the anti-seedliners present evidence like this last quotation? The reason is, they are too busy debating their own personal twisted form of Jew-deo-unchristian theology.

Because information concerning the Falasha “Jews” has only come forth within the last century, data concerning them is rather hard to come by. In his book *A History Of The Jews* by Abram Leon Sachar, we find this on page 250: “... The black Falashas of Abyssinia were another ancient community, historically allied to the Jews, living by pure Mosaism. They were proud of their supposed descent from Menelek, son of the Queen of Sheba by King Solomon.” The Falashas couldn’t have been practicing

pure Mosaism, for Moses wouldn't have allowed a negroid mamzer into the congregation!

In her book, *The Story Of The Jew*, Elma Ehrlich Levinger (1936) makes the following comment about the Falasha Jews under the heading, "The Wandering Jew" on page 13: "In Abyssinia you would meet the Falashas, black Jews who have almost forgotten their Judaism, who in every way but a few

religious rites resemble the dark-skinned, thick-lipped natives among whom they have lived so long." I would complement Elma Ehrlich Levinger on her first chapter heading title, as "The Wandering Jew" fits Cain's descendants perfectly!

Abba Eban, in his book, and also in a television series, *Heritage, Civilization and the Jews* (1984), all but admitted that the modern-day "Jews" are not Israelites; but then, falsely, claimed lineage to "father Abraham"! At the time Abba Eban was writing his book, many of the Jews were not sympathetic with allowing the Falasha Jews into their ranks. Since then, however, they have recognized them and have allowed them to immigrate into Palestine as full-fledged "Jews."

Another enlightening book discussing the papyri found at Elephantine is the *Dictionary Of New Testament Background* by Craig A. Evans & Stanley E. Porter, pages 283 and 574: "... At the time of the Babylonian conquest some Jews fled to Egypt (Jer 43:6-7; 44:1; 46:14); Aramaic papyri of the fifth century B.C. give evidence of a Jewish military colony at Elephantine, a colony that included a Jewish temple."

Also page 574, under "Jewish History: Persian Period ... Extrabiblical Sources": "The extrabiblical sources include the papyri left by a Jewish colony in

Egypt at Elephantine. This provides valuable original material, especially in the way of legal documents and references to the colony itself, but little of it throws direct light on events in Palestine ... A number of coins were issued in Judah itself and mention the name of the province (Yehud); a few mention Hezekiah the governor, and there is one with the name of Johanan the priest.

"The Jewish military colony lived on the island of Elephantine in southern Egypt. It may have been founded before the fall of Jerusalem in 587 B.C., though its origins are obscure. They worshipped Yahweh but did so in their own local temple. When this was destroyed as a conspiracy of the priesthood of the local Egyptian cult, they wrote to the governor asking permission to rebuild it. They also wrote to 'the high priest and his companions the priests who are in Jerusalem and to Ostan the brother of Anan and the nobles of the Jews' and 'to Delaiah and Shemaiah sons of Sanballat governor of Samaria' (Porten and Yardeni 68-71). Their letter indicates that the high priest, the other priests and the Jerusalem nobility were in charge of the community even though a Persian governor had also been appointed over the province. It also shows, in contrast to the book of Nehemiah, that Sanballat was an important official in the Persian local government. Interestingly, the Jerusalem establishment did not reply, perhaps because they were opposed to the Elephantine temple. The only record of an answer is a memorandum jointly from Bagohi and Delaiah, permitting the temple to be rebuilt and resume some offerings but not those of blood sacrifice (Porten and Yardeni, 76-77)."

Ian Wilson's *The Bible Is History*, published in 1999, makes the following observations concerning the Elephantine papyri (and I agree to some extent), pages 168-169: "... They came to Egypt to help Pharaoh Psammetichus I (664-610) fight the Nubians to the south ... This far-flung Hebrew colony was not only Yahwist (suggesting that it may have offered its services to Psammetichus quite independently of Manasseh), but also built its own temple of Yahweh on the island. There can be no doubt about this since one of the papyri datable to 407 BC and preserved today in Berlin's State Museum, specifically complains of the very recent destruction of 'the temple

of Yahweh the god which is in Elephantine.’ Furthermore, today’s leading Jewish papyrologist, Bezalel Porten, collating the papyri’s various references to this edifice, has determined that this temple had a cedar roof just like its Jerusalem counterpart, that it matched its dimensions very closely and was oriented to Jerusalem ... this ... ancient community of Jews subsequently journeyed to and settled in Ethiopia, as the Falashas ...”

An informative source running 13 pages on Elephantine is *The Bible And Archaeology* by J. A. Thompson. On page 224 the English translation of the

Elephantine papyri says: “Our fathers built this temple in the fortress of Elephantine, back in the days of the kingdom of Egypt, and when Cambyses came to Egypt he found it built ...” Evidently, the temple at Elephantine must have been built somewhere between 590 and 525 B.C. I’m also persuaded that the Almighty stirred up Cyrus, king of Persia, to proclaim only the rebuilding of the Temple at Jerusalem, not Elephantine, 2 Chr. 36:22; Ezra 1:1, (making those at Elephantine “evil figs”). The object of this presentation is to demonstrate there is more to Jeremiah 24 than what Ted. R. Weiland claims.

“[Tintin in the Congo](#)” – a classic 1920s comic strip about Belgium’s celebrated fictional boy reporter – is not racist, a Brussels court ruled on Wednesday.

The Brussels Appeals Court upheld a 2011 ruling against Congolese immigrant Bienvenu Mbutu Mondondo and the Belgian Council of Black Associations, who wanted the book banned.

In 2010 Mbutu, who lives in Belgium, Congo’s former colonial ruler, said Tintin employed a little black helper who was seen as “stupid and without qualities”.

“It makes people think that blacks have not evolved,” he said.

In one scene, a black woman prostrates herself before Tintin, saying: “White man very great. White mister is

behaviour.”

Not so, said Brussels judges, for whom “Tintin in the Congo” is full of “gentle and candid humour”.

The cartoon strip, written in the late 1920s, was Belgian writer Hergé’s second Tintin adventure. It was followed by stories in which the author tried to add greater realism and historical accuracy.

Hergé himself recognised that “Tintin in the Congo” was a “youthful sin” that reflected the prejudices of the time.

In 2007 a British court ruled that “Tintin in the Congo” should be sold with a warning that it includes racist content.

Mbutu has also tried to have the cartoon banned in France, unsuccessfully.

THE ENEMY AT THE GATE

Many excellent books contain similar conclusive evidence of the true nature of Communism, but the purposes of this particular book is to simply and adequately describe the background to world events at the time in relation to the rise and fall of the Third Reich.

In April, 1937, Mr. RA. Butler, the Parliamentary Under-Secretary, India Office, reported in the House of Commons that free tuition was available for Indian students returned to India as Bolshevik recruiters and agitators against Britain.

HITLER'S RESISTANCE TO BOLSHEVISM:

(Condensed from the Fuhrer's closing speech, Nuremberg Congress of Honour).

"We do not deny the grave concern which we feel at the thought of other nations becoming a victim of Bolshevism towards which we are deadly antagonistic.

"This deadly enmity of ours is not based on an obstinate refusal to recognise any ideas that may be contrary to ours. But this enmity is based on a natural feeling of revulsion towards a diabolical doctrine that threatens the world at large and us.

"The first phase in the fight of National Socialism against Communism did not take place in Russia. Soviet Communism already tried to poison Germany between the years 1918 and 1920, and its methods of penetration into this country was much the same as its present-day military efforts in moving the Bolshevik military machine closer and closer to our frontiers.

"We have stamped out Bolshevism which Moscow's bloodfiends such as Lewin, Axelroth, Neumann, Bela-Kuhn, etc. tried to introduce into Germany. And it is because we see day by day these efforts of Soviet rulers to meddle in our domestic affairs have not yet ceased, that we are forced to regard Bolshevism beyond our frontiers as our deadly enemy.

"We have fought Bolshevism in Germany as a Weltanschauung that is, as a form of philosophy that endeavoured to poison and destroy our people. And Bolshevism will continue to be fought if it attempts to introduce its sordid Spanish methods into Germany.

"It is not the aim of Bolshevism to free nations from their ailments. Its object is to exterminate all that is healthy and replace the same by depravity and degenerate elements. . .

". . . we do not want a situation here in Germany, as in Russia, in which 98% of official key positions are held by alien Jews. Under no circumstances do we want our national intelligence debased.

"... Communism however cannot deny that in Russia today 98% of all official positions are held by Jews who not only can never be classed as members of the proletariat, but who have never earned an honest penny in their lives.

"... we have fought Bolshevism because its leaders had planned for us a slaughter house on Russian and Spanish lines. Such is the difference between the Bolshevik and the National Socialist revolutions. The one transforms prosperous and peaceful countries into a waste of ruin and devastation, whilst the other, re-builds a broken-down and poverty stricken Reich into an economically sound and prosperous state."

"We believe that it is a bigger task to put 5 million people back to work than to burn down houses and churches and allow hundreds of thousands of workers and peasants and others to kill each other. We have also fought Bolshevism on general economic grounds. From time to time the world hears of hunger famines in Russia. Since, 1917, that is, since the victory of Bolshevism, there is no end to this form of distress,

"This self-same Russia, starving for close on 20 years, was one of the richest grain countries in the world.

"When compared with Germany, Russia possesses 18 times more land per head of population, and yet what a sorry form of economic policy this country must have to deny its people a decent form of livelihood. If Bolshevism in Russia, however, does not succeed in getting nine farmers to produce sufficient to at least support one non-farmer what then would have

happened in Germany, where two and a half farmers produce sufficient to support seven and a half non-farmers? What would have happened to Germany and the whole of its economic structure if Jewish-Bolshevik economic malpractice had ever been allowed to take root here?

"We have fought Bolshevism because a victory for it in Germany would have spelt starvation for perhaps 50% of our population. If Russia is incapable of supporting not even eight people per square kilometre, then in Germany under Bolshevik rule, not even ten millions would have had the necessary minimum standard of living. For here in Germany our 68 million people occupy the same area which in Russia would not support more than 5 million.

"Bolshevism preaches world revolution, and it would use the German workers as cannon fodder for the attainment of its goal. We National Socialists, however, do not want our military forces to be used for forcing upon other nations something that they do not want. Our Army does not swear an oath that it will carry our National Socialist ideology to other nations.

"British politicians in England have so far not had the opportunity of learning what Communism in one's own country stands for. But we have. As I am the one who has fought against this Judeo-Soviet teaching in Germany and stamped it out, I flatter myself that I possess more understanding of the true character of Bolshevism than those arm-chair critics who at most have read up on the subject a little. Today, I follow the spread of Bolshevik poison throughout the world just as assiduously as I followed its poisonous trail years ago in Germany, and never lost an opportunity of warning the country.

"The abhorrent mass-murders of nationalists, the burning alive of wives of nationalist officers after soaking them in petrol ~ the revolting murder of children of nationalist parents as for example in Spain, should serve as a warning to help to break down resistance on other countries. . ."

"If my international opponents reproach me today that I have refused this co-operation with Russia, I make the following declaration: I do not and did not reject co-operation with Russia but with Bolshevism, which lays claim to world rulership.

"The German nation has not only wept but has laughed heartily throughout its life and I will not see it descend into the gloom of international communism and the dictatorship of hate. I tremble for Europe at the very thought of what would happen to our old and over-populated continent if this Asiatic concept of the world, which is destructive of all our ideals, should be successful in bringing upon us the chaos of the Bolshevik revolution." ~ Adolf Hitler, March, 7th, 1936

In Their Own Words: Soviet Russia Oppressed Christianity and Permitted Judaism

The four pictures here were provided by a friend who recently visited the Ukraine. Because the trip was not planned for tourism, some of the pictures are not the best quality since they were only taken with a cellphone, however they are clearly readable. The original high-resolution images are available at mk.christogenea.org

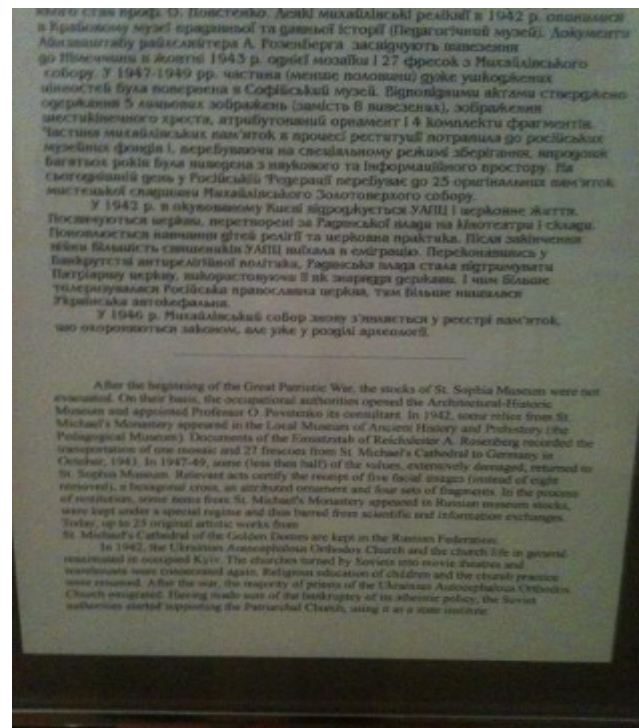
The first two images were taken in the St. Sophia Museum which is in the St Michael's Monestry Complex in central Kyiv (Kiev), where the history of the church there is recorded. The placard pictured describes the period during the Second World War, and relates how Christianity was actively restored during the occupation of German Axis forces.

The second set of photos are of a plaque on the side of a synagogue in Kherson Ukraine which has been recently restored. On the plaque the Jews themselves describe how "prayer" continued there UNTIL the occupation by German Axis forces in 1941, upon which time such activity was stopped. So the Jews were able to keep their synagogues open during Soviet Communist rule, but the Christians were not, and the German Axis forces actively restored Christian worship and practices during their occupation of Kyiv (Kiev), while the Jews were forced to close their synagogue.

These are clear facts which cannot be argued with. Considering the circumstances by which the Jews always claim that they suffered under Communism, and also claim that the National Socialists cared not for Christianity, it is easily demonstrable from available public proclamations that they are indeed found to be liars once again.

The pictures help to prove that the Soviets closed Christian churches, and left Jewish synagogues unmolested. Contrarily, the National Socialist Germans restored Christian churches to operation, and destroyed at least this one Jewish synagogue.

The English portion of the caption above shows that the Soviets closed churches from the Bolshevik period until they were reopened by the Germans during their occupation of the Ukraine:

After the beginning of the Great Patriotic War, the stocks of St. Sophia Museum were not evacuated. On their basis, the occupational authorities opened the Architectural-Historic Museum and appointed Professor O. Povstenko its consultant. In 1942, some relics from St. Michael's Monastery appeared in the Local Museum of Ancient History and Prehistory (the Pedagogical Museum). Documents of the Einsatzstab of Reichsleiter A. Rosenberg recorded the transportation of one mosaic and 27 frescoes from St. Michael's Cathedral to Germany in October, 1943. In 1947-49, some (less than half) of the values, extensively damaged, returned to St. Sophia Museum. Relevant acts certify the receipt of five facial images (instead of eight removed), a hexagonal cross, an attributed ornament and four sets of fragments. In the process of restitution, some items from St. Michael's Monastery appeared in Russian museum stocks, were kept under a special regime and thus barred from scientific and information exchanges. Today, up to 25 original artistic works from St. Michael's Cathedral of the Golden Domes are kept in the Russian Federation.

In 1942, the Ukrainian Autocephalous Orthodox Church and the church life in general reanimated in occupied Kyiv. The churches turned by Soviets into movie theatres and warehouses were consecrated again. Religious education of children and the church practice were resumed. After the war, the majority of priests of the Ukrainian Autocephalous Orthodox Church emigrated. Having made sure of the bankruptcy of its atheistic policy, the Soviet authorities started supporting the Patriarchal Church, using it as a state institute.

Opposite, the English portion of the caption shows that the Soviets left the synagogues open and operating unmolested from the Bolshevik period until they were closed by the Germans during their occupation of the Ukraine:

The Synagogue Chabad was founded in 1895. Till 1941 the synagogue was used as a prayer house of the Jewish community. But during the occupation of the city the building was destroyed. It was rebuilt in 1947 and re-equipped into a municipal narcological dispensary. On the 13th of November 1993 the

synagogue was turned over to the Kherson regional religious community Chabad. The Synagogue was opened anew on the 14th of September 2010.



The Non-Jewish Stake in the Holocaust Mythology

A high-ranking police officer in Tucson, Arizona was reported as saying that one-third of all automobile accidents in the city were related to medicated drivers. The story reports:

Prior to the Iraq war, American soldiers in combat zones did not take psychiatric medications, according to PBS Frontline documentary [The Wounded Platoon](#), which aired in May 2010. But by the time of the 2007 surge more than 20,000 of our deployed troops were taking antidepressants and sleeping pills. These drugs allowed soldiers with post-traumatic stress disorder to remain in combat when they otherwise could not. "What I use medications for is to treat very specific side effects," said Army psychiatrist Col. George Brandt. "I don't want somebody in a helpless mode in a combat environment. I want to make sure I don't have someone with suicidal thoughts where everyone is armed."

PTSD, TBI routinely treated with a Cocktail of Mind-altering Drugs

In the military today, soldiers who suffer TBIs – Traumatic Brain Injuries – routinely receive treatment with mind-altering psychiatric drugs. As reported in WIRED, in an article [What Role Did Accused Soldier's Brain Injury play in Afghan Massacre?](#): TBI's are known as the "[signature wounds](#)" of soldiers in the Middle East, where an astonishing **200,000 soldiers** have already been diagnosed with the condition. They are routinely treated with [psychiatric drugs](#) that have known side effects of promoting violence.

An untold number of active-duty troops and recent veterans of the wars in Iraq and [Afghanistan](#) are coming home with mental health conditions inflicted during service – and their spouses and children are suffering too. Now, with solid data slowly emerging from the nearly decade-long wars, the severity of the

crisis is starting to show.

A Shockingly large portion of U.S. Military Personnel are on Multiple Mind-altering Prescriptions: Narcotics, Antidepressants, Antipsychotics and more ...

One Defense Department report reveals that an astonishing **20 percent** of U.S. troops are on psychiatric drugs, and that they are often handed as much as a 180-day supply of those pills before being deployed. From an article [Doping Up The Troops](#)

A June 2010 internal report from the Defense Department's Pharmacoeconomic Center at Fort Sam Houston in San Antonio showed that 213,972, or 20 percent of the 1.1 million active-duty troops surveyed, were taking some form of psychotropic drug: antidepressants, antipsychotics, sedative hypnotics, or other controlled substances. Dr. Greg Smith, who runs the Los Angeles-based Comprehensive Pain Relief Group, said he was shocked by CENTCOM's drug policy for deployed troops. "If I was a commander I'd worry about what these troops would do," as a result of their medications, Smith said.

Even the New York Times has covered the epidemic of psychiatric drugs on U.S. troops. In an article entitled, "*For Some Troops, Powerful Drug Cocktails Have Deadly Results*" (February 12, 2011), the paper reports:

Airman Mena died instead in his Albuquerque apartment, on July 21, 2009, five months after leaving the Air Force on a medical discharge. A toxicologist found eight prescription medications in his blood, including three antidepressants, a sedative, a sleeping pill and two potent painkillers.

Yet his death was no suicide, the medical examiner concluded. What killed Airman Mena was not an overdose of any one drug, but the interaction of many. He was 23.

After a decade of treating thousands of wounded troops, the military's medical system is awash in prescription drugs – and the results have sometimes been deadly.

The story goes on to warn about the risk of suicides (a

violent act, obviously) caused by the interaction of multiple psychiatric drugs:

By some estimates, well over 300,000 troops have returned from Iraq or Afghanistan with P.T.S.D., depression, traumatic brain injury or some combination of those. The Pentagon has looked to pharmacology to treat those complex problems, following the lead of civilian medicine. As a result, psychiatric drugs have been used more widely across the military than in any previous war.

But those medications, along with narcotic painkillers, are being increasingly linked to a rising tide of other problems, among them drug dependency, suicide and fatal accidents – sometimes from the interaction of the drugs themselves. An Army report on suicide released last year documented the problem, saying one-third of the force was on at least one prescription medication.



But rather than offering them real treatment, the recipe for the U.S. military today is to "drug 'em and send 'em back to battle." So now we have active-duty troops operating in Afghanistan who are **ticking time bombs of psychiatric medications**.

When those time bombs go off, we get suicides, accidents and even the occasional massacre of innocent civilians.

So is there an answer?

Safer Alternatives are Available

The U.S. military has begun to investigate **battlefield acupuncture** and is seeing outstanding results. Watch this extraordinary video showing battlefield acupuncture working for active duty military personnel in Afghanistan:

Even MSNBC has covered the story, reporting: Now the Air Force, which runs the military's only acupuncture clinic, is training doctors to take acupuncture to the war zones of Iraq and Afghanistan. A pilot program starting in March will prepare 44 Air Force, Navy and Army doctors to use acupuncture as part of emergency care in combat and in frontline hospitals, not just on bases back home. They will learn "battlefield acupuncture," a method Niemtow developed in 2001 that's derived from traditional ear acupuncture but uses the short needles to better fit under combat helmets so soldiers can continue their missions with the needles inserted to relieve pain. The needles are applied to five points on the outer ear. Niemtow says most of his patients say their pain decreases within minutes.

Col. Arnyce Pock, medical director for the Air Force Medical Corps, said acupuncture comes without the side effects that are common after taking traditional painkillers. Acupuncture also quickly treats pain.

"It allows troops to reduce the number of narcotics they take for pain, and have a better assessment of any underlying brain injury they may have," Pock said. "When they're on narcotics, you can't do that because they're feeling the effects of the drugs."

The U.S. Department of Defense has even promoted the use of acupuncture as a safe, natural alternative to dangerous (deadly) narcotics and other drugs. As reported at Defense.gov:

"The Air Force Acupuncture Center is the first facility of its kind in DOD ever," Air Force Col. (Dr.) John Baxter said. "It is a full-time acupuncture facility, and not only is it here to treat patients, it's here to teach other providers and to do research." Baxter is director of the Pentagon Flight Medicine Clinic and a credentialed acupuncturist. Acupuncture is being used as a treatment everywhere in the Defense Department, "but the Air Force led the way with two formal training programs of 20 physicians each," Baxter said. "The Navy has one training program with 20

physicians and efforts are underway to have another tri-service training program."

What will happen if we keep Drugging our Soldiers? More Violence, Suicides and Massacres
