The Racist Right

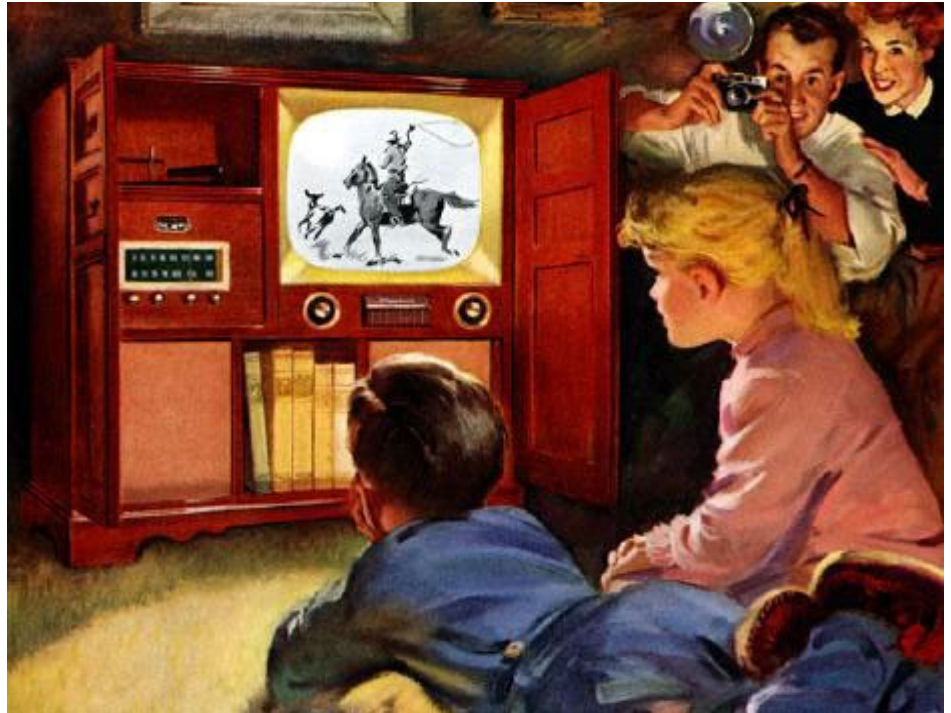
Not very long ago, the nations of Christendom were quite ethnically homogenous. Even those with significant non-White populations were nevertheless fairly well segregated, regardless of whether the non-Whites in White nations were indigenous - as the Aborigines of Australia, or introduced - as the Negroes in America.

Then along came Jewish racial and political agitation, and a century-long campaign to integrate non-Whites into the White populations of all White nations, thereby destroying White racial homogeneity everywhere. This has been no secret, it is a plan announced openly by the Jews long before it happened, that they would do this to the White race. Examples are readily found in Israel Zangwill's *The Melting Pot*, a play which opened at the Columbia Theater in Washington, D.C. on October 5th, 1908, or Edna Ferber's *Showboat*, which debuted as a play on Broadway in New York City in 1927.

Jews such as [Israel Zangwill](#), Israel Cohen, [Melvin Meyer](#), [Joachim Prinz](#), Edith Stern, Julius Rosenwald, Julius Rosenthal, Lillian Wald, Emil G. Hirsch, [Carol Ruth Silver](#), Stephen Wise, Henry Malkewitz, [Barbara Lerner Spectre](#), [Anetta Kahane](#), these are just a few names out of the thousands of Jewish so-called "civil rights" leaders and activists worldwide. Several of the Jews listed here were among the founders of the NAACP, an idea which Jews conceived. Jews have been at the vanguard of immigration and integration movements in every White nation for the past hundred years and more.

Impossible ideas such as pluralism, multi-culturalism, diversity, things which have never existed in nature and which have always failed miserably in history, are ideas of the Jews foisted upon White society so that Whites can be deceived into miscegenation and the self-destruction of their own race and cultures. The Jews flood White nations with aliens, and then they stoke racial discord in order to pressure Whites into ceding concessions for special treatment to those same aliens.

But in these last few decades, at the same time that the Jews are agitating racial integration of aliens and

Whites, the holocaust myth and the myths of their own religion allow the Jews themselves to decry integration with others, and therefore Jewish Supremacism has become the only politically acceptable form of Supremacism. However, and quite sadly, there are now many Whites who while rejecting the notion of Jewish Supremacism have also in turn surrendered their own race to the Jewish ideals of racial pluralism and diversity – regardless of the fact that wherever these things have been tried in the past, the result has been devastating.

Therefore today we have a division amongst those who would endeavor to save mankind from Jewish Supremacism. On the one hand, many of them are still pro-White separatists who understand the value of the White race and the need to defend Whites and White cultures from the flood of aliens. However on the other hand, many of them are not. These are those who, while denouncing Jewish Zionism, have fully accepted the Jewish paradigms concerning race and who then in turn speak out against all forms of racism. This later group actually assists the Jews in their original cause against the White race, regardless of the failure or success of Zionism itself.

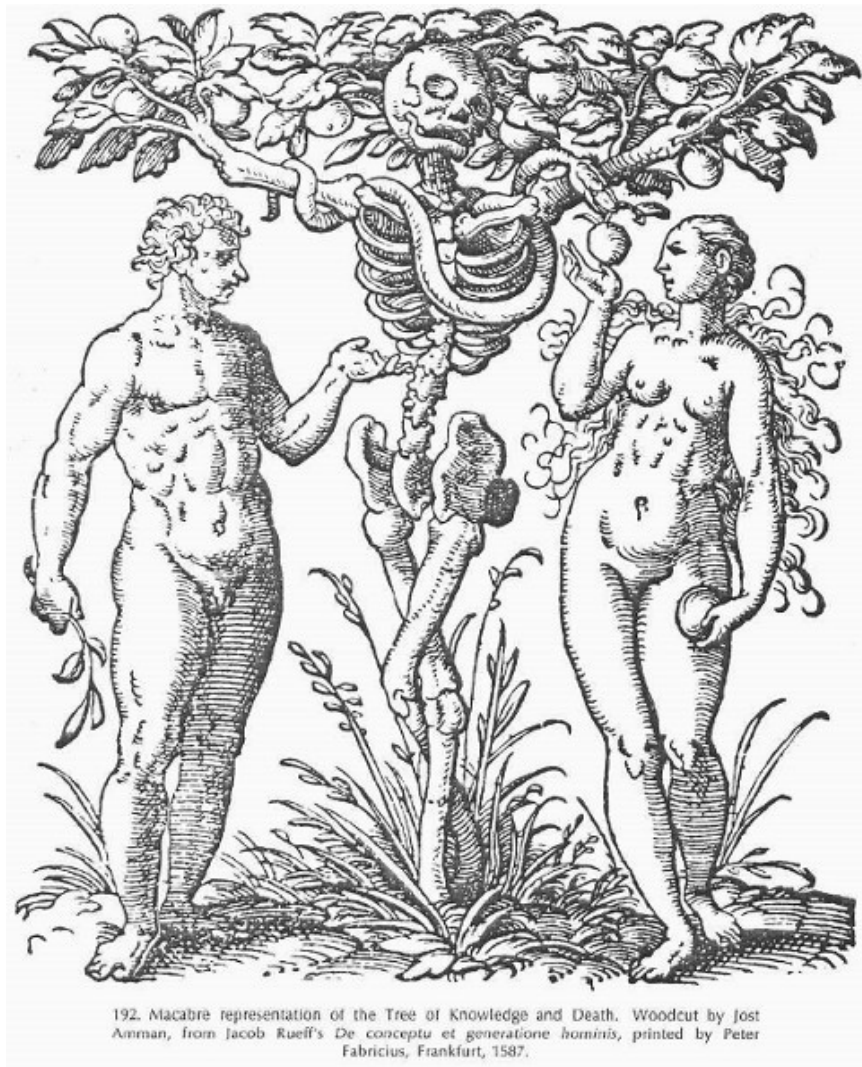
The original White Nationalists – the Ku Klux Klan being the most publicly ostracized by the Jewish media – were all pro-White racists. Typically they were also Christians. The generic term *White Nationalist* itself is relatively new. Originally, through the 1980's and even more recently in some circles, Whites with nationalist tendencies were called *Christian Patriots*. While many anti-Zionists come from the liberal left, true conservatives are *supposed* to be racists, since conservation of the nation or republic would also necessitate the maintenance of the original racial stock which created it. For that reason alone did the preamble to the United States' Constitution express the intent to “secure the Blessings of Liberty to ourselves and our Posterity”. Posterity means *descendants*. Those blessings of liberty for which our White ancestors fought so hard were never intended for the floods of aliens. That idea is also Jewish propaganda.

We would make the assertion that Whites cannot survive at all without a return to the values of positive Christianity, the same Christianity which excluded Jews from European society and defended Whites from the resulting onslaught of Arab and Turkic hordes in the Middle Ages. Additionally, the path to White survival must include the lesson that Whites stop projecting their own values onto the people of other races, who have never naturally shared any of those values. While some individuals among the other races may learn to mimic White behavior for the sake of the rewards of cooperating in a White society, such a phenomena is rarely lasting, and in subsequent generations their bastard children always cause a degradation of the host White society.

Furthermore, Whites must have clear ideals which characterize White identity, and strive to maintain them in everyday life, or Whites shall not survive as distinct ethnic groups and members of a wider distinct race. Whites must maintain these ideals even if all Whites do not share such characteristics. Only the recognition and elevation of an ideal can motivate a community to protect it, since the ideal becomes a symbol representing the identity of a people. If one is offended by the maintenance of the ideal, then that person obviously does not belong as part of the group.

Thus is the essence of true White Nationalism. It is also the essence of true English, German, Irish, Dutch, Danish or American Nationalism. A flood of Kaffirs or Turks cannot be English or German any more than the English settlers of Australia became Aborigines, or the New Zealanders became Maori. Civilization is a racial construct, and not a geographical mishap. Therefore the real Right is a Racist Right, and anything else is really Left.

The Revelation of Yahshua Christ
Chapter 20
William R Finck

XX 1 And I saw a messenger descending from out of heaven having the key of the bottomless pit and a great chain in his hand. 2 And he held fast the dragon, that serpent of old, who is the False Accuser and the Adversary, and he bound him for a thousand years 3 and cast him into the bottomless pit, and barred and set a seal upon it, that he may no longer deceive the Nations, until the thousand years should be completed. After these it is necessary for him to be released for a short time.

Just as Revelation chapters 12 and 13 were overviews of the prophecies which had preceded, told from differing perspectives and including different aspects of the same story, so is Revelation chapter 20 an overview of what has been, and of what is about to transpire, so that those for whom it is intended may understand and be able to identify these things.

The dragon, that serpent of old, is those who are of the assembly of the Adversary who claim to be Judah and are not (Revelation 2:9, 3:9). These people are actually the Kenite-Canaanite-Edomite jews, all of those tribes being related as is evident in the Book of Genesis (i.e. chapters 4, 10, 15 and 36), who infiltrated Judaea long before the first century BC (i.e.



Ezekiel chapters 35 and 36, Malachi chapters 1 and 2, Luke 11:50-51, Romans 9, John 8:33-47, Revelation 12:4 et al). When Christianity became the official religion of the Roman Empire, laws were passed against the jews in the 4th and 5th centuries, which excoriated the jew from Christian society. It became unlawful for jews to hold any public office or military position, to hold Christian slaves, or to loan money to Christians at usury. From the time of Justinian jews caught owning Christian slaves faced execution. Many jews were therefore persuaded to leave the grounds of the Empire, and they migrated into Khazaria, Arabia and elsewhere.

In Medieval Europe those jews who remained were forced to live in separate communities, but within those communities they were allowed their own laws. They existed in Europe as chattel property of the nobles, for the profit of the nobles. This is when it was fulfilled, as found in Revelation 3:9, that those who claim to be Judaeans and are not, Christ “shall make them that they shall come and they shall worship before your feet”, as the jews were forced to do for a thousand years before Christian nobles throughout Europe.

4 And I saw thrones, and they who sat upon them,

and judgment had been given to them, and the souls of those having been beheaded on account of the testimony of Yahshua and on account of the Word of Yahweh and who did not worship the beast nor his image and did not receive the inscribed mark upon their foreheads and upon their hands. And they lived and ruled with Christ for a thousand years.

For a thousand years – for better or for worse – Christianity prevailed in Europe and Christian governance, albeit often in name only, was the general way of life. The martyrs, those early Christians who did not worship the first beast, who died in pagan Rome at the instigation of the Jews during the persecutions of Christians, were now vindicated and venerated as the heroes and examples that they were, although one cannot endorse the Romish Catholic practice of making statues and praying to the images of men. The Jews attempted to destroy Christianity, and used the Romans to persecute them. But the testimony of the Christian martyrs prevailed over the Jews!

5 This is the first restoration. 6 Blessed and holy is he having a part in the first restoration. Over these the second death does not have authority, but they shall be priests of Yahweh and of Christ and they shall rule with Him for the thousand years.

Verse 5 here contains only the words “this is the first restoration”, restoration being a literal meaning of the Greek word usually translated “resurrection” in most Bibles. In the King James Version and most others which are based upon the so-called Majority Texts, there is a lengthy interpolation inserted at the beginning of verse 5 which reads “But the rest of the dead lived not again until the thousand years were finished.” This interpolation has caused many to uphold the idea that none of Revelation Chapter 20 has yet been fulfilled, because there is no resurrection since the time of Christ. Yet none of this interpolation belongs in the text. It is an addition to the manuscripts, which found its way into certain texts after the 9th century AD. Even the Majority Text manuscripts are divided on this interpolation: those which have it – and which the King James Version of Revelation was based upon – are in the minority. The Majority Text manuscripts of the Koine Greek tradition do not have this interpolation, and they are by far the more

numerous. The interpolation is found only in a minority of manuscripts which were derived and preserved from a commentary on the Revelation made by a medieval monk named Andreas of Caesarea. But these represent only a minor portion of Majority Text manuscripts of the Revelation, and the words are not in any of the much earlier manuscripts of the Revelation which we now possess – such as the Codex Sinaiticus. It is very clear to inquiring scholars that the interpolation does not belong in our texts of the Revelation, but most editions of the Bible include it anyway, because of so-called “church tradition”, ignoring the warnings and curses admonishing those making additions to this book, which are found at Revelation chapter 22, verses 18 and 19!

7 And when the thousand years are completed, the Adversary shall be released from his prison 8 and shall go out to deceive the Nations which are in the four corners of the earth, Gog and Magog, to gather them to battle, of which the number of them is as the sand of the sea.

This is another prophecy of that same event found in Ezekiel chapter 39. Let us read Revelation 17, verses 7 through 14, once again: “7 And the messenger said to me: 'For what reason do you marvel? I shall tell you the mystery of the woman and of the beast carrying her, having the seven heads and ten horns! 8 The beast which you saw was and is not and is going to ascend from out of the bottomless pit and go into destruction, and those dwelling upon the earth, whose name is not written in the book of life from the foundation of Society, shall marvel seeing the beast that was and is not and shall be present. 9 Thus is the mind having wisdom: The seven heads are seven mountains, where the woman sits upon them. And there are seven kings: 10 five have fallen, one is, another has not yet come, and when he should come it is necessary that he remains a short time. 11 And the beast which was and is not even he is the eighth and is from of the seven, and goes into destruction. 12 And the ten horns which you saw are ten kings, who have never received a kingdom, but they shall receive authority as kings for one hour with the beast. 13 These have one mind and power and they give their authority to the beast. 14 These shall make war with the Lamb and the Lamb shall overcome them, because He is Prince of Princes and King of Kings and those with Him called and chosen and faithful!”

Revelation chapter 17 explains that the eighth beast (verse 11) is the same as that beast upon which the woman is seated, which ascends from out of the pit (verse 8). Mystery Babylon, the eighth beast, is therefore shown to be one and the same as this Satan who is released from prison – the Adversary who emerges from the pit – here in Revelation chapter 20! This has already happened, and it is the very reason why all of the nations of the world are deceived and under the control of the international jew today! This process began with the di Medici popes and the acceptance of usury by Christendom, and culminated when the jew was finally emancipated in Europe, at the time of the French Revolution and Napoleon Bonaparte. Satan had surely been locked away, the jews kept apart from Christians, for a thousand years. Now with his emancipation he was free to go out and deceive the nations with his cries for liberty, equality, and fraternity, which today have all the world's goat nations threatening the very existence of the White Christian race.



9 And they had gone up upon the breadth of the earth and encircled the encampment of the saints and the beloved city, and fire descended from out of heaven and devoured them. 10 And the False Accuser who deceived them is cast into the lake of fire and sulfur where are also the beast and the false prophet, and they shall be tormented day and night for the eternal ages.

Now whether there is ever an actual military invasion of the White Christian nations by aliens does not matter. Already, all of the White Christian nations have been and are currently being overrun, looted and pillaged by aliens without a military. In many White nations today, genocide is being disguised merely as criminal behavior, and hidden behind statistics while reports everywhere are distorted or squelched by jewish-controlled media outlets. Christendom is overrun by the aliens which hate the whore, while Whites who do stand up and speak out are persecuted

even by those of their own race! Such is all the proof required, that Yahweh God has handed their kingdom over to this last beast, as described at Revelation 17:17. Those Whites who worship the beast, who take the side of the beast against their own race, fail to love their brother, and take upon themselves the mark of the beast.

At the end of this age, upon the return of Christ, the False Accuser, or devil, which is the Adversary, or Satan – all jewry and all of those who opposed Christ – are cast into the Lake of Fire. The Adversary, the beast, and the false prophet are no more. There are

several parables given by Christ and recorded in the Gospels which discuss this same thing, and they must be included in the discussion here.

The explanation of the parable of the wheat and the tares, in part, from Matthew 13: “37 ... He sowing the good seed is the Son of Man; 38 now the field is the world, and the good seed, these are the sons of the

kingdom. But the tares are the sons of the Evil One, 39 and the enemy who sows them is the False Accuser, and the harvest is the consummation of the age, and the reapers are messengers. 40 Therefore just as the tares are gathered and burn in fire, thusly it shall be at the consummation of the age. 41 The Son of Man shall send His messengers, and they shall gather from His kingdom all offenses and those creating lawlessness 42 and they shall cast them into the furnace of fire. There shall be weeping and gnashing of teeth! [If this were a purifying fire, as many fools pronounce, then the enemies of God would be glorifying Him rather than gnashing their teeth.] 43 Then the righteous shall shine forth like the sun in the kingdom of their Father. He having an ear must hear!” The children of God can sin, but they do not create sin. The fallen angels and their progeny are the authors of sin. They planted the tares at the foundation of the world, which is the Adamic society. That is the meaning of another parable, which is found in Genesis chapter 3. 1 John 3:9 states: “Each who has been born from of Yahweh does not create wrongdoing, because

His seed abides in him, and he is not able to do wrong, because from of Yahweh he has been born.” As David said, and Paul quoted, “blessed is the man to whom Yahweh will not impute sin”, and that describes only the children of Israel, the legitimate seed of Abraham.

The parable of the net, from Matthew 13:“47 Again, the kingdom of the heavens is like a net having been cast into the sea and it gathers from out of every race, 48 which when it is full, bringing up upon the shore and sitting they gather the good ones into vessels, but the rotten ones they cast out. 49 Thus it shall be at the consummation of the age, the messengers shall go out and they shall separate the wicked from the midst of the righteous 50 and they shall cast them into the furnace of fire. There shall be weeping and gnashing of teeth!” In this parable, Yahshua Christ informs us in the Gospel itself, that He foresaw universalism, but that He will not accept universalism! The antithesis to universalism is defined, where the bad fish are not sent back into the sea, but are rather cast into the furnace of fire. Again, if this were a “purifying fire”, rather than a destructive fire, there would be rejoicing, and not a weeping and gnashing of teeth. The sea in prophecy often refers to the great mass of the world's people as a whole. Revelation 21:1 says that "the sea is no longer", because it is no longer needed: all the fish are gone!

The parable of the sheep and the goats, from Matthew chapter 25: “31 And when the Son of Man should come in His effulgence and all the messengers with Him, then He shall sit upon His throne of honor. 32 And they shall gather before Him all the nations and He shall separate them from one another just as the shepherd separates the sheep from the goats. 33 And He shall indeed stand the sheep at His right hand, but the goats at His left hand. 34 Then the King shall say to those at His right hand: ‘Come, those blessed of My Father, you shall inherit the kingdom which has been prepared for you from the foundation of Society! 35 For I hungered and you gave Me to eat; I had thirst and you had given Me drink; I was a visitor and you had taken Me in; 36 naked and you had clothed Me; I had been sick and you watched over Me; I was in prison and you had come to Me.’ 37 Then the righteous shall respond to Him saying: ‘Master, when have we seen You hungry and nourished You, or thirsting and had given drink? 38 And when have we seen You a visitor and had taken You in, or naked and

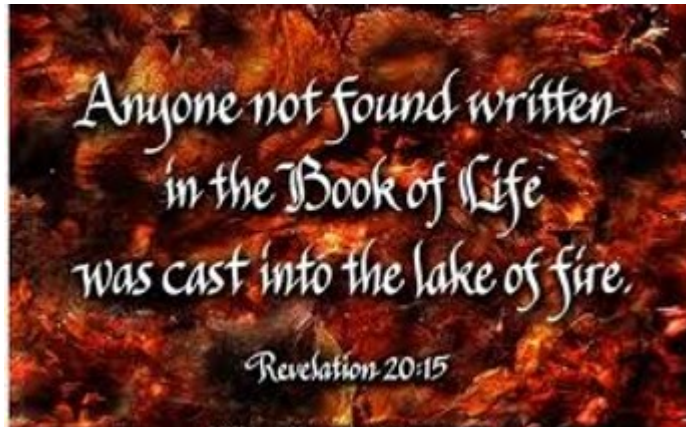
had clothed You? 39 And when have we seen You being sick or in prison and had come to You?’ 40 And replying the King shall say to them: ‘Truly I say to you, for whomever of the least of My brethren have you done one of these things, you have done them for Me!’ 41 Then He shall say also to those at the left hand: ‘Go from Me, accursed, into the eternal fire which has been prepared for the False Accuser and his messengers! [The goat nations have the same fate as the fallen angels.] 42 For I hungered and you did not give Me to eat, and I had thirst and you had not given Me drink; 43 I was a visitor and you had not taken Me in, naked and you had not clothed Me, sick and in prison and you had not visited Me!’ 44 Then they themselves shall also respond saying: ‘Master, when have we seen You hungry or thirsting or a visitor or naked or sick or in prison and had not served You?’ 45 Then He shall respond to them saying: ‘Truly I say to you, for whomever you had not done one of the least of these things, neither have you done them for Me!’ 46 And they shall go off into the eternal punishment, but the righteous into eternal life.” One thing most commentators miss when assessing this parable, is that the goats are judged for how they have treated the sheep! For Yahshua said “for whomever of the least of My brethren have you done one of these things, you have done them for Me”. From the start, in verses 32 and 33 the division between the sheep and the goats is made upon ethnic lines, and not upon behavioral lines. The sheep were chosen to be His servant people, and the goats cannot be His servant people. It is whom He chooses, not whom men choose – and thus there shall be weeping and gnashing of teeth, because He chose only the sheep!

In any of these examples, there is no third alternative, one is a sheep or a goat, a wheat or a tare, and of the good race of fish or of a bad race of fish. As Paul said in Hebrews at 12:8, one is a son, or one is a bastard. There is no other choice. There is no third alternative anywhere. Those who offend, the offenses of Matthew 13:41, are the bastards, and they must be, since they were created by man in violation of the Genesis law of “kind after kind”. The apostle John explains in the fourth chapter of his first epistle that there are those who are from of God, and there are those who are from of the world. Their origin is in the world. Christ exclaimed in Matthew 15 that “Every plant which My heavenly Father has not planted shall be uprooted!” While Yahweh created all things, He only created all

things which He created! The things which man created are only mere corruptions of the creation of Yahweh, and these things cannot ever be restored to Yahweh. The so-called “restoration of all things” is only a restoration of all things which Yahweh created, and there are clearly many plants here which He did not plant! The goat nations are goats and not sheep, because they are bastards and not Adam. There is no third alternative which can be found honestly and explicitly in Scripture. Those who pretend to have found a third alternative, have invented it for themselves and with their words they deceive themselves, and seek to deceive others.

11 And I saw a great white throne and He sitting upon it, from whose presence the earth and the heaven had fled, and a place is not found for them. 12 And I saw the dead: the great ones and the small ones, standing before the throne. And books had been opened, and another book was opened, which is that of life, and the dead were judged from out of the things written in the books according to their works. 13 And the sea had given over those dead who were in it, and Death and Hades had given over those who were in them, and each are judged according to their works. 14 And Death and Hades are cast into the lake of fire. This is the second death: the lake of fire. 15 And if one is not found written in the book of life, he is cast into the lake of fire.

Here “the earth and heaven” are allegories for the people of the land and their government. This describes the final judgement of God. All those written into the Book of Life shall live, and all others shall be cast into the Lake of Fire. Again, like the parables described above, there is no third choice. One either goes on to eternal life, or eternal destruction, which is a cessation of existence. The sheep nations – the nations of Israel, are preserved. The goat nations all go into the Lake of Fire. If you believe otherwise, the time to repent is now. There shall indeed be weeping and gnashing of teeth.



Yahshua Christ Himself is the “Word of Life”, as the apostle describes at 1 John chapter 1: “1 That which was from the beginning, that which we have heard, that which we have seen with our eyes, that which we have observed, and our hands have touched concerning the Word of Life: 2 that the life was made manifest, and we have seen and we bear witness and we announce to you the eternal life which was with the Father and has been made manifest to us.” Their hands, meaning those of the apostles, had touched Christ, the Word of Life. And if He is the Word of Life, then the Gospel must be the book of Life. It really is that simple.

Christ stated at Luke 10:22: “All things have been given over to Me by My Father, and no one knows who the Son is if not the Father, and who the Father is if not the Son, and the Son shall reveal it to whom He should determine.” This same thing is recorded at

Matthew 11:27 thus: “All things have been handed over to Me by My Father, and no one knows the Son if not the Father, nor does anyone know the Father if not the Son, and to whom the Son may wish to reveal Him.”

In the Gospel, in John chapter 10, we find, in part: “Truly, truly I say to you that I am the door of the sheep! ... I am the door! If one should enter by Me he shall be preserved and shall enter in and shall go out and he shall find pasture... I have come in order that they would have life and they would have abundance! ... I am the Good Shepherd. The Good Shepherd lays down His life on behalf of the sheep! ... I am the Good Shepherd and I know Mine and Mine know Me, just as the Father knows Me and I know the Father, and I lay down My life on behalf of the sheep. And I have other sheep which are not from this pen, and these it is necessary for Me to bring and they shall hear My voice, and they shall be one flock, one shepherd.... For this reason the Father loves Me, because I lay down My life in order that I would receive it again. 18 No one takes it from Me. Rather I lay it down by Myself. I have authority to lay it down, and I have authority to receive it again. This command

I have received from My Father.... But you do not believe, because you are not My sheep! [Where He was speaking to certain of the rulers of Judaea, who were Edomites.] 27 My sheep hear My voice, and I know them and they follow Me, 28 and I give to them eternal life and they are not lost forever and one shall not snatch them from My hand. 29 My Father who gave them to Me is greater than all, and no one is able to snatch them from the hand of the Father! 30 I and the Father are One!"

Therefore from the Gospel it is clear, there is no path to Yahweh God except through Christ, and Christ only

came "but unto the lost sheep of the House of Israel", as He Himself exclaimed, which is recorded in Matthew chapter 15. In the new heaven and new earth of Revelation Chapters 21 and 22 which follow, it is therefore manifest that of all the people here in this world presently, there is only a place for the Children of Israel. For no one else – except those of the other branches of the Adamic race which Christ attested shall also be resurrected (for the first promise of a restoration to eternal life in the Tree of Life, which is Yahshua Christ, is in Genesis chapter 3) – no one else is written into the Book of Life.

The Curse on Cain Proven

The subject of this discussion is based upon Gen. 4:11-12, where Cain had murdered Abel, which states:

¹¹ And now art thou cursed from the earth, which hath opened her mouth to receive thy brother's blood from thy hand; ¹² When thou tillest the ground, it shall not henceforth

yield unto thee her strength; a fugitive and a vagabond shalt thou be in the earth.

Many have formed an incorrect premise that Cain and Abel were pure genetic blood brothers, only because Gen. 4:1 is a corrupt passage in the original Hebrew. *The Interpreter's Bible*, a twelve volume collaborative work of 36 'consulting editors', plus 124 other 'contributors', makes the following observation on this verse, vol. 1, p. 517:

"Cain seems originally to have been the ancestor of the Kenites ... The meaning of the name is 'metalworker' or 'smith'; here, however, it is represented as a derivation of a word meaning 'acquire', 'get' – one of the popular etymologies frequent in Genesis – hence the mother's words I have gotten a man. – *From the Lord* (KJV) is a rendering, following the LXX and Vulg., of '*eth Yahweh*', which is literally, 'with Yahweh', and so unintelligible here (the help of [RSV] is not in the Hebrew). It seems probable that '*eth*' should be '*oth*' – so, 'the mark of Yahweh' – and that the words are a gloss ..."
[underlining mine]

Secondly, *The Interpreter's One-Volume Commentary On The Bible*, edited by Charles M. Laymon, makes the following comment on this passage, on page 6: "... under circumstances which are

obscure (vs. 1b can scarcely be translated, still less understood). His younger brother was named Abel, which suggests the Hebrew word for breath."

Therefore, if Genesis 4:1 is "unintelligible" and "can scarcely be translated, still less understood", how can one prove anything by quoting it? Additionally, if the words are "a gloss", where is the foundation for any premise assumed from this verse alone?

What is virtually overlooked in the story of Cain and Abel in the fourth chapter of Genesis is the fact that they were both offering a sacrifice, and in the Bible, only priests were authorized to do so. Secondly, unless circumstances prevented it, it was always the firstborn son that was given this dignity of priesthood. Inasmuch as we understand that Eve was the mother of both Cain and Abel, it is obvious that Cain was the firstborn of the serpent (i.e., Satan), and that Abel was the firstborn of Adam. Or are we to believe the preposterous conjecture that Adam had two firstborn sons? (Read my paper, *The Battle For The Priesthood*.)

Therefore, if Cain was really cursed by the Almighty that he could never be a successful farmer, and if there are descendants of the Kenites with us today as there were in later Biblical times (i.e. 1 Chr. 2:55), then we should have historical evidence to substantiate Yahweh's Word, and three historical examples will overwhelmingly prove it, as follows:

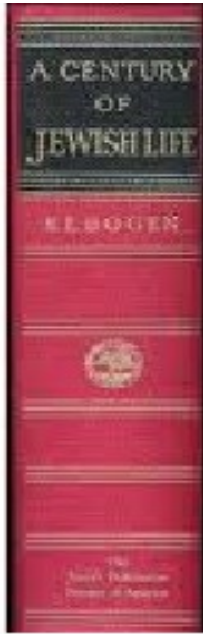
UNABLE TO OVERCOME THE CURSE OF CAIN

When the jews began to migrate to America in significant numbers, they attempted several "back-to-the-land" movements. Imagine jewish farmers thriving on farms of their own, something they have never been able to do for any prolonged period of time. These movements failed miserably. Here it is in their own words. Now quoting from the

book *A Century of Jewish Life*, by Ismar Elbogen, pp. 333-335

“Michael Heilprin was an enthusiastic partisan of the back-to-the-land movement and was happy to find that many immigrants expressed a strong desire to devote themselves to agricultural pursuits. He made it his business to raise funds for this purpose. Settlements were attempted in several states, but unfortunately all of them miscarried. One time it was the water that was at fault, another time it was a crop failure; once drought, again frost and hail spoiled flourishing crops that were almost ready to harvest. Always it was complete lack of experience and consequently ill-chosen ground which was to blame for the failure. The settlers worked with all their might and contented themselves with the barest minimum, but none of the settlements survived its difficulties longer than four years. Individual farmers could set their teeth and outface failure until their soil rendered a return, and indeed many did so. But for closed colonies the requisite experience and capital were never available. Most of the enthusiasts were forced to return to the city disillusioned. A few colonies in southern New Jersey, like Alliance, Carmel, Rosenhayn, maintained themselves because their proximity to large cities provided them a favorable market and because the Baron de Hirsch Fund stood behind them.

“Heilprin’s influence in the creation of this Fund was considerable. In Constantinople Maurice de Hirsch was in contact with Oscar S. Straus (1840-1926), the United States ambassador to Turkey. Straus informed de Hirsch of the miserable condition of the immigrants in America. Prepared, as always, to give productive help, de Hirsch asked for a plan, and one was prepared by Michael Heilprin and met with de Hirsch’s approval. He made the income, and later the principal sum, of ten million francs (\$2,400,000) available, and left the disposition of these moneys to the judgment of an American committee. Upon this committee sat men most experienced in such affairs, among others Schiff, Straus and Judge Mayer Sulzberger. In addition to temporary help immediately upon landing, such as providing shelter, distributing immigrants in the interior of the country and the



purchase of tools for artisans, measures were taken for providing permanent help by making the immigrants self-sustaining. There was much difference of opinion in matters of detail, but eventually unity was achieved. In 1890 the Fund began to operate, and the American administration was given broad powers” And the jews tried the same so-called “back-to-the-land” movement in Canada, which also failed.

Ibid. p. 323: “Canada, too, had a considerable share of immigration. The proximity of the United States, the extent and fertility of the country, and the sparsity of its population were inducements to immigration but prevented a firm and independent development. The reception of the first refugees was very cordial. All charitable work was on a voluntary basis, and the personal interest and warmth with which they were met encouraged the immigrants and made it easy for them to settle down, so that they could soon help others to settle. When immigration became particularly heavy, in 1888, the Young Men’s Hebrew Benevolent Society of Montreal, which had always felt responsible for the immigrants, approached Baron de Hirsch and solicited the same interest on behalf of immigrants to Canada as he showed in those to the United States. The petition was promptly heeded; permanent assistance was promised and given. In 1891 the Baron de Hirsch Institute was opened. This provided shelter for newcomers and also secular education, with evening classes for adults. The Institute became more important as immigration grew after the turn of the century. Not content with this work, Baron de Hirsch and later the Jewish Colonization Association, which established a separate Canadian Committee, promoted the settlement of Jews as farmers. The government favored these efforts by putting land at their disposal gratis. As in almost all other countries these settlements began with a very difficult period of trial. Their success was retarded by unfavorable location and failure of crops. According to a census of 1920 there were 3,500 Jewish persons in Canada living by agriculture, and the annual value of their products was a million dollars.” That would be \$285.71 per year per jewish farmer, hardly a living wage even back then! That would amount to about \$23.80 per month to meet

the needs of one Jewish family!

Ibid. p. 324: “These figures signify little in view of the greatly increased immigration which took place, especially in the bad decade between the pogrom of Kishinev and the World War. Whereas there were only something more than 16,000 Jews in Canada in 1901, in 1911 the number was 50,000, or 1.03% of the total population, and in 1921 it had grown to 126,196, or 1.44%. This enormous absolute increase was received into the cities, of which some, like Winnipeg and Vancouver, were founded during this period and grew at an astounding rate. The Jews wandered from east to west along the railroad, and many settled at the stations fixed by the railroad. Their small stores became central points for the agricultural regions round about. There farmers not only found their necessities, but frequently an interpreter for the various languages spoken in the country, someone to read and write their letters, and sympathetic understanding for their human problems. At these railroad stops villages came into existence, and also Jewish congregations. They are to be found strewn over the whole broad dominion. But the main body of the Jews settled in a few large cities. Montreal, Toronto, and Winnipeg contain about three-fourths of the total Jewish population. The character of the congregations was determined by the character of the immigrants, who brought a conservative attitude into an essentially conservative country. It is significant that, as late as 1921, 87% of the Jewish population recorded their mother tongue as Yiddish. Proximity to the United States determined the character of charitable institutions, hospitals, orphanages and the like; all such establishments followed the pattern set in the United States. The relief organizations for the victims of pogroms and for work in Palestine found ready support in Canada”

The reader has now been given the first two exhibits of the failed back-to-the-land ventures in the United States and Canada. I will next quote from a book entitled *Judaism In Action*, published in 1936. The author did not leave us his name, but his Bibliography on pages 344-345 is outstanding! In it, the author documents many hidden details of the Bolshevik Revolution. I will quote a portion of the Testimony given before the Overman Committee, pp.

15-20: “Testimony of Theodor Kryshtofovich

“This witness testified that he left Petrograd on December 15, 1918, and that he had been there continuously for the three years previous to that date; that he belonged to no political party in Russia, but had lived among the peasants and workmen, teaching them agriculture. He at one time had been employed by the Russian Department of Agriculture, as an agent, in the United States.

“On page 424 he testified in regard to the Jewish aspect of the movement as follows:

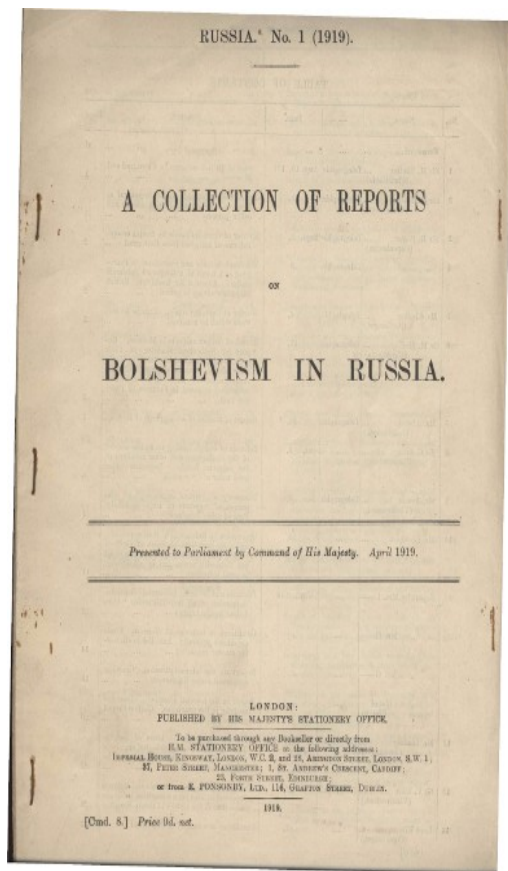
““And, besides these refugees, most of the people that are governing Russia now are Jews. I am not against Jews in general. They are a very capable and energetic people, but, as you Americans say, the right man must be in the right place. Their place is in the commission houses, in banks, in the offices, but not in the government of a fine agricultural country. They do not understand anything about agriculture, about production, about keeping materials, and about distribution. They do not know anything about those things at all.”

“Senator Wolcott, ‘You mean those that are in charge of the Bolsheviki, do you not?’

“Mr. Kryshtofovich. ‘I am talking about the Bolsheviki; because if you take out Bolshevik government, Lenine is a Russian and all these constellations that are turning around this sun are Jews. They have changed their names. For instance, Trotzky is not Trotzky, but Bronstein. We have Apfelbaum, and so on, and so on.’”

“(b) Other Evidence

“It is important that the other official documents pertaining to the Bolshevik activities in Russia also refer to the question which we are now discussing, namely, the Jewish character of the Bolshevik regime. In this connection we quote, from the British White Book, Russia No. 1 (1919), entitled ‘A Collection of Reports on Bolshevism in Russia, Presented to Parliament by Command of His Majesty, April, 1919.’



by name Vainen and Safarof, went with Lenine when he made a journey across Germany' (page 41).

“Again, in a report made by Rev. B.S. Lombard to Earl Curzon on March 23, 1919, referring to the results of the Bolshevik regime in Russia, among other things, the following is stated:

“All business became paralyzed, shops were closed, Jews became possessors of most of the business houses, and horrible scenes of starvation became common in the country districts. The peasants put their children to death rather than see them starve. In a village on the Dvina, not far from Schlusselfurg, a mother hanged three of her children' (page 57).

“Mr. Henry C. Emery, formerly Chairman of the United States Tariff Board, recently wrote a treatise on Bolshevism, of which Lord Bryce has said:

“It seems to me the sanest and clearest exposition of Bolshevist theory and practice that I have seen and confirms my view that between them and us there can be no peace.’

“Mr. Emery comes to the conclusion that Bolshevism is the promotion of a ruthless and universal class war, and that ‘a Bolshevik is a man who believes in the overthrow of the institution of private property by force of arms.’ While this is the definition which he gives of Bolshevism as a movement, and his argument in support of it is certainly a very able one, it is interesting to note what he says in regard to the Jewish support of the movement:

“In the minds of some people, especially in Russia, Bolshevism takes on the color of a revolt of the Jews against the Russians, who have so long kept them in subjection. Lenin is of course a pure Russian, and it is a mistake to say that all the other leaders of importance are Jews. On the other hand, the Jews have been active in the movement out of all proportion to their relative numbers. No one who ever made a visit to Smolny Institute, when that was the headquarters of the Bolshevik government at Petrograd, could understand how easy it was to get the impression that the Jews had at last seized the power.’

“Mr. Robert Wilton, a well-known Englishman, who was the Petrograd correspondent of

“This document was published in London at the government printing office in 1919. In exhibit No. 33, a cablegram: dispatched by Mr. Alston to Earl Curzon, from Vladivostok to London, February 8, 1919 (‘telegraphic – following from consul at Ekaterinburg, 6th February’), the following is stated:

“From examination of several labourer and peasant witnesses, I have evidence to the effect that [the] very smallest percentage of this district were pro-Bolshevik, majority of labourers sympathising with summoning of Constituent Assembly. Witnesses further stated that Bolshevik leaders did not represent Russian working classes, most of them being Jews’ (page 33).

“In a cable dispatch from General Knox to the British War Office on February 5, 1919, from Omsk, Siberia, details are given as to the murder of the Imperial Russian family. This cable reads in part as follows:

“With regard to the murder of the Imperial family at Ekaterinburg, there is further evidence to show that there were two parties in the local Soviet, one which was anxious to save Imperial family, and the latter, headed by five Jews, two of whom were determined to have them murdered. These two Jews,

the *London Times*, and a Knight of St. George, in his book entitled *Russia's Agony*¹, refers to the part which the Jews played in undermining the Kerensky government and establishing the Bolshevik rule:

“Subversion had been carried out by a handful of pseudo-Jew Extremists in the Soviet, but the Soviet was a party to the traitorous business. Most of the leaders – especially the pseudo-Jews – were a truculent pack, cowering behind the soldiery, intent upon realizing their revolutionary ‘ideals,’ but terrified by a possibility of failure and eventual reprisals.’

“The author also states: ‘Afterwards their numbers (referring to the Jew Extremists in the Soviet) increased largely, and although they studiously concealed their identity under assumed Russian or Polish names, it became known that the principal ones were: Nahamkez – Steklov, Apfelbaum – Zinoviev, Rosenfeldt – Kamenev, Goldmann – Gorev, Goldberg – Mekowski, Zederbaum – Martov, Himmer – Sukhanov, Krachman – Zagorski, Hollander – Tlieshkovnski, Louier – Larim, Seffer – Bogdanov, Among the leaders of this gang – under Lenin – were Trotzky, whose real name was Bronstein, and Feldmann, alias Chernov. [¹*Russia's Agony*, pp. 137,138, published by Edward Arnold, London, 1918.]

We should take note that all those testifying before the Overman Committee did not use the same terms we might use today, for they too, being White Caucasians, were also blinded to their Israel Identity, and the ethnic origin of our common enemy! Had we have lived during their era, no doubt we couldn't have described these terrible experiences any better than they did!

After the Bolsheviks had slaughtered approximately twenty million White Ukrainian farmers, and other industrious kinsmen, and the food supply was nearly depleted, the jewish Bolsheviks decided to establish collective farms. The leaders of the Bolsheviks then forced nearly everyone to move into jewish Bolshevik owned tenant housing in nearby cities or towns, and be transported daily to work in the fields, which turned out to be just another jewish failure, as collective farming gave no incentive to the workers. It would appear, then, the curse upon Cain included the management of farming. The Bolsheviks

did allow the Russians to have a small garden plot, and from that time until now, the greater part of the food supply for the Russian people came from those garden plots!

While in the United States, we were enjoying large, clean supermarkets with a wide selection of various foods, the markets in the Soviet Union appeared more like an oversize barn or warehouse with birds flying around the ceiling, and droppings from the birds everywhere present, and a danger of being the recipient of the discharge from one or more of the birds. These highly unclean Soviet food markets were lined with hundreds of empty shelves, and what shelves did contain something, only a small selection was available.

Dangerous for us today in the United States is the fact that, little by little our farming system is changing to the collective farm system that failed in the Soviet Union. During the 1970s and 80s, our unlawful so-called Federal Reserve system jacked up their interest to farmers to 20 plus 1 percent, and as a result, many of our independent farmers went bankrupt and had to take a job in a factory, or have his farm become a corporate farm, while he became a tenant-farmer on the land that he and his forefathers had owned for untold generations.

But this is only part of the story! Little by little, these corporate style collective farmers in the United States have been encouraged to hire illegal aliens to work our land. This is a problem, as only Adam-man was commissioned to till the ground, and was created by Yahweh specifically for that purpose at:

Satan's Secret Agents

Let's begin by considering the corrosive work of the Frankfurt School: a group of German-American scholars, mostly Jewish, who developed highly provocative and original perspectives on contemporary society and culture, drawing on Hegel, Marx, Nietzsche, Freud, and Weber.

Their idea of a “cultural revolution” was not particularly new. Joseph, Comte de Maistre (1753-1821), who for fifteen years had been a Freemason, had this to say: “Until now, nations were killed by conquest, that is by invasion. But here an important question arises: can a nation not die on its own soil, without resettlement or invasion, by allowing the flies of decomposition to corrupt to the very core those original and constituent principles which make it what it is?”

What was the Frankfurt School?

Well, in the days following the Bolshevik Revolution in Russia, it was believed that a Workers' Revolution would sweep into Europe and, eventually, into the United States. It failed to do so. Towards the end of 1922, the Communist International (Comintern) began to consider the reasons for this failure.

On Lenin's initiative, a meeting was organized at the Marx-Engels Institute in Moscow. The aim of the meeting was to throw light on the meaning of Marx's Cultural Revolution. What did “cultural revolution” entail? What was it all about?

First amongst those present, was Georg Lukács, a Jewish Hungarian aristocrat and son of a banker. He had become a Communist during World War I. A good Marxist theoretician, he had developed the idea of

LD: The fact that they spoke very poor English was no disqualification. They were Jewish, and so they managed to obtain prestigious academic appointments through Jewish influence, i.e., through networking — a system that works exceptionally well even today and which accounts for the huge and unfair preponderance of Jews in academia.

The School included among its members the 1960s guru of the New Left Herbert Marcuse — denounced by Pope Paul VI for his theory of liberation which "opens the way for [sexual] licence cloaked as liberty" — Max Horkheimer, Theodor Adorno, the popular writer Erich Fromm, Leo Lowenthal, and Jurgen Habermas. All these individuals except Habermas were of Jewish origin.

Basically, the Frankfurt School believed that as long as an individual had the belief — or even the hope of belief — that his divine gift of reason could solve the problems facing society, then that society would never reach the state of hopelessness and alienation that they considered necessary to provoke a socialist revolution.

Their task, therefore, was as swiftly as possible to undermine the "Judeo-Christian legacy."

LD: "Judeo-Christian" is an oxymoron, a contradiction in

terms, given that Judaism and Christianity are at opposite ends of the religious spectrum. Since most Jews are actively hostile to Christianity, and since Talmudic Jews actually take pleasure in the thought of Christ being boiled in excrement in hell, to speak of the “Judeo-Christian legacy” is clearly nonsensical.

To undermine Western civilization, the Frankfurt School Jews called for the most negative and destructive criticism possible of every sphere of life. To de-stabilize society and bring it to its knees, to engineer collapse, to produce crisis and catastrophe — this became the aim of these maladjusted and mentally sick Jewish revolutionaries masquerading as high-powered intellectuals.

Their policies, they hoped, would spread like a virus — “continuing the work of the Western Marxists by other means”, as one of their members noted.

To further the advance of their “quiet” cultural revolution, the Frankfurt School made the following twelve recommendations — all of them calculated to undermine the foundations of society and create the dystopia we now see all around us:

1. The creation of racism offences and hate speech laws.
2. Continual change to create confusion (e.g., in school curricula).
3. Masturbation propaganda in schools, combined with the homosexualization of children and their corruption by exposing them to child porn in the classroom.
4. The systematic undermining of parental and teachers’ authority.
5. Huge immigration to destroy national identity and foment future race wars.
6. The systematic promotion of excessive drinking and recreational drugs.
7. The systematic promotion of sexual deviance in society.
8. An unreliable legal system with bias against the

victims of crime.

9. Dependency on state benefits.

10. Control and dumbing down of media. (Six Jewish companies now control 96 percent of the world’s media. LD).

11. Encouraging the breakdown of the family.

12. All all-out attack on Christianity and the emptying of churches.

LD: In the Soviet Union, under Stalin and his Communist Jews, the emptying of churches was accomplished by the simple expedient of burning the churches down—thousands of them—and building synagogues instead. See *The Communist Nations Since 1917*, chapter 3, by Anna M. Cienciala (<http://web.ku.edu/~eceurope/>)..

Coincidentally, most of these same aims and

objectives were set out prominently in the pages of that alleged “forgery”, The Protocols of the Elders of Zion. The Jewish philosophers of the Frankfurt School, it seems, had been heavily influenced by the Protocols. They were clearly impressed by what they read there and decided to implement its recommendations in their own sinister agenda.

One of the main ideas of the Frankfurt School was to exploit Freud’s idea of “pansexuality”: the search for indiscriminate sexual pleasure, the promotion of “unisex”, the blurring of distinctions between the sexes, the overthrowing of traditional

relationships between men and women, and, finally, the undermining of heterosexuality at the expense of homosexuality — as, for example, in the idea of “same-sex marriage” and the adoption of children by homosexual couples.

Willi Münzenberg summed up the Frankfurt School’s long-term operation thus: “We will make the West so corrupt that it stinks.”

“We must organise the intellectuals and use them TO MAKE WESTERN CIVILIZATION STINK! Only then, after they have CORRUPTED ALL ITS

VALUES AND MADE LIFE IMPOSSIBLE, can we impose the dictatorship of the proletariat.” (Emphasis added)

LD: According to Sean McMeekin’s *The Red Millionaire: A political biography of Willi Munzenberg*, MUnzenberg was “the perpetrator of some of the most colossal lies of the modern age.... He helped unleash a plague of moral blindness upon the world from which we have still not recovered.”

The Frankfurt School believed there were two types of revolution: (a) Political revolution and (b) Cultural revolution. They were more concerned with cultural revolution, the demolition of the established order from within. “Modern forms of subjection are marked by mildness”, they taught. So-called “reforms” were to be made so slowly and subtly that these changes for the worse were barely perceptible. The School saw the undermining of the social order as a long-term project.

LD: The systematic erosion of Christian moral values and the promotion of sexual perversion is known as cultural Marxism. Today, thanks to the efforts of organized Jewry which controls 96 percent of the world’s media, cultural Marxism has largely triumphed and Christianity lies in ruins. To many dispassionate observers, society has now reached its rockbottom moral nadir — as Jewish Marxists such as Willi Munzenberg (see quote above) would have been only too happy to witness — had he been around today.

These iconoclasts kept their sights firmly fixed on the family, education, media, sex and popular culture. Each of these would be their target. If things did not go from bad to worse, year after year, they were not succeeding. To these revolutionary Jewish thinkers, bad was good — and worse was better.

The Destruction of the Family and the Promotion of Feminism

The School’s Critical Theory preached that the “authoritarian personality” was a product of the patriarchal family — an idea directly linked to Engels’ *Origins of the Family, Private Property and the State*,

which promoted matriarchy.

Already Karl Marx had written, in the *Communist Manifesto* (1848), about the radical notion of a “community of women”. In *The German Ideology* (1845), he had written disparagingly about the idea of the family as the basic unit of society. This was one of the basic tenets of the Critical Theory: the need to break down the family unit.

LD: All families were essentially evil, these thinkers believed — even happy families — so they had to be destroyed. It was better if children had no parents, or did not know who their parents were. Or if they were orphans of the state. It was better if romantic love between the sexes, leading to stable long-term marriages, were destroyed in favor of short-term, unstable, promiscuous relationships. After all, the former might lead to happiness for all concerned, and that was clearly impermissible — for the whole point of the Cultural Revolution was “to create a culture of pessimism” (Lukacs) and “to make life impossible for everyone.” (Munzenberg).

The Institute scholars therefore preached that “Even a partial breakdown of parental authority in the family might tend to increase the readiness of a coming generation to accept social change.”

LD: These neo-Freudian Marxist philosophers of the Frankfurt School were clearly out to create trouble: to drive a wedge between parent and child and sow division in the family. Whatever was good in human relationships simply had to be destroyed. If people didn’t have problems, then problems would have to be manufactured “to make life impossible.” (Munzenberg).

All this prepared the way for the warfare against the masculine gender promoted by Marcuse under the guise of “Women’s liberation” and by the New Left movement in the 1960s. They proposed transforming our culture into a female-dominated one.

LD: The idea that women should run society and wear the trousers, telling men what to do, had an enormous appeal to certain bossy types of women with a surplus of testosterone,

particularly to butch lesbians and man-hating matriarchs. Many of these misguided females were to become evangelists for radical Feminism, some even proposing to cut themselves off from the male sex completely and live in communes of their own. Curiously enough, the number of Jewish feminists is huge —out of all proportion to their percentage in the population.

In 1933, Wilhelm Reich, an honored and adulated member of the Frankfurt School, wrote in *The Mass Psychology of Fascism* that matriarchy was the only genuine family type of “natural society.” He was, as such, to be an inspiration to the feminists.

LD: Reich, incidentally, a compulsive masturbator and sexual pervert, had entertained incestuous longings for his own mother and practiced bestiality with horses while still a child. (See *Masters of Porn: The Systematic Promotion of Sexual Deviance* by Dr. Lasha Darkmoon at theoccidentalobserver.net).

This versatile sexual deviant, now a cult figure on the left, along with the equally sex-obsessed Herbert Marcuse —popularizer of the slogan **MAKE LOVE, NOT WAR**— were to be godfathers of the Sexual Revolution of the 1960s as well as the patron saints of the Feminist movement.

The Indoctrination of Children through Education

Bertrand Russell was to join the Frankfurt School in their efforts at mass social engineering. He spilled the beans in his 1951 book, *The Impact of Science on Society*. He wrote:

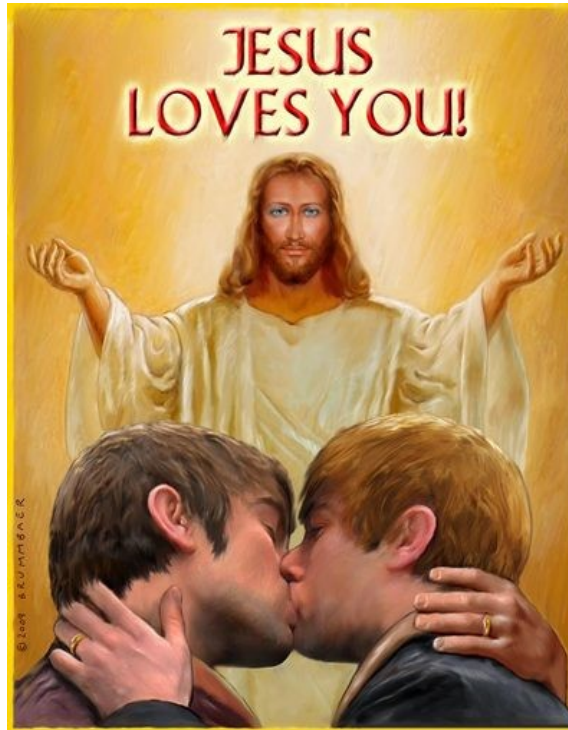
The social psychologists of the future will have a number of classes of school children on whom they will try different methods of producing an unshakable conviction that snow is black. Various results will soon be arrived at. First, that the influence of home is obstructive. Second, that not much can be done unless indoctrination begins before the age of ten. Third, that verses set to music and repeatedly intoned are very effective. Fourth, that the opinion that snow is white must be held to show a morbid taste for eccentricity.

But I anticipate. It is for future scientists to make these

maxims precise and discover exactly how much it costs per head to make children believe that snow is black, and how much less it would cost to make them believe it is dark gray.

When the technique has been perfected, every government that has been in charge of education for a generation will be able to control its subjects securely without the need of armies or policemen.

LD: The irony is unmistakable, but that is beside the point. Russell was all for turning the world upside down and ushering in *Brave New World*: atheism, feminism, and “sexual liberation” i.e., the green light to promiscuity, perversion, and abortion on demand.



The devaluation of values so sought after by the luminaries of the Frankfurt School has now largely been achieved through sex education and media propaganda: in particular, by the promotion of masturbation, pornography, and the systematic high pressure salesmanship of homosexuality in schools.

LD: This, then, is the secret agenda of organized Jewry as represented by the Cultural Marxists of the Frankfurt School: the destruction of traditional values, the destruction of the moral order, the destruction of the family unit, the destruction of religion, the destruction of meaning and purpose, and, finally, the destruction of happiness itself.

These are the people who now rule over us. They are in control. They create new wars with the same rapidity that a stage magician pulls rabbits from a hat. And they make sure that the people they rule over, their subject populations, are either demoralized debt slaves in insecure jobs or unemployed bums living on state benefits and a diet of junk food and sleazy junk entertainment laid on by the Jews.

Satan’s Secret Agents have been only too successful in creating a New World Order that bears a remarkable resemblance to hell.

HITLER THE VOTE WINNER

75 Million Germans say "YES" to One Nation, One People, One Leader.

"No democratic Government in the world can submit itself to a popular vote in greater trust and with greater confidence than can the National Socialist Government of Germany." ~

Adolf Hitler, 30th January, 1935.

The election on July, 31st, 1932 was a victory for the National Socialists. They polled 13,574,000 votes and with 38% of the total votes cast legitimately and democratically became the largest Party in the Reichstag with 230 seats. The Social Democrats had 133 seats and the Communists 89. On January 30th, Adolf Hitler was appointed Chancellor of Germany.

At the polls of March, 5th, the NSDAP polled 17,277,180 votes; an increase of 5.5 million bringing their voting percentage up to 44%, which when placed in coalition with the Nationalists led by Franz von Papen and Alfred Hugenberg who had polled 3,136,760 votes, showed an overwhelming majority of Germans had in free and open elections made their preference for German nationalism clear.

Immediately after his appointment as Chancellor, Adolf Hitler, in his first appeal to the German nation on February, 1st, 1933, asked to be allowed just four years in order to carry out the task of national reconstruction. He repeated the same request when a few days later, when at a speech in the Berlin Sportpalast, he said:

"During fourteen years the German nation has been at the mercy of decadent elements which have abused its confidence. During fourteen years those elements have done nothing but destroy, disintegrate and



dissolve. Hence it is neither temerity nor presumption if, appearing before the nation today, I ask: German nation, give us four years time, after which you can arraign us before your tribunal and you can judge me!

"Allow me four years, and I swear to you, as truly as I have now undertaken my duties, I will depart. It is not for any

reward or benefit that I have taken office, but only for your sake. It has been the greatest decision of my whole life.

"I cannot rid myself of my faith in my people, nor lose the conviction that this people will resuscitate again one day. I cannot be severed from the love of a people that I know to be my own. And I nourish the conviction that the hour will come when millions of men who now curse us will take their stand behind us to welcome the new Reich, our common creation born of a painful and laborious struggle and an arduous triumph ~ a Reich which is the symbol of greatness, honour, strength, honesty and justice."

True to his word, on March 29th, 1936, the German nation was given as promised the opportunity to express their approval or disapproval of the National Socialist state. It was an entirely free election without fear or intimidation with adequate provision made for monitoring by neutral observers.

THE OUTCOME

Total qualified votes: 45,453,691

Total votes cast: 45,001,489 (99%)

Votes 'no' or invalid: 540,211

Votes for Hitlers NSDAP: 44,461,278 (98.8%)

Small wonder that of all the books written and documentaries produced on the Third Reich, none

dare to publish facts such as these. As someone wisely said; 'history is the propaganda of the victors.'

GOVERNMENT BY THE PEOPLE

The National Socialist electoral system was not based on the parliamentary system but was nonetheless democratic. Of the parliamentary system of government, Hitler was scathing:

"... a turbulent mass of people, all gesticulating and bawling against one another, with a pathetic old man shaking his bell and making frantic efforts to call the House to a sense of dignity by friendly appeals, exhortations and grave warnings. I could not refrain from laughing." ~ Adolf Hitler, Mein Kampf, p. 53
"Several weeks later I paid a second visit. This time the house presented an entirely different picture, so much so that one could hardly recognise it as the same place. The hall was practically empty. They were sleeping in the other rooms below. Only a few deputies were in their places, yawning in each other's faces. One was speechifying. A Deputy Speaker was in the chair. When he looked round it was plain that he felt bored." ~ Adolf Hitler, Mein Kampf, p. 53
"As a contrast to this kind of democracy we have the German democracy, which is a true democracy; for here a leader is freely chosen and is obliged to accept full responsibility for all his actions and omissions. The problems to be dealt with are not put to the vote of the majority; but they are decided upon by the individual, and as a guarantee of responsibility for those decisions he pledges all he has in the world and even his life." ~ Adolf Hitler, Mein Kampf, p.61

The National Socialist system of government was largely based on referenda in which the really important issues of the day were debated and voted upon by the German people. When, for instance, Adolf Hitler felt it necessary to prove the German nation's sincerity in its peaceful intentions, he called for an election combined with a plebiscite (referendum) that stated:

"It is not for my own sake that I asked for this national vote, but for the sake of the German people. It is not I who require such a vote of confidence to strengthen and sustain me; it is the German people who require a Chancellor supported by such confidence before the

world. For I am nothing my fellow- countrymen, but your mouthpiece, and do not wish to be anything but the representative of your life and the defender of your vital interests." ~ Adolf Hitler.

"The German Government and the German nation are united in the sincere wish to examine and solve dispassionately, by means of negotiations, all pending questions with all other nations, including Germany's former adversaries. The German Government and the German nation are prepared to conclude long term continental pacts of non-aggression with the object of securing peace, the economic prosperity, and the general reconstruction of Europe." Adolf Hitler

This general election and plebiscite took place on November 12th, 1933. Of a total of 43,491,575 votes recorded, 40,632,628 were cast in favour of the Government, this being a majority of 95%.

HITLER THE VOTE WINNER (THE SAAR REGION)

The Versailles Treaty deprived Germany of the Saar territory, falsely claiming as justification that the region was historically French and with a French population of 150,000. In fact, the French population was just 2,000. For every French citizen in the Saar, there were 250 Germans.

On January, 13th, 1935, two years after the election of Adolf Hitler, free elections observed by international observers were held in which the electorate were asked whether they wished to remain as French citizens or would prefer to become part of the Third Reich.

In Favour of Unification with Germany: 477,119
Those Favouring No Change: 46,513
In Favour of Remaining French: 2,124

There was a 90.5% majority in favour of reunification with Germany. Yet another election the propagandists choose to ignore for reasons transparent.

HITLER THE VOTE WINNER (AUSTRIA)

On March 13th, 1938, the Austrian Government

enacted a constitutional law concerning a plebiscite for the reunion of Austria with the Third Reich. On 18th, March, 1938, Hitler dissolved the Reichstag and announced conformity with the plebiscite which was announced on April, 10th, 1938. The peoples of both nations were to be given the opportunity to decide for or against unification with Hitler's Germany.

Coincidentally, on the very day I include this relevant quotation (31st, January, 1993), 54 years on from the Fuhrer's recommendation, the Czech and Slovak people of their own free will took Hitler's advice and separated themselves from each other, amidst much rejoicing. During the same period (1939) Lord Halifax warned that Hitler intended to establish an independent Ukrainian state.

Is it not interesting that these paragons of the democratic process and signatories of the Atlantic Charter, who had set themselves up as the guarantors of small nations' independence, should have been so alarmed when that Czechs, Slovaks, Ukrainians and others too, opted for independence. How ironic also that this was Adolf Hitler's advice.

"There has never been a government in Germany which had a better right to claim that it represented the broad masses of the people than has the National Socialist Government. The elections held on November, 12th, 1933, when 95% of the valid votes recorded by the German people were given for Herr Hitler and his policy, proved that the German people unanimously back the German Government." Dr. Joseph Goebbels

THE ECONOMIC MIRACLE

The following figures are typical of the increase in German production, progress and living standards between 1932 and 1937, and are taken from a three hour reported address by the German Chancellor.

"In 1932, before National Socialism acquired power, the German national income amounted to 45.2 milliard Reichsmarks. . . and in 1937 reached the round figure of 68 milliard Reichsmarks. In contrast to this increase in income the general cost of living index remained practically unchanged. In other words, while

the national income increased by nearly 50% the increase in the general cost of living rose by only 4%."

Five years of National Socialist industrial and economic activity show that:

Paper manufacture has increased by 50%

Manufacture of diesel oil has increased by 66%

Production of coal has increased by 68%

Production of oil fuel has increased by 80%

Production of mineral oil has increased by 90%

Production of artificial silk has increased by 100%

Production of Kerosene has increased by 110%

Production of steel has increased by 167%

Production of lubricating oil has increased by 190%

Production of petrol/ motor fuels increased by 470%.

Aluminium production by 570% and the production of Zellwoille by 2,500%."

"We have been successful in increasing our foreign trade in imports from 4.2 to 5.5 milliard Reichsmarks and in exports from 4.9 milliard in 1933 to 5.9 milliard Reichsmarks in 1937."

"After the USA, Germany today is once more the leading steel producing country in the world." ~ Adolf Hitler

THE FOLLOWING NUMBER OF VEHICLES WERE LICENSED:

ROADS: "For the maintenance and development of German roads, including the super highways, the following sums have been spent.

1932: 440 million Reichsmarks
1933: 708 million Reichsmarks
1935: 1325 million Reichsmarks
1937: 1450 million Reichsmarks

"... the displacement of earth by far exceeds the building achievement of the Panama Canal."

"The following large bridges were built. 6 bridges over the Rhine, 4 over the Elbe, 2 over the Oder, 3 over the Danube, 1 over the Weser, and 1 over the Pregel. In addition, 3,400 further bridges were built in connection with the superhighways."

"Every year a thousand kilometres of motor-roads will be opened until the greatest work in the history of mankind is completed." (Adolf Hitler)

"340,000 houses were built in 1937 ~ twice the number built in 1932. Altogether 1,400,000 houses have been put on the housing market since the National Socialists acquired power.

"In 1932, only 19 out of every 1,000 people in Germany owned cars as compared with 41 in France and 37 in Great Britain; today, however, the figure for Germany is 35 in every 1,000 as compared with 51 per 1,000 in France and Great Britain.

"Total industrial production in Germany is today 144% greater than in 1932. Even the peak year of 1929 was exceeded as early as 1936, while today about 30% more industrial goods are produced than in 1929. The production of capital goods has risen much more strongly than has the production of consumption goods, being now four times as great as in 1932 and

more than one and a half times as great as 1929.

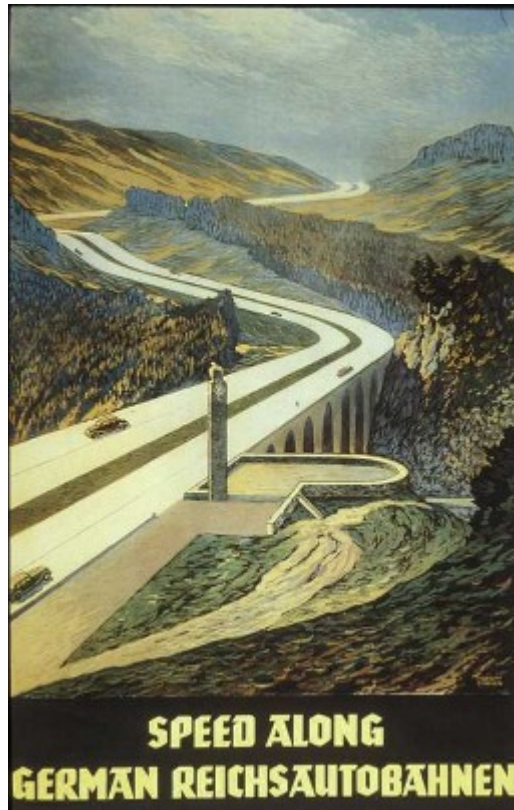
"Progress in the field of domestic raw material production has been even greater. Iron ore production has risen from an average of 843,000 metric tons for the first three months of 1932 to 1,226,000 metric

tons in the first three months of 1938. This means an increase of 45%. Furthermore there has been great progress in domestic oil production. In 1938, staple fibre production has reached 155,000 metric tons as compared with 5,400 metric tons in 1933 and 102,000 metric tons in 1937."

(Adolf Hitler)

"In the sphere of economic life all action must be governed by one law; capital serves industry, and industry serves the people." ~ Adolf Hitler

"German economic salvation has been brought about solely through the efforts of the German people and the experience they have gained. Countries abroad have contributed nothing to this." Adolf Hitler



"Germany's economic salvation was due solely to the nation's own efforts under its own leadership." - Adolf Hitler

"We have made it possible, without gold and without foreign exchange, to maintain the value of the German mark. Behind the German mark stands the German capacity for work, while some foreign countries, suffocated by gold, have been compelled to devalue their currencies." (Adolf Hitler)

"Today in May, 1938, the world around us suffers from the anxiety which the unemployment of millions brings with it. In Germany we begin to be anxious because we have not enough workmen." (Adolf Hitler)

CRUSH THE COMPETITION

Germany's reduced dependency upon imports and its phenomenal increase in productivity and exports provided Germany with an economic and social advantage with which neither Britain, the USA and the USSR could compete. Furthermore, severe social deprivation, the effect of the Great Depression, social unrest and economic uncertainty in these countries were in contrast to Germany which was experiencing an economic and social miracle. Germany had to be destroyed.

Hitler was well aware that Britain and America would seek to resolve their problem by initiating a trade war that would destroy Germany and grab its markets.

"The war was not just a matter of the elimination of Fascism in Germany, but rather of obtaining German sales markets." (Winston Churchill. Fulton. March 1946)

Hitler said that he understood that Germany's economic prosperity caused problems, and put forward a proposal that soon, after steps being taken for mutual disarmament. There would be an exchange of opinions on the economic situation in Europe.

"Britain was taking advantage of the situation to go to war against Germany because the Reich had become too strong and had upset the European balance." (Ralph Franklin Keeling)

ON WAR BEING DECLARED

"Uneasiness ruled in the House of Commons. A delegate of the Labour Party met with the British Foreign Minister Halifax on September 2nd, (1939) in the lobby of Parliament. 'Do you still have hope?' he asked. 'If you mean hope for war,' answered Halifax, 'then your hope will be fulfilled tomorrow.' 'God be thanked!' replied the representative of the British Labour Party. (Professor Michael Freund)

"In Britain, Lord Halifax was reported as being 'redeemed'. . . "He ordered beer. We laughed and joked." (H. Roth. Are We Being Lied To?)

"Germany is too strong. We must destroy her." (Winston Churchill, Nov. 1936 to US General Wood.)

"I believe now that Hitler and the German people did not want war. But we declared war on Germany, intent on destroying it, in accordance with our principle of balance of power, and we were encouraged by the Americans' around Roosevelt." (Sir. Hartley Shaw cross. British Attorney General)

INTERNATIONAL TRADE

"You will be visiting Japan, where goods that are flooding the world's markets are being manufactured under entirely different labour conditions. That will, one day also apply to Russia. The powers-that-be in Moscow will, if necessary, allow part of the populace to starve in order to maintain the export trade." (Adolf Hitler, Paris Soir, January 26th 1936)

In fact, such was the reason and result of the Ukrainian famine; artificially created by 'Uncle Joe Stalin' precisely for that purpose, the effects of which led to an estimated 30 million Russian deaths.

"I want bread and work for my people. And certainly I do not wish to have it through the operation of credit guarantees, but through permanent labour, the products of which I can either exchange for foreign goods or for domestic goods in our internal commercial circulation.

"Germany has an enormous number of men who not only want to work but also to eat. I cannot build the future of the German nation on the assurances of a foreign statesman or on any international help, but only on the real basis of steady production, for which I must find a market at home and abroad." (Adolf Hitler, Paris Soir, January 26th, 1936)

The terms of the Versailles Treaty and various other trade restriction impositions had put Germany at a trading disadvantage. Hitler's Germany however turned the tables by adopting a system of trade-barter. In this way he effectively eliminated the international financiers and fixers, corroding their influence and giving Germany the trading advantages. The German system was so obviously superior that this unfortunately made war even more inevitable.

"The Nazi phenomenon arose from the German desire to avenge the defeat of 1918 and to find a place in the

sun for the most dynamic of European nations." (Hon. Major General Khub Chand. Indian statesman and diplomat. Doenitz at Nuremberg. A re-Appraisal)

"The reproach that world trade is declining as a result of the German method of barter trade can, if it is correct at all, only be addressed to those who are to blame for this development. They are those countries who by means of their currency manoeuvres arbitrarily destroy every fixed relationship between individual currencies in accordance with their own egotistical requirements.

"In these circumstances however the German system of exchanging something that has been turned out as an honest job of work for something equally honestly produced is a far more straightforward way of doing business than by payment in foreign currency, which a year later is devalued by so much percent." (Adolf Hitler. 6th Anniversary Speech)

Joining with Samuel Untermyer in calling for a war against Germany, Bernard Baruch, at the same time, was promoting preparations for war against Germany. "I emphasised that the defeat of Germany and Japan and their elimination from world trade would give Britain a tremendous opportunity to swell her foreign commerce in both volume and profit." "It is likely that Germany's successful competition through bilateral agreements and the banking nations desire to liquidate such interest-free competition was an important factor in the United States and Britain promoting war against Germany." Sorry, No donations to whites allowed!



The work of numerous shelters like Childline would not be possible without the generosity and compassion of businesses, individuals, Department of Health and Social Development that fund them.

In terms of section 18A of the Income Tax Act, donations to Public Benefit Organizations' such as the above non-profit organisations are tax deductible and businesses used to be able to also earn points on it's BEE scorecard by donating to registered institutions like Childline. Not for long anymore if a new proposed bill is approved. Businesses could lose black economic empowerment points for making donations to charities which do not have 100 percent black beneficiaries, it was reported on Thursday. The Platinum Weekly thought it to be a hoax and immediately investigated. Yes, Ripleys believe it or not, black on white (so to speak), on the website of the DTI, a confirmation of the above mentioned. Amendments was proposed to the BEE Codes of Good Practice, on the trade and industry department's website, and available for public comment until December 2. "All stakeholders who have concerns and objections are requested to make use of the 60-day period to make their submission," the department said.

Bridget Brun, a Durban BEE agency head, told the media: "This amendment will have a huge effect. It means that if the charity benefits any Indian, white, coloured or even a Mozambican or Zimbabwean

child, companies will not be able to claim points on their BEE scorecard. We are going to have segregated facilities." Childline head Joan van Niekerk said BEE laws were becoming ridiculous.

"We don't know the race of the child who phones us. It's inappropriate to ask, 'Are you black, and how black are you?' *This is a different kind of apartheid.*"



Durban - Charities could face ruin over a government proposal that firms could lose black economic empowerment (BEE) points if they donate to charities that do not have 100 percent black beneficiaries.

Some charities believe the proposal means that any firm that donates to a charity that helps a white, coloured or Indian person may not be able to claim points for its BEE scorecard. It could also mean that if just one white child or

person is among a group of black people the charity is helping, the firm that donates to it could lose its points.

A BEE scorecard is used by the government to measure a company's BEE compliance. Those that comply do business more easily with other companies also wanting to increase their scorecard and are favoured by the government in all aspects relating to business.

The hypocrisy of the Jewish-controlled media in America and around the globe is startling, and we do not understand how the general masses can miss it.

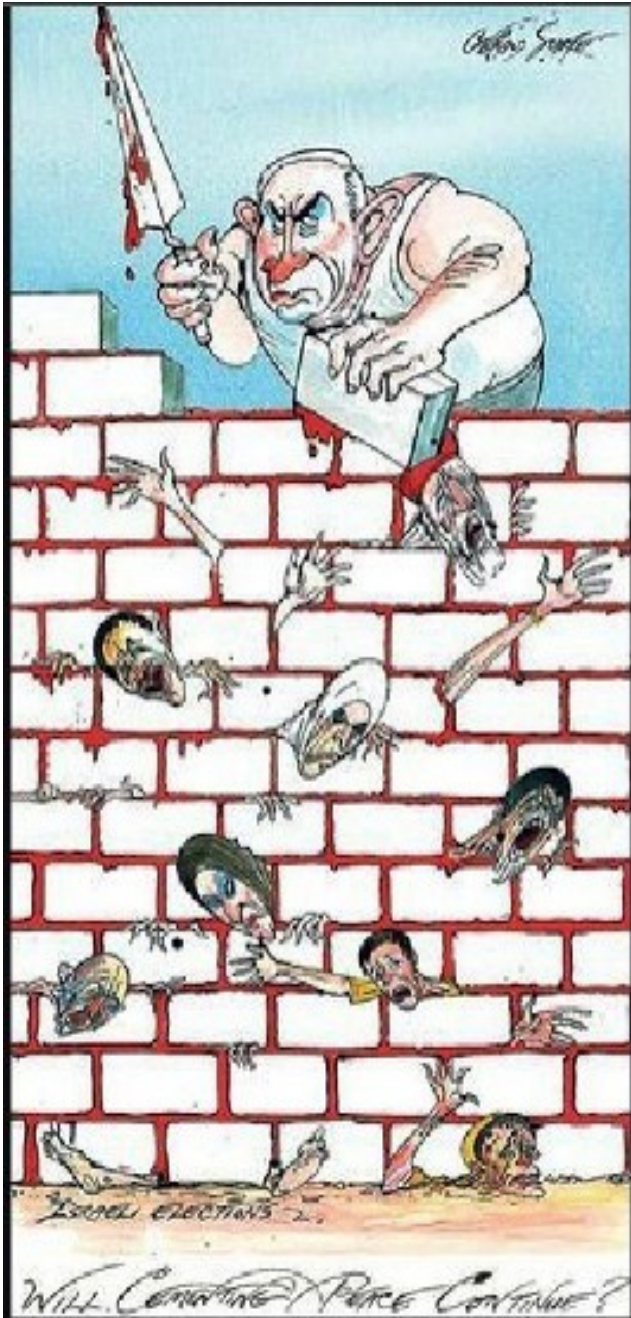

Gardasil Destroys Girl's Ovaries

It should have been Predicted

A huge array of terrible effects have been attributed to Gardasil. They were predictable—and we're likely to see many more over the next few years. Here's why it could, and should, have been predicted.



As noted in Gaia Health [Gardasil Destroys Girl's Ovaries: Research on Ovaries Never Considered](#), the *BMJ* has published the case report of a healthy 16-year-old Australian girl whose womanhood appears to have been stolen by Gardasil vaccinations. She became fully menopausal, her ovaries irrevocably shut down, *without experiencing womanhood**. That article focuses on the fact that Merck, Gardasil's developer, had to be aware of potential harm to ovaries and either hid research documenting it or simply didn't do it.

This article focuses on the how readily so many Gardasil disorders could—and should—have been predicted, simply by examining the known effects of two ingredients.

The article, [Premature ovarian failure 3 years after menarche in a 16-year-old girl following human papillomavirus vaccination¹](#), draws direct attention to three primary facts:

- The girl has been thoroughly examined and tested. There is no known explanation other than the series of three Gardasil vaccinations she had.
- Ovarian death—premature menopause—is generally believed to result from an autoimmune disorder.
- They were unable to obtain data on the

histology of rat ovaries resulting from the Human Papillomavirus Quadrivalent Vaccine (Gardasil), though it was performed on rat testes and made available.

These three facts are chilling, but further examination has shown that there's even worse. Adverse effects like premature menopause—and worse—could, and should, have been predicted.

Two Risky Ingredients

Gardasil contains two ingredients that are known to cause some of the damage that is now being seen. They are polysorbate 80 (brand names Tween 80, Alkest, and Canarcel) and L-histidine. Polysorbate 80 has been shown in at least one study to do great harm to female reproductive organs. The risk from L-histidine is more subtle, as its absence is the issue, but it's likely more pervasive. The mechanism that would cause a lack of L-histidine is explained.

Polysorbate 80

Polysorbate 80 is known to cause damage to female rats' reproductive system², and there is no reason to believe that the human reproductive system is spared. [Delayed effects of neonatal exposure to Tween 80 on female reproductive organs in rats](#) from NCBI states:

Treatment with Tween 80 accelerated maturation, prolonged the oestrus cycle, and induced persistent vaginal oestrus. The relative weight of the uterus and ovaries was decreased relative to the untreated controls. Squamous cell metaplasia of the epithelial lining of the uterus and cytological changes in the uterus were indicative of chronic oestrogenic stimulation. Ovaries were without corpora lutea, and had degenerative follicles.

Surely it should come as no surprise that at least [one girl's ovaries were lost](#) after taking Gardasil vaccinations. It was predictable.

Polysorbate 80 can cause anaphylactic shock. A study in the *Annals of Allergy, Asthma & Immunology*³ concluded:

Polysorbate 80 is a ubiquitously used solubilizing agent that can cause severe non-immunologic anaphylactoid reactions.

The most frightening trait of polysorbate 80 may be that it crosses the blood-brain barrier and can take other substances with it. It is used for that purpose. The drugs loperamide⁴ and doxorubicin⁵ are coated with polysorbate for just this purpose—to drag them into the brain.

So what else can polysorbate 80 drag into the brain? Gardasil utilizes aluminum as an adjuvant, even though it's a dangerous neurotoxin. Injection of aluminum is associated with several neurological disorders, as is reported in [Gaia Health](#) and Sage Journal [Mechanisms of aluminum adjuvant toxicity and autoimmunity in pediatric populations](#)⁶, rheumatoid arthritis, autoimmune thyroid disease, inflammatory bowel disease, multiple sclerosis, diabetes, and autism may all be associated with aluminum adjuvants in vaccines.

Can polysorbate open the blood-brain barrier to let aluminum in? No one really knows because no one has looked. There is, though, no legitimate reason to assume that it cannot.

Considering how significant the risks of polysorbate 80 are, surely the precautionary rule should be applied before mass vaccinations of girls. And then there's L-Histidine ...

L-Histidine

L-histidine is a precursor of histamine, which triggers the inflammation response in allergic reactions. We may think of histamine as negative, but it is, in fact, crucial for health. Though it can be excessive in the inflammatory response it triggers in allergic reactions, we wouldn't survive without the inflammation it triggers in general infections.

L-histidine is an essential amino acid with several other functions, including⁷:

- Tissue repair and growth.
- Maintaining the myelin sheath of nerves.
- Production of both red and white blood cells.
- Production of histamine, carnosine, and anserine.
- Acting as an antioxidant.
- Stimulating gastric secretions.
- Sexual arousal and orgasm in women.
- Acting as a neurotransmitter.
- Stimulating secretion of pepsin and hydrochloric acid, making it essential in digestion.
- Circadian rhythm.

Low levels of L-histidine have been associated with rheumatoid arthritis⁷. It's required for processing and chelation of copper, zinc, cobalt, and iron^{8,9,10,11}, all of which are classed as heavy metals and noted for causing a variety of severe disorders when held in the body in excessive amounts.

Excessive amounts of these heavy metals can result in a large array of symptoms and conditions, including the milder ones of:

- Nausea
- Vomiting
- Diarrhea
- Irritable bowel
- Stomach pain
- Headache
- Sweating
- Joint pain

All of these symptoms are frequently reported by girls who are given the Gardasil vaccine. The question is: How do these symptoms of heavy metal intoxication relate to L-histidine in Gardasil? L-histidine is a necessary amino acid. It's normally found in the body.

All of these symptoms are related to inadequate amounts of the substance, so how can injecting it result in less L-histidine?

It is the seemingly innocuous nature that's at issue. L-histidine is an amino acid that naturally occurs in the body. So too does squalene occur in the body naturally. It's one of a group of oils used as adjuvants. However, they are not used in vaccines for human beings, with the insane and devastating exception of squalene. They are used to induce autoimmune disorders in laboratory animals so that they can be studied for response to potential treatments for those disorders. That's why squalene is so dangerous and is clearly what's behind Gulf War Syndrome. You can read about the likely connection between squalene and Swedish and Finnish narcolepsy outbreaks at Gaia Health in [How the Flu Vaccine Causes Narcolepsy](#).

Unless otherwise demonstrated, it must be assumed that injecting L-histidine can result in an autoimmune disorder in which L-histidine is attacked by the immune system, resulting in a shortage of it and the substances requiring it for manufacture.

For example:

- Joint pain is a common complaint of girls who have been injected with Gardasil. Rheumatoid arthritis is known to be associated with low levels of L-histidine¹². Of course, low levels of L-histidine can be expected if the immune system sees it as an enemy because it's been injected. Therefore, joint pain and arthritis were predictable sequelae of Gardasil.
- Weight gain has been reported in girls who've been given Gardasil. This should have surprised no one. The hypothalamus converts L-histidine into histamine for the purpose of suppressing hunger¹³. If an autoimmune condition destroys L-histidine, then there may be inadequate histamine and weight gain is a likely result.
- Will we see an epidemic of miscarriages and birth defects in girls who don't have the

misfortune of becoming sterile from Gardasil? It seems likely, because histamine is necessary in the development of embryos and organs¹⁴.

It was entirely predictable that any bodily function that relies on L-histidine or one of the substances for which it's a precursor, including histamine, carnosine, and anserine, could be affected. It should come as no surprise that adverse effects of Gardasil include a wide range of disorders and deaths. It would have been surprising had Gardasil not produced them!



Why?

Gardasil may be the first vaccine to utilize L-histidine. The reason it's included doesn't seem to be explained anywhere. The adverse effects of polysorbate 80 are well known, especially when it's injected. Polysorbate 80's ability to bypass the blood-brain barrier is not new information; yet, it was included in this vaccine that utilizes a known neurotoxin, aluminum.

The question that must be asked is: Why? What reason could possibly exist for a vaccine that could predictably result in such incredible harm? Much of the potential damage will likely not be seen for years. Will we find that the

already-high rate of infertility skyrockets? Will those who do manage to conceive suffer the anguish of miscarriages and babies with birth defects? How many will suffer from autoimmune disorders, such as rheumatoid arthritis? How many will suffer from neurological disorders, such as the [Tourette's-like tics suffered by girls in New York](#)?

Joel Lord from The Vaccine Resistance Movement refers to Gardasil, along with Cervarix, as [A Legacy of Shame](#). We are now seeing only the beginning of the adverse effects that have likely been caused. Autoimmune disorders tend to take time to show up. It takes time before pubescent girls become sexually active. How many of them will never experience the potential of sexual intimacy because the vaccine's L-histidine has stolen their ability of sexual arousal and orgasm?

The simplest reason of all is, of course, money. Merck and its minions simply value money over anything else, including the quality of countless young women's lives. Nor do they appear to care how many will suffer early deaths. Are there other reasons? In my view, nothing could be more insidious than to willingly hide the terrible and predictable potential of a product simply to get rich. Others, though, see this as part of a conspiracy. What are your views?

What is Christian Identity?
