## Scatterers and Gatherers

Yahshua Christ links three concepts in Matthew chapter 12, which are scattering and gathering, blasphemy of the Holy Spirit, and good and bad trees. From the King James Version: “30 He that is not with me is against me; and he that gathereth not with me scattereth abroad. 31 Wherefore I say unto you, All manner of sin and blasphemy shall be forgiven unto men: but the blasphemy *against* the *Holy* Ghost shall not be forgiven unto men. 32 And whosoever speaketh a word against the Son of man, it shall be forgiven him: but whosoever speaketh against the Holy Ghost, it shall not be forgiven him, neither in this world, neither in the *world* to come. 33 Either make the tree good, and his fruit good; or else make the tree corrupt, and his fruit corrupt: for the tree is known by *his* fruit.”

In another place Yahshua again mentions gathering along with good and corrupt trees, where He links these with two other concepts, which are the strait gate and the false prophets who are not truly sheep but are really wolves. From Matthew 7: “13 Enter ye in at the strait gate: for wide *is* the gate, and broad *is* the way, that leadeth to destruction, and many there be which go in thereat: 14 Because strait *is* the gate, and narrow *is* the way, which leadeth unto life, and few there be that find it. 15 Beware of false prophets, which come to you in sheep's clothing, but inwardly they are ravening wolves. 16 Ye shall know them by their fruits. Do men gather grapes of thorns, or figs of thistles? 17 Even so every good tree bringeth forth good fruit; but a corrupt tree bringeth forth evil fruit. 18 A good tree cannot bring forth evil fruit, neither *can* a corrupt tree bring forth good fruit. 19 Every tree that bringeth not forth good fruit is hewn down, and cast into the fire.”

Because Christ Himself has linked these things together for us, it is not improper for us to list and evaluate all of these basic concepts in order to determine just what these symbols which He uses represent. First we shall list the concepts once more, but all together this time: 1) scattering and gathering; 2) blasphemy of the Holy Spirit; 3) the strait gate; 4) false prophets; 5) good and corrupt trees. While many men have attempted to understand these things by themselves, they can only truly be understood in relation to one another, because Yahshua Christ related these things to one another.

### 1) Scattering and gathering.

The same Yahshua Christ who said in John chapter 10 “7 Then said Jesus unto them again, Verily, verily, I say unto you, I am the door of the sheep.... 9 I am the door: by me if any man enter in, he shall be saved, and shall go in and out, and find pasture” also said in Matthew chapter 15 “I am not sent but unto the lost sheep of the house of Israel.” The same Yahshua Christ who said in John chapter 10 “ 14 I am the good shepherd, and know my *sheep*, and am known of mine” is that God Incarnate who said to the children of Israel in Amos 3:2: “You only have I known of all the families of the earth: therefore I will punish you for all your iniquities.”

The children of Israel were punished in the destruction of their ancient kingdom, being cast out from the sight of Yahweh their God and taken into captivity by the Assyrians and Babylonians. Yet Israel, the children of Israel, the seed of Israel, are promised a later regathering and a return to Yahweh their God in Christ. All of the promises of this later gathering of Israel are exclusive to Israel. For that reason the apostle Paul later writes in Romans chapter 8: “ 29 For whom he did foreknow, he also did predestinate *to be*

conformed to the image of his Son, that he might be the firstborn among many brethren. 30 Moreover whom he did predestinate, them he also called: and whom he called, them he also justified: and whom he justified, them he also glorified.” These can only be those same people of Amos 3:2, which Paul's epistles demonstrate in many other places.

Psalm 106: “47 Save us, O LORD our God, and gather us from among the heathen, to give thanks unto thy holy name, *and* to triumph in thy praise. 48 Blessed *be* the LORD God of Israel from everlasting to everlasting: and let all the people say, Amen. Praise ye the LORD.”

Psalm 107: “1 O give thanks unto the LORD, for *he is* good: for his mercy *endureth* for ever. 2 Let the redeemed of the LORD say *so*, whom he hath redeemed from the hand of the enemy; 3 And gathered them out of the lands, from the east, and from the west, from the north, and from the south.”

Isaiah 11: “12 And he shall set up an ensign for the nations, and shall assemble the outcasts of Israel, and gather together the dispersed of Judah from the four corners of the earth.”

Isaiah 43: “5 Fear not: for I *am* with thee: I will bring thy seed from the east, and gather thee from the west.”

Jeremiah 29: “14 And I will be found of you, saith the LORD: and I will turn away your captivity, and I will gather you from all the nations, and from all the places whither I have driven you, saith the LORD; and I will bring you again into the place whence I caused you to be carried away captive.”

Jeremiah 31: “10 Hear the word of the LORD, O ye nations, and declare *it* in the isles afar off, and say, He that scattered Israel will gather him, and keep him, as a shepherd *doth* his flock.”

Jeremiah 32: “37 Behold, I will gather them out of all countries, whither I have driven them in mine anger, and in my fury, and in great wrath; and I will bring them again unto this place, and I will cause them to dwell safely.”

Ezekiel 20: “34 And I will bring you out from the people, and will gather you out of the countries wherein ye are scattered, with a mighty hand, and with a stretched out arm, and with fury poured out.”

Luke 13: “27 But he shall say, I tell you, I know you not whence ye are; depart from me, all ye workers of iniquity. 28 There shall be weeping and gnashing of teeth, when ye shall see Abraham, and Isaac, and Jacob, and all the prophets, in the kingdom of God, and you yourselves thrust out. 29 And they shall come from the east, and from the west, and from the north, and from the south, and shall sit down in the kingdom of God.”

Yahweh is “... GOD which gathereth the outcasts of Israel ...” and there are no promises to gather anyone but Israel to the end-of-days gathering of Israel. Do men gather grapes of thorns, or figs of thistles? Of course they do not. Therefore since all of the promises of His regathering are exclusive to the children of Israel, it is only Israel whom the presumed gatherers are obliged to seek out. Attempting to gather anything but sheep to the sheepfold, one is not gathering with Christ, and one makes himself a scatterer rather than a gatherer. By attempting to add wolves, swine or dogs to the sheepfold, one surely causes the sheep to scatter!

Jeremiah 23: “1 Woe be unto the pastors that destroy and scatter the sheep of my pasture! saith the LORD. 2 Therefore thus saith the LORD God of Israel against the pastors that feed my people; Ye have scattered my flock, and driven them away, and have not visited them: behold, I will visit upon you the evil of your doings, saith the LORD. 3 And I will gather the remnant of my flock out of all countries whither I have driven them, and will bring them again to their folds; and they shall be fruitful and increase. 4 And I will set up shepherds over them which shall feed them: and they shall fear no more, nor be dismayed, neither shall they be lacking, saith the LORD. 5 Behold, the days come, saith the LORD, that I will raise unto David a righteous Branch, and a King shall reign and

prosper, and shall execute judgment and justice in the earth. 6 In his days Judah shall be saved, and Israel shall dwell safely: and this *is* his name whereby he shall be called, THE LORD OUR RIGHTEOUSNESS.”

## 2) Blasphemy of the Holy Spirit.

The Holy Spirit is a facet of the being of Yahweh, who demands of the children of Israel in Leviticus chapter 19 to be holy as He also is: “1 And the LORD spake unto Moses, saying, 2 Speak unto all the congregation of the children of Israel, and say unto them, Ye shall be holy: for I the LORD your God *am* holy.” The Hebrew word for *holy*, which is *qadosh* (Strong's Hebrew # 6918), means *sacred, set apart*. It's Greek equivalent is *hagios*, which more fully means *set apart for the purposes of a god* (Thayer's *Greek-English Lexicon*, Strong's Greek # 40) or *devoted to a god* (Liddell & Scott). The only people in all history who were dedicated to the purposes of Yahweh at His command were those in the loins of Isaac, and in that is the promise to Abraham, “in Isaac shall thy seed be called” (Genesis 21:12). Of these were the children of Jacob to whom the promises fell, the “vessels of mercy” of Romans chapter 9, and the children of Esau, the “vessels of destruction” of Paul's analogy which is found in that chapter. That Esau forfeited his birthright because he was a race-mixer and took wives of the daughters of Canaan is evident in the opening verses of Genesis chapter 27 (see also Hebrews 12:16), where Jacob is told that if he took a wife from the women of his own kinfolk that the promises to Abraham would fall upon him, and so he did.

For the children of Israel, this holiness which they obtained through Isaac is reinforced in Exodus chapter 19, where it is a part of the terms of the Old Covenant: “5 Now therefore, if ye will obey my voice indeed, and keep my covenant, then ye shall be a peculiar treasure unto me above all people: for all the earth *is* mine: 6 And ye shall be unto me a kingdom of priests, and an holy nation. These *are* the words which thou shalt speak unto the children of Israel.”

A *holy nation* in Biblical terms means a nation set apart for the purposes of Yahweh God, separated from all other nations. Therefore Peter, knowing that his intended audience was the children of those same Israelites dispersed in antiquity, and knowing that this plan of God's for the children of Israel had not changed with the New Covenant (i.e. Jeremiah 31:31-37, Matthew 15:24), makes a direct appeal to the words of God at both Exodus 19:5-6 and Hosea 1:10, a prophecy which also concerns the children of Israel exclusively. This is found in his first epistle, in 1 Peter chapter 2: “9 But ye *are* a chosen generation, a royal priesthood, an holy nation, a peculiar people; that ye should shew forth the praises of him who hath called you out of darkness into his marvellous light: 10 Which in time past *were* not a people, but *are* now the people of God: which had not obtained mercy, but now have obtained mercy.”

Therefore blasphemy of the Holy Spirit, which in Matthew chapter 12 Yahshua Christ connects to both scattering and gathering and the making of a tree good or corrupt, must mean speaking against the command that Israel be a holy and separate people.

## 3) The strait gate.

Yahshua Christ is the door of the sheep. He only came for the sheep. No one gets to the Father except through Him. Of course, He was not talking to anyone but Israel when He spoke this parable, so no one else was ever a candidate: for Israel alone has the promises of redemption and salvation mentioned throughout the Bible. The City of God described in the Revelation has on its gates the names of the twelve tribes of the children of Israel. The gate is strait indeed.

## 4) False prophets.

There are two different types of false prophets described by Paul: wolves among the sheep seeking to devour the flock, and sheep seeking to make their own way. This is found in Acts chapter 20: “28 Take heed therefore unto yourselves, and to all the flock, over the which the Holy Ghost hath made you overseers, to feed the church of God, which he hath purchased with his own blood. 29 For I know this, that after my departing shall grievous wolves enter in among you, not sparing the flock. 30 Also of your own selves shall

men arise, speaking perverse things, to draw away disciples after them.” Here Christ warns about wolves in sheep's clothing, seeking to devour the sheep. It is the averred purpose of Yahshua Christ to gather Israel. Wolves seek to enter the sheepfold in order to rob the sheep.

Yahshua Christ linked the false prophets who are inwardly ravening wolves to those who would gather grapes from thorns, or figs from thistles, in Matthew chapter 7. Therefore the false prophets would be those universalists who would insist upon gathering something other than sheep to the sheepfold. These are those who would cause the scattering and destruction of the sheep. Christ never told His followers to feed anything but sheep. They are not wolves, dogs, goats, pigs or swine who are fed and then somehow become sheep. That concept is found nowhere in Scripture! Rather, they must be sheep in the first place, and then they may be fed.

Following His resurrection, Yahshua told Peter three times that if he loved Him, he must feed His sheep, as it is recorded in John 21:15, 16 and 17. The story of the Israelites as the sheep of Yahweh God goes back into the Old Testament, and therefore no one else but Israel could be His sheep.

Psalm 74: “1 (A Maschil of Asaph) O God, why hast thou cast *us* off for ever? *why* doth thine anger smoke against the sheep of thy pasture? 2 Remember thy congregation, *which* thou hast purchased of old; the rod of thine inheritance, *which* thou hast redeemed; this mount Zion, wherein thou hast dwelt. 3 Lift up thy feet unto the perpetual desolations; *even* all *that* the enemy hath done wickedly in the sanctuary. 4 Thine enemies roar in the midst of thy congregations; they set up their ensigns *for* signs.”

Jeremiah 50: “17 Israel *is* a scattered sheep; the lions have driven *him* away: first the king of Assyria hath devoured him; and last this Nebuchadrezzar king of Babylon hath broken his bones. 18 Therefore thus saith the LORD of hosts, the God of Israel; Behold, I will punish the king of Babylon and his land, as I have punished the king of Assyria. 19 And I will bring Israel again to his habitation, and he shall feed on Carmel and Bashan, and his soul shall be satisfied upon mount Ephraim and Gilead.”

Ezekiel 34: “1 And the word of the LORD came unto me, saying, 2 Son of man, prophesy against the shepherds of Israel, prophesy, and say unto them, Thus saith the Lord GOD unto the shepherds; Woe be to the shepherds of Israel that do feed themselves! should not the shepherds feed the flocks? 3 Ye eat the fat, and ye clothe you with the wool, ye kill them that are fed: but ye feed not the flock. 4 The diseased have ye not strengthened, neither have ye healed that which was sick, neither have ye bound up that which was broken, neither have ye brought again that which was driven away, neither have ye sought that which was lost; but with force and with cruelty have ye ruled them. 5 And they were scattered, because there is no shepherd: and they became meat to all the beasts of the field, when they were scattered. 6 My sheep wandered through all the mountains, and upon every high hill: yea, my flock was scattered upon all the face of the earth, and none did search or seek after them.”

In many other passages of both the Psalms and the prophets, the children of Israel are identified as the sheep, the lost sheep, the scattered sheep, the flock of Yahweh. Thus they also are in the New Testament, for Yahshua Christ identified them in that very manner.

Psalm 80: 1 (To the chief Musician ... A Psalm of Asaph.) Give ear, O Shepherd of Israel, thou that leadest Joseph like a flock; thou that dwellest between the cherubims, shine forth. 2 Before Ephraim and Benjamin and Manasseh stir up thy strength, and come and save us. 3 Turn us again, O God, and cause thy face to shine; and we shall be saved. 4 O LORD God of hosts, how long wilt thou be angry against the prayer of thy people? 5 Thou feedest them with the bread of tears; and givest them tears to drink in great measure. 6 Thou makest us a strife unto our neighbours: and our enemies laugh among themselves. 7 Turn us again, O God of hosts, and cause thy face to shine; and we shall be saved. 8 Thou hast brought a vine out of Egypt: thou hast cast out the heathen, and planted it. 9 Thou

preparedst room before it, and didst cause it to take deep root, and it filled the land. 10 The hills were covered with the shadow of it, and the boughs thereof were like the goodly cedars. 11 She sent out her boughs unto the sea, and her branches unto the river. 12 Why hast thou then broken down her hedges, so that all they which pass by the way do pluck her? 13 The boar out of the wood doth waste it, and the wild beast of the field doth devour it. 14 Return, we beseech thee, O God of hosts: look down from heaven, and behold, and visit this vine; 15 And the vineyard which thy right hand hath planted, and the branch that thou madest strong for thyself. 16 It is burned with fire, it is cut down: they perish at the rebuke of thy countenance. 17 Let thy hand be upon the man of thy right hand, upon the son of man whom thou madest strong for thyself. 18 So will not we go back from thee: quicken us, and we will call upon thy name. 19 Turn us again, O LORD God of hosts, cause thy face to shine; and we shall be saved.

#### 5) Good and corrupt trees.

Psalm 80 tells us that Israel is a vine planted by Yahweh. It links the sheep of Yahweh's pasture with the branches of the vine, which leads us to the last item on our list of related concepts. As the Psalm tells us, the vine is the race of people that Yahweh brought out of Egypt. Christ later said to His apostles in John 15: "5 I am the vine, ye are the branches: He that abideth in me, and I in him, the same bringeth forth much fruit: for without me ye can do nothing." The Adamic race is nothing without their God, and without keeping His commandments. And the words of Christ here are very much like that first promise of salvation to the Adamic race. It is found in Genesis chapter 3: "22 And the LORD God said, Behold, the man is become as one of us, to know good and evil: and now, lest he put forth his hand, and take also of the tree of life, and eat, and live for ever"

In the Garden of Eden there were two trees, the Tree of Life and the Tree of the Knowledge of Good and Evil. The first tree is the tree planted by Yahweh, represented by the wheat of the Parable of the Wheat and the Tares, where the second tree is represented by the tares who were sown by the devil. Adam and Eve were expelled from the Garden for their sinful interaction with the Tree of the Knowledge of Good and Evil represented by the serpent, which Revelation chapter 12 connects to the the devil and the fallen angels. The man, collectively, would be saved by grasping onto his own race, the Tree of Life, which has God as its Originator: for Adam was the son of God (Luke 3:38).

When the children of Israel were found mingling with the Canaanite races and adopting their idolatrous practices, Yahweh exclaimed in Isaiah chapter 17: "10 Because thou hast forgotten the God of thy salvation, and hast not been mindful of the rock of thy strength, therefore shalt thou plant pleasant plants, and shalt set it with strange slips:" Likewise He exclaimed in Jeremiah chapter 2: "21 Yet I had planted thee a noble vine, wholly a right seed: how then art thou turned into the degenerate plant of a strange vine unto me?" Israel taken into captivity is portrayed as a ruined vine, and also as a ruined fig tree, in several places in Ezekiel, in Joel and in Nahum.

In Matthew chapter 12, immediately after explaining that blasphemy of the Holy Spirit would not be forgiven, Yahshua Christ said "33 Either make the tree good, and his fruit good; or else make the tree corrupt, and his fruit corrupt: for the tree is known by *his* fruit." Blasphemy of the Holy Spirit is speaking against Yahweh's command of separation for the children of Israel. Yahshua related that to the *making* of the tree either good or corrupt. The only way that man can make the tree, the vine of Israel, anything is to breed and multiply. Therefore when the ancient Israelites engaged in idolatry they began race-mixing, and they set Yahweh's vine with "strange slips", or turned it into the "degenerate plant of a strange vine". From Hosea chapter 5: "7 They have dealt treacherously against the LORD: for they have begotten strange children".

These "strange slips" and the leaves of this "degenerate plant of a strange vine" are bastards. Yahweh pronounces in the Scripture at Deuteronomy chapter 23 that "2 A bastard shall not enter into the congregation of the LORD; even to his tenth generation shall he not enter into the congregation of the LORD." The phrase "tenth generation" is an allegory which means *forever*, since after ten generations a bastard is still a bastard, for there is no correcting such hybridization. Paul speaks of the chastisement of the

children of Israel in Hebrews chapter 12, and he says “8 But if ye be without chastisement, whereof all are partakers, then are ye bastards, and not sons.” Salvation is destined for sons, and not for bastards, as Paul had explained in chapter 2 of that same epistle, “ 10 For it became him, for whom are all things, and by whom are all things, in bringing many sons unto glory, to make the captain of their salvation perfect through sufferings. 11 For both he that sanctifieth and they who are sanctified are all of one: for which cause he is not ashamed to call them brethren”. A bastard is not “of one”, or it would not be a bastard. Therefore Yahshua Christ said in Matthew chapter 15, “13 ... Every plant, which my heavenly Father hath not planted, shall be rooted up.”

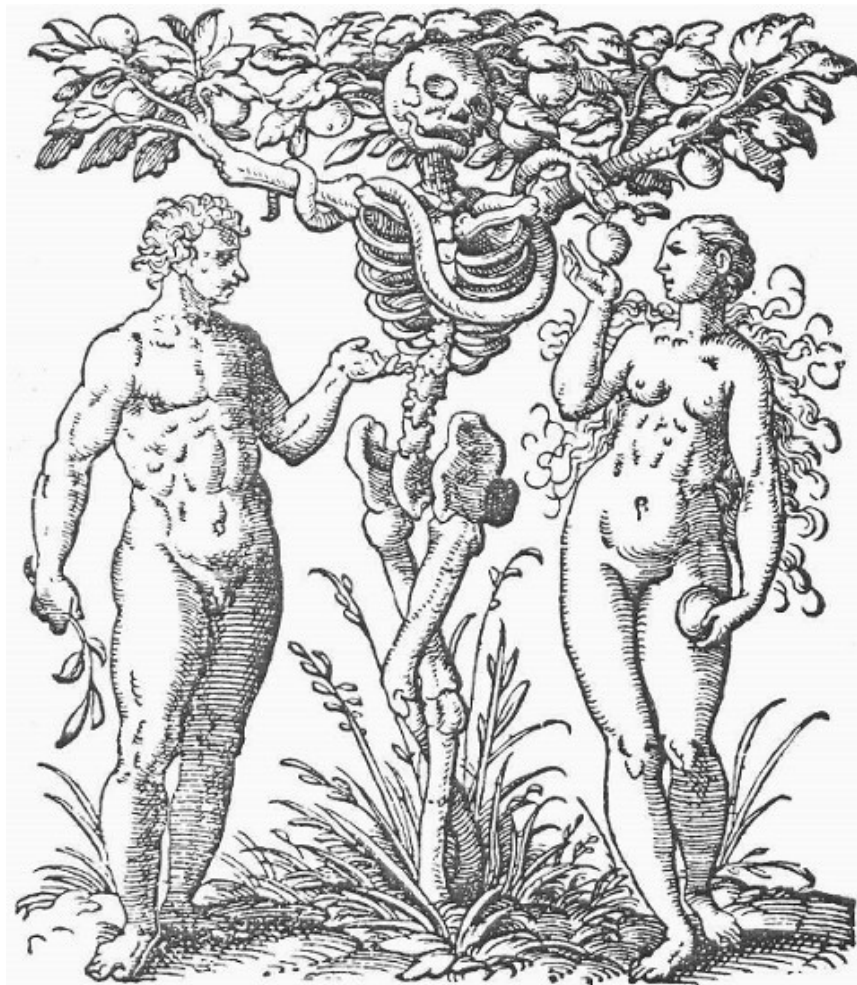
In the end, there is only one tree in the Garden of God, and its twelve fruits represent the twelve tribes of Israel. From Revelation chapter 22: “1 And he shewed me a pure river of water of life, clear as crystal, proceeding out of the throne of God and of the Lamb. 2 In the midst of the street of it, and on either side of the river, was there the tree of life, which bare twelve manner of fruits, and yielded her fruit every month: and the leaves of the tree were for the healing of the nations. 3 And there shall be no more curse: but the throne of God and of the Lamb shall be in it; and his servants shall serve him: 4 And they shall see his face; and his name shall be in their foreheads. 5 And there shall be no night there; and they need no candle, neither light of the sun; for the Lord God giveth them light: and they shall reign for ever and ever.”

Therefore, those who are truly gatherers are gathering with Christ, and they are gathering sheep. Those who do not gather with Him are scatterers, because they attempt to gather into the sheepfold something other than sheep. A scatterer is, in essence, a blasphemer of the Holy Spirit, a man attempting to gather grapes from thorns, being on the wide path to destruction by bringing wolves in among the sheep which results in the making of corrupt trees, and setting the Garden of God with strange slips.

Gatherers must not keep company with scatterers. For evil communications corrupt good manners.

**The Revelation of Yahshua Christ**  
**Chapter 21**

**XXI** **1** And I saw a new heaven and a new earth. For the first heaven and the first earth departed, and the sea is no longer.

The new heaven and earth represent a new organization of the people of God in a cleansed land. For instance Yahweh says at Ezekiel 39:12: "And seven months shall the house of Israel be burying of them, that they may cleanse the land". The sea in prophecy often represents the great mass of the world's peoples. Here the sea is no more, it no longer exists. This is the meaning of the parable of the net, found at Matthew 13:47-50: "47 Again, the kingdom of the heavens is like a net having been cast into the sea and it gathers from out of every race, 48 which when it is full, bringing up upon the shore and sitting they gather the good ones into vessels, but the rotten ones they cast out. 49 Thusly it shall be at the consummation of the age, the messengers shall go out and they shall separate the wicked from the midst of the righteous 50 and they shall cast them into the furnace of fire. There shall be weeping and gnashing of teeth!". The sea is no more, it is no longer necessary, because all the fish are removed! Therefore it is not that there are no more oceans, but rather that the word is used as an allegory. That the sea represents the mass of the world's peoples is also evident in Isaiah, at 27:1, where Yahweh says "In that day [speaking of His day of judgement, which we have here in the Revelation] the LORD with his sore and great and strong sword shall punish leviathan the piercing serpent, even leviathan that crooked serpent; and he shall slay the dragon that *is* in the sea." The dragon is world Jewry and all the other descendants of the serpent, in the sea of the world's peoples. All of these shall be cast into the Lake of Fire. An entirely



Adamic world shall be heaven indeed.

**2** And I saw a new holy city Jerusalem descending from out of heaven from Yahweh, having been prepared as a bride adorned for her husband. **3** And I heard a great voice from out of the throne, saying: "Behold! The tabernacle of Yahweh is with men, and He shall dwell with them, and they shall be His people, and Yahweh Himself shall be with them, **4** and He shall wipe every tear from their eyes, and death shall not be hereafter, nor grief, nor crying, nor toil, it shall be no longer: the former things have departed!"

Psalm 118:22 says that: "The stone which the builders refused is become the head stone of the corner. 23 This is the LORD'S doing; it is marvellous in our eyes." The builders were those original Israelites who demanded an earthly king, sinfully rejecting Yahweh as their king. Three times this passage is recorded in the New Testament as having been cited by Christ. But if He is the cornerstone, there is a need of many other stones to complete a building, which is the true temple of Yahweh. Therefore Peter likens Christians – the dispersed Israelites whom he is writing to – to living stones, at 2 Peter 2: "4 Coming forth to Him a living stone [which is Yahshua], indeed having been rejected as unfit by men but honored elect before Yahweh, 5 and yourselves as living stones are built a spiritual house for a holy priesthood to offer spiritual sacrifices acceptable to Yahweh through Yahshua Christ. Wherefore it is contained in the Scripture: 'Behold, I place in Zion an honored elect corner stone, and he believing in Him shall by no means be ashamed.'"

The true Tabernacle of Yahweh is Yahshua Christ, who is Yahweh God in the flesh of Adamic man. Leviticus 26 states: “12 And I will walk among you, and will be your God, and ye shall be my people.” He shall do that as Yahshua Christ, in the body of an Adamic man, so being, as Paul called him at Romans 8:29, “first-born among many brethren”. Ezekiel 37 states: “27 My tabernacle also shall be with them: yea, I will be their God, and they shall be my people. 28 And the heathen [or properly *nations*] shall know that I the LORD do sanctify Israel, when my sanctuary shall be in the midst of them for evermore.” Each Adamic man, therefore, having the Spirit of Yahweh, is made in the likeness and image of Yahweh. Paul wrote in Hebrews, in chapter 12: “18 For you have not approached touching a mountain and being scorched with fire, and in gloom and in darkness and in tempest, 19 and to a trumpet’s peal, and to a sound of words, which those hearing had declined, not a word to be agreed by them. 20 For they did not bear that being commanded: 'And if a beast should touch the mountain, he should be stoned.' 21 And so dreadful was that having appeared, Moses said 'I am frightened and trembling. 22 But you have approached Mount Sion and the city of Yahweh who lives, Jerusalem in the heavens, and to myriads of messengers, to a general gathering 23 and to an assembly of those first born being registered in the heavens, and to Yahweh judge of all, and to the Spirits of those righteous having been perfected; 24 and to a mediator of a new covenant of Yahshua, and to the blood of sprinkling, speaking better than Abel.” The Children of Israel, therefore, are the heavenly Jerusalem as Paul has described, the city of Yahweh from heaven, those who are “born from above”, as Christ put it in John chapter 3. Therefore He also said in the Revelation at 3:12: “He who prevails I shall make him a pillar in the temple of My God that he would no longer go outside, and I shall write upon him the Name of My God and the name of the City of My God, of the new Jerusalem which descends from heaven from My God, and My new Name.” The body politic, the people of Israel, they are the city of God.

**5 And He sitting upon the throne said: “Behold! I shall make all new things!” And He says: “Write! Because these words are trustworthy and true!”**

Save the whales, save the spotted tree owl, save the beasts, save the ozone layer: it is folly for man to think

that he – a created being – has control over this planet outside of the will of God. Men cannot save the creation of God – Yahweh shall decide that which He preserves, and that which He creates. The Greek phrase concerning new things may have been translated “Behold, I shall do all new things!”, and it is translated in that manner by Brenton in his Septuagint at Isaiah 43:19, however the Greek is not exactly the same there as it is here in the Revelation. The language does not permit that old, pre-existing things are being made new. Rather, it is stating that things not having existed before shall be created, or perhaps be done, if ποιέω is interpreted as to *do* rather than to *make*. There is also a quote of the earlier passage by Paul, who uses a different verb, at 2 Corinthians 5:17 where he says in allegory: “Therefore if one is among the number of Christ a new creation, the old things pass away. 'Behold! New things have come!’” The King James rendering is impossible, that somehow all things become new, especially in Paul's statement in 2 Corinthians, since there is only one word in the neuter gender (ἰδοὺ γέγονεν καινά) which denotes “new things” and therefore the words cannot be separated.

**6 And He said to me: “They are made! I am the Alpha and the Omega, the beginning and the end! To him who thirsts I shall give freely from out of the fountain of the water of life.**

The King James Version has the exclamation “It is done!” Rather than “They are made!”. The phrase comes from a single Greek word, γέγοναν, which is an Indicative Perfect Active 3<sup>rd</sup> Person Plural verb. It cannot possibly be “it is”, but only “they are”. This further substantiates the rendering in verse 5, “I shall make all new things” and not, as the King James Version has it, “all things new”.

This is the Revelation of Yahshua Christ. Therefore Yahshua Christ is claiming to be “the Alpha and the Omega”, as he also had at Revelation 1:8 and 1:11. This claim to be first and last belongs to Yahweh God, and Yahweh only, as is apparent at Isaiah 41:4, 44:6 and 48:12:

Isaiah 41:4 “Who hath wrought and done it, calling the generations from the beginning? I the LORD, the first, and with the last; I am he.”

Isaiah 44:6 “Thus saith the LORD the King of Israel,

and his redeemer the LORD of hosts; I am the first, and I am the last; and beside me there is no God.”

Isaiah 48:12 “Hearken unto me, O Jacob and Israel, my called; I am he; I am the first, I also am the last.”

Therefore, the only way that Yahshua Christ can claim to be the Alpha and the Omega, the beginning and the end, is for Him to be Yahweh God Himself, which of course He is, as it is explained in John chapter 1. The catholic idea of a trinity, and all those who dispute the deity of Christ, are quite wrong. The Word was with God, God was the Word, and the Word was made flesh and walked amongst us, He is Yahshua Christ. When Thomas, as it is recorded in the Gospel of John, looked upon Christ and exclaimed “My Lord and my God!”, he knew exactly what he was saying.

**7 He who prevails shall inherit these things and I shall be a God for him and he shall be a son for Me.**

The woman Hannah is recorded as having said, at 1 Samuel chapter 2: “6 The LORD killeth, and maketh alive: he bringeth down to the grave, and bringeth up. 7 The LORD maketh poor, and maketh rich: he bringeth low, and lifteth up. 8 He raiseth up the poor out of the dust, and lifteth up the beggar from the dunghill, to set them among princes, and to make them inherit the throne of glory: for the pillars of the earth are the LORD'S, and he hath set the world upon them. 9 He will keep the feet of his saints, and the wicked shall be silent in darkness; for by strength shall no man prevail. 10 The adversaries of the LORD shall be broken to pieces; out of heaven shall he thunder upon them: the LORD shall judge the ends of the earth; and he shall give strength unto his king, and exalt the horn of his anointed.’ The overcomers are indeed the children of Israel. Therefore, Paul says in his comparison of Jacob and Esau, in Romans chapter 9: “16 So then, it is not of he that wishes, nor of he that strives, but of he Yahweh shows mercy upon.” While in response to the question “are those being preserved but few?” Yahshua Christ warns the apostles, at Luke 13:24: “Strive to enter in through the narrow door, because many, I say to you, shall seek to



enter and they shall not prevail”, Paul explains that also, at Philippians 2:14-16: “14 Do all things apart from murmuring and disputing, 15 that you would be perfect and with unmixed blood, blameless children of Yahweh in the midst of a race crooked and perverted - among whom you appear as luminaries in the Society, 16 upholding the Word of Life for a boast with me in the day of Christ, that not in vain have I run nor in vain have I labored.” The keeping of the commandments of God means the keeping of the bloodline of Israel. The overcomers are all of those Israelites who remain at the end of the age.

**8 But for the cowards and the faithless and abominable and murderers and fornicators and drug-makers and idolaters and all those who lie, their fate is burning in the lake in fire and sulfur, which is the second death!”**

All of the enemies of Yahweh are already cast into the Lake of Fire, and all who are not written into the Book of Life. This verse is therefore exemplary, that there are none of these left, and there shall be none of these in the Kingdom of God. Likewise Paul made similar statements,

where he wrote at 1 Corinthians chapter 5: “9 Or do you not know that the unjust will not inherit the kingdom of Yahweh? Do not be led astray: neither fornicators, nor idolaters, nor adulterers, nor effeminate, nor homosexuals, 10 nor thieves, nor covetous, nor drunkards, nor railers, nor rapacious shall inherit the kingdom of Yahweh.”

Fornicators are those engaging in any sort of illicit sexual activity, among which is race-mixing (i.e. 1 Corinthians 10, Jude 7). The word drug-makers here is from the Greek word φαρμακός, a very interesting word. It literally means to refer to dispensers of φάρμακον, which is a drug or a medicine. Later, it became a term of reproach used to designate one who is sacrificed for an atonement, probably in the sense of a person who is used as a cure. Realizing that, one may come to the conclusion that the only valid medicine for the children of Israel is Yahshua Christ.

The phrase “second death” may be interpreted as

being connected to the fate of those people who are without the Spirit of Yahweh which He Imparted to Adam: the aliens and descendants of the line of the Serpent of Genesis 3, a line which is much broader in scope than the descendants of Cain alone, since the tree of the knowledge of good and evil was already a tree – an allegory for a race of people - before Adam was even placed into the garden, where it is already found. It is in reference to these children of the serpent, the fallen angels, and to the bastards that Jude uses the phrase “twice dead” in his epistle at verse 12: “12 These are the spots in your feasts of charity, feasting together without fear, tending to themselves, clouds without water being carried away by the winds, late-autumn trees without fruit, twice dead being uprooted, 13 stormy waves of the sea foaming up their own shame, wandering stars for whom the gloom of darkness is kept forever!”

**9 And one from among the seven messengers having the seven bowls full of the seven last plagues came and spoke with me, saying: “Come! I shall show to you the bride, the wife of the Lamb!” 10 And he took me away in the Spirit up to a mountain great and high, and showed to me the holy city Jerusalem descending from out of heaven from Yahweh, 11 having the effulgence of Yahweh, her radiance like precious stone as jasper stone, clear as crystal; 12 having a wall great and high, having twelve gates, and above the gates twelve messengers, and names inscribed which are the names of the twelve tribes of the sons of Israel: 13 from the east three gates, and from the north three gates, and from the south three gates, and from the west three gates. 14 And the wall of the city has twelve foundations, and upon them the twelve names of the twelve ambassadors of the Lamb.**

The names of the twelve tribes themselves are the twelve gates, because the only way into the City of God is to be born of one of those tribes!

**15 And he speaking with me had a golden measuring-rod, that he may measure the city and her gates and her wall. 16 And the city lies foursquare and her length as great as the breadth. And he measured the city with the rod for twelve thousand stades, her length and the breadth and the height are the same. 17 And he measured her wall, a hundred forty-four cubits measure of a**

**man, which is of a messenger. 18 And the structure of her wall was jasper, and the city pure gold like pure glass. 19 And the foundations of the walls of the city all adorned with precious stone: the first foundation jasper, the second sapphire, the third chalcedony, the fourth emerald, 20 the fifth sardonyx, the sixth sardius, the seventh olivine, the eighth beryl, the ninth topaz, the tenth chrysoptase, the eleventh hyacinth, the twelfth amethyst. 21 And the twelve gates twelve pearls, each one of the gates was from of one pearl. And the streets of the city pure gold, as transparent glass.**

The city is foursquare just as the Tabernacle in the Wilderness was foursquare, and just as the sheet in Peter's famous vision of Acts chapter 10 was foursquare. The breastplate made for the high priest, described in Exodus chapter 28, was also foursquare. All of this helps to signify that the Kingdom of Yahweh is meant for the Children of Israel exclusively, because it is measured to fit Israel only. Likewise the measurement of the city, being twelve thousand stades in each direction, is also calculated. In order to sate any curiosity, the Greek *stade* was 606.75 English feet, and therefore 12,000 stades is very close to 1,379 English miles. As it has been made manifest at verse 2 above, that the City of God is an allegory for the Children of God, and so it is here, that the description of the city descended from heaven, with its gold and precious stones and 12 gates, is an allegory for the people of the twelve tribes of Israel, who have the Spirit of Yahweh and who were therefore “born from above”. The stones are those of the breastplate made for the high priest, each stone also representing a tribe of Israel, for which see Exodus 28:17-21. While the names of the stones are somewhat different, that may be partially due to a misunderstanding of the meanings of the ancient words by their interpreters, for the Exodus was written roughly 1600 years before the Revelation of John, and in a different language.

From Exodus chapter 28, here is a partial description of the construction of the foursquare breastplate: “17 And thou shalt set in it settings of stones, even four rows of stones: the first row shall be a sardius, a topaz, and a carbuncle: this shall be the first row. 18 And the second row shall be an emerald, a sapphire, and a diamond. 19 And the third row a ligure, an agate, and an amethyst. 20 And the fourth row a beryl, and an onyx,

and a jasper: they shall be set in gold in their inclosings. 21 And the stones shall be with the names of the children of Israel, twelve, according to their names, like the engravings of a signet; every one with his name shall they be according to the twelve tribes.”

**22 And I saw no temple in her, for Prince Yahweh Almighty is her temple, and the Lamb.**

The Lamb is Yahweh Himself, and the Greek does not necessitate that a distinction is made between the two. Speaking of Christ, Paul said at Colossians 2:9: “For in Him dwells all the fullness of the Divinity bodily”. One cannot expect the entire being which is Yahweh God to inhabit the body of a mere man, yet the body of Yahshua Christ is indeed His temple.

**23 And the city has not need of the sun nor of the moon that they would illuminate her, for the effulgence of Yahweh illuminates her, and her lamp is the Lamb.**

Yahweh is the true light of the world, and the bright and morning star; note Revelation 2:28 and 22:16..

**24 And the Nations shall walk by her light, and the kings of the earth shall bring their honor into her, 25 and her gates shall not be closed by day (for there shall not be night there), 26 and they shall bring the honor and the dignity of the Nations into her. 27 And there may not enter into her anything common and which makes an abomination and a lie, except those written in the book of life of the Lamb.**

The Nations may be interpreted as being those Adamic Genesis 10 nations, which were also those nations which were to be blessed in Abraham's seed (Genesis 22:18). The first promise of the restoration of the Adamic race is found at Genesis 3:22: “KJV: Genesis 3:22. ¶And the LORD God said, Behold, the man is become as one of us, to know good and evil: and now, lest he put forth his hand, and take also of the tree of life, and eat, and live for ever”. This precedes, and is apart from, the special covenants Yahweh later made with Abraham and Jacob, which they do not annul. For Christ testifies that the other Adamic families shall also be in the resurrection, at Matthew 12:41-42, Luke 11:31-32, of which there are also indications in the prophets, such as the as-of-yet unfulfilled Isaiah

19:23-25 where it says “23 In that day shall there be a highway out of Egypt to Assyria, and the Assyrian shall come into Egypt, and the Egyptian into Assyria, and the Egyptians shall serve with the Assyrians. 24 In that day shall Israel be the third with Egypt and with Assyria, even a blessing in the midst of the land: 25 Whom the LORD of hosts shall bless, saying, Blessed be Egypt my people, and Assyria the work of my hands, and Israel mine inheritance”. Yet no bastard or non-Adamic being can ever claim a part in any of these covenants.

The phrase “the kings of the earth” must now be referring to the Children of Israel. For whether Revelation 1:6 and 5:10 should read “kings”, as they do in the King James Version, or “a kingdom”, as they do in the oldest extant manuscripts, is immaterial, because Revelation 5:10 says of the children of Israel that “they shall rule over the earth”. This is the “royal priesthood” and “holy nation” of Exodus 19:6 and the “elect race, ... royal priesthood, ... holy nation, ... peculiar people” of 1 Peter 2:9, all referring to Israel.

Revelation 1:4-6: “4 Iohannes, to the seven assemblies which are in Asia, favor and peace to you from He who is and who was and who is coming, and from the seven spirits which are before His throne 5 and from Yahshua Christ, the Witness, the Faithful One, the First Born from the dead and He ruling the kings of the earth. To He who loves us and has released us from our errors with His blood, 6 and has made us a kingdom, priests to Yahweh – even His Father – to Him is the honor and the sovereignty for the eternal ages, truly.”

Psalms 118:22 says that: “The stone which the builders refused is become the head stone of the corner. 23 This is the LORD doing and it is marvellous in our eyes. Revelation 5:8-10:”8 And when He received the scroll, the four living creatures and the twenty-four elders fell before the Lamb each having a lyre and golden bowls full of incense, which are the prayers of the saints, 9 and they sang a new song, saying 'You are worthy to receive the scroll and to open its seven seals, because You have been slaughtered and You have purchased for Yahweh with Your blood out of each tribe and tongue and people and nation 10 and have made them a kingdom and priests for our God, and they shall rule over the earth!’”

# Special Notice to All Who Deny Two-Seedline

## Part 21

It is highly important that we continue to pursue the subject of Two Seedline as taught in Genesis 3:15. The word “seed” in that verse is the same for the “serpent” as it is for the “woman.” Doggedly, the anti-seedliners are insistent on interpreting the seed of the woman as “physical”, while rendering the seed of the serpent as “spiritual.” Yet “seed” in both cases is the same Hebrew word, #2233. This is taking liberty with Yahweh’s Word beyond all logical reason, and is highly unethical and inconsistent. This is the very same word as the “seed” promised to Abraham in Genesis 22:17, and can only mean physical “seed.” There is a threefold use of the word “seed” in Scripture: (1) Agricultural, (2) Physiological, and (3) Figurative. A man’s “seed” or emission of “semen” is a physiological use of the term derived from the Hebrew *zera* and the Greek *sperma*, *sporos*. Thus, *zera* in Genesis 3:15 for the serpent can only mean the *zera* or *sperma* of the serpent, that is, his offspring. Any other interpretation does violence to Yahweh’s Word in that passage. *Insight On The Scriptures*, volume 2, page 877 says, under the subheading “The seed of the Serpent”: “Jesus identified the Jewish religious leaders of his day as a part of the Serpent’s seed, saying to them: ‘Serpents, offspring [Gr., *gennemata*, ‘generated ones’] of vipers, how are you to flee the judgment of Gehenna?’ — Mt. 23:33, *Int.*” The *New Concise Bible Dictionary* under “Seed” says: “... The offspring of people are called ‘seed’ (e.g. Gn. 3:15) ...”

Today, we live in a world controlled by this enemy, and we are losing our WAR to him. This enemy has full command over the political, economic and religious aspects of our lives. He is using all these tools in an attempt to destroy the White Israel Race. Therefore, it would be tremendously irresponsible, on the part of those who understand the nature of the

enemy, to sit idly by saying nothing. This situation is serious enough in itself, without having distracters on the sidelines playing theology games while our very existence is at stake. I have already completed 20 *Special Notices To All Who Deny Two Seedline*, and I will write another 20 should it be necessary. This time we will key-in on a spurious statement made by Stephen E. Jones in his book *The Babylonian Connection*, on page 66. In my estimation, he has done more damage to the Israel Identity Message than anyone I’m aware of, though there are several others vying to overtake and surpass him for that position. This is what he said:

“It should be obvious that the woman was the mother of both Cain and Abel. There were not two fathers. Furthermore, seed (the power of procreation) is a physical thing, and outside of God alone, only physical, fleshly beings have seed and can reproduce sexually. Satan is supposedly a spirit-being like the angels in heaven, which ‘neither marry nor are given in marriage’ (Luke 20:34:36).”

If you have this book by Jones, you will notice he didn’t go into any depth on that passage. First of all, this subject can be found in three of the Gospels at Matthew 22:23-30; Mark 12:18-25 and Luke 20:27-36. Therefore, it is necessary to study all three for a full comprehension of the topic. By not doing this, Jones, by sleight-of-hand, was able to change the thrust of that passage. The reason for understanding this subterfuge by Jones is because the future of our children depends on it. Otherwise, you can only look forward to having some Biblical *mamzers* in your family tree. My intention is to protect your children from that kind of danger. The usual reward for doing this is to be scoffed at by the Jew-deo-*un*christian community and ridicule by the anti-seedliners, many of which, like Jones, also teach universalism. Let’s now read these three passages:

Matthew 22:23-30: “23 The same day came to him the Sadducees, which say that there is no resurrection, and asked him, 24 Saying, Master, Moses said, If a man die, having no children, his brother shall marry his wife, and raise up seed unto his brother. 25 Now there were with us seven brethren: and the first, when he had married a wife, deceased, and having no

issue, left his wife unto his brother: 26 Likewise the second also, and the third, unto the seventh. 27 And last of all the woman died also. 28 Therefore, in the resurrection whose wife shall she be of the seven? for they all had her. 29 Jesus answered and said unto them, Ye do err, not knowing the scriptures, nor the power of God. 30 For in the resurrection they neither marry, nor are given in marriage, but are as the angels of God in heaven.”

Mark 12:18-25: “18 Then come unto him the Sadducees, which say there is no resurrection; and they asked him, saying, 19 Master, Moses wrote unto us, If a man’s brother die, and leave his wife behind him, and leave no children, that his brother should take his wife, and raise up seed unto his brother. 20 Now there were seven brethren: and the first took a wife, and dying left no seed. 21 And the second took her, and died, neither left he any seed: and the third likewise. 22 And the seven had her, and left no seed: last of all the woman died also. 23 In the resurrection therefore, when they shall rise, whose wife shall she be of them? for the seven had her to wife. 24 And Jesus answering said unto them, Do ye not therefore err, because ye know not the scriptures, neither the power of God? 25 For when they shall rise from the dead, they neither marry, nor are given in marriage; but are as the angels which are in heaven.”

Luke 20:27-36: “27 Then came to him certain of the Sadducees, which deny that there is any resurrection; and they asked him, 28 Saying, Master, Moses wrote unto us, If any man’s brother die, having a wife, and he die without children, that his brother should take his wife, and raise up seed unto his brother. 29 There were therefore seven brethren: and the first took a wife, and died without children. 30 And the second took her to wife, and he died childless. 31 And the third took her; and in like manner the seven also: and they left no children, and died. 32 Last of all the woman died also. 33 Therefore in the resurrection whose wife of them is she? for seven had her to wife. 34 And Jesus answering said unto them, The children of this world marry, and are given in marriage: 35 But they which shall be accounted worthy to obtain that world, and the resurrection from the dead, neither marry, nor are given in marriage. 36 Neither can they die any more: for they are equal unto the angels; and are the children of God, being the children of the resurrection.”

We can make two observations from these passages: (1) The words “seed”, “issue” and

“children” are used interchangeably throughout, and that is the way it should be interpreted in Genesis 3:15! Although there are three Greek words used (#5043, #4690 and #815), the context remains the same. (2) You will notice that I underlined the phrases “as the angels of God in heaven”, “the angels which are in heaven” and “for they are equal unto the angels” in these passages. It is obvious it is referring to the angels who did not confederate themselves with Satan in his rebellion. It is very important we separate the angels who remained faithful to the Almighty from those who fell. This is an important little detail Stephen E. Jones elected to ignore. You will notice he chose to quote the passage where it said “for they are equal unto the angels.” This is the height of intellectual dishonesty.

### WHAT THESE PASSAGES REALLY MEAN

Fortunately, these portions of Scripture are not problematic or controversial in nature. Of all my sixteen various Bible commentaries, they convey pretty much the same general opinion. Therefore, because they are very similar, in essence, when I am quoting from one, I am quoting from them all. Also, because the story is the same in all three Gospels, the commentary from one passage will correspond with the others. Therefore, I will use the commentary which explains this story best. From the *King James Bible Commentary*, page 1219, we read the following on Matthew 22:23-29:

“The Sadducees made the next attempt to discredit Jesus and were even more severely humiliated. As the liberal party within first-century A.D. Judaism, they rejected belief in the supernatural, especially angels and the resurrection of the dead (see Paul’s encounter in Acts 23:8ff.) ‘**Moses said**’ is a reference to Deuteronomy 25:5, where the practice of levirate marriage called for an unmarried brother to take his widowed brother’s wife to be his own (cf. Gen. 38:8). This ancient practice was recognized by the Jews [sic. Judeans] but rarely followed in those days. The absurd hypothetical case which follows represents another theological dilemma, this time attempting to discredit the legitimacy of the resurrection, which the Sadducees rejected. Thus, their question: **whose wife shall she be?** This extreme example must have been thought by them to be the ultimate proof of the foolishness of this doctrine. All seven brothers had been married to her, **Therefore in the resurrection whose wife shall she be of the**

**seven?** They must have snickered as they asked such a ridiculous question, but the smile would soon be wiped off their faces by Jesus' reply. **Ye do err, not knowing the scriptures.** Jesus had extreme contempt for the Sadducees because they made light of the Bible and the **power of God** (i.e., His resurrection power, cf. Phil. 3:10). This is His strongest recorded rebuke of this Jewish party."

This is what led up to the statement about the angels. It should be pointed out that all the anti-seedliners who also hold to the "no devil" doctrine indirectly agree with the Sadducees, and they also "err, not knowing the Scriptures." *The Wycliffe Bible Commentary*, page 1062, says this on Luke 20:34: "And Jesus answering said unto them. The Sadducees had the right logic but the wrong premise. They were assuming wrongly that the conditions in the future life would be identical with those here. Jesus asserted that in the age to come there would be neither marriage nor death."

The best reference on this topic I could find comes from *Peake's Commentary on the Bible*, page 839, on Luke 20:34-35 and reads: "In this age men marry, but in the age to come they are immortal, and do not marry, living for ever like the angels (c.f. Enoch 15:6ff.) ... Lk, corrects Mk's apparent implication that all the sons of this age will attain the resurrection life. It is very unlikely that Lk's change in Mk's wording implies a view that men are fitted by celibacy in this life to attain the age to come; marriage is considered in this passage solely from the point of view of legal relationship and the procreation of children. No conclusion can be drawn from it concerning the character of Christian's marriage." What I liked about this reference is that it takes us to Enoch 15:6, which we will read the entire chapter next (Enoch 15:1 to 15:10):

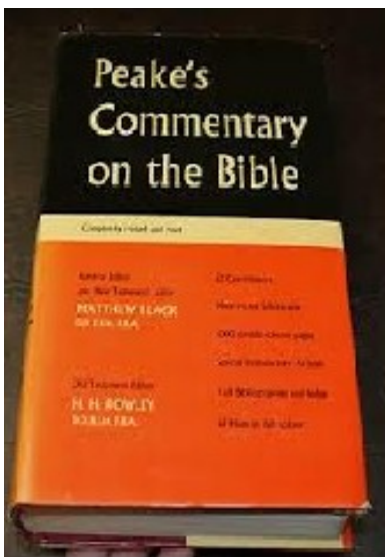
"1 Then addressing me, He spoke and said: Hear, neither be afraid, O Enoch, O righteous man, and scribe of righteousness: approach hither, and hear my voice. Go, say to the Watchers of heaven, who have sent thee to pray for them; You ought to pray for men, and not men for you. 2 Wherefore have you forsaken the lofty and holy heaven, which endures for ever, and have lain with women; have defiled

yourselves with the daughters of men; have taken to yourselves wives; have acted like the sons of the earth, and have begotten giants? (Gen. 6:2, 4). 3 You being spiritual, holy, and living a life which is eternal, have polluted yourselves with women; have begotten in carnal blood; have lusted in the blood of men; and have done as those *who are* flesh and blood do. 4 These however die and perish. 5 Therefore have I given to them wives, that they might cohabit with them; that sons might be born of them, and that this might be transacted upon earth. 6 But you from the beginning were made spiritual, living a life which is eternal, and not subject to death in all the generations of the world. 7 Therefore I made not wives for you, because being spiritual, your dwelling is in heaven

(Matt. 22:30). 8 Now the giants, who have been born of spirit and of flesh, shall be called upon earth evil spirits, and on earth shall be their habitation. Evil spirits shall proceed from their flesh, because they were created from above; from the holy Watchers was their beginning and primary foundation. Evil spirits shall they be upon earth, and the spirits of the wicked shall they be called. The habitation of the spirits of heaven shall be in heaven; but upon earth shall be the habitation of terrestrial spirits, who are born in earth (1 Cor. 15:40). 9 The spirits of the giants shall be like clouds,

which shall oppress, corrupt, fall, contend, and bruise upon earth. 10 They shall cause lamentation. No food shall they eat; and they shall be thirsty; they shall be concealed, and those spirits shall rise up against the sons of men, and against women; for they come from (from them) during the days of slaughter and destruction (Lk. 4:33, 36; Matt. 8:28-34)."

From this evidence we can clearly see that Stephen E. Jones is entirely discredited through his manipulative deception. All one need do is to read Jude to see the connection to Enoch 15. In verse 4 we read: "For there are certain men crept in unawares, who were before of old ordained to this condemnation, ungodly men ..." In verse 6 it continues: "And the angels which kept not their first estate, but left their own habitation ..." Verse 7 speaks of "fornication" (race-mixing) and "going after strange flesh." Verse 11 says: "... they have gone in the way of Cain." Did not the angels of Genesis 6 commit





the same violation as Satan did with Eve? Notice the same term “clouds”, as in Enoch 15, above in Jude 12! Notice the term “wandering stars” in verse 13, and remember the curse of a “vagabond” on Cain. Also notice the Book of Enoch is referred to in Jude 14! In verses 15-19, notice all the evil traits of the descendants of those wicked, satanic people. Then use the cross-references to each verse of Jude and expand on the subject. Then, in turn, check all the cross references to those passages, and you will encounter a never-ending Bible study on this subject. Jones and all the other antichrist, anti-seedliners should be ashamed! Today America and all the other Israel nations are becoming one giant Sodom and Gomorrah going after strange flesh, and Jones and company are wittingly or unwittingly aiding and abetting that satanic objective.

Think of the situation from this perspective: If we Two Seedliners prove to be incorrect (and we are not), it would only amount to embarrassment, but if the anti-seedliners prove to be in error (and they are), the end would not only amount to embarrassment, but total racial disaster. I am persuaded that at the Judgment, Yahweh will ask the anti-seedliners “Why did you give My enemies aid and comfort?” The Two Seedliners should take solace in the fact they are performing their Yahweh given duty. If there is one single piece of Biblical evidence that the false Judeans (“Jews”) were and are the descendants of Cain, Matthew 23:35 and Luke 11:51 should erase all doubt where it says: “That upon you may come all the righteous blood shed upon the earth, from the blood of righteous Abel unto the blood of Zacharias ...” [the father of John the Baptist]. Who else killed Abel but Cain? Who else was a “liar” and a “murderer” from the beginning but Satan and his offspring, Cain? (John 8:44) Our Redeemer would have been highly derelict and dishonest had these charges not been true. Yet this is one of the many fantastic positions held by the anti-seedliners.

### **GENESIS 3:15 AND THE AVENGER OF BLOOD**

Rightly does *The Wycliffe Bible Commentary* describe Genesis 3:15 as a “blood-feud” on page 8, also called the *protoevangelium* (first gospel). Having quoted this *Wycliffe* observation several times in the past, I will omit it here. I cease to be amazed at the preposterous commentary by the anti-seedliners on this passage! First of all, in order to be a “blood-feud”,

it would require two kinds of blood to be involved! Secondly, the “avenger of blood” had to be a family member next-of-kin. Therefore, the only way we can look at the murder of Abel by Cain is from a kinsman-ship perspective. Knowing that the Almighty would not break His own laws, we need to look at Abel’s murder from a Biblical-legal point-of-view. By doing so, we can identify who the “avenger of blood” for Abel’s murder was and continues to be.

Before resolving that, we must determine whether it was accidental or deliberate homicide. Inasmuch as Yahweh confronted Cain before he committed his deed, warning him that “sin croucheth at the door”, it was premeditated murder, not manslaughter. Nowhere in Scripture does it indicate otherwise. The question at once arises: why wasn’t Cain immediately punished for his crime? Among many reasons for that, there were no witnesses to the crime, and the “avenger of blood” in the person of Seth hadn’t been born yet. Thus, it became the responsibility of Seth and his descendants to avenge for Abel’s murder, (chief among them, Yahshua the Messiah). Therein lies the “enmity” for both parties of Genesis 3:15. To put this in a better light, I will quote from *The Zondervan Pictorial Encyclopedia of the Bible*, volume A-C, page 422:

“AVENGER OF BLOOD (בַּאֵל הַדָּם, *redeemer*; fully, בַּאֵל הַדָּם, *redeemer of blood*). The meaning of the verb בַּאֵל, is *to loose, set free, redeem, vindicate*; in the case of homicide, to vindicate the right of man to life, to free the land from the pollution that follows upon the spilling of blood without due cause. To avenge is not to seek revenge, but to take vengeance on behalf of someone, to redress a wrong by exacting from a wrongdoer satisfaction for an offense committed.

“In the OT the *go’el* (Redeemer, Avenger) is one — usually the nearest relative (which ‘goel’ consequently has also come to mean) — charged with vindicating justice either by redeeming family property expropriated or sold under constraint or (in the case of *go’el had’dam*, the avenger of blood) avenging the unlawful slaying of a family member.

“The avenger of blood is a figure that appears in primitive justice. By ancient custom it was the right, indeed the duty, of the nearest of kin to avenge the slaying of a relative. This is perhaps why Cain feared for his life after slaying Abel (Gen. 4:14), and why Lamech justified himself (Gen. 4:23, 24) ...”

Remember that Abel’s blood cried out from the

ground (Genesis 4:10)? The reason it did is because it was crying out for the **avenger of blood to redeem or vindicate** him. This will not be fully completed until Seth finishes his job as avenger of blood. From *The Interpreter's Dictionary of the Bible*, volume A-D, we read this on page 321:

“**AVENGER OF BLOOD** [בְּאֵל הַדָּם , redeemer of blood]. The kinsman (brother, son ...) of a slain man who, as his redeemer ... was duty bound to claim back his life from the slayer by killing him. Cf. the LXX rendering, ὁ ἀγγιστεύων τὸ αἷμα (Num. 35:19): ‘he who performs the kinsman’s office with regard to blood.’

“In societies that lack a strong central authority the defense of private property and life is the task of the kinship group. The kinship group is both a defensive and an offensive unit: all are obliged to defend the right of any member, and all are accountable for the delict [misdemeanor] of any member. If a person is slain, his kin take vengeance for him upon the slayer, or on one or more of the slayer’s kinship group. This in turn may give rise to counter-vengeance, and a blood feud, terminating at times only with the extinction of a family, is set in motion.

“In biblical Israel the sovereignty of the kinship group over matters affecting its private interest was just beginning to be superseded by communal authority. Biblical law still recognizes the kinsman as responsible for prosecuting homicide (Num. 35:19) ...”

This should start to give you some idea of what the law required in the murder of righteous Abel. I’ve not so much as heard or read any of the anti-seedliners ever mention the “avenger of blood”, or applied it in the case of Cain. From the book *The Institutes of Biblical Law*, by Rousas John Rushdoony, he says this on page 189: “In Deuteronomy 19:11-13, pity for a murderer in a case of premeditated murder is forbidden. No extenuating circumstances can be pleaded against the fact of murder by premeditation ... In Deuteronomy 19:21, the general law of justice is stated: the punishment must fit the crime; there must be a comparable restitution or death. Pity cannot be used to set aside justice.” Therefore, we are not to feel sorry for Cain or his descendants, the impostor-Judahites called “Jews”, for whatever divinely-directed punishment they receive. Inasmuch as they are also listed among the ten Canaanite nations mentioned in Genesis 15:19-21 known as “Kenites”, it

is interesting what Rushdoony says again on page 189: “In Deuteronomy 7:16, pity for the evil inhabitants of Canaan was forbidden; God’s pity for them, and His patience, had lasted for centuries. Now the time for pity was gone: it was a time for judgment and death.” To be accurate, that punishment had been pending since the murder of Abel. Not only are the descendants of Cain, the “Jews”, guilty of the murder of Abel but also the Messiah, for they said: “His blood *be* on us and on our children”, Matthew 27:25. For that, the punishment must also fit the crime.

## **PUNISHMENT FOR CAIN WAS PUT ON HOLD**

Yes, the Israelites, when entering Canaan, were instructed to annihilate every last Canaanite to the man, including women and children, and have no pity on them. While they killed many of them, they didn’t complete the job. We are told in Numbers 33:55 the following: “But if ye will not drive out the inhabitants of the land from before you; then it shall come to pass, that those which ye let remain of them *shall be* pricks in your eyes, and thorns in your sides, and shall vex you in the land wherein you dwell.” The Canaanites, or what we know today as “Jews”, are still in all of our Israel lands, and indeed, they are pricks and thorns to us. Just remember that, the next time they draw blood from you in the form of usury, or income tax, or you send your children off to fight in a “Jewish” contrived war; just to mention a few of the ways they gouge us.

From what we have contemplated in this paper, it should be obvious that it is foolish to consider Genesis 3:15 and 4:1 without taking the “avenger of blood” into account. The anti-seedliners totally miss this significant part of the equation. To condense it into the fewest words possible, I will quote from the *New Concise Bible Dictionary*, edited by Derek Williams, page 46: “**AVENGER OF BLOOD.** A murder victim’s next-of-kin had responsibility for avenging the death; he was allowed to execute the murderer but no-one else (Dt. 24:16). The law of Moses [sic. Yahweh] provided safety for accidental killers ...” This responsibility fell to Seth and his descendants, and when Deuteronomy 24:16 is correctly understood, it will be seen to be playing itself out today!

## on Why We Hate Jews

### Part One

Now that I have your attention from that provocative title, let me say that by using the word 'hate' I do not mean to imply some sort of alleged systematic gassing and cremation of the most hideous and satanic breed of people on the face of the earth, although that may be a future consideration in light of Bible prophecy.



George Orwell predicted newspeak, which today is called political correctness under a jewish communist totalitarian state called democracy. We have 'hate crime' laws which Orwell termed 'thought crimes'. Lenin and Stalin instituted 'hate crime' laws early on in the officially atheistic Soviet Union. One of the first being to outlaw any anti-jewish speech or writings, which were punishable by death. Under the 'hate crime' laws, the career politicians have legislated what is called 'hate speech'. Hate speech means anything the jews hate to hear, especially the truth about themselves. Therefore, truth is hate to those who hate the truth.

I could have titled this message "The Truth About Jews", but I don't think it would have hit the same nerve. At this point, some people may think I've got a lot of nerve talking about God's Chosen People. The point of this message, however, is that if people knew the truth about jews, they would hate them just as I do, and would be committing 'hate speech' by rejecting the idea that jews are God's Chosen People. God has chosen jews to fulfill a role, but it is the complete opposite of what they purportedly represent. What they represent is the evil and wickedness of an antichrist nature in the world. They are perpetually engaged in damage control from generation to generation, if they are not being purged en masse from an entire country. Through their efforts, darkness covers the earth. Jews are a dead end for this planet.

Nobody who has invested much time down a blind alley likes the messenger who shines a light at the brick wall up ahead. Christians who have invested their time in support of the jews would rather anticipate a thermonuclear evaporation of everything

than peace on earth. This message is going to give you a long list; a dirty laundry list, of why White Christians should hate jews. Make no mistake about it: jews hate the Lord Jesus Christ. God continues to this day to warn His people about helping the ungodly and loving them that hate Him. What is the result of such misguided support? *"Therefore is wrath upon thee"* II Chron. 19:2. That's right ... wrath, judgment and

punishment!

There has never been a fulfilment of Genesis 12:3 (the Abrahamic Covenant) with jews. It seems the more they are blessed, the greater we are cursed. After 2000 years, this should be cause for a re-evaluation of jews. Let us, therefore, examine the long line of offenses found in jewry that we hate. In other words, those things we are vehemently opposed to (and God is too!). I will first itemize these things with a word or a phrase and then follow up with explanatory briefs.

Judaism and the Talmud (the first violation from which all others flow), Murder, Lies, Stealing, Race mixing, Espionage, The Occult Sexual immorality, Aborticide, Terrorism Satanism / insanity, Usury, Slavery, Drugs Political corruption, Religious corruption Media monopoly, Lawyers, Doctors Corporations, Agriculture, Scientific exploitation, Holocaust industry, Organized crime, Internationalism Kosher tax, Disarmament / pacifism, Conspiracies Evil and wicked

Please note that there are 29 elements that constitute the justification for enmity between the crucifiers and the crucified. The number 29 in the Bible symbolizes departure. Indeed, as we shall see shortly, the jews have departed from everything being decent, right and good. After all is said and done, we can come to no other conclusion than those who call themselves jews are an evil people manifested in a congenital wickedness, confirmed in history and the Word of God. The judaised automatons of state-approved

501c3 churches, if they've gotten this far, have probably already accused us non-judaised Christians with the misnomer of suffering from 'anti-Semitic' delusions.

We are but the few crying in the wilderness, while many false prophets (teachers) shall rise and deceive many (Mt. 24:11). *"He who gives an answer before he hears, it is folly and shame to him"* Proverbs 18:13. Such people are without eyes to see jewry standing on the unholy threshold of total world domination; not as something blessed of God, but rather as a criminal enterprise.

Let us begin our string of indictments with the foremost insidious representation of jews being judaism.

## Judaism

If a gang of career criminals codified their criminal practices and fine-tuned their code book over time for better crimes, could they then proclaim it a religion? That's exactly what the Talmud is to judaism. Many are deceived about the origins of judaism and the jewish people. We have an excellent article, "[The Antisemantics of the Word Jew](#)", detailing who and what jews are and are not. Suffice it to say for this message: judaism was born in Babylon circa 6th century BC, when the bad figs of Judah became mongrelized, if not racially, at least spiritually. Ezra tried to separate this new subspecies of half-breeds from the good figs of racially pure Judah. Nevertheless, these 'jews' merged with another mongrel people, the descendants of Esau, and became the Pharisees at the time of Christ. The Lord condemned them in the strongest possible language. Why? What did they do?

The Scriptures record that Jesus charged them with having an inherent spirit of guilt for having the elements which defined satan, or the devil. *"Ye are of your father the devil, and the lust of your father ye will do"* John 8:44. This was a metaphor of sin and lawlessness. Indeed, this gang of hypocrites, a generation of vipers, a ruthless bunch of mongrels hated and despised the truth and justice of God's Word/Law. So what did they do?

They devised an oral tradition of laws that contradicted their ancient predecessors of racially pure Israel. *"Thus have ye [jews] made the commandment of God of none effect by your tradition"* (Mt. 15:6). So how does that affect us today? Well, we still have a

conflict of interest in the world between the racially pure and the racially mixed; between the holy laws of God and the unholy laws of the ungodly. That's what Genesis 3:15 is all about. We are informed by the Jewish Encyclopedia (1905) that "With the destruction of the Temple (70 AD) ... Jewish life was regulated by the Pharisees; the whole history of Judaism was reconstructed from the Pharisaic point of view. ... A new chain of tradition supplanted the older priestly tradition. Pharisaism shaped the character of Judaism and the life and thought of the Jew for all the future." So why has the Talmud been kept a secret for so long, and not published into English until 1934 with the Soncino Edition? Because, throughout European history, when the laws of the Talmud became commonly known, it was burned and jews were exiled.

The Talmud's primary law is that mongrel jews are the highest life form on earth. Racially pure White Christians are considered inferior animals and slaves at best. The righteous indignation generated by non-jews is always portrayed by jews as 'persecution' or 'anti-Semitism'. The Babylonian Talmud is the most vehemently hateful literature in the world, directed against Jesus Christ and Christianity, and therefore, viciously at war against the true Israel of God ... the White Race. Besides this demented preoccupation with the destruction of racially pure Christians, the jewish religion (or criminal code) is obsessed with the most pornographic perversions known to man.

For example, the Talmud teaches that Jesus was an illegitimate bastard conceived during menstruation to a prostitute (Kallah, 1b, 18b and Sanhedrin 67a) and that Jesus is now in hell "boiling in hot semen" (Gittin 57a), which is one of many depraved punishments of the jewish imagination. Got vitriol? The book of Sanhedrin (781 pages) is the chief repository for the choicest slanders leveled against Jesus Christ asserting that the Lord is deserving of "decapitation", "stoning to death", "burning in dung", "strangling in dung", "hanging" and "crucifixion". Why? Because He dared to speak the truth about the epitome of mongrelization: the Pharisees. If you're not loving jews less, there's more.

Most hyphenated judeo-Christians believe that the God of judaism is the same monotheistic God of Christianity and the Old Testament. Double-talk is the part and parcel of Talmudic judaism, which Christ called the "Synagogue of Satan." Jews

condescendingly declare their devotion to "pure monotheism", which they call the "Unity of God". However, this precludes their belief in His deity being incarnate in Jesus Christ. The cryptic Talmudic translation of the "Unity of God" is in Jewish reality, the oneness of the pantheistic "en sof"; the unknowing, unknowable, self-perking mass; each phase run by individual 'gods' or spirits, like Metatron (sun god); identical with pantheistic paganism (Satanism). To the Jew, the en sof is the "infinite all that stands beyond God". Judaism, as compared to "whited sepulchers" constitutes the showmanship of placing God in a shell game for the outside world in which 'now you seem 'em, now you don't.' Their inside doctrine of the en sof is a nature essence, which has no attributes and can neither know nor be known. This is your basic run of the mill atheism and foundation for all pagan pantheisms. It's also called 'dialectical materialism', and 'secular humanism'.

Most Christians do not understand any of this religious gobbledygook that Jews put forth. To the dumbed-down non-Jews, they are told that the Jewish religion simply believes in the Old Testament (which is not true), and that they are still awaiting their

promised Messiah (because they murdered Jesus Christ in their unbelief of who He was). However, in Judaism the dirty little secret is that the Messiah is already here and it's the Jewish people themselves. "The Messiah [is] without metaphor the Jewish people" Kethuboth 111a.

The first English translation of the Babylonian Talmud was in 1903. Even though much effort was made to remove pornographic obscenities in the name of religion and identifications found in the original, this abridged version nevertheless revealed in its Introduction that, "The Talmud is one of the wonders of the world ... after 20 centuries of its existence, powerful enemies have exhausted every effort to destroy it and yet ... it survived in its entirety ... It's foe failed to destroy even a single line ... It still denominates the minds of a whole people, who venerate its contents as divine truth." On the other hand, Jews have been working hard for the last 2000 years to destroy every line and precept of the Christians' Holy Bible. That's why we have so many versions. The Jews do not suffer from a variety of Talmudic versions. There are 63 volumes to the Talmud, dwarfing most sets of encyclopedias.

It's incredible how these scums are ready to boycott this great artist's legacy, just because after one hundred years there was discovered a painting of his, which is highly incriminating towards the Jewish community. These political circles already managed to influence our academia to renegade some of our most precious writers and poets, only because they dared to name the Jew as one of the core reasons Hungary and all the Western World are on a cultural, social and spiritual decline. I seriously hope this time we will fight for the integrity and good-name of this great painter, and they won't eradicate another brilliant Hungarian from our public discourse. The masses need to be exposed to such art.*

The #2 reason why we hate jews is because they are the world's foremost murderers. It is not so much the perverse nature of jewry as much as its diabolical character that internationally threatens the world. In the preface to the book "The World Significance of the Russian Revolution", jewish writer Oscar Levy said, "There is scarcely an event in modern Europe that cannot be traced back to the Jews. We Jews today are nothing else but the world's seducers; its destroyers; its revolutionaries." One of the hallmarks of the jewish religion and its people according to the apostle Paul was that they "Killed the Lord Jesus and the prophets, and have persecuted us; and they please not God, and are contrary to all men" I Thes. 2:15. A very common thread interwoven throughout the Talmud is stated by Rabbi Simon ben Yohai in the Jewish Encyclopedia, "The best among the Gentiles deserves to be killed." Hosea 4:6 says, "My people [meaning White Christian Israelites] are destroyed for a lack of knowledge." We just mentioned Oscar Levy bragging about being the

world's destroyers. Jews want us destroyed. And do you know what? Our people don't know squat about jews.

[Baal worship in American churches](#) keeps our people spiritually anesthetized in order to further jewish aims and ambitions. "As it is written [in the Talmud], For Thy sake [for Christ] we are killed all the day long; we are accounted as sheep for slaughter" (Romans 8:36). This comes from the Old Testament Psalms (44:22), which the jews have bastardized in their Talmud to mean the murder of Christians has been sanctioned by God, which says, "There is a law concerning the slaughter of foreigners, who are the same as beasts... The ones who do not follow the Jewish religious law have to be offered to God as a sacrifice" (Thikune Zohar, edition Berdiwetsch 88b). This law commands the jews to butcher non-jews.

The Greek historian, Herodotus, wrote about this jewish cult sacrificing humans to their devil-god Moloch (Vol. II, p.45). When Christ said, "Your father was a murderer from the beginning" (John 8:44), He was referencng these jews to their god Moloch. In the 'Protocols of the Learned Elders of Zion' (a secret document exposing the jewish conspiracy), Protocol Number 11 states, "The goyim (a derogatory term for White Christians) are a flock of sheep, and we are their wolves. And you know what happens when wolves get hold of the flock?" The Talmud teaches that wherever it is possible, a jew should kill Christians and do so without mercy. "The life of a Goi and all his physical powers belong to a Jew" (A. Rohl, Die Polem p. 20). Even Christians who read the jews' filthy Talmud are slated for death: "Rabbi Jochanan says: A Goi who pries into the law is guilty of death" Sanhedrin (59a). In Zohar (I, 25a) it says, "The people of the earth (non-jews) are idolaters, and it has been written about them: Let them be wiped off the face of the earth." These rabbinic writings are not isolated aberrations, but rather they are the definitive norm of jewish thought. The homicidal tendency is cultured bloodlust in a petrie dish from cradle to grave.

Jews are taught from childhood, the fundamental justifications for the taking of innocent life. Their deviant theology is clearly reflected in the immoral pathology of Talmudic exhortations that, 'thou shalt kill'. That's why there is no comparison to jewish law and God's Law of the Christian Bible when dealing with the subject of taking life. For example, murder committed by a White Christian is punishable,

whereas if a Jew murders a White Christian or any other non-Jew, there is no death penalty (according to the Talmud). If a Jew accidentally kills another Jew when his intent was to kill a Goy, he is not criminally liable (Sanhedrin 78b-79a).

The American public has been inundated with Jewish propaganda touting the brotherhood of Jews and Christians. However, the following passages betray any such association: "The Jews are human beings, but the nations of the world are not human beings but beasts" Saba Mevia 114, 6; "It is permitted to kill a Jewish denunciator everywhere. It is permitted to kill him before he denounces" Schuichan Qruch, Choszen Hajpispzat jog; "An orthodox Jew is not bound to observe principles of morality towards people of other tribes. He may act contrary to morality, if profitable to himself or to Jews in general" Schalchan arach, Choszen Hasixpat 348; "To communicate anything to a Goy about our religious relations would be equal to the killing of all Jews, for if the Goyim knew what we teach about them they would kill us openly" Libbre David 37; "It is the law to kill anyone who denies the Torah. The Christians belong to the denying ones of the Torah" Coschen Hamischpat 425 Hagah 425.5; "Christian birth rate must be diminished materially" Zohar (II 64b); "Jews are not to prevent the death of a Christian" Choschen Ham (425 5); "Do not save Christians in danger of death, (Jews) instructed to let them die" Hilkkoth Akum (x,1); "Even the best of the Goyim [Christian] should be killed" Abhodah Zarah (25b)T; "If a Jew kills a Christian he commits no sin" Sepher Or Israel 177b; "Extermination of Christians necessary" Zohar (11 43a); "[a Jew is] Innocent of murder if intent was to kill a Christian" Makkoth (7b); "Christians who are not Jews enemies must also die" Iore Dea (158, 1).

Are you beginning to see why some White Christians used to talk about "the Jewish question"? The question was and is, 'what do we do about the construct of Jewish genocide against our race'? Whenever the criminality of the Talmud was revealed in all its horror, it was ordered burned, expunged or censored. It was burned at the stake in nearly every century from the 11th to the 18th in Italy, France, Germany, Spain and many other countries.

At one time or another the Jews have been expelled from every country in Europe. Entire Jewish populations have been purged. Just to give you a thumbnail chronology of real history, France was one

of the first European nations which forced the deportations of Jews in 1182 AD; England in 1290; France again in 1306 and 1322; Hungary in 1360; Belgium in 1370; Austria in 1420; Bavaria in 1442; Netherlands in 1444; Poland in 1483; Spain in 1492; Italy in 1492; Lithuania in 1495; Portugal in 1496; Prussia in 1510; Italy in 1540; Prague in 1541 and 1557; the Papal States in 1569; Hamburg in 1649; Vienna in 1669; Slovakia in 1744; Moscow in 1891. This is just the short list to impress upon you the gravity of wholesale rejection against Jews. The great repulsion has put Jews under worldwide suspicion, and for good reason.

The suspicion under which Jews are held is murder. It is not ordinary murder, but rather systematic murder that has a special name, called Ritual Murder. The accusation is immediately raised, regardless of time or location, where a corpse bears the conspicuous signs of Jewish ritual murder. The accusation, from a gamut of nations, has always been leveled against Jews and no others, because of the trademark of the crime practiced against its victims. There are approximately 131 documented ritual murders committed by Jews. How many thousands, perhaps hundreds of thousands have remained undiscovered is anybody's guess. What today's White Christians must not close their minds to, is that the sordid history of the Jewish people is a continuum of mass-murders and a lust for blood.

What exactly is the ritual and why is it part of the Jewish religion? Joseph Kastein, an official historian of Jewry, has stated that Jews believe "Blood is the seat of the soul." In contradistinction to the Christian view that the heart or one's spirit determines our soul or personality, Jews believe that by drinking the blood of a Christian victim, who was perfect in every way, they (Jews) could overcome their physical shortcomings and become as powerful as the intelligent civilized beings among whom they had formed their parasitic communities. The strange parallels can be traced back to the social pathologies of ancient Babylonian Baal worship and permutations found in the pagan practice of cannibalism. Secret occult societies have followed the lead of satanic instructions found in the Jewish Kaballah.

The Jews are charged with enticing White Christian children, and at times adults, into the synagogue or into a more secret place for sacrificial slaughter. The victim is tied down, stripped and pierced with sharp

ritual knives in the identical places where the body of Christ was inflicted. As the blood is drained into cups, the Jewish leaders drink the blood, calling down curses upon Christ and on all non-Jewish people. Only by performing this rite, do they believe they can continue to survive and prosper within the host nation. The Jews are charged with mixing this blood into their unleavened bread and using it to practice superstitious magic. The Jews are charged with torturing their victims, bleeding them white, crowning them with thorns, beating and stabbing them in a complete re-enactment of the crucifixion. All Jews, unless they are mentally retarded, are aware of the blood ritual and its importance to Jewish culture. However, only the most influential leaders, rabbis and rich Jews are allowed to participate in the ceremony. Ordinary Jews are forbidden because the criminal practice is fraught with security risks for the entire Jewish community (as past history has proven).

Most uprisings against Jews during the past 2000 years have developed from the discovery of this syndicated and institutionalized crime. There is a trickle-down application for those Jews who do not participate in the actual crime scenario. The ritual blood is used in other ways by drying it for use in weddings, funerals, circumcisions, pregnancies and older Jews believing they can become younger by ingesting it. The remainder of the blood is preserved with the greatest of care by the local rabbis and sold in small bottles as certified Christian blood. Catholic scholar, James E. Bulger, states that the drinking of blood is a black magic ritual which enables the Jewish rabbis to predict the future. During the Jewish Passover, a Jewish father will mock the Christian communion by pouring a few drops of ritualized blood into a glass of wine and sprinkles the dinner table saying, "We beg God to send down the ten plagues upon the enemies of the Jewish religion" and after they wine and dine, he says "Thus (like the child whose blood has been mixed in the bread and wine) may all Goyim burn in hell!" Make no mistake about it, Jewish ritual murder is still going on today and all levels of government do nothing, because they are up to their necks in whitewash and cover-ups. Those who know what's going on keep their mouths shut and receive their 30 pieces of silver. Why would Jews stop now in this day and age when they're on a roll? Ex-congressman Paul Findly wrote a book called "They Dare To Speak Out," which describes those officials in government who do not take the bribe and whose careers are virtually

destroyed.

Jews have the power to conceal their crimes as their media controlled image portrays themselves as the eternal victim. The Jewish reaction to what they call the 'blood libel' charge has always been 've is beink poiseuted'. With a straight face, they maintain that down through the millenniums of history, there has been a humongous conspiracy to frame them. According to this theory, in all of the European nations mentioned earlier and in places as far apart as Montreal and Argentina, there exists one big long, continuous plot to murder White children at certain times of the year, drain them of blood and then plant the bodies on Jewish premises so they get caught. That's one heck of a conspiracy folks! But, are we to believe that our ancestors were just antisemitic fools, who periodically plotted to persecute Jews, if the real-life child-killers were non-Jews? Would they allow the real killers to go free because they wanted a Jewish scapegoat? Why, time after time, did the ritual murders cease after the Jewish killers were prosecuted and usually driven from the land?

In the United States, perhaps the most famous victim of Jewish ritual murder was the son of Charles Lindbergh on March 1, 1932, during the time of the Jewish annual feast of Purim. Lindbergh's father, a U.S. Congressman, had published a scathing indictment against the Warburg Jewish banker's passage of the Federal Reserve Act, which federal agents confiscated and burned. After Charles became a national hero from his solo flight across the Atlantic and following in his father's footsteps to warn the American public about the evil ambitions of Jewry to start World War II against Germany, his little boy was slain as a warning to back off.

Eustace Mullins, in his book "New History of the Jews" said, "In the U.S., Jews have been able to practice ritual murder of gentile children with impunity, because they control the press, and because they hold so many high public offices. It has been estimated, by a leading police official, that 4,000 children disappear in the U.S. each year. There is no question that the majority of them are victims of Jewish ritual murder. So prevalent has the custom become in this country that Jews are able to ship large quantities of the children's blood to Israel for use in their ceremonies there. One of the problems of the Jewish homeland in Israel has been a shortage of Christian children who could be used in the ritual

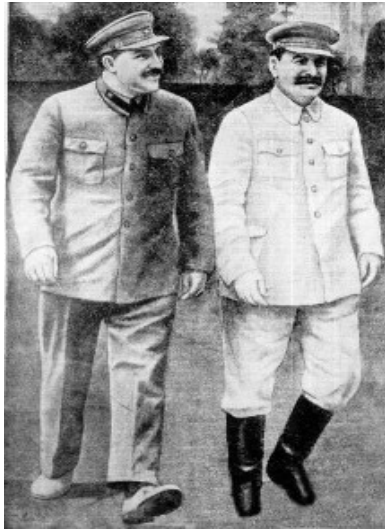


ceremony, and the U.S., which has also furnished most of the money to Israel, has also provided much of the required children's blood."

How many Christians are aware of the appalling estimate of 100,000 children missing each year? Thousands are murdered with the blood drained from their little bodies. The jewish people are entirely capable and complicit in committing this dastardly deed. The immense weight of historical evidence conclusively points to the repetitive psyche of murder in the jewish soul for Jesus Christ and everything Christian. How many of the innocent youngsters you see on milk cartons have fallen prey to the ceremonial knives of rabbis and lie buried in secret graves or were ground up into dog food in some jewish-owned processing plant? This all may sound unthinkable and outlandishly far-fetched to the cognitive dissonant mind that has been conditioned to eagerly accept the mythos of 6 million gas-bag jews turning into ash, after 60 years of Pavlovian movies, books and TV. It would be quite another story if these medias were not owned and/or controlled by jews. You would be hearing about the greatest murder plot against humanity in the history of the world.

The jew cannot escape what it has taken upon itself. Every jew enjoys their station in life because of their lust for blood. Their benefactors are crucifiers and mass murderers. At one time you could read who was the biggest mass murderer in the history of mankind in the Guinness Book of World Records, however that is no longer a category. If it were, you would read about Lazar Kaganovich, Stalin's jew, who planned and implemented the extermination of 20 million Russian and Ukranian peasants. Within the first 5 years of jewish rule in the Soviet Union, the blood-stained terror eliminated 6,000 teachers, 8,000 medical doctors, 54,000 army officers, 260,000 soldiers, 150,000 police, 12,800 civil servants, 355,000 of the upper class, 192,000 middle class workers and 815,000 peasants. Between the years of 1921-22 over 5 million died of socially engineered starvation. In 1933, the Archbishop of Canterbury reported 6 million victims of famine. Aleksandr Solzhenitsyn cites the research of the exiled Soviet statistician I. A.

Kurganov, who had access to secret government figures, as estimating that the number of people killed by the Soviet Secret Police, between the Revolution and 1959, totaled at least 66 million. This is the actual system of Talmudic bloodshed and death carried out by hysterical and neurotic jews of the worst sort of criminal megalomania imaginable, who would have it copied in every country and among every people with the same terror, in so far as they might find the potential to do so.

There is an underworld in the world of organized crime that a famous New York prosecutor nicknamed "Murder Incorporated" on Sept. 11, 1931. At this point in time a paradigm shift occurred (in the world of crime) as the old guard greaser Sicilian mobsters were eclipsed by a newly rising gangster, many of whom were non-Italian and lethally streamlined for a new era of an American criminal corporation. Richard Kelly Hoskins calls it the International Trade Cartel. Others call it communism, Zionism, the New World Order, the Global Economy or the United Nations. I prefer to call it the satanic antichrists of world jewry.

The transformation of ultra-depredations and moral trauma committed at the highest levels of our society makes it nearly impossible to discern the grotesque structure that has taken shape in the form of a superbly efficient assassination machine. It's just not called the American-Jewish Crime Corporation or registered with the New York Stock Exchange, because it has absorbed the major players of the professional business world into their insatiable grab for power. It is the ethnic identity of these habitual terrorists that is relevant to our wake-up call for survival.

We must realize that the political process of a constitutional republic was profoundly compromised with the jewish mafia engineering the election of Franklin D. Roosevelt in 1932. Meyer Lansky and other jewish crime lords decided who the president of the United States would be (then and ever since). The murder of John F. Kennedy, his brother Robert and his son John Jr. is not an unsolved mystery in light of mounting evidence towards the empire of jewish criminals. Hollywood has carefully perpetuated the façade of 'Dago' stereotypes in all of the gangster

genre movies, while the real mob bosses have remained hidden. John Gotti was a minor player betrayed by his own brotherhood and a perfect collar for law enforcement propaganda. Whenever the cops or prosecutors bust the real culprits i.e. the jews, you can count on the shrill whine of 'antisemitism' by gangsters who wrap themselves in the camouflage of religion. Ronald Reagan was given a warning shot after publicly talking about abolishing the jewish IRS. Not wanting to end up like JFK, Reagan appointed U.S. Federal Judge Irving Kaufman, to head his new Crime Commission to crack down on 'Organized Crime'. Kaufman was secretly a high level member of the Anti-Defamation League, a vicious hidden foe of America and Christianity. After 2 ½ years, this jews great revelation was denouncing new criminal networks emerging in the U.S. from Italian, Japanese, Chinese and Mexican organizations. Of course, this jew never once mentions the Mishpucka (which means family i.e. the jewish crime family), the most secret, deadly, powerful organized crime family in the world and the only one dedicated to the total destruction of White Christian America.

The Mishpucka is not anything new, just a well concealed cult usurping peaceful governments and their people, while posing as philanthropists and do-gooders. In 1977, U.S. Congressman Henry Gonzalez of Texas disgustingly explained that he had resigned the chairmanship of the House Committee to Investigate Assassinations "Because vast and powerful forces, including the country's most sophisticated crime element, won't stand for it. The criminal element is all-pervasive, loaded with nothing but money and in many ways more potent than the government itself." Of course, he couldn't have been alluding to anyone other than jews.

This matriarchal god (the mother of harlots) is Babylonian as is the Talmud (abominations of the earth). Rev. 17:5 speaks of "*Mystery Babylon the Great*", which is a final culmination of all previous beast empires, "*Drunken with the blood of the saints, and with the blood of the martyrs of Jesus*" (Rev. 17:6). A 'mystery' in Scripture is a previously hidden truth, now divinely revealed, but in which a supernatural element still remains despite the revelation.

There is a reckoning coming, a fulfillment of prophecy between the children of those who have departed from God and the children of those who have remained with God. It's the war of Obadiah between Christians and jews. "*And the house of Jacob shall be a fire, and the house of Joseph a flame, and the house of Esau [jewry] for stubble, and they shall kindle in them, and devour them, and there shall not be any remaining of the house of Esau, for the Lord hath spoken it*" (Obadiah 18).

You might say we owe them a Holocaust. We've been paying their bills for 50 years and at some point we're finally going to get what we paid for. Which brings us to the third element of why we hate jews as Martin Luther titled his book "The Jews and Their Lies." As we move into this study, we'll see more examples of death and murder in the other elements.

## Thoughts on the Jewish problem & The HoloHoax

The following is a written version of the ideas at the beginning of my recent Heretics' Hour radio program of 3-25-13 titled "Time to Blow the HoloHoax Out of the Water." Some people get upset when the word "holohoax" is used instead of "holocaust," thinking it is unnecessarily antagonizing to Jews — but I think it is proper, if just to keep from having to repeat *their word*, Holocaust, over and over and thus reinforcing a word that to those of us in the know, is offensive to us. *Right: In Yad Vashem's over-the-top "Hall of Names."*

**What holds the HoloHoax in place? Not the truth, not the facts. To find out, look at it this way.** Imagine that it was "blown out of the water." No more gas chambers. No more familiar sentences in newspapers and magazines, radio and TV, plus all over the Internet, reminding us daily that "6 million Jews were killed by the Nazis." No more aging "survivors" trekking to public schools, public libraries, community centers and any other venue that is offered, to tell how they escaped from a gas chamber during history's most evil event.

But how much else would also go? How many jobs would be lost. (Re-training would be on a massive scale.) How many books would need to be rewritten, or trashed altogether. How much embarrassment would be felt among how many people of the educated class. Yes, it boggles the mind.

But even demolishing the Hoax to that extent would not do away with the mass deportation of Jews, experienced by them as a traumatic event, which was carried out by the National Socialist regime of Adolf Hitler. This mass deportation from Nazi-occupied Europe, and the concentration and transit camp system built to facilitate that move, really happened. Labor

camp cropped up, after 1942 especially, because of a shortage of German manpower due to the war on the Soviet Union — which also greatly hampered, and ultimately prevented, the plan to move the Jews further east into the Russian interior. Thus, the decision was made to place them in labor camps and try to get some war-industry benefit out of them. All of this presented great challenges to the Germans.

What we can, and should, call "The Great Jewish Deportation," rather than "Holocaust" is a fact. So is the concentration and labor and transit camp system, overseen by Heinrich Himmler, Reichsführer SS. No matter what else is wrong with the HoloHoax, this remains to be dealt with, and always will because it was a reality. What attaches to it, and is untrue but hard to get rid of, are the stories about SS brutality in the camps that Jews and their communist non-Jewish allies love to tell. But this also can be effectively countered by revisionist scholarship and the weakened credibility of the "survivors" who tell and have told these stories. What doesn't go away, ever, is the deportation itself and the widespread idea that it was wrong and inhumane, and in fact constitutes a crime against humanity (in loose, not legal, language). In the language of the Jews, it is the inevitable result of antisemitism — though they like to spell it anti-Semitism.

### Antisemitism is our stumbling block

The idea I'm presenting is that the real problem we face is The Jewish Problem, also known as "the Jewish Question" — which Jewry turns around on us and calls antisemitism. Henry Ford's early publication of his ambitious work was titled *The International Jew – The World's Foremost Problem*. It was later shortened to *The World's Problem*. And even then,

when Jews were identified as having a detrimental influence on the country they had only recently come to in great numbers, the United States, the Jewish leaders characterized such criticism with cries of “religious persecution” and “antisemitism.” And they always won with such tactics, too. Therefore, the critical need that we better understand The Jewish Problem.

The major effort of the Jews *throughout history* has been to prevent their expulsion from their host countries. Think about it – as parasites, which they truly are, it is critical to their survival to remain in host countries. I’m aware that calling a whole race of people parasites is considered antisemitic in itself. Okay, it is — but it is also true. From their early tribal times (beginning at least 2500 years ago) they were a wandering people who sought out “others” with whom they could trade and also live among and gain, through one way or another, some of the wealth of these “others.” This *is* the story of the Jews. Natural, or perhaps even genetic, traders – they sought out foreign places and peoples where they could make a living from trade, primarily, but also through performing services of various kinds. Jews were not tillers of the land and had little loyalty to a homeland or a particular place with which they identified. They easily became Internationalists, and still cling to those values to this day, values in which their sense of security comes from wealth and tribal/family bonds as Jews, crossing national boundaries.

Thus, their way of life *is* parasitic. It’s not a nice word, but it is true nonetheless. Jews don’t bring benefit to the population of the countries they inhabit (always temporarily because they do not strongly identify with it); rather they enrich themselves from it. They live off their host (the work and wealth of people united by blood, soil, language and history) exactly as do parasites in the animal/insect world. When this is noticed and resented by the host population, the Jews cry persecution in some way or other — the contemporary cry has become “antisemitism.”

### **The Survival Instinct plays a key role**

Everything in nature is built, or has evolved, with survival as the strongest, most primary instinct or value. Survival is our first concern as humans, before anything else can matter. For Jews, survival depends on the willingness of their hosts to allow the Jews to live as parasites among them. This requires a great amount of propaganda and thought-control by the

Jews, which is why they went first of all for control of communication outlets, which we now call Media.

Through their foresight, planning and propaganda, they managed to disable the survival instinct of their White host population by convincing us that our survival was not at risk. The very idea seemed impossible to us and was not entertained ... until very recent times when we see with our bare eyes (if we’re not blind) the terribly dangerous demographic and political situation we are facing.

Jews, however, have never lost touch with their survival instinct – and those individuals who appear to be assimilating too much are reminded, through a variety of ruthless tactics, to get back into the tribal thinking or bad things will happen. The HoloHoax is made to order for that.

### **Revisionism and the “good Jew”**

The “good Jew” is our worst enemy. Otherwise admirable revisionists who search for the good Jew - some who actually love the Jew and others who are merely tolerant of them in our midst, sometimes because they fear crossing them – are nullifying their own work. The end of the HoloHoax cannot come when such beliefs and “values” are held. If the deportation of Jews from Europe is the only basis left for the “Holocaust,” but that deportation was unwarranted – was not justified on grounds of their harm to European society – then the Jewish Holocaust cannot be completely dismantled. The harm done to Jews, not to us, is what will stand in history.

Considering this, defining the rightness or wrongness of expelling Jews *en masse* from any of their host nations is the key to solving The Jewish Problem. The idea that it is wrong to do so, and cannot be justified under any circumstances, IS The Jewish Problem today. This idea must be re-examined in the light of the increasing criminalization of antisemitism, in the form of “hate laws” and large fines and prison sentences for hurting the feelings of Jews by not liking them and/or not wanting to live with them.

This campaign to create a total intolerance of antisemitism is a huge project of International Jewry. The [Alliance Israelite Universelle](#) was founded in 1860 in France as an international organization to defend against any perceived slurs or “attacks” on Jews anywhere in the world. This included, at that time, legal charges of ritual murder of Christian children and adults against religious Jews. World

renowned Jewish legal minds volunteered their services to defend any Jew who was so charged. Today, all Jewish criminals are still defended (think of the 1913 Leo Frank murder case in Georgia, Israeli spies, and today's rabbinical pedophiles) and great efforts made to "hush up" the gory or incriminating details from the White public. Disapproval of this kind of Jewish cover-up is labelled antisemitic.

On "[The International Jew' Study Hour](#)" program here at The White Network, Hadding Scott and I have just been reading about the American Jewish Committee, begun in 1906 in New York for the same purpose – to protect Jews from negative publicity. They pretend Jews need physical protection – that antisemitism leads to physical violence against Jews – but in reality that has not been demonstrated. In actuality, their purpose is to stop cold any anti-Jewish thinking, feeling or believing, and to cause Whites to feel guilty and ashamed of such thoughts. In Chapter 36 of TIJ we read something very relevant to this essay:

For a long time in the United States the people did not know how to refer to the Jews, whether as Hebrews or Israelites or what, because the fear of giving offense had been so diligently cultivated in all quarters.

### **How to respond to the charge of "antisemitism"**

If, as I'm stating, the HoloHoax is a result of The Jewish Problem, and we can't rid ourselves of the first without ridding ourselves of the second –then revisionism has mental and emotional blocks to overcome. When revisionists want to talk about facts, forensics and the reliability of documents, Jews only respond with charges of antisemitism. Because of this, CODOH (Committee for Open Debate on the Holocaust) is somewhat behind the times in its current form in the fight for truth. There *is* no debate and no hope for any future debate. Since the 1970's, when the Holocaust Industry ("exterminationists") found they were losing the debate to the revisionists, all pretense of debate has stopped. We should not still be looking for debate when the Holocaust Industry moved on to the use of government and judicial power long ago. Only he who has the power counts.

Jews have been establishing their power for centuries, while they outwardly claim they only seek fairness

and equality. Thus, our many revisionists (some of whom have already spent years in prison for staying the course) who insist on talking in terms of "fairness and equality" in return, are fooling themselves. It is painful to say, but their efforts are, in the end, not enough to do the job.

"Waking up" is more than some people think it is. Waking up to the facts of the HoloHoax is only the first part. Waking up to the reality of united Jewish power and united Jewish parasitism, which are two things Jews can never let go of as they are essential to their survival, is the rest of the waking-up process.

Postscript: An interesting quote sent to me by reader/listener Michel might shed more light on The Jewish Problem. Douglas Rushkoff, Jewish author of *Nothing Sacred: The Truth about Judaism*, was featured in a 2005 film "[Protocols of Zion](#)". At the 1:05:48 mark, he said: The thing that makes Judaism dangerous to everybody – to every race, to every nation, to every idea - is that we smash things that aren't true. We don't believe in the boundaries of nation states, we don't believe in these individual Gods that protect individual groups of people; these are all artificial constructions, and Judaism really teaches us how to see that. In a sense our detractors have it right, in that we are a corrosive force. We're breaking down the false gods of all nations and all people because they're not real ... and that's very upsetting to people.

This reminds me of the [video](#) of the Jewess in Sweden who so carefully explains that the Jews are behind the introduction of diverse races and cultures in Europe, and it's for our own good, as well as being an unstoppable force. A quote from another Jewess commenting on Rushkoff's book:

# Witness to History

## LIFE IN HITLER'S GERMANY chapter 5

Michael Walsh – British Historian

**E**conomic and social conditions began to improve. Hitler's Government by September, 1936 had reduced unemployment from 6,014,000 (January, 1933) to less than 338,000 by 1936. National income had increased from 41 billion marks to 56 billions. German trade was prospering. Deficits of the cities and provinces had almost disappeared. Expenditure for armaments was minor.

Unemployment was eliminated mainly by:

- 1) Increased government spending on public works; infrastructure, railways, roads, public building projects.
- 2) Indirect support to private works projects.
- 3) A sharp reduction in taxation to create incentive.
- 4) Reduction in taxation and increased state contributions to make employment more attractive.
- 5) Public good workfare schemes, (non-competitive) with private and government schemes.

The effect was an injection of increased wages into the national economy, increased consumer spending which in itself led to job increases. By 1936 there was a shortage of labor, especially in the building and metallurgical trades.

### TAXATION

"The taxation of families, especially of those with numerous children, has been noticeably decreased."

### CIVIL LIBERTIES

All workers (and their employers) were protected by a 'Tribunal of Social Honour' which laid down conditions of employment which were superior to any comparable legislation in the world. Except for reasons force majeure it was illegal to dismiss an employee, all of which including employers had recourse to independent mediation by tribunal.



### THE STATE

"We have laid firm foundations for the new State: we have sown seeds that have sunk deep. We have won millions upon millions of men for the ideas on which this State is based; we have introduced them to the life of this State, always in the conviction that it is not laws which protect a State; it is the living will, the

faith, the confidence, and the courage of a people which are its true protection." Adolf Hitler

"The national State divides its inhabitants into three classes: State citizens, State subjects, and foreigners. It must be held in greater honour to be a citizen of this Reich even if only a crossing-sweeper, than to be a king in a foreign State." - Adolf Hitler

### CLASS

"We have not broken down classes in order to set new ones in their place; we have broken down classes to make way for the German people as a whole. Our education also trains men to respect intellectual achievement: we bring one to respect the spade, another to respect the compass or the pen. All now are but German fellow-countrymen, and it is their achievement which determines their value." - Adolf Hitler

"What is necessary is to teach each class and profession the importance of the others. All together form one mighty body; laborer, peasant, and professional man." - Adolf Hitler

### LABOR

"All work which is necessary ennobles him who performs it. Only one thing is shameful - to contribute nothing to the community." - Adolf Hitler

"Nothing falls into a man's lap from heaven. It is from

labor that life grows." - Adolf Hitler

"Social honour recognizes no distinction between the employer and the unemployed. All of them work for a common purpose and are entitled to equal honour and respect." - Adolf Hitler

**SOCIAL WELFARE** - based on the concept of 'one for all and all for one.' All German workers received a pension and insurance in the event of sickness or disability. Whilst some of these rights are taken for granted today, it should be remembered that at the time, such social protection was unheard of outside of Germany.

### **YOUNG PEOPLE**

Child labor was prohibited, hours of work regulated (especially for expectant and new mothers), safe working conditions provided for, persons between 14 and 18 years of age prohibited from working in excess of 8-hours daily; night work for young persons similarly prohibited, paid holidays of persons below 16 years (15 working days), above 16-years (12 working days); usually increased to 18 days without regard to age.

"I have heard of no instance where workers had lost important rights or amenities."

"Good work is undoubtedly being done towards eliminating corruption in public and business life, and administration is being re organized on more efficient and economical lines."

- H. Powys-Greenwood. Hitler's First Year

"The whole of education should be designed so as to occupy a boy's free time in cultivation of his body. He has no right to loaf about idly; but after his day's work is done he ought to harden his young body, so that life may not find him soft when he enters it. No one should be allowed to sin at the expense of posterity, that is, of the race." - Adolf Hitler

### **FREEDOM OF MOVEMENT AND SPEECH**

"Last July, feeling that the Press of this country was willfully lying and conducting a political campaign against Germany, I resolved to go to Berlin and make free and independent investigation. I was determined to do pretty much as I pleased when I got there, and no one interfered with my movements. I found Germany, comparatively speaking, a free country,

much freer than some of its neighbours. My own views were not always acceptable to my many friends, among whom I can count Jews and Gentiles, Nazis and Communists, Democrats and Socialists. Soon I found that being a Nazi does not preclude one holding views that few Labor men in my own country would dare to express to their 'comrades' of the national Labor Party." - G.E.O Knight. In Defence of Germany

### **BANNED**

The ritual slaughter of animals.

"The Jews enjoy absolute religious freedom, and the resolution passed by the Zionist Congress in Prague in which the German Government was accused of pursuing a policy of religious persecution towards the Jews was entirely unfounded. The resolution was probably motivated by the fact that the 'Law for the Protection of Animals' prohibited the slaughter of animals according to Jewish rites." Cesare Santoro. Hitler Germany

Also banned, Vivisection Abortion, Child Labor  
The use of truncheons or other methods of violent restraint generally used by policemen.

### **BENEFITS**

During the first years of National Socialist government, the improvement in the German peoples standard of living, social security and their holiday and leisure facilities, placed Germany well ahead of all other nations including the United States. Such prosperity and social benefits have never reached the same scale anywhere in the world unless perhaps in a few privileged conclaves of society.

### **VIOLENCE**

More people died as a result of the tiny abortive Easter Uprising against British rule in Ireland (1916) than died as a result of political violence in Germany during the entire National Socialist revolution." Adolf Hitler

### **THE NATIONAL SOCIALIST FORM OF DEMOCRACY**

The National Socialist form of democracy was based on the principle of 'community of the people' which had its origins at the time of Pericles. This conception of democracy as an expression of the popular will was confirmed in the National Socialist regime by conferring on the nation the right of organizing

plebiscites (referendum) in order to give utterance to the peoples desires. Thus, the National Socialist form of democracy was more pure and more representative than that of a parliamentary regime which takes no account of majority opinion (capital punishment, immigration, Europe, to name a few); political ability or experience, genuine motivation, interest, nationality; and is often based on social background and influenced by interests; commercial for instance, in which the national good comes secondary.

"The result of the revolution in Germany has been to establish a democracy in the best sense of the word. We are steering towards an order of things guaranteeing a process of a natural and reasonable selection in the domain of political leadership, thanks to which that leadership will be entrusted to the most competent, irrespective of their descent, name or fortune. The memorable words of the great Corsican that every soldier carries a Field Marshal's baton in his knapsack, will find its political complement in Germany." - Adolf Hitler

"What the German nation has ardently desired for centuries is henceforth a reality; one single, fraternally united people, liberated from the mutual prejudices and hindrances of past times." Adolf Hitler

"The will of the people is the will of the government, and vice versa. The new political structure raised in Germany is a kind of ennobled democracy; i.e., the government derives its authority from the people, but the possibility of misinterpreting the peoples will or of sterilizing it by the intervention of parliamentary methods has been eliminated altogether." - Dr. Joseph Goebbels

"The movement was consolidated together in one Reich a people who were hitherto kept in disunion but various lines of division.... religious divisions, class divisions, professional divisions, political divisions and the territorial divisions into the various autonomous federal states. This unification is now an historical fact. Nationalism has founded a genuine folk community.

"Formerly the votes of the people were distributed among several political parties. Eventually the number of these parties came to thirty-six. They had no great common platform to offer to a people who were struggling to live. They carried on their political campaigns against one another in a quarrel over paltry and selfish issues.

"Today the people of Germany vote for one leader and one party in a consolidated unity that has never before been dreamed of. The whole of Germany was aroused to struggle for these great questions which are of vital importance to a nation's existence." - Rudolf Hess. Stockholm



"The parliamentary principle of decision by majorities only appears during quite short periods of history, and those are always periods of decadence in nations and States." - Adolf Hitler

### **THE THIRD REICH LTD**

The NSDAP became (April 8th 1933) in effect a public corporation, the constitution of which removed all suspicion of a personal dictatorship

by Adolf Hitler.

"We have deliberately built up an organization counting many thousands of adherents, in which there is no dictator. And when our adversaries say; 'It is easy for you to say this, since you are yourself the dictator,' we reply: no gentlemen, you are mistaken. There is no question of a single dictator, but of ten thousand dictators, each of them in his place." - Adolf Hitler

In a speech to the Reichstag, he stressed that whilst people outside Germany are perpetually talking of democracy and dictatorship:- " They have not understood that the result of the revolution in Germany has been to establish a democracy in the best sense of the word. We are steering towards an order of things guaranteeing a process of natural and reasonable selection in the domain of political



leadership, thanks to which that leadership will be entrusted to the most competent, irrespective of their descent, name or fortune." - Adolf Hitler

### **HITLER, THE PEOPLES VOICE**

".... Hitler has repeatedly taken the opportunity of consulting the nation and has each time obtained its wholehearted approval of his policy and methods of government." - Cesare Santoro, Hitler Germany

"I myself was and still am a child of the people. It was not for the capitalists that I undertook this struggle; it was for the German working man that I took my stand." - Adolf Hitler

### **WOMANHOOD**

"I give women the same rights as men; but I do not think they are the same to the one as to the other. The woman is the life-partner of the man. She ought not to be burdened with the tasks for which man alone is made. But in every case where women do not marry - and there are many in Germany owing to the shortage of men - they have the right to earn their living just in the same way as any man." Adolf Hitler, Paris Soir, January 26th 1936

"The National Socialist State refuses to admit female labor in factories merely because such labour is cheap. There is, of course, a certain amount of industrial work which can only be performed by women, but an essential condition is that this sort of work should not be injurious to health." - Adolf Hitler

"The phrase, 'Emancipation of Women' is only an invention of the Jewish intellect and its content is stamped with the same spirit. In the really good periods of German life the German woman never needed to emancipate herself." Adolf Hitler

### **SERVICE TO THE COMMUNITY**

"The readiness to sacrifice one's personal work and, if necessary, even one's life for others shows its most highly developed form in the Aryan race. The greatness of the Aryan is not based on his intellectual powers; but rather on his willingness to devote all his faculties to the service of his community." - Adolf Hitler

### **INTEREST FREE LOANS**

Interest free loans of up to 1,000 Deutschmark were

paid to newly-married couples provided that the wife having hitherto been a wage earner, relieves the labor market by her marriage. The loan is redeemable at the rate of 1% per month, and for each child born is reduced by 25%. 925,000 newly married couples took advantage of this scheme, and they produced 825,000 children.

### **CAPITALISM - COMMUNISM**

"Capitalism and Bolshevism are the two sides of the same international Jewish coin." - Adolf Hitler

### **MOTHER AND CHILD**

An organization known as 'Mother and Child' was formed to provide for the welfare; health, safety, financial security, and recreation of expectant mothers, mothers and their children. This provided for 26,000 local centers staffed by 227,000 (100,000 voluntary) communal sisters, matrons, governess', and nurses. Also provided 160 centers which by 1937 had provided 1,800,000 children with holidays. A further 308 centers were established for mothers of which there were by 1937, 71,000 who had taken advantage of a break. There were 4,319 day nurseries and kindergartens and 2,700,000 mothers had taken advantage of NSV assistance.

### **CHILD CARE**

"In Germany today there are nearly two-thirds more kindergartens than before National Socialism assumed power. Thousands and thousands of children have been sent to special holiday and sunshine homes in the country and at the seaside. Their numbers would suffice to flank both sides of the Berlin-Nuremberg road."

"We have now been successful in decreasing the percentage of infant mortality from 7.09% in 1932 to 6.6% in 1936. In this way, and notwithstanding the increase in the birth-rate we have presented the nation with 140,000 baby boys and girls - a figure that is the equivalent to the population of Lubeck..... tears must be turned into smiles and no effort must be spared in order to create a healthy and strong nationhood." - Herr Hilgenfeldt. Head of Welfare Organisation

### **MORALITY**

The fight against the poisoning of the soul must be waged alongside cultivation of the body. The life of the people must be freed from the asphyxiating

perfume of modern eroticism. The aim and method must be governed by the thought of preserving our nation's health in body and soul. The right of personal freedom comes second in importance to the duty of maintaining the race." - Adolf Hitler

## **HOUSING**

A subsidized housing program was based on providing all German families with a maximum of two storey accommodation each with its own garden "thereby developing attachment to the soil." The building of maisonettes and flats was discouraged.

## **SOCIAL WORK**

"The purpose of social work should not be to distribute favors, but to restore rights." - Adolf Hitler

## **FOREIGN VISITORS**

"I wish very much that your tourists would visit us not merely when sporting events are on but also that they could visit the country, I mean the whole country. There will be no organized propaganda tours to conceal the truth from them. We shall not tell them that Germany is a paradise, for there is no such thing on earth. But your tourists can travel here unhampered and complete freedom and see for themselves that Germany lives in peace and order and at work. They will observe our revival, the efforts we are making and our good will for peace. That is all I hope." - Adolf Hitler, Paris Soir, January, 26th, 1936

"Thousands of Americans, Englishmen and Frenchmen have visited Germany during the months after the national revolution and were able to testify as eye-witnesses that there is no country in the world where law and order are better maintained than in present-day Germany. That there is no country in the world where person and property are held in better respect than in our own, but that there is perhaps also no country in the world where a more rigorous fight is put up against those who believe that they are free to let loose their lower instincts to the detriment of their fellow-beings." - Adolf Hitler

## **RACE**

"We do not say that one race is superior to another, but we do say that there is a difference between the various Races of the world." - W. Gross, M.D., Racio-Political Department. Berlin

"The German intends henceforth to be the master of his own house to the exclusion of alien elements. Hence, in Hitler's view, the German Government must see to it that only persons of authentic descent are admitted to exert an influence on the destiny of the German people." - Cesaro Santoro. Hitler Germany

"Differentiation of treatment is not motivated by the difference of value of the two races, but of the fundamental difference of their respective natures." "Every public function, of whatever nature it may be - whether in the Reich, in the States, or in the municipalities - should be confided exclusively to German citizens." - Article VI NSDAP Program

The National Socialist view on nationality was to claim the honest legislation of immigration policy already practiced by other countries. The United States classified immigrants as desirables or undesirables according to their country of origin, as does Australia and many other countries.

"The world is undoubtedly going through great changes. The only question is whether the outcome will be the good of Aryan humanity or profits for the Jew. The task of the national state will, therefore, be to preserve the race and fit it to meet the final and great decisions on this globe by suitable education of its youth." - Adolf Hitler

Germany is a Christian nation of which more than 46 million belong to the German Evangelical (Protestant) Church, and 30 million to the Roman Catholic faith.

"And so I believe today that my conduct is in accordance with the will of the Almighty Creator. In

"We wish to fill our culture once more with the spirit of Christianity - but not only in theory." - Adolf Hitler

## **HOLIDAYS AND LEISURE**

Before National Socialism, millions of people had never seen the inside of a theatre. A survey found 87.6% (men) and 81.3% (women) had never seen an operatic performance; whilst 63.8% (men) 72.2% (women) had never visited a theatre.

By 1936, 22,100,000 had visited theatres, 18,600,000 visited film performances, and 5,600,000 attended concerts, 3,300,000 factory exhibitions, and 50,000,000 to cultural extravaganzas. 230 colleges for popular/hobby education had been established, 62,000 educational conferences had been attended by 10 million.

It was arranged so that all workers traveled during their holidays on the premise that it was no holiday unless there was a change of air. In two years there were 384 sea voyages taking 490,000 workers on foreign cruises, more than 60,000 national holiday excursions (19 million participants), 113,000 hiking tours with 3 million participants. A holiday camp with full holiday facilities was built to accommodate 20,000 people.

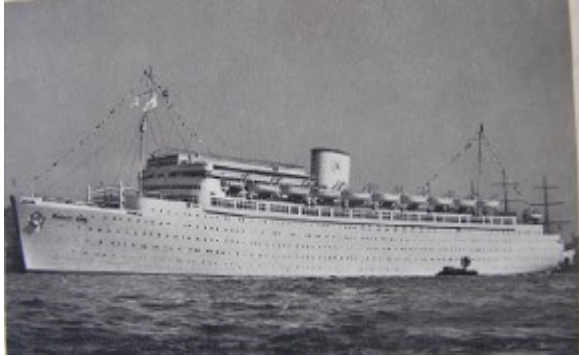
Every big commercial or public concern was provided with its own sports and recreation grounds, swimming baths. A fleet of yachts was put at the disposal of water sports enthusiasts, likewise winter and summer sports equipment and facilities. Likewise, all factories, offices, stores and shops were fitted out for recreation yards, swimming pools, clean and modern canteens, comradeship houses, sports grounds.

"It is hoped for every worker to have an adequate annual holiday. I saw one of the first holiday special trains leave Berlin with 1,000 workers for Bavarian mountains." - H. Powys-Greenwood

## **ADOLF HITLER ON ACHIEVEMENTS**

"Recently the German Labor Front launched its own ships, the Wilhelm Gustloff and the Robert Ley, which were especially built and fitted for such sea trips. It is planned to build about twenty steamers for this purpose. The comfort and living conditions in that

ship are but little different from those in the great liners. Just as on the great luxurious liners, so on the Wilhelm Gustloff and the Robert Ley, you can have your daily bath in fresh water, enjoy hot and cold water in your cabin; drink ice water, swim in a large pool, play in the sports room, enjoy all the deck games and dance in the evening or attend some entertainment."

The cost of such trips was 158.37DM and were limited to workers who earned less than 300DM a month, with preference going to those who earned less than 200DM a month. The ordinary German worker and his family enjoyed a standard of living which was at the time exclusive to the very rich in America and in Britain, where ordinary workers at the time rarely went to the theatre or concerts, and the holiday of a lifetime might be a few days in Blackpool or Margate. Foreign holidays and cruises on ocean going liners could only be dreamed about; and social deprivation, unemployment and harsh working conditions were the lot of most people. One can imagine the impression that German standard of living might make on other Europeans who might look beyond the curtain of distortion and consider National Socialism as an alternative form of government.

"Five years of National Socialist constructive work have brought about; the right for every worker to claim a holiday on full pay. Minimum and not maximum holidays are fixed." - Adolf Hitler, Fifth Anniversary Speech

"Today our achievements are so vast that the whole world has become interested in them."

"We have done rightly in organizing trips to foreign countries. We shall continue along these lines [and in the spring of next year we shall have six large steamers carrying workers to Lisbon and Madeira....

During the National Socialist Party Congress in Nuremberg, I announced a reduction of 30% would be made on future 'Kraft durch Freude' trips. Many experts at that time shook their heads and believed this to be impossible to practice. Today, after only a few weeks of preparation, I am able to announce that this reduction will be applicable to 350,000 holiday makers in 1936 - without in any way reducing the actual takings on the inn keeping, hotel, restaurant traders, etc. In other words this means that the German worker will be able to spend a week's holiday for the sum of between 12 and 16 Marks, inclusive of fare and lodging and admission to special entertainments... Here I should like to announce a new and still greater scheme:- We intend to bring from overseas those fellow countrymen and their families who otherwise could never have a chance to visit their homeland. Our 'Kraft Durch Freude' fleet will be used for this purpose during the winter months and between the seasons. The cost of such trips will be maintained at a very low rate. These trips will in no way interfere or compete with the existing steamship trade. Those with sufficient means can continue to travel in the ordinary passenger boats to Germany, as formerly." - Adolf Hitler

"Our final aim is, we want to achieve a position wherein we can give each of the 14 million German workers an annual holiday of from 12 to 14 days." "We shall proceed with the construction of new ships and new holiday quarters... a new health resort with 20,000 beds will be built on the island of Rugen in the Baltic. ## **Grape Seed Extract May Beat Chemo in Late-Stage Cancer**

The study in question was produced in the University of Colorado Cancer Center and published in the journal *Cancer Letters*. It was an *in vitro* study, not *in vivo*. That is, no living creatures were involved. The

study was performed on cell cultures. That might make it seem relatively insignificant. However, much prior research has already documented grape seed extract's ability to control and kill cancer, so that's not in much doubt. What this study discovered is a plausible means by which it happens. This is the kind of information that modern medicine craves.

Have you ever noticed how there's so much focus on the idea that cholesterol causes heart disease? It doesn't, but that doesn't deter the ongoing research that assumes it to be true. That's because modern medicine demands to know how something works—or at least to be given an explanation, whether true or not. There's an assumption that, if you know that A is associated with B, then controlling A will prevent or cure B. It doesn't seem to matter if it's true, only that it sounds plausible.

### **The "Plausible" Mode of Action**

Rather than focusing on what really counts—survival and return to health—medicine focuses on markers that are based on plausible modes of action.

Once a “plausible” mode of action idea has caught on, research funds get directed towards it. A search goes on to find ways to control that presumed connection. That’s why we have statins. They’re associated with heart disease. They don’t cause it, but a seemingly plausible theory was produced saying that cholesterol causes heart disease. Therefore, since statins can reduce cholesterol, they’re the first thing a doctor prescribes when someone has any sort of heart disease sign—even just being past the age of 40 or 50.

Statins don’t produce health. In fact, they destroy it, causing memory loss, muscle damage, and death. But they’re a perfect example of a plausible idea getting research funding, drugs being developed to cause a change in a marker, doctors prescribing it, and enormous profits getting funneled to Big Pharma.

Ultimately, does it matter whether a treatment can meet some arbitrary marker, or is it more important that it heals you? The answer should be obvious—and it is to everyone but a medical system that’s gone awry. Modern medicine wants a product that’s owned by Big Pharma because that apparently means it’s science-based. That it invariably costs an exorbitant amount and doesn’t cure isn’t of concern. All that matters is that arbitrary markers be met.

Therefore, while it’s interesting to learn something about how a treatment works, let’s get on with it. Let’s focus on the fact that grape seed extract does work and inform people so they can take advantage of it.

## Health Benefits of Grape Seed Extract

It’s well established that resveratrol, which is found in both grape seeds and skins, is the active ingredient that does so much good. So, what can resveratrol, or grape seed or grape skin extract do for you? Let’s take a look at what studies have shown:

## Bee Alert

**H**oney bees are dying all over the globe. Here's why!

Since 2007, the media has been reporting about the dramatic loss of bees in Europe and North America. As many as 50% to 90% of the bee populations have simply vanished, leaving their hives empty and forcing farmers to demand investigations to determine the cause.

At first it was only the honeybees that were decimated — then the bumblebee populations began to disappear. Bumblebees are responsible for pollinating an estimated 15 percent of all the crops grown in the U.S., worth \$3 billion, particularly those raised in greenhouses. Those include tomatoes, peppers and strawberries. Colony collapse disorder impacts agricultural systems as well as natural ecosystems worldwide, with the potential to affect global food security as well as the pollination of wild plants.

The crisis was eventually given a name: Colony Collapse Disorder or CCD.

### **CCD is a "fake disease!"**

But it now appears that a much more basic culprit has killed the bees — Bayer Corporation. Colony Collapse Disorder is poisoning with a known insect neurotoxin called Clothianidin, a neonicotinoid pesticide manufactured by Bayer, which has been clearly linked to massive bee die offs in Germany and France as well

as the American continent. The April 2012 issue of Science Daily for solid proof that Bayer's Imidacloprid is the latest culprit. This, after initial findings that their product, Clothianidin, causes widespread bee deaths and has been banned in several European countries.

While ever these known toxic products continue to be used, the U.S. can expect continuing bee population to downward spiral. "If I had to predict, total colony losses in the U.S. will be as high as we have ever seen," USDA's Pettis says.

### **Fast forward to March 2013**

The **Chemical & Engineering** News reports that 'The Midwest U.S. and parts of Canada experienced unusually high numbers of dying honeybees associated with last year's corn planting. The culprit is believed to be contaminated dust, generated when seeds treated with neonicotinoid pesticides rub against each other inside planters that use air to enable uniform planting of seeds. Dust is released in the exhaust when seeds are expelled from the planter to the soil.'

'To combat the dust problem, the seed industry is developing new products and cleaning processes to better ensure that the pesticides, which protect germinating seeds from soil pests, adhere to seeds during planting. A group of stakeholders has also formed a collaboration to get a better handle on

honeybee foraging conditions around cornfields and to test a new lubricant for seeds that could reduce the amount of pesticide-laden dust emitted during corn planting.'

Last month the [Corn Dust Research Consortium](#), was set up by the pesticide industry, seed companies, farm equipment manufacturers, corn growers, bee-keepers, conservation/environmental groups, and researchers from academia and the U.S. and Canadian governments.

Their aim is two-fold, says Laurie Davies Adams, executive director of the [Pollinator Partnership](#), a nonprofit group that is coordinating the effort.

First to introduce safe working practices for growers to minimize exposure of forager honeybees to seed dust while attempting to protect the bees' foraging environment.

Second, an alternative lubricant system is being trialled to minimize the amount of dust generated during the planting of pesticide-treated seed. Discovering the foraging conditions around cornfields at planting time is also under investigation.

It has been reported that preliminary results of one new lubricant, a polyethylene wax developed by [Bayer CropScience](#) appears promising.

Using seeds treated with pesticides and other chemicals has become almost a knee-jerk response of farming today but not everyone agrees that the benefits of neonicotinoid insecticides outweigh their known risks to honeybees. Earlier this year, the European Commission proposed a two-year ban on the use of three neonicotinoid insecticides on crops in the European Union that attract bees. This was the result of findings by the European Food Safety Authority which showed significant risks to bees associated with the neurotoxic chemicals. However, the EU Commission was unable to implement the ban due to a lack of consensus.

### **Damage Limitation Exercise? What a scientist didn't tell the New York Times about his [study on bee deaths](#)**

Previously, writes Fortune Magazine, 'a [front-page New York Times article](#), under the headline "Scientists

and Soldiers Solve a Bee Mystery," described how a newly released study pinpoints a different cause for colony die-off: "a fungus tag-teaming with a virus." The study, written in collaboration with Army scientists at the Edgewood Chemical Biological Center outside Baltimore, analyzed the proteins of afflicted bees using a new Army software system. The Bayer pesticides, however, go unmentioned.

'What the *Times* article did not explore -- nor did the study disclose -- was the relationship between the study's lead author, Montana bee researcher Dr. Jerry Bromenshenk, and **Bayer Crop Science**. In recent years Bromenshenk has received a significant research grant from Bayer to study bee pollination. Indeed, before receiving the Bayer funding, Bromenshenk was lined up on the opposite side: He had signed on to serve as an expert witness for beekeepers who brought a class-action lawsuit against Bayer in 2003. He then dropped out and received the grant'.



### **Problem, Reaction Solution**

Now Pettis, of USDA ARS bee laboratories concludes in a self congratulatory tone, "A problem was identified, and we skipped the steps where we pointed fingers at one another for a couple of years, disputed the research, and sued one another," while Davies Adams of Pollinator Partnership notes. "We went right into a problem-solving mode. When people actually sit down and talk to each other, you can come up with some solutions."

We would ask in whose interest are these so called solutions? We have here Big Pharma Bayer producing a toxic product which is wiping out bee colonies in the western world not to mention what it might be doing to the long term health of the farmers inhaling the neurotoxic dust. Bayer profits from the pesticide and is now poised to profit from providing the solution to the problem they created in the first place

If greed were not the motivating factor, then the most immediate and beneficial course of action would be obvious. Ban neonicotinoid insecticides and mandate Bayer to massively fund research into the re-population of bee colonies and their sustainability.
