Stripped Bare and Naked

While it would take a volume of print to prove some of the assertions which are going to be made here this month, we have already presented much of that in [Christreich](#), our commentary on the Revelation of Yahshua (Jesus) Christ.

There is only one woman in the eyes of Yahweh our God, allegorically speaking, and that woman is the twelve tribes of Israel collectively. In her obedience to her God, she is the bride, and she is promised rewards both earthly and heavenly. But in her disobedience she is a whore, and she is punished with an earthly punishment for her whoredoms. The proof is also, as our New England ancestors used to say, in the pudding: For the things from Scripture which are about to be expressed here are not only relative to the events of today, but they are the only way in which such events can be understood.

That the children of Israel are, collectively speaking, the whore of the Revelation is fully evident from the text of the Old Testament, where the language is quite explicit, for instance in Ezekiel 16:25: "Thou hast built thy high place at every head of the way, and hast made thy beauty to be abhorred, and hast opened thy feet to every one that passed by, and multiplied thy whoredoms." The high places were the ancient centers of idolatry. The pagan temples of the past accepted all comers, and they were centers for banking, prostitution, dining and entertainment. But the children of Israel were to be a separate people, and not engage with the rest of the world in any of those things. While there are many references to this in Scripture, the primary reference is found at Exodus 19:5: "Now therefore, if ye will obey my voice indeed, and keep my covenant, then ye shall be a peculiar treasure unto me above all people: for all the earth is mine". The phrase "opened thy feet" in the passage of Ezekiel cited above is quite archaic. Today it would be literally rendered "spread your legs", and the proof of that interpretation is found in Deuteronomy 28:57 where a similar phrase is used in the same manner. Spreading their legs is exactly what the children of Israel do when they mingle with the other races of the world, which is what Ezekiel refers to with the remark concerning "every one that passed by". For doing such things, these same children of Israel were warned, at Amos 3:2: "You only have I known of all the families of the earth: therefore I will punish you for all your iniquities." The books of the prophets, and the entire Revelation, are all about that punishment.

In Revelation 12 we see a woman, which clearly represents the twelve tribes of Israel, flee to the wilderness from the face of the dragon: "1 And there appeared a great wonder in heaven; a woman clothed with the sun, and the moon under her feet, and upon her head a crown of twelve stars ... 6 And the woman fled into the wilderness, where she hath a place prepared of God, that they should feed her there a thousand two hundred and threescore days." For quite some time the woman in the wilderness was nourished with the Gospel: for the Saxon and Keltic and related nations of Europe are indeed the literal descendants of the woman, the literal, genealogical children of Israel, and their acceptance of Christianity was the fulfillment of prophecy, that Israel would return to Yahweh their God through His Christ.

However prophesying of another, much later period, the Revelator again returns to the wilderness, where

the woman was left to be nourished, in Revelation 17: “3 So he carried me away in the spirit into the wilderness: and I saw a woman sit upon a scarlet coloured beast, full of names of blasphemy, having seven heads and ten horns. 4 And the woman was arrayed in purple and scarlet colour, and decked with gold and precious stones and pearls, having a golden cup in her hand full of abominations and filthiness of her fornication: 5 And upon her forehead was a name written, MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH. 6 And I saw the woman drunken with the blood of the saints, and with the blood of the martyrs of Jesus: and when I saw her, I wondered with great admiration.”

Although the woman, represented in the Christian nations of Europe, was nourished with the Gospel for well over a thousand years, she nevertheless had joined herself to the beast, and in doing so she became one with Mystery Babylon, and the mother of harlots and abominations. In ancient times, the children of Israel had played the harlot before Yahweh their God, in their intercourse with the other nations of the world, and they were punished for it by being put out of their ancient kingdom. This is described most succinctly in Hosea chapter 2: “1 Say ye unto your brethren, Ammi [*my people*]; and to your sisters, Ruhamah [*having obtained mercy*]. 2 Plead with your mother, plead: for she is not my wife, neither am I her husband: let her therefore put away her whoredoms out of her sight, and her adulteries from between her breasts; 3 Lest I strip her naked, and set her as in the day that she was born, and make her as a wilderness, and set her like a dry land, and slay her with thirst. 4 And I will not have mercy upon her children; for they be the children of whoredoms. 5 For their mother hath played the harlot: she that conceived them hath done shamefully: for she said, I will go after my lovers, that give me my bread and my water, my wool and my flax, mine oil and my drink. 6 Therefore, behold, I will hedge up thy way with thorns, and make a wall, that she shall not find her paths.”

Verse 5 of this passage of Hosea links the harlotry of the ancient children of Israel to intercourse in trade with other nations (Hosea 2:5). Likewise, Revelation chapter 18 links the beast to which the whore is joined to international trade. This is the root cause of the woman's “abominations and filthiness of her fornication”. Globalism and free trade, and therefore modern international corporatism, are the contemporary manifestations of this Biblical whoredom. The punishment for such whoredom is that the children of Israel would be stripped naked by Yahweh their God (Hosea 2:3). The prophecy continues: “7 And she shall follow after her lovers, but she shall not overtake them; and she shall seek them, but shall not find them: then shall she say, I will go and return to my first husband; for then was it better with me than now. 8 For she did not know that I gave her corn, and wine, and oil, and multiplied her silver and gold, which they prepared for Baal. 9 Therefore will I return, and take away my corn in the time thereof, and my wine in the season thereof, and will recover my wool and my flax given to cover her nakedness. 10 And now will I discover her lewdness in the sight of her lovers, and none shall deliver her out of mine hand. 11 I will also cause all her mirth to cease, her feast days, her new moons, and her sabbaths, and all her solemn feasts. 12 And I will destroy her vines and her fig trees, whereof she hath said, These are my rewards that my lovers have given me: and I will make them a forest, and the beasts of the field shall eat them. 13 And I will visit upon her the days of Baalim, wherein she burned incense to them, and she decked herself with her earrings and her jewels, and she went after her lovers, and forgot me, saith the LORD.” The children of Israel failed to remain a separate people, and rather pursued the fruits to be gained in international trade and intercourse with the world's other peoples. Therefore Yahweh their God made certain that those fruits were destroyed, to be devoured by the “beasts of the field” (Hosea 2:12).

Yet hope was offered to Israel, through repentance and an acceptance of Yahweh their God, who promised to betroth Himself to them once again. The nature of this hope is outlined towards the end of this same chapter of Hosea: “14 Therefore, behold, I will allure her, and bring her into the wilderness, and speak comfortably unto her. 15 And I will give her her vineyards from thence, and the valley of Achor for a door of hope: and she shall sing there, as in the days of her youth, and as in the day when she came up out of the land of Egypt...” The “valley of Achor” was so named when the Israelite Achan was stoned, for having surreptitiously withheld a “Babylonish garment” along with enough silver and gold to go into the banking

business. The door of hope offered in the valley of Achor is that once we understand what a usury-based economy and the international banking system have done to enslave us, we can begin to understand our situation.

This repentance and return to obedience prophesied by Hosea had happened in an acceptance of the Gospel and a turning to Christ. Christ illustrates this by referring to Himself as the bridegroom. Paul illustrates this once again in 2 Corinthians 11:2 where he says "For I am jealous over you with godly jealousy: for I have espoused you to one husband, that I may present you as a chaste virgin to Christ." That the Corinthians, as well as many of the other nations of Europe, were indeed descended from the dispersed Israelites of old is the subject of Paul's message to them in his earlier epistle, in 1 Corinthians chapter 10, and elsewhere in places such as Romans chapter 4 and in Galatians chapter 4. Throughout the entire Middle Ages, Christianity kept usury out of Europe almost completely, and the Jews were kept out of participating in the rights of citizenship in the White nations.

The Christian children of Israel in Europe were indeed also to have been a separate people, as the apostle Peter tells them in 1 Peter 2:9-10, where he is referring both to Exodus 19:5 and to the promised restoration of Israel which was prophesied in Hosea chapters 1 and 2: "9 But ye are a chosen generation, a royal priesthood, an holy nation, a peculiar people; that ye should shew forth the praises of him who hath called you out of darkness into his marvellous light: 10 Which in time past were not a people, but are now the people of God: which had not obtained mercy, but now have obtained mercy." However because the children of Israel do not learn from history, they are bound to repeat the errors of the past. The Revelation of Christ, therefore, tells us that all these things must happen once more before the actual consummation of His betrothal to Israel, which is the Marriage Supper of the Lamb described in Revelation chapter 19. This marriage supper follows the fall of Mystery Babylon described in Revelation chapters 17 and 18.

Revelation 17: "9 And here is the mind which hath wisdom. The seven heads are seven mountains, on which the woman sitteth. 10 And there are seven kings: five are fallen, and one is, and the other is not yet come; and when he cometh, he must continue a short space. 11 And the beast that was, and is not, even he is the eighth, and is of the seven, and goeth into perdition. 12 And the ten horns which thou sawest are ten kings, which have received no kingdom as yet; but receive power as kings one hour with the beast. 13 These have one mind, and shall give their power and strength unto the beast. 14 These shall make war with the Lamb, and the Lamb shall overcome them: for he is Lord of lords, and King of kings: and they that are with him are called, and chosen, and faithful. 15 And he saith unto me, The waters which thou sawest, where the whore sitteth, are peoples, and multitudes, and nations, and tongues. 16 And the ten horns which thou sawest upon the beast, these shall hate the whore, and shall make her desolate and naked, and shall eat her flesh, and burn her with fire. 17 For God hath put in their hearts to fulfil his will, and to agree, and give their kingdom unto the beast, until the words of God shall be fulfilled. 18 And the woman which thou sawest is that great city, which reigneth over the kings of the earth."

The seven heads are the seven world empires which had at one time or another ruled over the children of Israel. Mountains often represent large nations in Scripture, and they certainly do here. Four of these empires were prophesied by Daniel, twice, in chapters two and seven of his book. However Daniel was only depicting a limited time relative to his own future, although the visions in his seventh chapter have a wider scope than that of his second. This vision in John encompasses a much wider period. When the seventh of these world empires had passed, the beast "was, and is not", and an eighth beast would arise from them. This beast, although the whore had joined herself to it, would hate the whore and make war against it. Notice that the punishment inflicted against the whore by this beast is much the same as that punishment inflicted upon the ancient children of Israel for their whoredoms which was described in Hosea: that the whore would be left desolate, or stripped bare and naked.

Again from Revelation 17: "16 And the ten horns which thou sawest upon the beast, these shall hate the whore, and shall make her desolate and naked, and shall eat her flesh, and burn her with fire. 17 For God hath put in their hearts to fulfil his will, and to agree, and give their kingdom unto the beast, until the words

of God shall be fulfilled. 18 And the woman which thou sawest is that great city, which reigneth over the kings of the earth.” The woman can be the whore riding the beast, wearing the name “Mystery Babylon”, and also be the great city itself, because according to the Law of God a woman becomes one flesh with her husband: therefore the woman here, the whore, becomes one with the beast in her fornication.

As the Revelation explains, the eighth beast is not a king itself, but reigns over the kings of the earth. Yet it was also “of the seven” former kingdoms, all of which reigned over the earth at one time and another. All of these seven kings were world empires ruling over men contrary to the Word of God. We learn from Revelation chapter 13, where these kingdoms are described in a somewhat different manner, that it is the dragon which gives its power unto the beast. It is explained in Revelation chapter 12 that the dragon is Satan: that collective entity which have forever been opposed to Yahweh God and the people of God.

Yet the Revelation describes the woman as “the great city, which reigns over the kings of the earth” (17:18) and also that Babylon is “that great city” (18:21). However initially the woman was separate from the beast and only sat upon the beast (17:3-4). This is because the woman, once having joined herself to the beast, has become one with the beast, as the marriage laws of Yahweh God state: “Therefore shall a man leave his father and his mother, and shall cleave unto his wife: and they shall be one flesh” (Genesis 2:24).

The dragon has always given its power to the beast, because the same demonic people have been behind the forces that have empowered every world empire. As we see in Luke chapter 4, the devil rules over the kingdoms of this world: “5 And the devil, taking him up into an high mountain, shewed unto him all the kingdoms of the world in a moment of time. 6 And the devil said unto him, All this power will I give thee, and the glory of them: for that is delivered unto me; and to whomsoever I will I give it. 7 If thou therefore wilt worship me, all shall be thine.” Until Christ returns, devils continue to rule over the kingdoms of this world, and these people have also promoted the tenets of ancient Babylon all throughout time. These include globalism (the tower of Babel was an attempt at globalism), usury-banking, democracy, ecumenism, ritualism, and all of the pagan practices which include sexual immorality, race-mixing, and many other things which are opposed to Yahweh God. The word Babylon is derived from a Hebrew word which means *confusion*.

Today the primary torch-bearers of all of these ancient and evil practices are Jews. These jews are also the primary actors in the usury banking system which has over these last two centuries risen to control the commerce and the governments of the modern world. Their Kenite and Canaanite ancestors were the usurers of the ancient world. Their Nephilim “fallen angel” ancestors were the authors of those pagan religions and of every vile practice among men. These people were the usurers, king-makers and empire-builders of the ancient world, just as they are today. Today they are far more open than they apparently were in the ancient past, and especially through the Middle Ages. The world's jewish-controlled central banking system is indeed the eighth beast of the Revelation.



It is fitting, that this banking system has found its origination in certain Jewish families which had first come to control the Bank of England, then the central banks of the European continent and America, and it is head-quartered in London, in a district called “The City”. This is literally the “great city, which reigns over the kings of the earth”. It is owned and operated by the dragon, Satan, and the international Jew is the Synagogue of Satan, those who say they are Judah, and are not, but are of the seed of Canaan and Esau (Revelation 2:9, 3:9). It is married to the woman, the Saxon people who are true Israel. It is just as fitting, and no coincidence, that the symbolic overseers of The City are a pair of effigies called *Gog* and *Magog*. This is how the whore is joined to the beast, yet the beast hates the whore, and leaves her desolate and naked (Revelation 17:16).

It can be demonstrated (as we frequently have at [Christogenea](#)) that the thousand years when Satan was locked into the pit, described in Revelation chapter 20, describes the period when the Jews were ostracized from Christian society, which included nearly the entire White Adamic world of the time, and they were not allowed citizenship even where they were granted residence. This thousand years period ended with the emancipation of the Jews at the time of Napoleon, just after the French Revolution. Once this is understood, the prophecy of the following Scripture is perfectly evident in history, from Revelation 20:7-10: “7 And when the thousand years are expired, Satan shall be loosed out of his prison, 8 And shall go out to deceive the nations which are in the four quarters of the earth, Gog and Magog, to gather them together to battle: the number of whom is as the sand of the sea. 9 And they went up on the breadth of the earth, and compassed the camp of the saints about, and the beloved city: and fire came down from God out of heaven, and devoured them. 10 And the devil that deceived them was cast into the lake of fire and brimstone, where the beast and the false prophet are, and shall be tormented day and night for ever and ever.”

The picture drawn in the words of the prophet Ezekiel in his famous chapters 38 and 39 depict that very same event forewarned in Revelation chapter 20. From Ezekiel 38: “2 Son of man, set thy face against Gog, the land of Magog, the chief prince of Meshech and Tubal, and prophesy against him, 3 And say, Thus saith the Lord GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal...” In these chapters of Ezekiel, Gog and Magog lead a great army (38:4-6) “against the mountains of Israel” (38:8). This army is described as being “like a cloud to cover the land”. There are some commentators who would interpret that text (38:9) as describing an army which comes in under the cover of a cloud, as if being unnoticed. The interpretation is intriguing, but unnecessary. In the age of nuclear weapons and other vast arsenals of firepower, as well as live satellite imagery giving ample time for defense, it is unlikely that a vast army could successfully invade any modern western nation. Unless the invasion was made surreptitiously, under some sort of pretense.

The hordes of Gog and Magog are depicted by Ezekiel (38:11-12) to “... go up to the land of unwalled villages ... to them that are at rest, that dwell safely, all of them dwelling without walls, and having neither bars nor gates, to take a spoil, and to take a prey; to turn thine hand upon the desolate places that are now inhabited, and upon the people that are gathered out of the nations, which have gotten cattle and goods, that dwell in the midst of the land.” The “people gathered out of the nations” are the children of Israel in their dispersions (Micah chapter 4). While a casual reading of Ezekiel seems to indicate that a military invasion is being described, and a military invasion cannot be entirely ruled out, yet such an invasion is not necessary to the fulfillment of the prophecy: for the hordes of Gog and Magog have already invaded and covered the mountains of Israel like a cloud.

Once it is realized that the eighth beast of the Revelation is the world's central banking system, which functions at the command of that “great city, which reigneth over the kings of the earth”, and that this is also represented by Gog and Magog, it is not a far stretch to see that the hordes of aliens flooding into White nations everywhere, the nations formerly known as Christendom, are indeed the very hordes of Gog and Magog: the push for more and more immigration into White lands is the work of the international bankers and the global corporations which they control. There is nothing else in all history or philosophy, or especially in Scripture, which explains how the world's greatest culture should self-destruct by allowing itself to be overrun with mindless savages.

These alien hordes pouring into all White nations under the guise of “immigration” are no different than conquering armies. In Ezekiel's time they would have been seen as armies. They are looting and pillaging White industry and culture under a cloud of legality, and they are even able to do so at the expense of the Whites in those nations. Therefore true Israel has once again become the whore who has “built thy high place at every head of the way, and hast made thy beauty to be abhorred, and hast opened thy feet to every one that passed by, and multiplied thy whoredoms”, as the whore who has joined herself to the beast of global commercialism. How could the White race not be the Whore? She has surrendered her culture to aliens, and her institutions now cater to them. She has not only allowed herself to be overrun, but she herself has financed her own defeat through her social welfare, tax abatements, and other programs which benefit

the invading aliens exclusively at the expense of her own people. She has made laws against her own interests, and now her women, even her children, are being raped, bought, or given away to the aliens. There are multiple thousands of White victims of minority crimes daily, and Whites do not see it for what it is: a violent invasion downplayed or ignored by a Jewish-controlled media. This is just as the curses of disobedience upon a sinful Israel which are recorded in Deuteronomy have warned: “Thy sons and thy daughters shall be given unto another people, and thine eyes shall look, and fail with longing for them all the day long: and there shall be no might in thine hand” (28:32). This is how the children of Israel, the whore of the Revelation, is to be left stripped bare and naked (Hosea 2:3, Revelation 17:16).

The Mexicans, the Arabs, the Turks, the Negroes, the Asians, these are the hordes of Gog and Magog. These are the beasts of Isaiah 56 and Jeremiah 31. These are the locust plagues of Joel. Yet there is further hope at the end, once the people of God realize that they have suffered enough. However that hope is only in Christ, which we see in the rest of Hosea's message of hope to Israel: “16 And it shall be at that day, saith the LORD, that thou shalt call me Ishi; and shalt call me no more Baali. 17 For I will take away the names of Baalim out of her mouth, and they shall no more be remembered by their name. 18 And in that day will I make a covenant for them with the beasts of the field, and with the fowls of heaven, and with the creeping things of the ground: and I will break the bow and the sword and the battle out of the earth, and will make them to lie down safely. 19 And I will betroth thee unto me for ever; yea, I will betroth thee unto me in righteousness, and in judgment, and in lovingkindness, and in mercies. 20 I will even betroth thee unto me in faithfulness: and thou shalt know the LORD. 21 And it shall come to pass in that day, I will hear, saith the LORD, I will hear the heavens, and they shall hear the earth; 22 And the earth shall hear the corn, and the wine, and the oil; and they shall hear Jezreel. 23 And I will sow her unto me in the earth; and I will have mercy upon her that had not obtained mercy; and I will say to them which were not my people, Thou art my people; and they shall say, Thou art my God. ”

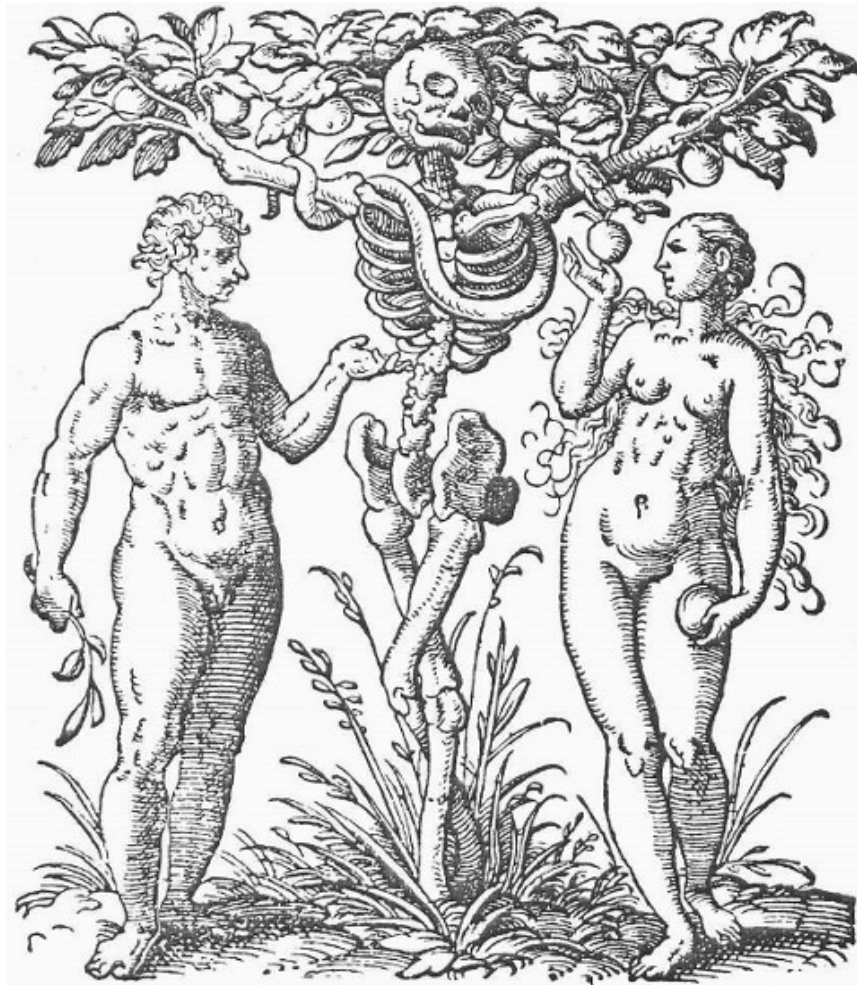

The Prophecy of Joel

Part 2

William R Finck

Our commentary on the prophecy of Joel was first presented on Christogenea Internet Radio on April 13th and 20th, 2012. Here we present it in print for the benefit of our Saxon Messenger readers. Our editorial this month, Stripped Bare and Naked, is a reflection upon some of the ideas expressed in this prophecy in the perspective of current world events.

One facet of this prophecy of Joel to recall from the first part of this presentation, which shall certainly be expounded upon here, is that this prophecy of Joel is applicable both to the time when Joel wrote, and to the time of the future “great and the terrible day of the LORD”, as the King James text reads at Joel 2:31. It was seen then, that this dual interpretation of Joel is recognized and accepted even by mainstream commentators. The *Thomas Nelson Study Bible* says in this regard that “Two events are compared in the course of Joel's prophecy: (1) the locust plague upon Judah in the days of the prophet, and (2) the far greater coming day of the Lord. The latter is set forth in the figure of the former.” This admission of the nature of Joel's prophecy is not only true, it is also amazing that it is admitted by a mainstream source, since they would never admit the implications if they were aware of them. That is because the locusts of Joel are not *locusts*, but, as it was established here in our first part, they represent *people*. And just as it was people who devoured the substance of Israel in ancient times, so it is today. It is important that we can identify who these people are. As we proceed with the second part of this presentation of Joel we will discuss that at length.

Here we shall begin with the latter part of Joel chapter 2, and compare Joel 2:19-25 with Ezekiel 38. Then we will compare other similar Biblical prophecies.

In ancient Palestine the invading armies were generally from the north, and therefore they are described in that manner here in Joel 2:20. The national wealth of Israel and Judah were devoured, first by the Canaanites and Hittites, and then later by the invading Assyrians and Babylonians. That is the

interpretation of the prophecy for Joel's own time, however we have seen that Joel's prophecy also has applicability in the “great and terrible day of the Lord” (Joel 2:31), which Christians watch for here in this time. It is evident now that this day is upon us, and has been for some decades, though it is something that most of us have not recognized.

We shall begin with Revelation 20:7-10, from the King James Version: “7 And when the thousand years are expired, Satan shall be loosed out of his prison, 8 And shall go out to deceive the nations which are in the four quarters of the earth, Gog and Magog, to gather them together to battle: the number of whom is as the sand of the sea. 9 And they went up on the breadth of the earth, and compassed the camp of the saints about, and the beloved city: and fire came down from God out of heaven, and devoured them. 10 And the devil that deceived them was cast into the lake of fire and brimstone, where the beast and the false prophet are, and shall be tormented day and night for ever and ever.”

For a thousand years in Christian Europe did the true people of God prevail over the Jew, who collectively is Satan, or the Adversary. The Jew has plotted against Christianity and the people of Europe from the time of Christ (and for thousands of years before that, if Old Testament history were truly understood, and the histories of Josephus, that the people now called Jews are actually from the stock of the Canaanites and Edomites, with whom many of the remnant of Judah had mixed themselves). Upon the emancipation of the Jew in the early days of Napoleon, instigated by the French Revolution, the Jew became free and equal citizens of Christians in Europe. From that time, Satan

has used the false ideals of liberty, equality, and fraternity, in one form or another, to gather all of the world's hominid beasts into Christians lands, where they are hostile both to Christianity and to the White race which are the true people of God.



That is where we are today, at Revelation 20:9, and at Revelation 17:17 because Revelation chapter 20 is a summary reflection. Now to read from Joel chapter 2, which is a promise of deliverance:

19 Yea, the LORD will answer and say unto his people, Behold, I will send you corn, and wine, and oil, and ye shall be satisfied

therewith: and I will no more make you a reproach among the heathen: 20 But I will remove far off from you the northern army, and will drive him into a land barren and desolate, with his face toward the east sea, and his hinder part toward the utmost sea, and his stink shall come up, and his ill savour shall come up, because he hath done great things. 21 Fear not, O land; be glad and rejoice: for the LORD will do great things. 22 Be not afraid, ye beasts of the field: for the pastures of the wilderness do spring, for the tree beareth her fruit, the fig tree and the vine do yield their strength.

In Ezekiel chapters 38 and 39, we see a description of events comparable to both this part of Joel chapter 2, and to the passage from Revelation chapter 20 which we just read. In Revelation 20:8 we see that same Gog and Magog gathered against the children of Israel that are described in Ezekiel 38 and 39. Ezekiel 38:8 tells us that this describes a time afar off from Ezekiel's own time, and it says: "8 After many days thou shalt be visited: in the latter years thou shalt come into the land that is brought back from the sword, and is gathered out of many people, against the mountains of Israel, which have been always waste: but it is brought forth out of the nations, and they shall dwell safely all of them." Ezekiel 38:12 says that these beast armies would come against the mountains of Israel "To take a

spoil, and to take a prey; to turn thine hand upon the desolate places that are now inhabited, and upon the people that are gathered out of the nations, which have gotten cattle and goods, that dwell in the midst of the land." It can be established, that the geographical areas of the White nations of northern Europe and America had at one time and in Ezekiel's day always been waste, but were "now inhabited". Northern Europe had only been settled by White peoples who originated in the Mediterranean and the Near East in the centuries leading up to and following Ezekiel's own time, and was desolate for many centuries before that. North America also had been desolate, uncultivated and undeveloped, until Whites came from Europe. The people of these White nations of today represent the people "gathered out of the nations" of our Adamic race as those nations existed in Ezekiel's time.

In Joel we see that the northern army was compared to a locust plague. In Ezekiel 38:9 it says of Gog and Magog and their armies that they would "ascend and come like a storm, thou shalt be like a cloud to cover the land, thou, and all thy bands, and many people with thee." In Joel 2:20 Yahweh promises deliverance from these armies, where He says "But I will remove far off from you the northern army, and will drive him into a land barren and desolate, with his face toward the east sea, and his hinder part toward the utmost sea, and his stink shall come up, and his ill savour shall come up, because he hath done great things." In Ezekiel we see this same promise of deliverance, outlined in chapter 39, and Yahweh says at verse 11: "And it shall come to pass in that day, that I will give unto Gog a place there of graves in Israel, the valley of the passengers on the east of the sea: and it shall stop the noses of the passengers: and there shall they bury Gog and all his multitude: and they shall call it The valley of Hamongog." It shall stop the noses, because as we see in Joel, "his ill savour shall come up". The "valley of Hamongog" is the "valley of Jehoshaphat" of Joel 3:12, the "valley of decision" of Joel 3:14, all of these merely represent the idea of Yahweh's judgement against the hominid beasts.

23 Be glad then, ye children of Zion, and rejoice in the LORD your God: for he hath given you the former rain moderately, and he will cause to come down for you the rain, the former rain, and the latter rain in the first month. 24 And the floors shall be full of wheat, and the fats shall overflow with wine and oil. 25 And I will restore to you the

years that the locust hath eaten, the cankerworm, and the caterpillar, and the palmerworm, my great army which I sent among you.

As evidenced in Part 1 of this presentation, the former rain was that Spirit of God which the apostles and all those who turned to Christ received at the Pentecost after the Resurrection of Christ. Now Christians await the latter rain. The former rain was that deposit which marks an assurance of our deliverance in the latter.

Verse 25 promises a recovery from the “great army” which Yahweh sent among us. Here we see, that just as so often happened in Old Testament Israel, it is a trial from God that all of the world's hominid beasts have flooded into our lands and are devouring our children and our substance as we breathe this very moment. That does not mean that we have to like it, and we are told that we would not. From the consequences of our disobedience, found in Deuteronomy chapter 28: “32 Thy sons and thy daughters shall be given unto another people, and thine eyes shall look, and fail with longing for them all the day long: and there shall be no might in thine hand.... 41 Thou shalt beget sons and daughters, but thou shalt not enjoy them; for they shall go into captivity. 42 All thy trees and fruit of thy land shall the locust consume. 43 The stranger that is within thee shall get up above thee very high; and thou shalt come down very low.”

Isaiah 56:8-12 speaks of the regathering of dispersed Israel: “8 The Lord GOD which gathereth the outcasts of Israel saith, Yet will I gather others to him, beside those that are gathered unto him. 9 All ye beasts of the field, come to devour, yea, all ye beasts in the forest. 10 His watchmen are blind: they are all ignorant, they are all dumb dogs, they cannot bark; sleeping, lying down, loving to slumber. 11 Yea, they are greedy dogs which can never have enough, and they are shepherds that cannot understand: they all look to their own way, every one for his gain, from his quarter. 12 Come ye, say they, I will fetch wine, and we will fill ourselves with strong drink; and to morrow shall be as this day, and much more abundant.”

In ancient Israel, as evidenced in the prophets and the historical books, it was the political and religious leaders of the nation who led it into sin. Yahweh gathers us, and our political leaders and priests do not guard the flock. Rather, they care more for their own well-being, and their own gain, and allow the flock to be overrun with beasts. As it was in ancient Israel, so

it is today. Now Yahweh tells us that He sent this “great army” among us for which to chastise us. But when we examine our history, we see that we as a people have not resisted our leaders when they did those things which allowed our nation to be overrun, and therefore we cannot blame our God. The priests and pastors preach universalism, multiculturalism, and diversity from the pulpits, and no man resists them. The government dictates these things, and no man marches on the capitals. We have accepted and often even agreed to all of this sin, and therefore God cannot be blamed; only we as a people are to blame.

Jeremiah chapter 31 also foretells these things: “27 Behold, the days come, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast. 28 And it shall come to pass, that like as I have watched over them, to pluck up, and to break down, and to throw down, and to destroy, and to afflict; so will I watch over them, to build, and to plant, saith the LORD. 29 In those days they shall say no more, The fathers have eaten a sour grape, and the children's teeth are set on edge. 30 But every one shall die for his own iniquity: every man that eateth the sour grape, his teeth shall be set on edge.” The “sour grapes” are defined at Deuteronomy 32:32 where speaking of “a nation void of counsel” it says “For their vine is of the vine of Sodom, and of the fields of Gomorrah: their grapes are grapes of gall, their clusters are bitter”, and from this it is evident that the “sour grapes” are acts of adultery, fornication, and the other sins of ancient Sodom and Gomorrah.



Yahweh foresaw the sins of Esau, and therefore He hated Esau from the womb, even before he was born, because He knew what Esau would do. Yet Esau did those things of his own accord, Esau agreed to those sins, and therefore the blame cannot be placed on

God. That is our example for today, that is the patience of Job, and that is where we find our lesson in this life. Yahweh has sent all of these beasts among us for our chastisement. Those of us who accept the sin shall be punished in it. But we have a promise of restoration. These other races who have flooded our lands and who are devouring our substance, these are the beasts of Isaiah 56 and Jeremiah 31. These are the armies of Gog and Magog, and the “many people with them” of Ezekiel chapters 38 and 39. These are the Negro, the Mestizo, the Arab and the Asian. These are the cankerworm, the palmerworm, the locust, and the caterpillar, which in His permissive will Yahweh has allowed Satan – the Jew – to flood our lands with, in our sin and for our punishment.



To see these beasts as “fellow men”, even to give them credit as “other races”, imagining them to somehow be “people”, is sin unto itself and leads us into the greater sin of accepting them, although God knew that it was inevitable that we would do so.

Peter speaks of the non-Israelites who infiltrate our congregations and he says of them at 2 Peter 2:12 “But these, as natural brute beasts, made to be taken and destroyed, speak evil of the things that they understand not; and shall utterly perish in their own corruption”. Jude speaks of them likewise at verse 10 of his epistle, and then in verse 12 he says “These are spots in your feasts of charity, when they feast with you, feeding themselves without fear: clouds they are without water, carried about of winds; trees whose fruit withereth, without fruit, twice dead, plucked up by the roots.” And likewise at 2 Peter 2:13-14: “And [they] shall receive the reward of unrighteousness, as they that count it pleasure to riot in the day time. Spots they are and blemishes, sporting themselves with their own deceivings while they feast with you; Having eyes full of adultery, and that cannot cease from sin; beguiling unstable souls: an heart they have exercised with covetous practices; cursed children.” Everything

that the bastards and aliens do among us is sin. These are the Negro, the Mestizo, the Arab and the Asian. These are the cankerworm, the palmerworm, the locust, and the caterpillar, as I have translated Jude 19: “These are those making divisions, animals, not having the Spirit.” These non-Adamic hominids among us are “animals, not having the Spirit” which Adam has. It is disgraceful to accept them among us, and they are devouring our substance and our children. Yet here in Joel, as in the other prophets, we have a promise from Yahweh our God of full restoration, and we have a future without these beasts.

26 And ye shall eat in plenty, and be satisfied, and praise the name of the LORD your God, that hath dealt wondrously with you: and my people shall never be ashamed. 27 And ye shall know that I am in the midst of Israel, and that I am the LORD your God, and none else: and my people shall never be ashamed.

From the ASV, from Ezekiel 39:21-29: “21 And I will set my glory among the nations; and all the nations shall see my judgment that I have executed, and my hand that I have laid upon them. 22 So the house of Israel shall know that I am Jehovah their God, from that day and forward. 23 And the nations shall know that the house of Israel went into captivity for their iniquity; because they trespassed against me, and I hid my face from them: so I gave them into the hand of their adversaries, and they fell all of them by the sword. 24 According to their uncleanness and according to their transgressions did I unto them; and I hid my face from them. 25 Therefore thus saith the Lord Jehovah: Now will I bring back the captivity of Jacob, and have mercy upon the whole house of Israel; and I will be jealous for my holy name. 26 And they shall bear their shame, and all their trespasses whereby they have trespassed against me, when they shall dwell securely in their land, and none shall make them afraid; 27 when I have brought them back from the peoples, and gathered them out of their enemies' lands, and am sanctified in them in the sight of many nations. 28 And they shall know that I am Jehovah their God, in that I caused them to go into captivity among the nations, and have gathered them unto their own land; and I will leave none of them any more there; 29 neither will I hide my face any more from them; for I have poured out my Spirit upon the house of Israel, saith the Lord Jehovah.”

By “the nations” Ezekiel can only be understood to

mean the other Adamic nations of the oikoumenê [the civilized White world], including those of Israel, since much of Israel was already dispersed and had developed into many nations by the time when he wrote. We see in Ezekiel that same promise of the destruction of our enemies and the restoration of our people which we have in Joel. This is the Christian promise, as we see in the New Testament in Luke 1:72-75 where Zacharias declared the purpose of redemption for Israel: “To bring about mercy with our fathers and to call into remembrance His holy covenant, 73 the oath which He swore to Abraham our father, which is given to us: 74 being delivered fearlessly from the hands of our enemies to serve Him 75 in piety and in righteousness before Him for all of our days.”

28 And it shall come to pass afterward, that I will pour out my spirit upon all flesh; and your sons and your daughters shall prophesy, your old men shall dream dreams, your young men shall see visions: 29 And also upon the servants and upon the handmaids in those days will I pour out my spirit.

We see in both Ezekiel and in Joel that the promise of that latter rain of the Spirit marking our full restoration does not come until the time of the destruction of our enemies. By “all flesh” here the Word of God can only mean “all Adamic flesh”, which is evident from reading Isaiah chapter 44, verses 1-3: “1 Yet now hear, O Jacob my servant; and Israel, whom I have chosen: 2 Thus saith the LORD that made thee, and formed thee from the womb, which will help thee; Fear not, O Jacob, my servant; and thou, Jesurun, whom I have chosen. 3 For I will pour water upon him that is thirsty, and floods upon the dry ground: I will pour my spirit upon thy seed, and my blessing upon thine offspring....” [This is also evident at Genesis 6:12-13: “12 And God looked upon the earth, and, behold, it was corrupt; for all flesh had corrupted his way upon the earth. 13 And God said unto Noah, The end of all flesh is come before me; for the earth is filled with violence through them; and, behold, I will destroy them with the earth.” Since the Scriptures make it quite clear that there were Kenites and Rephaim and other peoples who were not destroyed in the flood but who were not on the ark, then those other peoples cannot fall into the category of “all flesh”, and therefore an understanding of the term must be governed by the context of Scripture, in spite of the fact that on occasion the term is used to

describe the flesh of beasts as well as man, such as in Genesis chapter 9.]

Numbers 16:22: “And they fell upon their faces, and said, O God, the God of the spirits of all flesh, shall one man sin, and wilt thou be wroth with all the congregation?”

Numbers 27:16: “Let the LORD, the God of the spirits of all flesh, set a man over the congregation.”

Isaiah 49:26: “And I will feed them that oppress thee with their own flesh [so we see that the Spirit of God shall not be poured out upon them, but only the Wrath of God]; and they shall be drunken with their own blood, as with sweet wine: and all flesh [all Adamic flesh] shall know that I the LORD am thy Saviour and thy Redeemer, the mighty One of Jacob.”

Yahweh is the “God of all flesh”, however the only flesh He is truly concerned with are those fleshly vessels which contain His Spirit: those vessels which are His sons and daughters. Yahweh in the prophecy of Isaiah makes no promise of beasts receiving the Spirit, but only man: and of men, only the children of Israel. Here in Joel, we cannot expect the context to exceed the bounds of that already-defined understanding.

Therefore Christ says in John chapter 3 that unless a man is born from above, he shall not see the kingdom of God. He won't be a beast in it, he won't be a slave in it, and he certainly won't be a partaker in it. If one's name is not written into the Book of Life, which is the Gospel promise, then one is destined for the Lake of Fire, along with Hell, Death, the Beast and the False Prophet, and which is therefore representative of a cessation of existence.



30 And I will shew wonders in the heavens and in the earth, blood, and fire, and pillars of smoke. 31 The sun shall be turned into darkness, and the moon into blood, before the great and the terrible day of the LORD come.

Revelation chapter 6, verses 12 to 17 speak of the Judgment of God upon the former Roman empire, which can be demonstrated from the entire context of the Revelation. The coming judgment of God upon the modern world is described by Joel in much the same manner: “12 And I saw when He opened the sixth seal, and there happened a great earthquake and the sun became black as a sackcloth of hair and the whole moon became as blood 13 and the stars of heaven fell to the earth, as a fig tree being shaken by a great wind casts its unripened figs, 14 and the heaven departed as a scroll being rolled and every mountain and island had been moved from their places. 15 And the kings of the earth and the great men and the commanders and the wealthy men and the powerful men and every slave and free man hid themselves in the caves and in the rocks of the mountains, 16 and they say to the mountains and to the rocks: 'Fall upon us!', and 'Hide us from the face of Him sitting upon the throne and from the wrath of the Lamb, 17 because the great day of Their wrath has come, and who is able to stand?’”

32 And it shall come to pass, that whosoever shall call on the name of the LORD shall be delivered: for in mount Zion and in Jerusalem shall be deliverance, as the LORD hath said, and in the remnant whom the LORD shall call.

From Revelation chapter 18: “4 And I heard another voice from out of heaven, saying: 'You come out from her, My people, that you should not partake in her errors, and that you would not receive from of her wounds, 5 because her errors have built up as far as heaven and Yahweh has called to mind her injustices! 6 You return to her as she also had rendered, and you double twice the things according to her works. In the cup which she had mixed, you mix double for her! 7 As much as she had magnified herself and lived wantonly, so much you give torment and grief to her! Because in her heart she says that 'I sit a queen and I am not a widow and I have not seen grief', 8 for this reason in one day shall her plagues come: death and grief and famine, and she shall be burned with fire, because mighty is Prince Yahweh who judges her!’”

From Micah 4:10-13 we see the nature of that call which is spoken of here in Joel 2:32: “10 Be in pain,

and labour to bring forth, O daughter of Zion, like a woman in travail: for now shalt thou go forth out of the city, and thou shalt dwell in the field, and thou shalt go even to Babylon; there shalt thou be delivered; there the LORD shall redeem thee from the hand of thine enemies. 11 Now also many nations are gathered against thee, that say, Let her be defiled, and let our eye look upon Zion. 12 But they know not the thoughts of the LORD, neither understand they his counsel: for he shall gather them as the sheaves into the floor. 13 Arise and thresh, O daughter of Zion: for I will make thine horn iron, and I will make thy hoofs brass: and thou shalt beat in pieces many people: and I will consecrate their gain unto the LORD, and their substance unto the Lord of the whole earth.”

From Obadiah 1:15-18 we can clarify what is meant in Micah: “15 For the day of the LORD is near upon all the heathen [nations]: as thou hast done, it shall be done unto thee: thy reward shall return upon thine own head. 16 For as ye have drunk upon my holy mountain, so shall all the heathen [nations] drink continually, yea, they shall drink, and they shall swallow down, and they shall be as though they had not been. [All non-Israel peoples shall be as though they had not existed.] 17 But upon mount Zion shall be deliverance, and there shall be holiness; and the house of Jacob shall possess their possessions. 18 And the house of Jacob shall be a fire, and the house of Joseph a flame, and the house of Esau for stubble, and they shall kindle in them, and devour them; and there shall not be any remaining of the house of Esau; for the LORD hath spoken it. [The house of Esau is for the most part the Jews, who have gathered all of these beasts against the people of God.]

For these passages from verses 28 through 32, Joel is called the “prophet of Pentecost”, since Peter is recorded as having said at Acts 2:14-21, after the Holy Spirit descended upon the apostles: “14 ... Men, Judaeans, and all of those dwelling in Jerusalem, let this be known to you, and hearken to my words. 15 For they are not intoxicated as you suspect, indeed it is the third hour of the day! 16 Rather this is that which was spoken through the prophet Joel: 17 'And it shall be in the days future, says Yahweh, I will pour out from My Spirit upon all flesh, and your sons and your daughters shall prophesy, and your youths shall see visions, and your elders shall dream dreams. 18 And then upon My menservants and upon My maidservants in those days I will pour out from My

Spirit and they shall prophesy. 19 And I shall make wonders in the heaven above, and signs upon the earth below, blood and fire and a vapor of smoke. 20 The sun shall be turned into darkness, and the moon into blood, before the coming great day and appearance of Yahweh. 21 And it shall be that all who shall be called by the Name of Yahweh shall be preserved.””

Now Peter believed and taught, as the other apostles also did, that the “coming great day and appearance of Yahweh” was imminent in his own time. Yet at a later date James seems to have better understood the former and the latter rains, and admonishes us accordingly in his epistle at James 5:7: “Be patient therefore, brethren, unto the coming of the Lord. Behold, the husbandman waiteth for the precious fruit of the earth, and hath long patience for it, until he receive the early and latter rain.” We now must have patience, awaiting that latter rain.

KJV Joel 3:1 For, behold, in those days, and in that time, when I shall bring again the captivity of Judah and Jerusalem, 2 I will also gather all nations, and will bring them down into the valley of Jehoshaphat, and will plead with them there for my people and for my heritage Israel, whom they have scattered among the nations, and parted my land. 3 And they have cast lots for my people; and have given a boy for an harlot, and sold a girl for wine, that they might drink.



Here we can date Joel's prophecy, where it says that Yahweh “will plead with them there for my people and for my heritage Israel, whom they have scattered among the nations, and parted my land”. Such a thing had happened only in the time of the Assyrians, part of

the “northern armies” of Joel's prophecy, who deported all of Israel except the cities of Tyre and Sidon, as well as Jerusalem, and divided the land to other peoples whom they later brought in from elsewhere. The Edomites also took part of the land, which is described in Ezekiel in his 35th and 36th chapters.

Tyre and Sidon are known from the Bible to continue unto the Babylonian invasion, and in the inscriptions they are said to have paid tribute to the Assyrians in order to escape destruction. So we see in Joel 3:4 that Tyre and Sidon are mentioned, but the rest of Israel is already “scattered among the nations”, in the Assyrian captivity. Therefore Joel must have prophesied in the period from 676 BC to 605 BC, after Assyrian activity in Palestine had ceased, and before the Babylonian conquests there had begun.

The Hebrew word shaphat, Strong's # 8199, is generally to *judge, govern, vindicate, or punish*. Here it appears in the name of the valley, Jehoshaphat, which is “Yahweh judges” or “Yahweh punishes”, and it is also translated in the King James as *plead*, which is archaic English and here the word shaphat is again to *judge* or to *punish*. The valley of Jehoshaphat is the valley of punishment. It is the “valley of passengers” and the “valley of Hamongog” of Ezekiel, where all of the armies of Gog and Magog are to be destroyed, and the children of Israel are employed seven months in their burial. It is all a prophetic allegory for the complete destruction of the non-Israelite hominids of the world, all of the non-Israel “nations” of Obadiah 16, where it says that they shall be as if they never existed.

Herodotus, in the second book of his *Histories*, at chapter 54 (2:54) and elsewhere talks at length of the Phoenician slave trade. Amos 1:9 mentions how the Tyrians were selling the children of Judah into slavery. Yet the Greeks themselves, and the Romans, and long before them the Assyrians, Egyptians, Babylonians and many others engaged in the trade of men in slavery. It was a fact of life in the ancient world, recognized in New Testament Scriptures.

While in the ancient world slavery was overt and considered a legitimate practice, today overt slavery is rare. While there is overt slavery in places under the full control of the Jews, such as in Tel Aviv where sex slavery is open and recognized, and overt slavery is still engaged in by the savages of Africa, it is generally not accepted in White nations. Yet in White

nations, we are all slaves of a different sort.

When we go to work for corporations today, we give up our rights to free speech and freedom of association for the sake of global trade, and we are in reality slaves. When we allow our sons and daughters to cohabit with aliens, engaging diversity for the sake of peace and prosperity, we are in reality selling them as slaves. We are then deprived of half of our earnings in order to support the imperial agenda of our governments, and we are in reality slaves. Our people are deceived into thinking that they have liberty, and today they are more enslaved than ever, and they do not even see their own shackles!

4 Yea, and what have ye to do with me, O Tyre, and Zidon, and all the coasts of Palestine? will ye render me a recompense? and if ye recompense me, swiftly and speedily will I return your recompense upon your own head;

The people of Tyre and Zidon, it can be shown from Ezekiel chapters 26 through 28, were indeed Israelites who had Canaanites and Philistines and other peoples among them. Yet regardless of the composition of the people, these cities represented the merchant world of Joel's time, and so they were singled out for the same things that the corporate merchant world of today can be judged for: the making of slaves and whores out of the children of God.



5 Because ye have taken my silver and my gold, and have carried into your temples my goodly pleasant things: 6 The children also of Judah and the children of Jerusalem have ye sold unto the Grecians, that ye might remove them far from their border.

The word *Grecians* here is wrong: in both the Hebrew and the Greek of the Septuagint, the word is Ionians. Let's read Amos 1:9: "Thus saith the LORD; For three transgressions of Tyrus, and for four, I will not turn away the punishment thereof; because they delivered up the whole captivity to Edom, and remembered not the brotherly covenant." Amos 1:9 establishes that the people of Tyre and Sidon were Israelites, partakers of the "brotherly covenant" with Judah, but remembering it not they were selling the people of Judah into slavery, in Amos to the Edomite merchants, and here to the Japhethite Ionians. They were also practicing paganism, as it is evident in Scripture that the children of Israel were practicing paganism from the days of king Jeroboam, as it says at 2 Kings 10:29: "Howbeit from the sins of Jeroboam the son of Nebat, who made Israel to sin, Jehu departed not from after them, to wit, the golden calves that were in Bethel, and that were in Dan." Today, our own fellow countrymen sell us into slavery every day, and most notably through anti-nationalist corporate policies and through corporate lobbying in our seats of government.

7 Behold, I will raise them out of the place whither ye have sold them, and will return your recompense upon your own head: 8 And I will sell your sons and your daughters into the hand of the children of Judah, and they shall sell them to the Sabeans, to a people far off: for the LORD hath spoken it.

One reaps what one sows: the children of Israel who abused those of Judah would be made to suffer likewise. Today, we see the children of our upper and middle classes, who have sold our nation out to our enemies, that they are in bed with our enemies, and that is their recompense!

9 Proclaim ye this among the Gentiles [nations]; Prepare war, wake up the mighty men, let all the men of war draw near; let them come up: 10 Beat your plowshares into swords, and your pruninghooks into spears: let the weak say, I am strong. 11 Assemble yourselves, and come, all ye heathen [nations], and gather yourselves together round about: thither cause thy mighty ones to come down, O LORD. 12 Let the heathen [nations] be wakened, and come up to the valley of Jehoshaphat: for there will I sit to judge all the heathen [nations] round about.

This is that gathering to battle of all of the world's other peoples against the children of Israel as we have

seen in Ezekiel 38: “1 And the word of the LORD came unto me, saying, 2 Son of man, set thy face against Gog, the land of Magog, the chief prince of Meshech and Tubal, and prophesy against him, 3 And say, Thus saith the Lord GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: 4 And I will turn thee back, and put hooks into thy jaws, and I will bring thee forth, and all thine army, horses and horsemen, all of them clothed with all sorts of armour, even a great company with bucklers and shields, all of them handling swords: 5 Persia, Ethiopia, and Libya with them; all of them with shield and helmet: 6 Gomer, and all his bands; the house of Togarmah of the north quarters, and all his bands: and many people with thee.” Yahweh is prophesying against Gog and Magog and all of the associated peoples: He brings them here, so that He may destroy them, and demonstrate His might and the efficacy of His will to the children of Israel. It can be demonstrated, that while this list of people at one time represented White nations, today they are all mixed with non-Whites, and that now it represents the arab, mixed negro, mixed Asian and mestizo populations of the world. Further on in the same chapter of Ezekiel: “16 And thou shalt come up against my people of Israel, as a cloud to cover the land; it shall be in the latter days, and I will bring thee against my land, that the heathen [or *nations*] may know me, when I shall be sanctified in thee, O Gog, before their eyes. 17 Thus saith the Lord GOD; Art thou he of whom I have spoken in old time by my servants the prophets of Israel, which prophesied in those days many years that I would bring thee against them? [This reference is to the 'leviathan' of Isaiah 27:1: 'In that day the LORD with his sore and great and strong sword shall punish leviathan the piercing serpent, even leviathan that crooked serpent; and he shall slay the dragon that is in the sea.'] 18 And it shall come to pass at the same time when Gog shall come against the land of Israel, saith the Lord GOD, that my fury shall come up in my face. 19 For in my jealousy and in the fire of my wrath have I spoken, Surely in that day there shall be a great shaking in the land of Israel; 20 So that the fishes of the sea, and the fowls of the heaven, and the beasts of the field, and all creeping things that creep upon the earth, and all the men that are upon the face of the earth, shall shake at my presence, and the mountains shall be thrown down, and the steep places shall fall, and every wall shall fall to the ground. 21 And I will call for a sword against him throughout all my

mountains, saith the Lord GOD: every man's sword shall be against his brother. 22 And I will plead [or *pass judgement, punish*] against him with pestilence and with blood; and I will rain upon him, and upon his bands, and upon the many people that are with him, an overflowing rain, and great hailstones, fire, and brimstone. 23 Thus will I magnify myself, and sanctify myself; and I will be known in the eyes of many nations, and they shall know that I am the LORD.”

All of those peoples who have come against the children of Israel shall indeed be destroyed. Joel 3:13 is reminiscent of the harvests of the earth described in Revelation chapter 14:

13 Put ye in the sickle, for the harvest is ripe: come, get you down; for the press is full, the fats [properly *vats*] overflow; for their wickedness is great. 14 Multitudes, multitudes in the valley of decision: for the day of the LORD is near in the valley of decision. 15 The sun and the moon shall be darkened, and the stars shall withdraw their shining.

As already described here, it is evident in Revelation chapter 6 that the darkening of the sun and the moon suggest the fall of empire and the dissolution of government and the rule of law. In the Christogenea commentary on the Revelation for [Revelation chapter 6](#) it was said that “The changes in sun and the moon represent the passing of the government and its bureaucracy.” The children of Israel are often compared to “the stars of heaven”, and here they shall withdraw their shining, representing the fall or withdrawal of many of the men occupying seats of power and authority in the government.



Revelation chapter 14 prophecies the harvest of the earth, in a much later period. There are two harvests in Revelation chapter 14. The first harvest is of the parched vine (although the word meaning *parched* is poorly translated in the King James and other versions):

Revelation 14:14-16: “14 And I looked, and behold, a white cloud! And he sitting upon the cloud like a son of man, having upon his head a gold crown and in his hand a sharp scythe. 15 And another messenger came out from the temple crying out with a great voice to him sitting upon the cloud: 'Swing your scythe and reap, because the hour to reap has come, because parched is the harvest of the earth!' 16 And he sitting upon the cloud cast his scythe upon the earth and harvested the earth.”

The second harvest is of the ripe vine:

Revelation 14:17-20: “17 And another messenger came out from the temple which is in heaven, he also having a sharp scythe. 18 And another messenger came out from the altar, he having authority over the fire, and uttered with a great voice to him having the sharp scythe, saying: 'Swing your sharp scythe and gather the clusters of the vine of the earth, because ripe are her grapes!' 19 And the messenger cast his scythe to the earth and gathered the vine of the earth and cast it into the great wine-vat of the wrath of Yahweh. 20 And the wine-vat was trampled outside of the city and blood came out from the wine-vat, as high as the bridles of horses for a thousand six hundred stades.”

Judah has not been delivered since the days of Joel. Therefore, it is evident that this tribulation has covered the entire seven times of Israel's punishment. Leviticus 26:18: “And if ye will not yet for all this hearken unto me, then I will punish you seven times more for your sins.” These seven times had not yet started in Joel's time! The tribulation is to culminate at the end of days, leading up to the “great and the terrible day of the LORD”, and we as Christians await the culmination of these events now.

16 The LORD also shall roar out of Zion, and utter his voice from Jerusalem; and the heavens and the earth shall shake: but the LORD will be the hope of his people, and the strength of the children of Israel. 17 So shall ye know that I am the LORD your God dwelling in Zion, my holy mountain: then shall Jerusalem be holy, and there shall no

strangers pass through her any more.



From the King James Version, Ezekiel chapter 39: “1 Therefore, thou son of man, prophesy against Gog, and say, Thus saith the Lord GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: 2 And I will turn thee back, and leave but the sixth part of thee, and will cause thee to come up from the north parts, and will bring thee upon the mountains of Israel: 3 And I will smite thy bow out of thy left hand, and will cause thine arrows to fall out of thy right hand. 4 Thou shalt fall upon the mountains of Israel, thou, and all thy bands, and the people that is with thee: I will give thee unto the ravenous birds of every sort, and to the beasts of the field to be devoured. 5 Thou shalt fall upon the open field: for I have spoken it, saith the Lord GOD. 6 And I will send a fire on Magog, and among them that dwell carelessly in the isles: and they shall know that I am the LORD. 7 So will I make my holy name known in the midst of my people Israel; and I will not let them pollute my holy name any more: and the heathen shall know that I am the LORD, the Holy One in Israel. 8 Behold, it is come, and it is done, saith the Lord GOD; this is the day whereof I have spoken. 9 And they that dwell in the cities of Israel shall go forth, and shall set on fire and burn the weapons, both the shields and the bucklers, the bows and the arrows, and the handstaves, and the spears, and they shall burn them with fire seven years: 10 So that they shall take no wood out of the field, neither cut down any out of the forests; for they shall burn the weapons with fire: and they shall spoil those that spoiled them, and rob those that robbed them, saith the Lord GOD. 11 And it shall come to pass in that day, that I will give unto Gog a place there of graves in Israel, the valley of the

passengers on the east of the sea: and it shall stop the noses of the passengers: and there shall they bury Gog and all his multitude: and they shall call it The valley of Hamongog. 12 And seven months shall the house of Israel be burying of them, that they may cleanse the land. 13 Yea, all the people of the land shall bury them; and it shall be to them a renown the day that I shall be glorified, saith the Lord GOD. 14 And they shall sever out men of continual employment, passing through the land to bury with the passengers those that remain upon the face of the earth, to cleanse it: after the end of seven months shall they search. 15 And the passengers that pass through the land, when any seeth a man's bone, then shall he set up a sign by it, till the buriers have buried it in the valley of Hamongog. 16 And also the name of the city shall be Hamonah. Thus shall they cleanse the land.” Once the land is cleansed, as Joel says, strangers will never pass through again. And the land is cleansed only in the complete destruction of all of our enemies. All of those non-White aliens who have infiltrated among us and who have come against us.

18 And it shall come to pass in that day, that the mountains shall drop down new wine, and the hills shall flow with milk, and all the rivers of Judah shall flow with waters, and a fountain shall come forth of the house of the LORD, and shall water the valley of Shittim.

The latter half of Ezekiel chapter 39 reads much like Revelation chapter 19 does, where the Wedding Supper of the Lamb is described. Here from Ezekiel 39, from the ASV: “17 And thou, son of man, thus saith the Lord Jehovah: Speak unto the birds of every sort, and to every beast of the field, Assemble yourselves, and come; gather yourselves on every side to my sacrifice that I do sacrifice for you, even a great sacrifice upon the mountains of Israel, that ye may eat flesh and drink blood. 18 Ye shall eat the flesh of the mighty, and drink the blood of the princes of the earth, of rams, of lambs, and of goats, of bullocks, all of them fatlings of Bashan. 19 And ye shall eat fat till ye be full, and drink blood till ye be drunken, of my sacrifice which I have sacrificed for you. 20 And ye shall be filled at my table with horses and chariots, with mighty men, and with all men of war, saith the Lord Jehovah. 21 And I will set my glory among the nations; and all the nations shall see my judgment that I have executed, and my hand that I have laid upon them. 22 So the house of Israel shall know that I am Jehovah their God, from that day and forward. 23 And

the nations shall know that the house of Israel went into captivity for their iniquity; because they trespassed against me, and I hid my face from them: so I gave them into the hand of their adversaries, and they fell all of them by the sword. 24 According to their uncleanness and according to their transgressions did I unto them; and I hid my face from them.

25 Therefore thus saith the Lord Jehovah: Now will I bring back the captivity of Jacob, and have mercy upon the whole house of Israel; and I will be jealous for my holy name. 26 And they shall bear their shame, and all their trespasses whereby they have trespassed against me, when they shall dwell securely in their land, and none shall make them afraid; 27 when I have brought them back from the peoples, and gathered them out of their enemies' lands, and am sanctified in them in the sight of many nations. 28 And they shall know that I am Jehovah their God, in that I caused them to go into captivity among the nations, and have gathered them unto their own land; and I will leave none of them any more there; 29 neither will I hide my face any more from them; for I have poured out my Spirit upon the house of Israel, saith the Lord Jehovah.”



Repeating Joel 3:18: “18 And it shall come to pass in that day, that the mountains shall drop down new wine, and the hills shall flow with milk, and all the rivers of Judah shall flow with waters, and a fountain shall come forth of the house of the LORD, and shall water the valley of Shittim.”

While the salvation of Yahweh is for all of the seed of Israel (i.e. Isaiah 45:25), Joel's prophecy is specifically aimed towards Judah. However Judah has never seen this salvation since the Babylonian captivity, and therefore it must still be expected. Furthermore, in Zechariah 12:7 it does state that Yahweh “shall save the tents of Judah first...”

The rivers of Judah and the fountain flowing with waters are promises much like those found in Revelation chapter 22: “1 And he showed to me a river of water of life, bright as crystal, coming out from the throne of Yahweh and of the Lamb. 2 In the middle of her street and with the river on the one side and the other is the tree of life producing twelve fruits, yielding each of its fruits by month, and the leaves of the tree are for the service of the Nations. [Which can never mean anything beyond the Adamic nations.] 3 And there shall no longer be any curse. And the throne of Yahweh and of the Lamb shall be in her, and His servants shall serve Him 4 and shall see His face, and His Name is upon their foreheads. 5 And there shall no longer be night, and they have not need for light of a lamp and for light of a sun, because Prince Yahweh shall shine upon them, and they shall rule for the eternal ages.”

19 Egypt shall be a desolation, and Edom shall be a desolate wilderness, for the violence against the children of Judah, because they have shed innocent blood in their land. 20 But Judah shall dwell for ever, and Jerusalem from generation to generation.


Egypt represents the captivity, and Edom the oppression of the children of Israel. Jeremiah 30:11 and 46:28 both state thus: “For I am with thee, saith the LORD, to save thee: though I make a full end of all nations whither I have scattered thee, yet will I not make a full end of thee: but I will correct thee in measure, and will not leave thee altogether unpunished.” Of course, the prophetic Jerusalem describes wherever the seat of government of God's

people is found.

21 For I will cleanse their blood that I have not cleansed: for the LORD dwelleth in Zion.

Many foolish men, particularly those with certain agendas, might persuade or be persuaded to believe that the cleansing of blood in verse 21 may have something to do with people of mixed race, and that is simply absurd when considering all of the other statements concerning bastards in Scripture. An honest word study reveals that except on one occasion where adultery is being condemned, which is in Hosea 4:2 where blood appears in the plural and it is explicitly stated that “blood toucheth blood”, wherever blood appears in the plural it is a metaphor for *bloodshed*, or *blood-guiltiness*. Therefore here, in context, blood in the plural at verse 21 must also refer to bloodshed, especially since the shedding of blood is the topic of discussion in verse 19. The *bloodshed* of the children of Israel shall be cleansed. Likewise Yahweh promises at Jeremiah 33:8: “And I will cleanse them from all their iniquity, whereby they have sinned against me; and I will pardon all their iniquities, whereby they have sinned, and whereby they have transgressed against me.” Of bastards, Christ says at Matthew 15:13 that “Every plant, which my heavenly Father hath not planted, shall be rooted up” along with all of the cankerworms, palmerworms, locusts and caterpillars, and there shall be no exceptions. No bastard is born from above, and no bastard is written into the Book of Life. All of those who teach contrary to these things, are liars and they themselves are part of the problem which we face this very day.

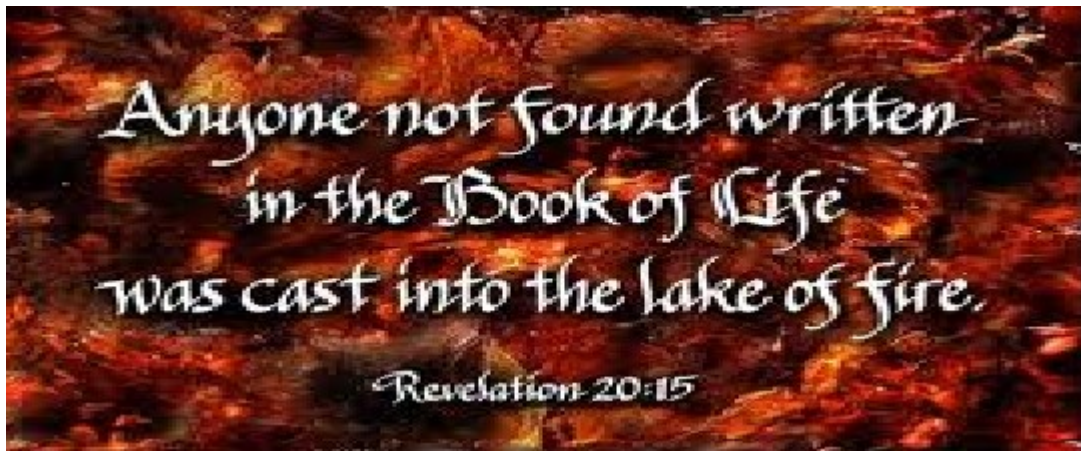

The Immigration Problem & Biblical Prophecy

William R Finck

I originally wrote this essay a couple of election cycles ago, when the issue of immigration was big news in the media. When the media starts talking about illegal immigration, it is usually only to portray those who resist it as backwards and racist. The results today, noticed at least five years after this paper was originally written, show that perspective to be the correct one. Here I have updated this paper somewhat, in order to discuss more recent events and to improve on its perspective.

With the practical marginalization of the somewhat more conservative “tea party” movement in the United States, after it was co-opted by the jewish-controlled media, and with public dissatisfaction over the failed usury-based economy growing, the spotlight has now turned to the new Bolsheviki, the “occupy” movement. The “occupy” movement, led by jews and sexual deviants, filled with the disgruntled unemployed and a motley collection of vagrants who have evidently never even occupied themselves, is obviously another false solution brought to us by those same international bankers who brought us the likes of Rush, Limbaugh, Glen Beck and Sarah Palin.

With all of this, and with a Neo-Marxist administration in the White House, the immigration problem in America is not even any longer a problem on the minds of most people. For their minds are programmed to consider only those issues that the same jewish-controlled media hangs in front of their faces. Bleeding from the bowels, the entire nation only considers the paper cut or the razor nick which the media squawks about each day on the television screen.

While it has fallen out of the limelight, the immigration problem is still our most pressing problem as a nation, but with a stalemated congress

and a Marxist president, the media has for the most part shelved it. It has however made a few exceptions for the recent news of the current administration's sudden and public upholding of certain immigration laws, an obvious political ploy after it had neglected and failed to enforce those same laws for nearly three years. In reality, the administration only wants to appear as if it is willing to uphold the laws which we have, while congress considers another major relaxation of those same laws under the so-called “DREAM Act”.

It is the inevitable will of God that America and the other White nations of the world are overrun with aliens. Therefore it is inevitable that the designs of international jewry against the White race shall proceed. This state of affairs will prevail, until the White race repents, and learns to reject the idols that it worships, which have been presented to it by that same international jewry. It is only inevitable, that those whom you worship become your gods and masters. Today all Christendom worships the jew, the eternal enemy of the one true God, and for as long as that happens, all Christendom shall suffer.

The importance of a knowledge of history as a prerequisite for understanding Biblical prophecy cannot be overstated! Since the prophecies foretell of events concerning tribes and nations, and most of the

Old Testament prophets wrote about 2500 years ago, how can one discern their writings without a knowledge of history since then? Lacking any basic understanding of history, today's churchgoers and Bible readers have been led to misidentify the tribes of the Old Testament, and so they wander down all sorts of crooked paths, their beliefs and their faith clouded with the errors of judeo-churchianity.

While many good White Christian people strongly dislike the idea that our nation is currently being overrun with aliens, few dare define their arguments based on racial terms. Their 'pastors' would slander them as "unChristian", and the dumbed-down "politically correct" majority would label them as "racists". This is too much for most to bear, so they either remain silent, or resort to arguments over the differences between "legal" and "illegal" immigrants, "rule of law" and "national sovereignty". Yet in reality there is no political solution to these problems. America became a "bankrupt" nation not 20 years after our economy was handed over to the jewish international bankers in 1913, and now has no "national sovereignty" whatsoever! The bankers want the Mexicans and other aliens to stay here, in order to keep their Ponzi scheme of a usury-based economy afloat, and so they will arrange it that the aliens remain. Soon the Congress will be browbeaten into passing a bill that few shall dare to call an "amnesty", yet that's what it will amount to, and suddenly all the "illegals" will become so-called "legals". *[This perspective, now at least five years old, still stands true. While congress has not passed such a bill yet, it is tried in every session.]*

At this very time, it is not only America being overrun with alien peoples, but every White Adamic nation on the face of the earth. Be it Britain, Canada, Australia, Germany, Russia, or France, aliens of one "third-world" race or another have been flooding into White nations in ever-increasing numbers. Yet there is no political solution to this problem, and none of the people of these inundated nations, all so-called "democracies", were ever asked beforehand their opinion on the matter. Rather, for the past few decades, we have been conditioned by the mass media, organized religions, and educational institutions to accept "diversity" and "multiculturalism" as inevitable reality. The very orchestration of all these establishments, in company with the immigration policies of the western bureaucracies, by itself reveals the hidden hand

operating behind the scenes.

When I was a child, the immigration laws were overhauled by Congress, led by the traitorous Ted Kennedy. A few years later, in 1972 or 1973 perhaps, I noticed the first Arabs, Pakistanis and Indians moving onto Jersey City. White flight had already been occurring for several years, and many of my friends from school had already moved to the suburbs. The Italian and Polish neighborhoods downtown and in Hoboken had already – in five short years – been overrun with Puerto Ricans and others from the Caribbean. From my childhood perspective, it seemed like they all moved in at once. During this same period, the population of negroes which had moved from the South in the late 1950's and early 1960's, precipitated a brown baby-boom and exploded in Newark and parts of Jersey City. A few years later, from the middle of the 1970's, the term "multiculturalism" became a buzz-word in schools, churches, and the media, seemingly all at the same time.



By the time I was a teen, I felt as if my culture and nation were being displaced. The very obvious coordination of the campaign for multiracial multiculturalism by itself revealed that there was indeed a wizard behind the curtains, pulling the levers that made it all happen. For me, time revealed that the wizard hailed from the synagogues and banking houses of New York. In the 1970's and early 1980's, it was fully noticeable that jews were the first group to flee the cities of New Jersey and head for the suburbs, as if they had some sort of advance warning. The shops that once lined the avenues of the cities suddenly moved to the malls an hour's drive away, and were replaced with newspaper stores and dollar

stores owned and operated by aliens.

Concerning the ancient Israelites, to be overrun with aliens was one of the consequences of being disobedient to Yahweh our God (Leviticus 26:14-46; Deuteronomy 28:15-68). The removal and diminishing of the aliens is among the blessings of obedience to Yahweh (Leviticus 26:3-13; Deuteronomy 28:1-14). While the circumstances of today are somewhat different than they were for our ancient ancestors, the general causes and effects have not changed, and there are other prophecies which do forebode our situation today, yet require much background in history and precedent Biblical prophecy to understand. Only brief outlines can be given here.

From before the Exodus, about 1450 B.C., up until the Assyrian deportations of Israel, 741-676 B.C., many of the Israelites had already been emigrating to the coasts of Europe, northern Africa, and the British Isles. There they had settled among many of the Japhethite tribes that had preceded them in those places. The main body of the Israelites, however, who were deported by the Assyrians and resettled among the other Adamic nations of Mesopotamia and near Asia, spread north into Asia and Europe. Of these the greater number migrated west as the Keltic (Keltic, as opposed to the proto-Keltic) and Germanic tribes. This was the scattering and regathering of Israel foretold by the prophets.

That the Germanic tribes of Europe are Israel can be clearly demonstrated from Daniel chapter 2. Once the first four kingdoms of Daniel's vision in that chapter are understood, and it is realized that the Roman empire was Daniel's fourth kingdom, knowing that the Germanic tribes destroyed the Roman empire, then Daniel 2:44-45 unmistakably identifies these tribes as the true Kingdom of Yahweh, and among them only may we find Daniel's fifth and final kingdom.



While many of the inhabitants of the Roman Empire were Israelites themselves, along with Adamic Japhethites and other Shemites (not to be confused with Jews), the Germanic tribes came to dominate Europe, and all of the northern European nations – including the English and French – sprung from elements of these tribes, along with the Japhethite Slavic nations to the east. These are, for the most part, the remnant of the White race today, and these are the true, legitimate Israel of the Bible, both New Testament and Old. These nations are properly “Christendom”, for which see Isaiah 45:3-4 and 62:2. The old Israel nations, along with all of the other Genesis 10 Adamic nations, of much of southern and eastern Europe, and all of Africa, and Asia, were destroyed long ago, overrun by aliens: the Arabs, Turks and Mongols. This was the flood of the serpent foretold at Revelation 12:15, and we must also note Jeremiah 46:28, which states: “Fear thou not, O Jacob my servant, saith the LORD: for I am with thee; for I will make a full end of all the nations whither I have driven thee: but I will not make a full end of thee, but correct thee in measure; yet will I not leave thee wholly unpunished.”

As the tribes of dispersed Israel regathered in Europe, and remained there for many centuries, Europe was not a final destination for many of them: there were other prophecies which had to be fulfilled. It is North America which certainly seems to be the place described by Ezekiel in chapters 37 & 38. Other prophecies also point to America as the future Zion and the “New Jerusalem”, for example Daniel 11:45. The further the children of Israel traveled from Palestine, the stronger a nation they became, as described in Micah chapter 4, which is a prophecy concerning the creation of America.

Isaiah chapter 56 is one prophecy concerning the regathering of Israel. In 56:8 the A.V. says “Yahweh God which gathereth the outcasts of Israel saith, Yet will I gather *others* to him, besides those that are gathered unto him”, and note that the word *others* was added to the text, which surely cannot infer any others but Israelite “others”. In Brenton's Septuagint the same verse reads: “saith Yahweh that gathers the dispersed of Israel; for I will gather to him a congregation”. The “outcasts of Israel” are the strangers of Isaiah 56:3 and 6, the eunuchs and the dry tree. This is so because Israel was deported in punishment, cast off, estranged and alienated from Yahweh, but later reconciled by His sacrifice and the

New Covenant (which the apostles explained in Ephesians 2:12-19; Colossians 1:20-22; 1 Peter 2:9-11). While many weak, universalist pastors use Isaiah 56:1-8 as an excuse to allow aliens into their congregations, they refuse to see that the New Covenant was made with only the houses, which are the families, of Israel and Judah. This is stated explicitly at Jeremiah 31:31-33, which Paul then repeats at Romans 9:4 and at Hebrews 8:8-13.

The “holy mountain” of Isaiah 56:7 surely seems to be America, the Zion of Jeremiah 3:14. America was founded from “one of a city, and two of a family” out of the Christian nations of northern Europe. Many of the initial colonies here were founded by various Christian sects from Europe, who were seeking freedom of worship, making America a “house of prayer for all [Israelite] people”. This was never true of any other place in prior history, and it is precisely the subject of Micah chapter 4. Everywhere beforetime, religious worship was oppressed and regulated by either the ‘Church’ or the ‘State’, something consciously avoided by the American founders. The “burnt offerings” and “sacrifices” of this passage at Isaiah 56:7 must, of course, be metaphors describing the toils of the American people. Compare the “holy mountain” phrase to Dan. 2:45, and know that America initially comprised mostly English, French, and German settlers: descendants of those same tribes which destroyed Rome.

Yet Yahweh our God surely foresaw that our ‘pastors’, His “watchmen” as they are called in Isaiah 56:10, would misinterpret 56:1-8, as they do much of scripture in their own greed and ignorance. For 56:9-12 reads from the A.V.: “9 All ye beasts of the field, come to devour, yea, all ye beasts in the forest. 10 His watchmen are blind: they are all ignorant, they are all dumb dogs, they cannot bark; sleeping, lying down, loving to slumber. 11 Yea, they are greedy dogs which can never have enough, and they are shepherds that cannot understand: they all look to their own way, every one for his gain, from his quarter. 12 Come ye, say they, I will fetch wine, and we will fill ourselves with strong drink; and tomorrow shall be as this day, and much more abundant.”

These dumb dogs are our universalist theologians and pastors, men such as “Bishop” John Spong or “Evangelist” Ted Weiland. Because of men such as them the beasts of the field, a phrase which is used as a pejorative term for the non-Adamic races (Genesis

9:5; Exodus 19:13; 22:19; Leviticus 20:15-16; Hebrews 12:20), have been given the opportunity to “come to devour” the children of Israel! While most White men and women seem to know that it’s wrong to be allowing the aliens to overrun us, the pastors and churches tell us differently. The Romish catholic church was even one of the primary agitators and organizers of the demonstrations by illegal and other immigrants which have recently taken place across the country, along with various (purportedly dead) Communist organizations, and mestizo supremacist groups such as La Raza. George W. Bush gave a televised speech on May 16th, 2006, which pleased La Raza so much that the extremist and racist mestizo group made many positive statements about the Bush immigration policy after it was outlined. Under the current administration, La Raza even gets federal funding! Often, it’s so-called “Christian outreach” ministries bringing all the world’s alien scum into our formerly all-White communities. It may justly be termed a Purpose Driven Cancer. The fraud that runs that ministry is one of the biggest offenders of the Word of God. Surely we have no political solution to this dilemma, with most of our own politicians in both major parties, and most of our so-called ‘church’ leaders also, being aligned against White Adamic civilization.

At Jeremiah 31:31 ff. we find the promise of a New Covenant made with the houses, which are the genetic families, of Israel and Judah. While this New Covenant was announced at the coming of Christ and the Apostolic period which followed, the final redemption of Israel has not yet occurred (for example, see Romans 8:21-23). And therefore Jeremiah 31:31 ff. must be discussing the culmination of the New Covenant, and not its announcement, and that culmination is to occur at Christ’s Second Advent (described in Revelation chapters 19 and 21). That this interpretation is correct is manifest reading Jeremiah 31:34, and 31:40 for which compare Ezekiel chapter 39.

Jeremiah 31:35-40: “35 Thus saith Yahweh, which giveth the sun for a light by day, and the ordinances of the moon and of the stars for a light by night, which divideth the sea when the waves thereof roar; Yahweh of hosts is his name: 36 If those ordinances depart from before me, saith Yahweh, then the seed of Israel also shall cease from being a nation before me for ever. 37 Thus saith Yahweh; If heaven above can be measured, and the foundations of the earth searched

out beneath, I will also cast off all the seed of Israel for all that they have done, saith Yahweh. 38 Behold, the days come, saith Yahweh, that the city shall be built to Yahweh from the tower of Hananeel unto the gate of the corner. 39 And the measuring line shall yet go forth over against it upon the hill Gareb, and shall compass about to Goath. 40 And the whole valley of the dead bodies, and of the ashes, and all the fields unto the brook of Kidron, unto the corner of the horse gate toward the east, shall be holy unto Yahweh; it shall not be plucked up, nor thrown down any more for ever.” Israel is assured survival by God. The valley of dead bodies, are the bodies of the invaders, described in more detail in Ezekiel chapter 39.

At Jeremiah 31:27-30, just before the prophecy concerning the New Covenant, we find the following: “27 Behold, the days come, saith Yahweh, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast. 28 And it shall come to pass, that like as I have watched over them, to pluck up, and to break down, and to throw down, and to destroy, and to afflict; so will I watch over them, to build, and to plant, saith Yahweh. 29 In those days they shall say no more, The fathers have eaten a sour grape, and the children’s teeth are set on edge. 30 But every one shall die for his own iniquity: every man that eateth the sour grape, his teeth shall be set on edge.”

Surely since the “seed of man” (man, Strong’s #120, adam) represents the White race, then the “seed of beast” must represent the non-Adamic races with which all of the Israel nations of the world are currently being sown. So these alien floods are a test from Yahweh our God, a punishment for our iniquity as He warned us in Leviticus and Deuteronomy. Yet that certainly does not clear the guilty of their crimes, those evil men who would love to have the White race consumed by the aliens. For “every man that eateth the sour grape” shall die. That this eating of sour grapes here represents race-mixing is evident elsewhere in the Bible. At Jude 7, we see the sin of the people of Sodom was fornication, the pursuit of “strange” (Greek *heteros*, #2087, other or different) flesh. Paul often warns us against fornication. At Deuteronomy 32:32 we see the “vine of Sodom” in comparison alongside “grapes of gall” whose “clusters are bitter”. Hence the “strange vine” of the bad-fig jews, those of Judah whom mixed with the Canaanites, of Jeremiah 2:21 and 24:1-10. While race-mixing has always hurt the children which result

from it, the day is coming when the race-mixers themselves shall be punished severely.

This is the time which we face today, just before the culmination of the New Covenant yet, after Israel had been fully gathered and had risen to world domination (for examples see Daniel 7:27 and Isaiah 63:18-19). We have been in this period for at least 90 years now. Shortly after World War I, alien and mixed races began eclipsing White Europeans as the primary immigrants into America. Over the past several decades, the non-Adamic races have been pouring into all White nations in ever-increasing numbers. Certainly this must be what Jeremiah describes at 31:27.



Ezekiel chapter 38 surely describes America, which has consistently been the one land where so many of the world’s aliens have desired to dwell. No other nation in world history has ever come close to the description given by Ezekiel at 38:8-12. America is the “land gathered out of many people”, who were all initially of the Keltic and Germanic tribes, and so it is “the mountains of Israel” which were waste, the “desolate places that are now inhabited”, and its people “gathered out of the [Adamic] nations”. America is the “land of unwalled villages”, full of much cattle and goods.

While the invasion of Gog and Magog and the Arab hordes into this land may yet culminate in an actual military invasion, such an event is not necessary in order to fulfill the prophecy. Millions of Asians, Arabs and other aliens fitting the description of the ravenous hordes given in this chapter are already here, and many have been here for a long time. The mixed race so-called “whites” (which are many of the people considered to be Sicilians or other southern Italians, Greeks, Spaniards, Portuguese, southern French and others – the descendants of the Arab and Turkic invasions of Medieval Europe), together with their Jewish cousins, along with all of the other aliens here,

along with the mestizos and the negroes, may already have true Whites outnumbered. Sure, while the government census reports still tell us that the nation is about 70% white, the numbers exclude millions of undocumented Mexicans and Chinese. They also consider all of the Sicilians and other arab Europeans, the jews, and non-black Hispanics to be “white”, along with the Turks, Arabs, Tatars and others. So the true percentage of White people in America is actually far less than 70%.

Paul, quoting Isaiah 54:1, repeats the prophet’s warning that Israel shall be outnumbered: “For it is written, ‘Be gladdened, barren who is not bearing; break fourth and shout, she who is not travailing; because many more are the children of the desolate than of she who has the husband’” (Gal. 4:27). And of course White women are not travailing in childbirth, having traded motherhood for careers and a lifestyle of hedonism. Remember this as the weekly news rags announce plummeting White birthrates. There was a news story on the radio recently, perhaps May 16th or 17th, 2006, that the Russian government is so alarmed over plummeting birthrates, they’re offering to pay Russian women to have children.

Yet at Luke 16:16-18 we have an assurance, that no matter who tries to force their way into the Kingdom of Yahweh (for which see also Matthew 11:12), He will only accept the children of Israel, who are “she who has the husband”, as His bride. In the end, it is only the twelve tribes of Israel who shall inherit the Kingdom: Revelation 19:1-10; 21:1-12; the nations descended from Abraham through Isaac and Jacob: Revelation 21:24-26.

And we Saxon Israelites have many other assurances. For no matter how hard our politicians and ‘churches’ try to supplant us with aliens, Daniel 2:44 states in part: “the kingdom shall not be left to other people”, and Daniel 7:27 states that “the kingdom, and dominion, and the greatness of the kingdom under the whole heaven, shall be given to the people of the saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve and obey him”.

Ezekiel 37:27-28 promises that Yahweh shall sanctify Israel: “My tabernacle also shall be with them: yea, I will be their God, and they shall be my people. And the heathen shall know that I Yahweh do sanctify Israel, when my sanctuary shall be in the midst of them for evermore.” Ezekiel chapters 38 and 39 tell us

that after the culmination of the invasion of America by our enemies, Yahweh Himself shall destroy every single one of them. Every single alien here shall be destroyed, and it will take the children of Israel 7 months to bury the bodies. From that point on, aliens shall not again sojourn among the children of Israel. In Joel 3:9-17 Yahweh promises: “9 Proclaim ye this among the Gentiles; Prepare war, wake up the mighty men, let all the men of war draw near; let them come up: 10 Beat your plowshares into swords, and your pruninghooks into spears: let the weak say, I am strong. 11 Assemble yourselves, and come, all ye heathen, and gather yourselves together round about: thither cause thy mighty ones to come down, O LORD. 12 Let the heathen be wakened, and come up to the valley of Jehoshaphat: for there will I sit to judge all the heathen round about. 13 Put ye in the sickle, for the harvest is ripe: come, get you down; for the press is full, the vats overflow; for their wickedness is great. 14 Multitudes, multitudes in the valley of decision: for the day of the LORD is near in the valley of decision. 15 The sun and the moon shall be darkened, and the stars shall withdraw their shining. 16 The LORD also shall roar out of Zion, and utter his voice from Jerusalem; and the heavens and the earth shall shake: but the LORD will be the hope of his people, and the strength of the children of Israel. 17 So shall ye know that I am Yahweh your God dwelling in Zion, my holy mountain: then shall Jerusalem be holy, and there shall no strangers pass through her any more.” In prophecy, Zion is His people, and Jerusalem in prophecy represents the seat of their government, no matter where they happen to be. So in spite of the liberals and miscegenists, all of the aliens among us shall be destroyed. Yet how many of the children of Israel shall be destroyed along with them?

Joel chapter 1 describes the economic conditions of the children of Israel in a land covered with parasites, the non-Adamic races: Joel 1:1-8: “1 The word of Yahweh that came to Joel the son of Pethuel. 2 Hear this, ye old men, and give ear, all ye inhabitants of the land. Hath this been in your days, or even in the days of your fathers? 3 Tell ye your children of it, and let your children tell their children, and their children another generation. 4 That which the palmerworm hath left hath the locust eaten; and that which the locust hath left hath the cankerworm eaten; and that which the cankerworm hath left hath the caterpillar eaten. 5 Awake, ye drunkards, and weep; and howl, all

ye drinkers of wine, because of the new wine; for it is cut off from your mouth. 6 For a nation is come up upon my land, strong, and without number, whose teeth are the teeth of a lion, and he hath the cheek teeth of a great lion. 7 He hath laid my vine waste, and barked my fig tree: he hath made it clean bare, and cast it away; the branches thereof are made white. 8 Lament like a virgin girded with sackcloth for the husband of her youth.” The locust, the cankerworm, the caterpillar, the palmerworm, the arab, the negro, the oriental, the mestizo. This is what we suffer today.

In Joel chapter 2 we have a call to repentance at 2:16-17: “16 Gather the people, sanctify the congregation, assemble the elders, gather the children, and those that suck the breasts: let the bridegroom go forth of his chamber [the revelation of Christ], and the bride out of her closet [the revelation of Israel the nation]. 17 Let the priests, the ministers of the LORD, weep between the porch and the altar, and let them say, Spare thy people, O LORD, and give not thine heritage to reproach, that the heathen should rule over them: wherefore should they say among the people, Where is their God?” (Exactly the state of religious affairs in our nation today.)



After this call to repentance, we see a promise of deliverance, in Joel 2: 25-27: “25 And I will restore to you the years that the locust hath eaten, the cankerworm, and the caterpillar, and the palmerworm, my great army which I sent among you. 26 And ye shall eat in plenty, and be satisfied, and praise the name of the LORD your God, that hath dealt wondrously with you: and my people shall never be ashamed. 27 And ye shall know that I am in the midst of Israel, and that I am the LORD your God, and none else: and my people shall never be ashamed.” So we see that the locust, the cankerworm, the caterpillar, and the palmerworm are the “great army” which

Yahweh sent among us. This must describe that same thing as the “seed of beast” of Jeremiah chapter 31: the arab, the negro, the oriental, the mestizo. This is indeed what we suffer today, and we see our road to deliverance is in repentance.

Before we can repent, we need a clear vision of just what sin it is that we are repenting from. Paul repeats the promise of God at 2 Corinthians chapter 6, as Yahweh has said, “I will dwell among them, and I will walk about; and I will be their God, and they will be my people.’ On which account ‘Come out from the midst of them and be separated,’ says the Prince, and ‘do not be joined to the impure, and I will admit you’”. We have no gospel message for the unclean. There is no gospel for beasts. Only the children of Israel were ever cleansed on the cross of Christ, according to the Word of God in His prophets. Refusing to be absolutely clear on the racial message of the gospel and covenants of God, we become scatterers, and not gatherers. We resist Christ, and he shall punish us all the more for our resistance.

Peter, writing in his first epistle to the elect, the sojourners scattered throughout various places in Anatolia, said: “But ye are a chosen race, a royal priesthood, a holy nation, a peculiar people ... Which in time past were not a people, but are now the people of Yahweh: which had not obtained mercy, but now have obtained mercy” (1 Peter 2:9-10). Peter wrote this not to jews, but to “lost” Greek and Keltic Israelites. 1 Peter 2:9 is a purposeful reference to Exodus 19:5-6, and 1 Peter 2:10 to Hosea 1:9-11, which concerns only Israel. The word “holy”, ἅγιος (hagios, #39), is “devoted to the gods, sacred, holy” (Liddell & Scott) in secular Greek, and so Thayer writes of the word: “set apart for God, to be, as it were, exclusively his”. No matter how long or how many of them resist, the children of Israel shall ultimately be a holy and separate people whether they like it or not. Since Isaac was placed on the altar by Abraham, and the fact that Yahshua Christ purchased them back (which is the meaning of redemption) after divorcing them because they sold themselves to sin, they have no choice but to become “holy”. As Paul explained in 1 Corinthians chapter 6: “19 Or do you not know that your body is a temple of the Holy Spirit in you? Which you have from Yahweh, and you are not your own? 20 Indeed you have been purchased for a price; so then you honor Yahweh in your body.”

Likewise Paul, from the Christogenea New Testament,

told the Philippians at 2:14-16: “14 Do all things apart from murmuring and disputing, 15 that you would be perfect and with unmixed blood, blameless children of Yahweh in the midst of a race crooked and perverted - among whom you appear as luminaries in the cosmos, 16 upholding the Word of Life for a boast with me in the day of Christ ...” by which Paul surely refers to His Second Advent.

At 2 Corinthians 6:14-18, Paul warns us to separate ourselves from the unclean (where the A.V. has improperly added thing), because Christ has no accord with Beliar. Babylon is the word used to describe the world’s political, economic and religious systems at the end of the age. Both Beliar (or Belial), meaning worthlessness, and Babylon, from a word meaning confusion, are originally Hebrew words which are from root words which describe something mixed, for which see Strong’s Hebrew dictionary #s 894, 1101, 1097 and 1098. The mixed-race “children of Belial” often caused trouble for the Old Testament Israelites, which for examples see Deuteronomy 13: 13; or Judges. 19:22 and 20:13. Today’s religious, political & social organizations promote everything mixed, and they strive to pollute everything not mixed! The doom of Babylon is foretold at Revelation chapters 17-18. At Rev. 18:4 the children of Israel are warned: “Come out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues”. With so much of Biblical prophecy fulfilled, should one dare think lightly of the balance? Truly, “a friend of the world is the enemy of Yahweh” (James 4:4). Indeed, what we observe today was forecast by the prophets!

I will close by repeating Jeremiah 46:28 “Fear thou not, O Jacob my servant, saith the LORD: for I am with thee; for I will make a full end of all the nations whither I have driven thee: but I will not make a full end of thee, but correct thee in measure; yet will I not leave thee wholly unpunished.” Wherever the children of Israel have had passage in their journeys, that nation has no future worth investing in. Additionally, here is Ezekiel KJV Ezekiel 39:1-14, which prophecies of all those who have invaded our Israelite nations today: “1 Therefore, thou son of man, prophesy against Gog, and say, Thus saith Yahweh GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: 2 And I will turn thee back, and leave but the sixth part of thee, and will cause thee to come up from the north parts, and will bring thee upon the mountains of Israel: 3 And I will smite thy bow out of thy left hand, and will cause

thine arrows to fall out of thy right hand. 4 Thou shalt fall upon the mountains of Israel, thou, and all thy bands, and the people that is with thee: I will give thee unto the ravenous birds of every sort, and to the beasts of the field to be devoured. [Compare Revelation chapter 19, the destruction of all of our enemies is the marriage supper of the lamb.] 5 Thou shalt fall upon the open field: for I have spoken it, saith the Lord GOD.



6 And I will send a fire on Magog, and among them that dwell carelessly in the isles: and they shall know that I am Yahweh. 7 So will I make my holy name known in the midst of my people Israel; and I will not let them pollute my holy name any more: and the nations shall know that I am Yahweh, the Holy One in Israel. 8 Behold, it is come, and it is done, saith Yahweh GOD; this is the day whereof I have spoken. 9 And they that dwell in the cities of Israel shall go forth, and shall set on fire and burn the weapons, both the shields and the bucklers, the bows and the arrows, and the handstaves, and the spears, and they shall burn them with fire seven years: 10 So that they shall take no wood out of the field, neither cut down any out of the forests; for they shall burn the weapons with fire: and they shall spoil those that spoiled them, and rob those that robbed them, saith the Lord GOD. 11 And it shall come to pass in that day, that I will give unto Gog a place there of graves in Israel, the valley of the passengers on the east of the sea: and it shall stop the noses of the passengers: and there shall they bury Gog and all his multitude: and they shall call it The valley of Hamongog. 12 And seven months shall the house of Israel be burying of them, that they may cleanse the land. 13 Yea, all the people of the land shall bury them; and it shall be to them a renown the day that I shall be glorified, saith the Lord GOD. 14 And they shall sever out men of continual employment, passing through the land to bury with the passengers those that remain upon the face of the earth, to cleanse it: after the end of seven months shall they search.”

Psalms 118 is a Messianic prophecy for the second

advent of Christ, and a prayer which all Israel should utter today: “1 O give thanks unto Yahweh; for he is good: because his mercy endureth for ever. 2 Let Israel now say, that his mercy endureth for ever. 3 Let the house of Aaron now say, that his mercy endureth for ever. 4 Let them now that fear Yahweh say, that his mercy endureth for ever. 5 I called upon Yahweh in distress: Yahweh answered me, and set me in a large place. 6 Yahweh is on my side; I will not fear: what can man do unto me? 7 Yahweh taketh my part with them that help me: therefore shall I see my desire upon them that hate me. 8 It is better to trust in Yahweh than to put confidence in man. 9 It is better to trust in Yahweh than to put confidence in princes. [There is no political solution to our woes.] 10 All nations compassed me about: but in the name of Yahweh will I destroy them. 11 They compassed me about; yea, they compassed me about: but in the name of Yahweh I will destroy them. 12 They compassed me about like bees; they are quenched as the fire of thorns: for in the name of Yahweh I will destroy them. [The 'I' representing the Body of Christ.]”

In Isaiah chapter 41:8-12 Yahweh again guarantees the complete destruction of all those who come against Israel in the latter days: “8 But thou, Israel, art my servant, Jacob whom I have chosen, the seed of Abraham my friend. 9 Thou whom I have taken from the ends of the earth, and called thee from the chief men thereof, and said unto thee, Thou art my servant; I have chosen thee, and not cast thee away. 10 Fear thou not; for I am with thee: be not dismayed; for I am thy God: I will strengthen thee; yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness. 11 Behold, all they that were incensed against thee shall be ashamed and confounded: they

shall be as nothing; **and they that strive with thee shall perish.** 12 Thou shalt seek them, and shalt not find them, even them that contended with thee: they that war against thee shall be as nothing, and as a thing of nought.” [If we cannot find them, how the hell could we teach them the law, as some frauds in Christian Identity insist?]

The locust, the cankerworm, the caterpillar, the palmerworm. If these worms described by Joel are the “great army” which Yahweh sent among us, manifestly in order to chastise and to test us, then these worms are another allegory for the beasts which Yahweh sowed the house of Israel and the house of Judah with in these times, as He spoke at Jeremiah chapter 31 verses 27 to 30. They are also another allegory for the armies of Gog and Magog seen here in Ezekiel chapter 39. The locust, the cankerworm, the caterpillar, the palmerworm, the arab, the negro, the oriental, the mestizo. All of these groups are seeking the destruction of the White world today, without exception. The end of these beasts is described in 2 Peter chapter 2, where the apostle explains to us that these natural brute beasts who sit among us and share our blessings unworthily are made to be taken and destroyed. They have no other fate, for everything that offends and all of those not found written in the Book of Life shall go off into the Lake of Fire, into eternal destruction. That is how Yahweh shall sanctify Israel, as promised in many of the Old Testament prophecies cited above. That is why, in Revelation chapters 21 and 22, only the twelve tribes of the children of Israel are mentioned, and none others. Only those who resist the will of God can imagine that there could be others.





In jeopardy: Future of White South Africans

Genocide Watch expert warns population on verge of extermination

As former South Africa President Nelson Mandela remains hospitalized and reportedly in serious condition, questions about the future of increasingly marginalized European-descent South Africans are edging into international headlines.

Recent developments on multiple fronts are striking fear into the hearts of many Afrikaners, descendants of primarily northern Europeans who began arriving in South Africa three to four centuries ago.

From legally mandated race-based economic discrimination against whites to the thousands of farm murders targeting Boers across the nation, the problems are only getting worse. Poverty and unrest are spreading quickly as well.

Genocide

The world's most prominent expert on genocide, President Dr. Gregory Stanton of Genocide Watch, already warned last year that the Afrikaner population could be on the verge of a government-linked extermination campaign.

During a fact-finding mission to South Africa, Stanton, who helped fight against apartheid, found evidence implicating the ruling African National Congress (ANC)-South African Communist Party (SACP) government in a plot to eradicate whites as part of a scheme to foist Marxist tyranny on the nation.

In fact, after the investigation, World Net Daily [WND] [reported](#) that Genocide Watch [raised its alert level on South Africa to stage 6 out of 8 – the planning](#)

[and preparation phase of the extermination process.](#)

“There is thus strong circumstantial evidence of government support for the campaign of forced displacement and atrocities against white farmers and their families,” Stanton said in the Genocide Watch report, adding that the end goal was communist tyranny. “There is direct evidence of [South African] government incitement to genocide.”

As WND also reported, South African President Jacob Zuma routinely sings racist songs calling for the murder of whites.

Former ANC Youth Leader Julius Malema, a virulently racist self-styled communist with a significant following, is now forming a new political party to “fight white males,” South African media reported this week.

Malema's alliance will also seek to expropriate white-owned property without compensation, nationalize key industries and force whites to “behave in a manner that says they regret their conduct.”

Economic discrimination

Meanwhile, on the economic front, authorities are cracking down on the white minority as well.

Through a controversial program known as Black Economic Empowerment (BEE), the government has instituted a race-based employment regime specifically targeting whites.

Critics, even among prominent blacks, say the results of BEE have been disastrous.

Among the myriad problems associated with the race-based employment system: mass emigration of skilled workers contributing to “brain drain,” soaring poverty rates among whites, chaos for businesses and more.

Hundreds of thousands of economically excluded Afrikaners now live in squalid squatter camps throughout South Africa without so much as running water or electricity.

Hundreds of thousands more have fled to Western nations seeking a better life.

“The advent of black rule has been devastating for whole groups of whites, even highly educated ones,” Dan Roodt of the Pro-Afrikaans Action Group, PRAAG, told WND.

Among those groups, he said, are European-descent South Africans from virtually every economic field – especially people with cultural skills, bank workers, and government employees.

“Some of these people have definitely ended up on skid row,” Roodt added, pointing to the racist affirmative action policies as the cause.

“I definitely blame the system of reverse discrimination or anti-white racism for white poverty,” the author and prominent activist continued.

“Almost all whites are educated, literate and generally hard-working, so they should not be poor,” he said.

“The system makes them poor by denying them opportunities and expecting whites to be superhuman and to make money out of thin air.”

Roodt explained that once people are excluded from the economic life of a country, they “spiral downwards and lose everything,” making it increasingly difficult to re-enter society in the future.

“It makes me both sad and very angry to witness these scenes of whites living in third-world squalor while we have all the skills to employ them, but the system prevents us from doing so,” he added.

The corruption is out of control, too, Roodt explained, saying it was contributing to the growing economic problems facing the nation.

“South Africa’s ANC government is so corrupt that it is sometimes hard to distinguish between the ruling party and organized crime,” he said.

Media attention

Since the fall of apartheid in 1994 – when the Western establishment and Soviet powers finally succeeded in forcing the anti-communist, white-dominated government to relinquish power – the international press, which played a key role in the process, has been largely silent.

After almost two decades of ignoring the issues, however, the world media is starting to take notice – albeit slowly.

The British state-funded BBC, for example, featured a recent article headlined “[Do white people have a future in South Africa?](#)”

“The answer, as with so many similar existential questions, is ‘Yes – but...’,” reported BBC News World Affairs Editor John Simpson after exploring the problems.

While acknowledging that whites still own much of the nation’s wealth, Simpson concluded that only certain segments of the European minority have a genuine future in South Africa.

“Working-class white people, most of them Afrikaans-speakers, are going through an intense crisis,” the BBC noted.

“Those who fit in and succeed will certainly have a future,” the report stated. “As for the rest, there are no guarantees whatsoever.”

ANC reaction

A spokesman for the ANC could not be reached for comment by WND despite repeated attempts.

However, even though many experts said the BBC article barely scratched the surface, the reaction from the ruling ANC was to demonize the reporter and his employer, saying the BBC was suffering from an “apartheid hangover.”

“South Africa has never been in a situation where whites have been singled out and persecuted,” ANC spokesperson Keith Khoza was quoted as saying in South African media reports.

He also pointed out that crime and poverty affect all South Africans, which is true, though few dispute the fact that white farmers have been victimized in numbers all out of proportion even when compared with the rest of South Africa’s crime-ridden society.

“The BBC is living in their own world with their racist

tendencies where they wish to undermine the government of South Africa because it is largely a black government,” the spokesman claimed.

“This isn’t just an attack on the government of South Africa and the ANC, it’s an attack on South Africa as a whole,” he concluded.

Farm murders

In a development that was considered surprising by analysts and South African exiles who spoke with WND, the BBC also touched on the ongoing farm murders that have claimed as many as 10 percent of the nation’s European-descent farmers.



“Virtually every week the press here report the murders of white farmers, though you will not hear much about it in the media outside South Africa,” the report said. “In South Africa you are twice as likely to be murdered if you are a white farmer than if you are a police officer – and the police here have a particularly dangerous life. The killings of farmers are often particularly brutal.”

As WND also reported last year, authorities have done little about the problem other than try to conceal it from the world.

“The government has so far been unwilling to make solving and preventing these murders a priority,” the BBC report continued.

Indeed, even keeping an accurate count has been made all-but impossible by the ANC-SACP government, which regularly downplays the vicious farm murders and even stopped tracking useful statistics that would reveal the true scope of the problem.

Many of the victims, often children and babies, are brutally tortured before being killed.

The horrors have included drowning infants in boiling water, raping children, disemboweling whole families, dragging victims for miles behind a vehicle and other unimaginable atrocities.

Experts say the goal is to terrorize and eventually eliminate white farmers, with Genocide Watch’s Stanton and numerous other convinced that the ultimate aim is to establish communist tyranny.

With a population of around 5 million, whites today make up less than 10 percent of the population, down from above 20 percent a century ago.

Since the fall of apartheid in 1994, an estimated half-a-million have emigrated. Countless more would go if they could.

Land redistribution

In a separate BBC report, the state-funded news organization also documented the results of the South African government’s highly controversial land-redistribution policies.

The government admitted that 90 percent of farms it had “redistributed” from whites who farmed the land for generations to blacks with little knowledge of farming – almost 25,000 square miles of land so far – are now “failing.”

“The farms – which were active accruing revenue for the state – were handed over to people, and more than 90 percent of those are not functional,” Land Reform Minister Gugile Nkwinti conceded.

“They are not productive, and therefore the state loses the revenue,” Nkwinti continued. “We cannot afford to go on like that... No country can afford that.”

While the government plan was to redistribute a full third of white-owned land to blacks by 2014, there are now discussions about potentially trying to return some of the farms to their former owners in a bid to keep the tax revenues flowing.

In neighboring Zimbabwe, formerly known as Rhodesia, Marxist dictator and ANC ally Robert Mugabe violently expelled much of the population of white farmers. The land was then largely “redistributed” to cronies who knew nothing about farming.

Before that, the country was known as the “breadbasket” of Africa thanks to its massive agricultural export industry.

Today, Zimbabweans are starving as the nation increasingly depends on international food aid for survival.

Future in South Africa

Analysts on all sides of the issue seem to agree on at least one point: The eventual death of Mandela, 94, could make long-simmering problems explode to the forefront once again, potentially with deadly consequences.

The general public perception of Mandela, which tends to ignore or minimize his well-documented past involvement in terrorism and the international communist movement, considers the former president and ANC leader as something of a hero for his key role in the Western- and Soviet-backed takedown of apartheid.

When he dies, more than a few analysts say full-blown chaos could be unleashed in South Africa. One source with knowledge of the matter told WND that martial law may even be declared.

If the plight of significant segments of the Afrikaner population is bad now, however, the death of Mandela could mark a turning point toward total disaster – at least if current trends continue and the world remains silent.

What to do, though, remains unclear.

Afrikaners within South Africa and others exiled around the world have widely divergent views as to what route would be best for the European-descent minority.

Options

A few exiles, citizens and experts who spoke with WND suggested that there was no longer a viable future for Afrikaners in South Africa.

Along with advocates like Stanton of Genocide Watch, they say it is time for the United States and Europe to start urgently accepting vulnerable whites as refugees.

Others say a war for self-defense might be the only real option if the situation gets out of control – a conflict that would undoubtedly have disastrous consequences for all South Africans, but especially the white minority.

Plenty of South Africans, especially in cities like Cape Town, still do not see what analysts say are storm clouds building on the horizon. Most would simply

like to live in peace.

Incompatible cultures

For an increasingly significant segment of the population, it is becoming clearer that today's South Africa is simply not sustainable in the long term.

“South Africa is a colonial construct, currently an incompatible, unsustainable mix,” International Afrikaner Society President Hannes Louw told WND.

The major fault-line in what is dubbed the “Rainbow nation,” Louw said, is between Afrikaners – descendants of Europeans, Khoi Africans as well as former slaves from Africa, Indonesia, and India – and Bantu, descendants of migrant groups from central and eastern Africa.

“The time has come to face the facts: oil and water does not mix,” he continued.

“The same principles that applied to other countries, like North and South Sudan, also applies to South Africa – the country needs to be divided in two countries, a Western South Africa where Afrikaners are the majority and an Eastern South Africa where Bantus are the majority,” Louw said.



“Despite the current regime’s efforts to culturally colonize Western South Africa, with racist Black Economic Empowerment and busing in homeless Xhosa, Afrikaners are still the majority in in this region and that’s the saving grace,” he continued.

“The time has come for Afrikaners living in Western South Africa to democratically take back their inheritance, the land that was paid for with the lives of our ancestors, fertilized with their blood and watered with their tears,” Louw added. “But as Christians, let us not forget to do so responsibly in line with Biblical

principles, international law and the South African constitution.”

Afrikaner homeland

PRAAG leader Roodt, meanwhile, says the European minority in South Africa must achieve self-determination and self-governance if the Afrikaner people and culture are going to survive and thrive.

“The sooner whites realize that the only way out is an ethnic state or Israel of their own, the better,” he told WND. “I can only see the system deteriorating progressively, with anti-white discrimination becoming so pervasive and pernicious that no one will be able to survive.”

Experts say the idea of an independent homeland for Afrikaners is a non-starter with the South African ANC-SACP government, Western powers, and the United Nations.

Still, among certain segments of the white minority in South Africa, the idea is alluring and will likely become increasingly appealing going forward.

Survival

Henri Le Riche, a patriotic Afrikaner activist in exile in Australia who runs a [website](#) focused on many of issues affecting South Africa, told WND that there could still be a bright future for his people in their homeland.

“The Afrikaner is a small minority, and unlike the U.S. don’t have numbers in the population which will help in long term survival,” he explained.

That does not mean, though, that anyone should lose hope. There is potential, Le Riche continued.

“Whites do have a future in South Africa, but only if they embrace their own culture and stop feeling shame or embarrassed,” he said. “This, of course, is not easy in the current atmosphere, as morale is at its lowest due to affirmative action favoring black people, and discriminating against skilled white people.”

Revival and the West

However, Le Riche sees the problem as something that goes beyond his own nation and really affects the

West more broadly – particularly Americans, who he says have a lot in common with the Afrikaner.

There are two primary forces holding Western culture together, Le Riche said: family and religion.

“This is the focus point of Marxism in to break down these two pillars of our society, with the final goal to break down Western culture,” he explained. “We can see the effects of this Marxist strategy all over the world with moral decay in society and the breakup of families.”

Quoting an American, Le Riche said that the West may have defeated Communism during the Cold War, but Marxism is still winning. Communism, he added, is the structured form of Marxism – government.

Afrikaners and Americans

Le Riche offered two suggested ways for Afrikaners as a people to survive, which he believes apply to patriotic Americans as well.

For one, “do not feel guilty or shy about who or what you are,” he said.

“As humans we have good and bad points, and that goes for every nation on this earth’s history. Marxism focus on breaking down identity by form of making you feel ashamed of who you are, and your history.”

Secondly, Le Riche added, Afrikaners should reach out to Americans, and vice versa.

“As Afrikaners and Americans we have a very similar history spanning over a period of nearly 400 years on two different continents,” he said. “The nearest you will get to an American is an Afrikaner. No other nation comes as close.”

“Sadly, many Americans don’t even know the Afrikaner,” Le Riche continued. “Americans need to help Afrikaners selling themselves, selling their identity. Fight the goal of Marxism.”

He says Americans should look beyond “Fortress America” and build new friendships and re-connect with old allies like the Afrikaners.

“When it comes to our way of life and survival of our values in the long run, we need friends, many friends, and friendships, like relationships, need work,” the exiled activist and commentator said. “Let’s start building those relationships.”

Emma West

Finally Sentenced

Just a quick article to let you all know that Emma West's nightmare at the hands of the State was brought to an end today. After nearly 2 years of abuse from the *corrupt British government and the media*, Croydon Crown Court finally sentenced the worn down Emma West.

Emma 34, of New Addington had recently changed her plea from 'not guilty' to 'guilty' admitting the charge of 'racially-aggravated disorderly behaviour likely to cause harassment or distress' and was **bound over to keep the peace and handed a 24-month community order** by the Judge.

The court heard how she was mentally ill when committing her 'crime', had overdosed on anti-depressants and drank a large glass of wine before her 'outburst' - which no doubt subliminally says that it was her 'mental illness' and 'overdose' that caused her to tell the truth about immigration and how London has been culturally and racially destroyed by the illegal importation of millions of third world immigrants.

A judge said that 'West was clearly suffering from mental health problems at the time of the outburst'.

She received a mental health treatment order for assaulting a constable in a separate incident. The court heard she was 'reeking of alcohol' when she

carried out the 'verbal attack'. Prosecutor Julius Capon said: "*She in essence persecuted a number of passengers on the tram, subjecting them to some disgusting racial abuse.*"

The things she said included "you're not English", "none of you are English" and "get back to your own countries".

Mr Capon said many of the passengers were "upset" by West's behaviour. "*Some of them described themselves as being disgusted, shocked and horrified,*" he said.

David Martin-Sperry, defending Emma, said the defendant's offending was out of character, she was taking anti-depressants and she does not harbour any racist views. He added, she had unwittingly taken two and a half times the recommended dose and drunk a large glass of wine before launching the tirade.

So there you have it - Emma's not a racist, she only said what she said due to drink and drugs and really likes immigrants.

Now why don't I believe a word of that

MASS SURVEILLANCE IN THE ORWELLIAN POLICE STATE

Part 2: The Red Terror to Come

The National Security Agency's 1 million square foot, \$2 billion headquarters is located in Utah in a valley just south of Salt Lake City. The Utah Data Center is to be the headquarters and epicenter of terrestrial surveillance: here trillions of millions of intercepted phone calls, emails, and data trails will be collected and scrutinized by analysts over highly encrypted fiber-optic links.

A project of immense secrecy, the Utah Data Center's purpose, according to bestselling author and investigative journalist James Bamford, will be this:

... to intercept, decipher, analyze, and store vast swaths of the world's communications as they zap down from satellites and zip through the underground and undersea cables of international, foreign, and domestic networks.... Flowing through its servers and routers and stored in near-bottomless databases will be all forms of communication, including the complete contents of private emails, cell phone calls, and Google searches, as well as all sorts of personal data trails.... Should the agency ever fill the Utah center with a yottabyte of information, it would be equal to about 500 quintillion pages of text. — James Bamford, author of *The Shadow Factory: The Ultra-Secret NSA from 9/11 to the Eavesdropping on America*. (See Wired.com)

According to Google's former CEO, Eric Schmidt, the sum total of all human knowledge from the dawn of history up to 2003 comes to 5 exabytes. Our own calculations allow us to infer the following from this: given that one million exabytes equals one yottabyte or 10,000,000,000,000,000,000,000 bytes (10^{24}), one yottabyte of information would equal the sum total of all extraterrestrial knowledge on 200,000 planets identical to planet earth from their earliest times up to now.

To put it another way: 5 exabytes is equal to all the words ever spoken by mankind, while one yottabyte of information would take 11 trillion years to download from the internet using high-power broadband.

The mind boggles at the thought of such infinite oceans of knowledge, all of it theoretically recordable on a supercomputer.



According to Ray Kurzweil, American futurologist described by *Forbes* magazine as “the **ultimate thinking machine**”, the next few decades will bring about an exponential growth in computing power.

IBM is at present trying to simulate the human brain with its own cutting-edge supercomputer called Blue

Gene. What is Blue Gene’s brain capacity? You will be surprised to hear it’s a mere fraction of the human brain. It possesses only a billion neurons in comparison to the brain’s 20 billion. As for the connection between neurons known as synapses, it possesses 10 trillion of these compared to the human brain’s 200 trillion. For all its sophistication, the Blue Gene “supercomputer” possesses only 4.5 percent of the human brain’s capacity. (See [Scientific American](#))

Whoever made the human brain was clearly a super-intelligent Being of some kind—unless you prefer to think that this incredibly complex organ came about by chance after a remarkable series of accidents starting with the Big Bang 13.8 billion years ago.

According to Kurzweil, the human brain is about to be overtaken by computers. By 2045, he predicts,

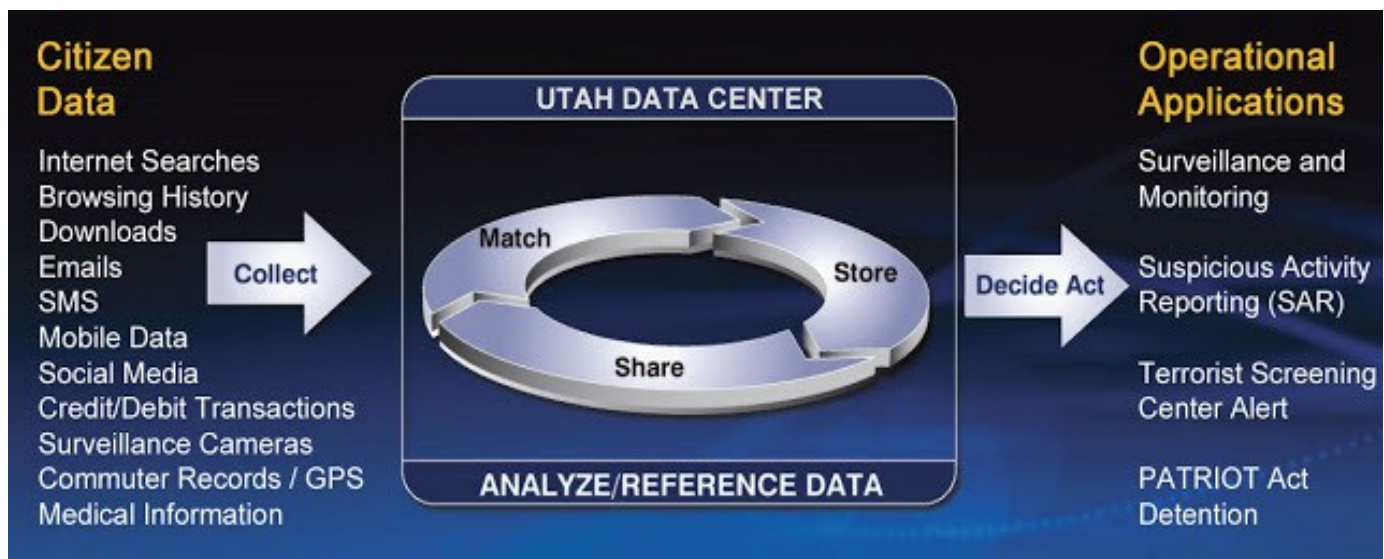
Singularity will occur—a merger between biology and technology. He says, “There will be no distinction, post-Singularity, [between human and machine.](#)” An ordinary computer in 2045 will possess [one billion times more power](#) than all human brains combined today.

Finally, by 2099, humans and computers will have merged. Literally, in every sense. By turning himself into a self-replicating machine, man will have achieved immortality.

Thus Kurzweil, a man known for his uncannily accurate predictions.

In such a Brave New World, there can be no secrets. Big Brother will not only know what you are doing, he will know what you are thinking. He will know what you are going to do before you even do it.

CITIZEN DATA: HOW THEY ARE BUILDING UP A SECRET DOSSIER ON YOU



Obviously the only way to find the vitally important information is to filter through the vast repository of irrelevant trash. This is done through a process known as *massive volume reduction* (MVR). The spooks say they are interested primarily in metadata, not in content. They only want to know your secrets if they are *worth* knowing. Your metadata basically tells them if you are a suitable candidate for more intrusive surveillance.

The information gathering process is facilitated by the use of “selectors”. These are key words or phrases. If you use these regularly, you automatically make yourself suspect. Search terms include subject

headings, phone numbers, and email addresses of interest. There are roughly 30,000-40,000 selector terms.

According to whistleblower William Binney, there is a target list in the US of 500,000 to a million people. These are the ones being watched. Investigative journalist Christopher Ketchum thinks this figure too low. A reliable source told him that the number of potential terrorists in America was much higher. “Eight million Americans are now listed in Main Core as potentially suspect,” Ketchum reported. “In the event of a national emergency, these people could be subject to everything from heightened surveillance

and tracking to direct questioning and possibly even detention.”

The idea that we are all being spied on in a responsible way, and that we have nothing to fear unless we are terrorists, will not bear scrutiny for a number of reasons. The famous Latin tag *Quis custodes custodiet?*—Who will watch the watchers?—says it all. We are referring here to Israeli infiltration. The fact that everything known to the NSA and GCHQ is also known to Israeli intelligence, through Israeli internet giants such as Verint and Narus, is a cause for extreme concern.

This is the problem then: not only does Big Brother in America know all your secrets, so does Big Brother in Israel.



Apart from Jonathan Pollard, a long list of American Jews have spied for Israel. Surprisingly, none of these Jews have been prosecuted and punished. Paul Wolfowitz, Richard Perle, Steven Bryen, Douglas Feith, Michael Ledeen, Steven Rosen, Keith Weissman, Jane Harman—the list goes on—have never been brought to justice. They cannot be indicted, no matter what crimes they commit, because they are beyond the law. The law applies only to ordinary citizens—to you and me. The ruling elite, now disproportionately Jewish, remains untouchable.

James Petras puts it like this:

It doesn’t take a genius to connect the dots.

Then there is Jacob “Kobi” Alexander, a former Israeli intelligence officer who founded Verint that monitors all the telephone calls at Verizon. He is now a fugitive from justice.

Former head of Comverse, parent company of Verint, Kobi Alexander is now a wanted man who fled US justice to Africa and is reportedly now hiding out in Israel. “It is important to note,” Christopher Bollyn writes, “that Kobi Alexander and Comverse were closely connected to Odigo, the Israeli messaging service that was used to warn Israelis to stay away from the World Trade Center on 9-11.”

They quickly grabbed the first of the girls, and bent her backwards over the edge of the table until her joints cracked. I was close to passing out as one of them took his knife and, before the very eyes of the other girls, cut off her right breast. He paused for a moment, then cut off the other side. I have never heard anyone scream as desperately as that girl. After this operation he drove his knife into her abdomen several times, which again was accompanied by the cheers of the Russians....

The Commissar [officer in charge, almost certainly Jewish] made sure I was watching. One girl had not undressed completely...around seventeen years of age. They soaked her bra with oil and set it on fire, and while she screamed, a thin iron rod was shoved into her vagina...

No consent, no democracy.

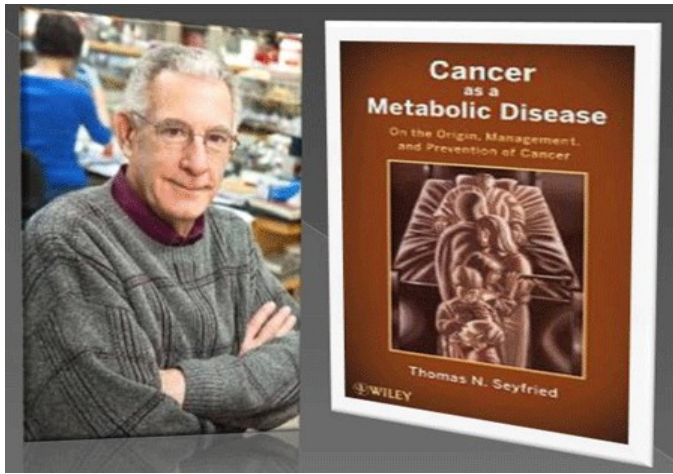

The Benefits of a Ketogenic Diet and Its Role in Cancer Treatment

Many people have been brainwashed into believing that cancer is some sort of vicarious illness which could strike them at any moment. Nothing could be further from the truth. The ignorant and foolish will go to extraordinary lengths to avoid this modern plague as in the self immolation of Angelina Jolie. The biochemistry of a human body does not build a fire wall between breast tissue and the rest of the body. The strategy for avoidance and protection is more simple and wholesome as Dr Joseph Mercola writes.

Could a ketogenic diet eventually be a “standard of care” drug-free treatment for cancer? Personally, I believe it’s absolutely crucial, for whatever type of cancer you’re trying to address, and hopefully some day it will be adopted as a first line of treatment.

A ketogenic diet calls for eliminating all but non-starchy vegetable carbohydrates, and replacing them with healthy fats and high-quality protein.

The premise is that since [cancer](#) cells need glucose to thrive, and carbohydrates turn into glucose in your body, then lowering the glucose level in your blood through carb and protein restriction literally starves the cancer cells into oblivion. Additionally, low protein intake tends to minimize the mTOR pathway that accelerates cell proliferation.

This type of diet, in which you restrict all but non-starchy vegetable carbs and replace them with low to moderate amounts of high-quality protein and high amounts of beneficial fat, is what I recommend for everyone, whether you have cancer or not. It’s a diet that will help optimize your weight and all chronic degenerative disease. Eating this way will help you convert from carb burning mode to fat burning.

Dr. Thomas Seyfried is one of the leading pioneer academic researchers in promoting how to treat cancer

nutritionally. He’s been teaching neurogenetics and neurochemistry as it relates to cancer treatment at Yale University and Boston College for the past 25 years.

He’s written over 150 peer-reviewed scientific articles and book chapters, and has also published a book, *Cancer as a Metabolic Disease: On the Origin, Management, and Prevention of Cancer*.

Ketogenic Diet Accepted as First Line Approach for Epilepsy Is Cancer Next?

The ketogenic diet has actually been used for managing seizures in children for quite some time. While Dr. Seyfried and his team worked on brain cancer and epilepsy in mice, one of his students suggested investigating whether or not a ketogenic diet might also be effective against tumors.

So, in the late ‘90s, they began dovetailing their work on ketogenic diets and epilepsy and cancer together, eventually bringing them to a better understanding of how changing your whole-body metabolic state can be effective in targeting and eliminating tumor cells.

Interestingly, clinical medicine has recognized the ketogenic diet as a valuable option in the treatment of epilepsy since the late 90’s. *“I served as the organizer for the Ketogenic Diet Special Interest*

Group at the American Epilepsy Society,” Dr. Seyfried says.

“We initially started as a small focus group with the folks from Johns Hopkins Medical School, where the diet has had its greatest use and impact. And then we started to grow and substantially increase interest mainly through the efforts of Jim Abrahams.

Jim started the Charlie Foundation for his son Charlie, who went through a near-death experience from seizures and was rescued using ketogenic diets. His colleague, Meryl Streep, the famous movie actress, became very involved in this.

Now the ketogenic diet is receiving considerable attention in the epilepsy community as a first line of approach. Although this is still not widely accepted, I have to admit that the ketogenic diet is now recognized as an important component for the management of refractory seizures in children.”

According to Dr. Seyfried, the mechanism by which the ketogenic diet manages seizures is not nearly as clear as the way the ketogenic diet manages cancer. This is ironic considering that it’s barely known, let alone applied, within oncology circles, while it’s already a first line of treatment for epilepsy. In the case of cancer, it’s well-established that it’s the glucose reduction that kills the cancer cells.

Cancer Is a Mitochondrial Metabolic Disease

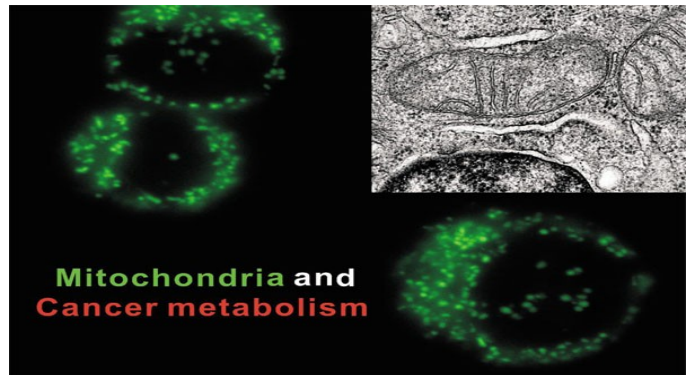
Dr. Seyfried has developed a process called metabolic control analysis, which essentially analyzes the metabolic flux through different pathways that occurs when you transition your body from one major fuel source to another major fuel source, to maintain energy homeostasis in your body. Many believe or are under the impression that cancer is primarily a genetic disease, but Dr. Seyfried dispels such notions.

“We’re not going to make major advances in the management of cancer until it becomes recognized as a metabolic disease. But in order to do that, you have to present a massive counterargument against the gene theory of cancer,” he says.

“One of the key issues here is that if you transplant

the nucleus of a cancer cell into a normal cell, you don’t get cancer cells. You can actually get normal tissues and sometimes a whole normal organism from the nucleus of a cancer cell. Now, if the tumors are being driven by driver genes – all these kinds of mutations and things that we hear about – how is it possible that all of this is changed when you place this cancer nucleus into the cytoplasm of a cell with normal mitochondria?

The gene theory cannot address this. It clearly argues strongly against the concept that genes are driving this process. Actually, a very few people inherit genes that predispose them to cancer. Most people inherit genes that prevent cancer. And those few genes that are inherited – the germ line like the BRCA1 mutations, B53, and a few other very rare cancers – these inherited mutations appear to disrupt the function of the mitochondria.”



According to Dr. Seyfried, the mitochondria—the main power generators in your cells—are the central point in the origin of most cancers. Your mitochondria can be damaged not only by inherited mutations, thereby increasing your risk for a particular type of cancer, such as the [BRCA1 and BRCA2](#) mutations that increase your risk of breast and ovarian cancer. They can also be damaged by environmental factors, such as toxins and radiation, both [ionizing](#) and [non-ionizing](#). Over time, damage to your mitochondria can lead to dysfunction and tumor formation.

“It’s ultimately a disease of the mitochondrial energy metabolism, which is the origin of the disease,” Dr. Seyfried says. “[O]nce the mitochondria become dysfunctional or insufficient in ability, mutations will occur. The drugs that have been developed based on the genome projects have been largely ineffective in

providing long-term care and are associated with toxic effects. As long as the field continues to focus on that part of the disease, which is a downstream epiphenomenon, there will be no major advances in the field simply because that's not the relevant aspect of the disease."

Sugar Is the Primary Fuel for Most Cancers

Controlling your blood-glucose leptin and insulin levels through diet, exercise and emotional stress relief can be one of the most crucial components to a cancer recovery program. These factors are also crucial in order to prevent cancer in the first place. In 1931, the Nobel Prize was awarded to German researcher Dr. Otto Warburg, who discovered that cancer cells have a fundamentally different energy metabolism compared to healthy cells, and that malignant tumors tend to feed on sugar. More recently, researchers discovered that while cancer cells feed on both glucose and fructose, [pancreatic tumor cells use fructose](#) specifically to divide and proliferate.

Dr. Seyfried's work confirms that sugar is the primary fuel for cancer, and that by restricting sugar and providing an alternate fuel, namely fat, you can dramatically reduce the rate of growth of cancer. He explains:



"When we're dealing with glucose and [cancer] management, we know from a large number of studies that if respiration of the tumor is ineffective, in order to survive, the cells must use an alternative source of energy, which is fermentation. We know that glucose is the primary fuel for fermentation. Fermentation becomes a primary energy-generating process in the tumor cell. By targeting the fuel for that process, we

then have the capability of potentially managing the disease."

The strategy Dr. Seyfried suggests is a low-carb, low to moderate protein, high-fat diet, which will effectively lower your blood sugar. This is an easily measurable parameter that you can check using a diabetic blood glucose meter. This type of diet, called a ketogenic diet, will also elevate ketone bodies, as fat is metabolized to ketones that your body can burn in the absence of food. When combined with calorie restriction, the end result will put your body in a metabolic state that is inhospitable to cancer cells.

"[Ketones] is a fat breakdown product that can replace glucose as a major fuel for many of the organs and especially our brain," he says.

Tumor cells, however, *cannot* use ketone bodies because of their respiratory insufficiency. So the ketogenic diet represents an elegant, non-toxic way to target and marginalize tumor cells. It also allows you to dramatically lower your glucose levels, as the ketones will protect your body against any hypoglycemia that might otherwise be induced by carb restriction.

"All of the newer cells in your body will be transitioned to these effective ketones, thereby preventing them from damage from hypoglycemia. At the same time, the tumor cells are now marginalized and under tremendous metabolic stress. It's a whole body therapy—you need to bring the whole body into this metabolic state," he explains.

"We like to call it a new state of metabolic homeostasis: a state where ketones have reached the steady state level in your blood and glucose has reached a steady lower level in your blood... If it's done right and implemented right, it has powerful therapeutic benefits on the majority of people who suffer from various kinds of cancers. Because all cancers have primarily the same metabolic defect."

For Cancer Protection, Reverse Your Glucose to Ketone Ratios

Dr. Seyfried uses ketones and glucose as the measures of this new metabolic state. The parameters associated with an ideal state are ketone levels equal to or higher

than the glucose level in your blood.

“There’s a high ratio of glucose to ketones. But in a fasted or therapeutic state, this ratio is actually reversed. Ketones can actually become higher than glucose,” he says. *“What they can do is they can get their blood sugars down to 2.5 to 3 millimolar [equivalent to about 55-65 mg/dl], and then their ketones to up to 3 or 4 millimolar, where the ratio is now reversed. It’s this state that now brings the body into this new physiology.”*

You can easily check your glucose levels at home, you’d need to work with a doctor to measure ketone levels in your blood. Generally speaking, a fasting glucose under 100 mg/dl suggests that you’re not insulin resistant, while a level between 100-125 suggests you’re either mildly insulin resistant or pre-diabetic. Here, Dr. Seyfried recommends getting your glucose down to a steady level of about 55-65 mg/dl, which is about HALF of what’s conventionally considered “good” or “normal.”

Blood ketones can be easily measured using the Medisense Precision Xtra blood glucose and ketone monitor from Abbot Laboratory. As many pharmacies might not stock the meter (bar code #, 93815 80347), it might be necessary to call Abbott directly (1-800-527 3339) to obtain the meter. According to Dr. Seyfried, the Precision Xtra seems the most accurate of all the ones he’s used.

It is important to mention, however, that the blood ketone strips are more expensive than the blood glucose strips. Dr. Seyfried therefore recommends measuring your blood ketones every few days rather than 3x/day for blood glucose. Although urine ketone measurement is a cheap way to assess ketones, urine ketone levels are not always indicative of blood ketone levels. It is best if you can measure ketones from both blood and urine.

“I work with nutritionists and physicians,” Dr. Seyfried says. *“The problem with cancer patients is that many of the practitioners are unfamiliar with this whole approach, so there’s this tremendous gap. We have knowledge of how to do this. We have patients willing to do it. But we lack professionals that are trained or even understand the concepts of how to implement these kinds of approaches.”*

All of the guidelines are included in Dr. Seyfried’s book, *Cancer as Metabolic Disease*, which is available on Amazon. He’s also published a couple of papers [1,2](#) that outline the guidelines and treatment strategies for cancer patients. One caveat to consider is your use of medications, as you need to know what the adverse effects might be if you use a medication at a particular dosage along with this kind of metabolic therapy.

The Importance of Intermittent Fasting

In my experience, the vast majority of people are adapted to burning carbs as their primary fuel, as opposed to burning fat. One of the most effective strategies I know of to become a fat burner is to restrict your eating to within a six- to eight-hour window, which means you’re fasting for about 16-18 hours each day. This upregulates the enzymes that are designed to burn fat as a fuel, and downregulates the glucose enzymes. This kind of [intermittent fasting plan](#) can be a useful modality to help you make the transition to a ketogenic diet.

“That’s the way it started in the clinic for children with epilepsy. Basically, the child is given a 24-hour and sometimes 48-hour fast – water only. And then the ketogenic diet is introduced in relatively measured and small amounts,” Dr. Seyfried says.

“Your body transitions naturally that way. Intermittent fasting is actually a very strong component of the approach. A three-day fast is uncomfortable, but it’s certainly doable. It gets your body into a new metabolic state, and then you can apply these therapies. The hardest part, I think, of this fasting is the first three to four days, depending on the individual and how many times they’ve done this.”



That's basically trying to break your addiction to glucose. The removal of glucose from the brain elicits the same kind of problems or events as you would if you were addicted to drugs, alcohol, or something like this. You get malaise, headaches, nausea, lightheadedness.

You get all the kinds of physiological effects that you would get from withdrawal of any addicting substance. I look at glucose as an addictive substance. It's an addictive metabolite. Your brain is comforted by having glucose; your body is comforted. And when you break that glucose addiction, you have these particular feelings.

... Fasting certainly has remarkable health benefits to the body: strengthening the mitochondria network system within the cells of your body. As long as the mitochondria of your cells remain healthy and functional, it's very unlikely that cancer can develop under these particular states."

Unless you have a very serious disease, I believe it is best for most people to implement intermittent fasting slowly over six to eight weeks rather than a three-day complete fast. You begin by not eating for three hours before you go to bed, and then gradually extend the time you eat breakfast until you have skipped breakfast entirely and your first meal of the day is at lunch time. Of course, you are only consuming non-starchy vegetables for carbs, low to moderate protein and high-quality fats. One of the things I've noticed is that once you've made the transition from burning carbs to burning fat as your primary fuel, the desire for junk foods and sugar just disappears like magic.

The Potential Role of Protein in Cancer Formation

Glutamine--one of the most common amino acids found in proteins—is another interesting aspect of cancer that Dr. Seyfried is still investigating. In his opinion, most oncologists who do cancer metabolism recognize that sugar (both glucose and fructose) is the prime fuel for driving tumor growth. However, mounting research also indicates that glucose and glutamine together act powerfully and synergistically on the growth of tumor cells.

"These two fuels work together in concert to provide a continual growth," he says.

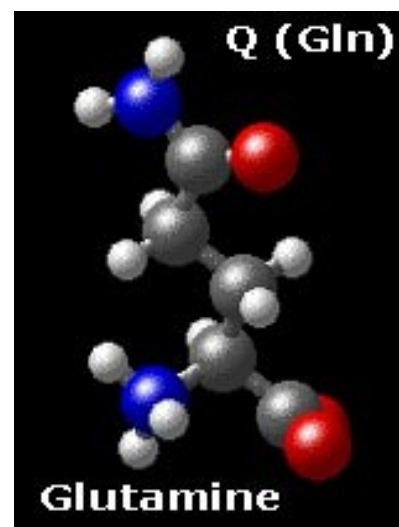
One of my early mentors was [Dr. Ron Rosedale](#). He taught me, about 20 years ago, about the importance of insulin control and then, more recently, about the importance of [reducing protein intake](#), for this very reason. Most Americans likely eat far more protein than they really need, and this excess could be a factor in cancer. The [Paleo](#) approach makes sense on many levels, especially with regards to intermittent fasting and lowering your glucose levels. The Paleo approach is very clear about reducing grains and any food that raises your blood sugar. But there are, of course, two other macronutrients left: fat and protein.

Many Paleo followers are overly concerned about getting high amounts of protein, which could increase your glutamine and branched chained amino acid levels, which in turn tend to activate mTOR. In some, that could be problematic.

According to Dr. Rosedale's research, the pathway known as the mammalian target of rapamycin (mTOR), is controlled by lowering your protein intake. This pathway may be another metabolic pathway that helps control and prevent cancer growth.

Calorie Restriction Is a Key Part of the Equation

Dr. Seyfried, however, is more cautious in his evaluation of mTOR and reducing protein for cancer prevention. In his view, the *most* important aspect of cancer prevention and treatment is the intermittent fasting, or overall calorie restriction, which includes eating less of *everything*, period. But while calories from carbohydrates should be virtually eliminated, calories from protein just need to be reduced, while most need to increase their intake of healthful fats to get a more ideal ratio of fat to protein. As far as the



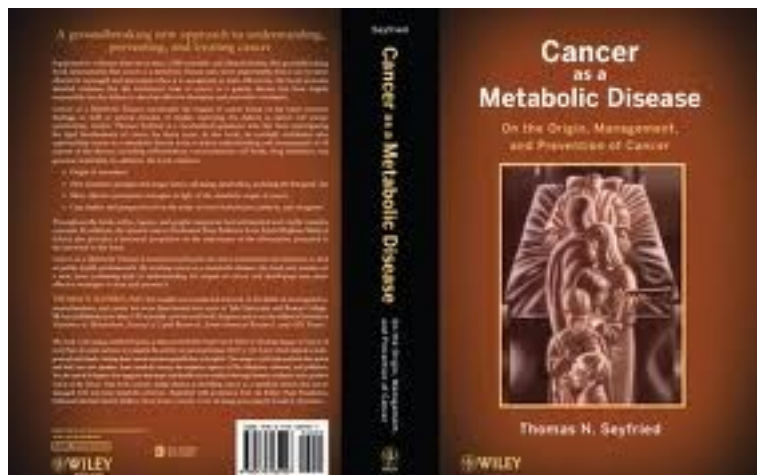
specific types of fats recommended, Dr. Seyfried uses medium-chain triglycerides, i.e. coconut oil, butter, macadamia nuts, and other types of saturated fats, which is what I've long recommended as well. *"The saturated fats are converted to ketones much more readily than polyunsaturated fats,"* he explains.

So, keep in mind that for cancer prevention and treatment, the actual calorie restriction is an important part of the equation:

"We did some studies on this with our model of glioma... The mTOR in our model was not dramatically changed by these metabolic therapies. But I know others have reported it, and this could be an important component for certain other kinds of cancers. But my limited work with this did not demonstrate this to be a major issue, at least in the glioma model that we looked at. We showed that you could give animals a high-fat, low-protein diet, as much as they want (zero carbs in this diet), and their blood glucose was just as high or higher than the mice that were eating the protein-carb diet.

It was more or less related to the total consumption of calories. Most calories boil down to glucose. Proteins will be metabolized to glucose. Carbs are metabolized to glucose; fats are not... We don't get any therapeutic benefit either in epilepsy or cancer when we allow the animals or people to eat as much of these high-fat diets as they want. We get no therapeutic benefit.

Therapeutic benefit comes from the restriction of the calories in the diet. The ketogenic diet or a low-carb, low-protein diet is simply a way to take the sting out of a therapeutic fast. Because as long as the glucose and ketones can get into the metabolic range (and you can do it with eating small amounts of a high-fat diet rather than therapeutic fasting), then that just makes people feel a little better about how they're doing this rather than feeling that I'm starving to death."



Hyperbaric Oxygen Therapy

I recently interviewed Dr. D'Agostino who is another cancer as a metabolic disease researcher. He published a recent paper³ that shows a phenomenal synergy with a ketogenic diet and the use of hyperbaric oxygen for cancers that have metastasized. These types of cancers are notoriously difficult to treat. I would strongly encourage anyone struggling with this challenge to consider this type of therapy.

More Information

From my perspective, it's nothing short of medical malpractice and negligence to fail to integrate this type of dietary strategy into a patient's cancer treatment plan (along with optimizing vitamin D). A ketogenic diet along with intermittent fasting can be easily integrated into whatever cancer treatment plan you decide to follow. Personally, I believe it's absolutely crucial, no matter what type of cancer you're trying to address.

That said, remember that a ketogenic diet, in which you replace carbs with low to moderate amounts of protein and high amounts of beneficial fat, like avocado, coconut oil, butter, olive oil and macadamia nuts is recommended for *everyone*, whether you have cancer or not. It's a diet that will help

optimize your weight and health overall, as eating this way will help you convert from carb burning mode, to fat burning.

To get more specifics about using a ketogenic diet and calorie restriction for the treatment of cancer, I highly recommend picking up Dr. Seyfried's book, *Cancer as a Metabolic Disease*. You can also review his papers,^{4,5} which outline the guidelines and treatment strategies for cancer patients. If you're a cancer patient, I'd recommend printing them out for your oncologist. He also has a [Facebook page](#)⁶ for his book, and a website connected to the Boston College.

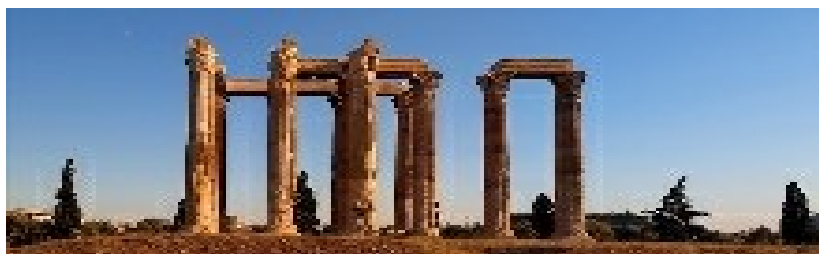
