The Christian Identity Objective

The collective thoughts of William Finck after having presented two spoken discussions on this very topic with Pastor Mark Downey, both of which are available for listening at Christogenea.

The hour is late, and all of the formerly Christian nations are overcome with the enemies of Christ. The dusk is far too advanced for Christians to be wasting precious time arguing over the place of beasts in the kingdom of God, when it should be obvious to all that after 500 years of trying to civilize and make Christians of them, there has been little but misery and failure, and they are still nothing but beasts. The negro takes the image of Christ, remodels it in its own image, and destroys everything it touches in His Name. The Oriental takes up the image of Christ, and adds it to his collection of mystical talismans, imagining that it is just one more tool in the arsenal of idols that will help him to gratify his lusts, along with shark fins and tiger penises. The Mexican takes up the image of Christ, but only as a child, and then worships the young virgin instead, yearning for the fulfillment of its own beastly impulses.

For a thousand years the Jew had tried to destroy Christendom from the outside, and had militarized both the African and Asian beasts against the West, but they failed to destroy it. So slowly the Jew crept into Christianity and undermined Christian institutions with anti-Christian ideas. And since they initially failed to flood Europe with the beasts, it was the Jew who convinced the popes to bring Europe to the beasts. So a universal doctrine which was at one time only universal to the civilized world, was transformed into a multiracial doctrine and the churches of Europe were prepared to accept the ideologies of the humanist revolutions, once they were convinced that they should humanize the beasts.

From this point Christianity was being offered along with bribes to the alien races, to have them behave in compliance with Christian expectations. When they refused to comply, it was often forced upon them. But these attempts to civilize the savages were not Christian at all. Rather, they were the workings of converso-Jews among the Jesuits and the imperialist popes, Jewish mercantile interests in Spain and Portugal which had soon relocated to Holland and England, and the later post-Reformation rulers of Europe who sought influence abroad in competition with the popes. Eventually, such religious imperialism disaffected most European Christians who have no affinity with the savages that the churches insisted upon taming.

The religious chaos which has resulted is due to the complete corruption of Judaized Christian churches with the satanic worship of the "universal brotherhood of man" characterized by the cries of the so-called French Revolution for liberty, equality and fraternity. The destruction of Christian institutions with satanic Jewish humanism over the last two hundred years has prepared Christendom for the onslaught it is now suffering. The devils deceived the west into exporting Christianity to the beasts, so that they could facilitate the objective of flooding all of Christendom with beasts.

The early Jewish instigation of pagan imperial Rome to persecute Christians, and then the Arab, Mongol and Turkic wars against the European nations after Europe had turned to Christ, are all parts of the same ongoing agenda to destroy Christianity, orchestrated by the same satanic Jew. It is described quite succinctly in Revelation chapter 12: "And the serpent cast out of his mouth water as a flood after the woman, that he might cause her to be carried away of the flood." Now its culmination is evident today, and that is also described in Revelation chapter 20, where we read that: "Satan ... shall go out to deceive the nations which are in the four quarters of the earth, Gog and Magog, to gather them together to battle: the number of whom *is* as the sand of the sea. And they went up on the breadth of the earth, and compassed the camp of the saints about..."

And this is where Christendom is today. The camp of the saints is not only surrounded, but it is being overrun, as a parallel description in Ezekiel chapters 38 and 39 also portrays. However rather than discuss the outcome, we will instead discuss how Christians who are not Judaized should perhaps react to the reality of the situation. Of course, we must remain under the assumption that professing Christians also accept what their Bibles say, and we shall continue under that assumption.

As Paul of Tarsus had stated several times, the promises of God can not be made of no effect. Making those statements, Paul did not refer to the "promises of Jesus", but rather to the "promises of God", meaning the promises attributed to the Old Testament God. To see them, one must read through the Old Testament. In a survey of those promises we see that one man's seed, or offspring, were to inherit the world, or the Adamic society of that time, and that they would become as the stars of heaven in multitude. From this point forward the descendants of that man who were deemed eligible to inherit these promises were, for various reasons, narrowed to one in particular: Jacob, from whom sprang the twelve tribes of Israel. As late as Acts chapter 26 Paul attests that the promises of Christ are for those same twelve tribes, and stated that the Jews were in opposition to them.

Now those who are inclined to Jewish egalitarianism may immediately object, citing one of the promises to Abraham where in Genesis chapter 12 it says that "in thee shall all families of the earth be blessed". However they neglect to consider that "all the families" who would be blessed could only be those Adamic families descended from Noah which had been described just a few verses earlier, in Genesis chapter 11. It can be proven historically, that all of these families were originally White, and that all modern Whites descended from these families, although most of them have since been destroyed, having become mixed with non-White races. No matter what one may think of the first 9 chapters of Genesis, the historical record from Genesis chapter 10 forward is quite clear.

Some may also object, that the flood of Noah covered the "whole earth", and therefore all people must have originated from the descendants of Noah, but that is not true. Just a few chapters after the descendants of Noah are listed in Genesis, we find the descendants of the giants, who are the Rephaim, and the descendants of Cain, who are the Kenites, as well as other tribes which did not descend from Noah, but which are alive and well in the time of Abraham, and listed in Genesis chapter 15. They survived the flood because they were not in the "whole earth" which the flood had destroyed. In Genesis chapter 4, Cain was driven "from the face of the earth" that was later destroyed in the flood, proving that he was elsewhere and that the flood did not cover the entire planet, but rather only the "whole earth" where the children of Seth had dwelt, the earth which Cain was driven away from.

So the promise to Abraham that "in thee shall all families of the earth be blessed" could only have pertained to those White families listed in Genesis chapter 10, and it was also secondary to the promises that Abraham's offspring would become many nations, and that they would inherit the earth. As Paul of

Tarsus had explained in Romans chapter 4, in 1 Corinthians chapter 10, and in Galatians chapters 3 and 4 and elsewhere, the White nations of Europe which arose after the time of Abraham are the children of Jacob-Israel and the heirs to those promises. The first objective of Christian Identity should be, of course, to confirm the identity of the heirs of those promises in the world today, and the destiny which is assured to those same people in Biblical prophecy.

As for the other, non-White races, their creation is not mentioned in the Bible, and there is no plan for their benefit ever mentioned in the Bible. We only see the promised destruction of all of those who come into contact with the children of Israel, first in the historical books of Scripture as the Israelites had invaded the land of Canaan, and then in the prophetic books of Scripture where the Israelites were being scattered abroad. For instance, in Jeremiah chapter 30 the Word of Yahweh God promises, in reference to the children of Israel, that He would "make a full end of all nations" where He had scattered them, but that He would not make an end of them, instead only correcting them in their punishment. This promise is repeated in Jeremiah chapter 46. The Scripture relates a similar message in Isaiah chapter 41 where it says to the scattered children of Israel: "11 Behold, all they that were incensed against thee shall be ashamed and confounded: they shall be as nothing; and they that strive with thee shall perish. 12 Thou shalt seek them, and shalt not find them, *even* them that contended with thee: they that war against thee shall be as nothing, and as a thing of nought."

As the apostle John had written to those having the promise of salvation: "we know that we are of God, and the whole world lieth in wickedness." In the entire scripture, all of the promises of salvation are for the children of Israel, and there are no promises of salvation for any of the other so-called races. Honest theology is the study of the covenants and promises of God, and it may be referred to Covenant Theology, which is the only valid theology since the promises of God cannot be "made of none effect". Unless, of course, one worships an entirely different god than Yahweh, the God of the Scriptures. In essence, Christian Identity is Covenant Theology identifying the parties to those covenants and promises in Scripture and in History, so it is the study of the fulfillment of Covenant Theology.

Since there is no plan for the other, non-White races in the Bible, to attempt to include them in the plan, or to imagine and create a plan for them, is to pretentiously add to the Word of God. Everything that God created is good, as it is described in Genesis chapters 1 and 2. But if the other races are not mentioned in those chapters, how can men imagine them to be good as well? In the parables and sayings of Christ found in the Gospel, there are good kinds and bad kinds, sheep which are preserved and goats which are destroyed, grapes and thorns, figs and thistles, wheat planted by Him and tares planted by the devil.

Are there people who were planted by the devil? What we are not told in Genesis, we are told in the Revelation of Jesus Christ. As Christ Himself had told us, He came to "utter things which have been kept secret from the foundation of the world." In the Revelation, in chapter 12, we read: "9 And the great dragon was cast out, that old serpent, called the Devil, and Satan, which deceiveth the whole world: he was cast out into the earth, and his angels were cast out with him." That old serpent is that old serpent of Genesis chapter 3, who was a representative of the Tree of the Knowledge of Good and Evil which the Adamic man was not ever supposed to touch. But he did, and in his punishment when he planted his seed, thorns and thistles would spring up. These are the thorns and thistles which Christ warned against, from which men would gather neither grapes nor figs. Christ had also described these as the tares among the wheat, because the sons of Adam and the later children of Israel had accepted those branches of the Tree of the Knowledge of Good and Evil, producing those thorns and thistles. Therefore the later children of Israel were told that because they did not exterminate them, they would be thorns and pricks to them, in their eyes and in their sides.

The only illustration in Scripture which explains the origin of the non-Adamic races is Revelation chapter 12 and the early presence of the Tree of the Knowledge of Good and Evil, as opposed to the Tree of Life, which was already present in the Garden of God when Adam was created. This is how, as it is described in Revelation chapter 12, the serpent had the ability to cast a flood from its mouth for which to pursue the woman, because that flood is from that evil tree associated with the serpent in Genesis. So the apostle Peter speaks of the interlopers amongst the Adamic children of Israel, those spots in their feasts of charity, and calls them "natural brute beasts made to be taken and destroyed", and referring to those same wicked men Jude likewise calls them "trees whose fruit withereth, without fruit, twice dead, plucked up by the roots..."

Many of the Judaized egalitarians who call themselves Identity Christians have accepted the old British Israel concept of Dominion Theology. This is a theology developed to promote imperialism, first put into practice by the Roman Catholic Church under the guidance of the Jesuits, but later adopted and adapted by British Israel believers to support the legitimacy of the structure of the British Empire. When the empire collapsed, it became evident that the British did not have a mandate to rule over the other races, and British Israel became a laughingstock, wholly discredited. Today it is even more so discredited because the other races, which were formerly subjects, are now running roughshod over Britain, and British Israel adherents have no sufficient answer for that development.

How is Christian Identity relevant in today's society? How can we help to steer Christian Identity down a path which is useful to our nation and race in these last days? By telling the truth about race, because the promises of God are for only one particular race, and because the promises of destruction are for all other races. If we do not face the entire truth concerning the issue of race, we cannot all "attain to the unity of the faith" to which Paul beckons us in Ephesians. But rather, we shall continue "being tossed as waves and carried about in every wind of teaching by the trickery of men, in villainy for the sake of the systematizing of deception", as he had also described in that very epistle. But if we believe that Christian Identity is true, then we must by obligation provide the solid foundation for which to survive the trials that all of what was formerly known as Christendom now faces, or we fail in our mission for Christ. However in the end Christ shall succeed, with or without us. So where do we want to be?

Quoting from our recent presentation of the Epistle to the Ephesians, and somewhat edited:

Paul had told the Galatians, who were indeed a portion of the descendants of the Israelites that had been taken into captivity by the Assyrians eight centuries before that epistle was written, that "God sent forth his Son, made of a woman, made under the law, to redeem them that were under the law", and all Israelites were at one time under the law of Yahweh their God. But because of their sins they were subject to judgment under that law after they had been alienated from God. However, in the Divine mercy which Yahweh had promised to the children of Israel, Paul also told them "24 Wherefore the law was our schoolmaster to bring us unto Christ, that we might be justified by faith. 25 But after that faith is come, we are no longer under a schoolmaster." Once the true faith of the Gospel is accepted, one is no longer an infant. Once the true faith of the Gospel is accepted, one no longer needs a schoolmaster, but should gladly endeavor to keep the commandments of God, as Christ Himself had said, "If you love Me, keep My commandments."

The last commandment which Christ had given was that Christians must love one another, and they cannot do that while trying to love other races, for whom Christ had not come. He not gathering with Christ is a scatterer. Men should not attempt to gather grapes from thorns, or figs from thistles.

Once the true faith of the Gospel is accepted, it must be realized that the common bond of unity in the faith begins with the fact that the faith is only for those of the seed of Abraham through Jacob Israel, which is consistent with the words of the apostles and the prophets. As he described this very thing, Paul had said in Ephesians chapter 2 that the Body of Christ was founded upon the apostles and the prophets. Anything contrary to the Word of God in the promises to Abraham and the words of the prophets does not belong to the Gospel, but rather it belongs to the system of deception created by the enemies of God which is also spoken of by Paul in that epistle.

Reading the words of the apostles together with the prophets the Word of God presents a clear narrative focused on a particular family, beginning with the promises to Abraham that his seed would become many nations, and that they would inherit the earth. Examining that narrative, if we observe the words of the apostles and prophets then we must accept that the people who are the called in Christ were those whom the Old Testament informs us would be called, and that the saints are those whom the Old Testament informs us are saints. So Paul refers to the "family of the faith" as the "household of the mystery", because up until Paul's time it was a mystery as to how those promises to Abraham were kept, and that was the mystery which Paul was commissioned to reveal. Therefore Paul had professed concerning this same faith, in Romans chapter 4, that the promise was indeed certain to all of the seed, meaning all of the people who descended from Abraham through Jacob Israel, as Paul explains in another way in Galatians chapter 3.

The prophet Daniel promises us that "the kingdom shall not be left to other people", meaning to anyone other than the children of Israel. Therefore the Kingdom of God is meant for none but the children of Israel. Who should attempt to give it to other people? That man is a serpent and an adversary to God.

The Judaized egalitarians within Christian Identity would make the claim that the children of Israel are to convey the law to the other races, thereby being God's "servant race". In truth, Yahweh had indeed called the children of Israel His servants, and they were His servants in order that they establish His Kingdom. However nowhere in Scripture is it written that His Kingdom would include the alien, non-Adamic races. In fact, they were never supposed to receive the law, and not even the other Adamic nations were given the law, as it says in Psalm 147: "19 He sheweth his word unto Jacob, his statutes and his judgments unto Israel. 20 He hath not dealt so with any nation: and *as for his* judgments, they have not known them. Praise ye the LORD." There in that Psalm, we see the Psalmist praise Yahweh God for not giving the other nations His law. So the egalitarians within Christian Identity are little more than "Social Justice Warriors" attempting to rip the bread out of the hands of the children, casting it to the floor and calling it "crumbs".

The laws of God commanded Israel to be a separate people, as we read in the words of Solomon in 1 Kings chapter 8: "For thou didst separate them from among all the people of the earth, *to be* thine inheritance, as thou spakest by the hand of Moses thy servant, when thou broughtest our fathers out of Egypt, O Lord GOD." This commission has not changed, as Peter had likewise told his Christian audience that "ye *are* a chosen generation, a royal priesthood, an holy nation, a peculiar people", and the proof that he was writing to the anciently dispersed children of Israel is found in the verse which follows where he cited a passage from Hosea that can only concern the anciently dispersed Israelites: "Which in time past *were* not a people, but *are* now the people of God: which had not obtained mercy, but now have obtained mercy." These things were specifically prophesied of Israel in Hosea chapter 1, using that same language.

So how can the children of Israel teach the other so-called races the law while being a separate people? The two ideas cannot agree, and therefore one of them is false. In Genesis, the sons of Noah are told that "the fear of you and the dread of you shall be upon every beast of the earth," and likewise the children of Israel were told, as it is in Joshua chapter 23, that "One man of you shall chase a thousand: for the LORD your God, he *it is* that fighteth for you, as he hath promised you." In respect to this, Paul of Tarsus had written in his epistle to the Hebrews that by faith the ancient children of Israel had "subdued kingdoms, wrought righteousness, obtained promises, stopped the mouths of lions, quenched the violence of fire, escaped the edge of the sword, out of weakness were made strong, waxed valiant in fight, turned to flight the armies of the aliens." If turning the armies of aliens to flight was no longer relevant in Christ, why would Paul even mention it as a feat performed out of faith? And if it was a feat performed out of faith back then, Paul himself offers it as an example for Christians today.

If King David was a type for Christ as King, as so many of the prophets admit, then we have Psalm 118 as our example in this same regard, where it says: "7 The LORD taketh my part with them that help me: therefore shall I see *my desire* upon them that hate me. 8 *It is* better to trust in the LORD than to put confidence in man. 9 *It is* better to trust in the LORD than to put confidence in princes. 10 All nations compassed me about: but in the name of the LORD will I destroy them. 11 They compassed me about; yea, they compassed me about: but in the name of the LORD I will destroy them. 12 They compassed me about like bees; they are quenched as the fire of thorns: for in the name of the LORD I will destroy them. 13 Thou hast thrust sore at me that I might fall: but the LORD helped me. 14 The LORD *is* my strength and song, and is become my salvation."

As the camp of the saints is surrounded by the enemies of Christ, as the children of Israel are trodden down by all of those nations which Satan has gathered against them, this is the only salvation which the children of Israel can expect, as it says also in Luke chapter 1 that His purpose is "that we should be saved from our enemies, and from the hand of all that hate us; to perform the mercy *promised* to our fathers, and to remember his holy covenant". This message is the Elijah message which Christ had said shall come before the coming of the Son of Man, which is described in Malachi chapter 4 where it is said that "he shall turn the heart of the fathers to the children, and the heart of the children to their fathers". This is the only way that the Christian Identity message can be relevant in today's corrupted society.

Any other message regarding race actually accepts the false doctrines of Jewish egalitarianism, and to be accepting of the flood which has come forth from the mouth of the serpent: which is the presence of so many racial aliens throughout the nations once called Christendom. Any other message is to be lukewarm, where Christ had said in the Revelation, in chapter 3: "I know thy works, that thou art neither cold nor hot: I would thou were cold or hot. So then because thou art lukewarm, and neither cold nor hot, I will spue thee out of my mouth." Being lukewarm is to compromise, and Scripture does not compromise.

We who can articulate an understanding of Covenant Theology have an obligation imposed upon us by our understanding: we must help to prepare our race for the wedding supper of the Lamb. But we must also know and acknowledge that all of those who are not a party to Israel the bride shall be dinner for the beasts and the fowls of heaven, as it is described in Revelation chapter 19. As the Word of Yahweh our God promises in Obadiah 16, they shall be as though they had not been. This is not only the proper Christian Identity objective, but it is also the true Christian obligation.

Christian Expectations

Christogenea Saturdays radio, March 12th, 2016

onight we are going to present some Bible basics, and concerning this, all Identity Christians should be on the same page. However sadly, many are not. Tonight is going to be an evening where I repeat myself often, because I hope to present several different chapters from the scriptures which also repeat the same things. They can be summarized like this: that we as a people, the formerly Christian nations, are being tried by the enemies of our God, who has permitted this for our sins which He long ago had foreseen, and there is only one way out of this trial, and that is by the same path that has long ago been spelled out in Scripture. Should we really think that we can change things for the better with an election? The Scriptures tell us no such thing, and, in fact, indicate quite the opposite. We are never going to vote ourselves out of our current predicament, and the longer we try the worse it will get.

In our last few programs here, we presented Adolf Hitler's final speech, where he had summarized some of the reasons why Germany was forced to war in 1939, and we hope to have explained that the cause of National Socialist Germany is the same cause which Identity Christians also have. Hitler's war should therefore be our war, in spite of the fact that our fathers fought on the wrong side of it, and many of our people still do. We also presented Joseph Goebbels' last speech, intending to show that even if Germany had no hope to win, Goebbels' remained hopeful, and maintained to the end the conviction

that God and justice would indeed prevail over Satan, the international Jew.

Last night, presenting the latter part of chapter 2 of Paul's epistle to the Colossians, we discussed the observation that so many Identity Christians are correctly persuaded that we should endeavor to follow the laws of Yahweh our God, but then on the other hand they often also intermingle a lot of the concepts of right and wrong from the greater society, or from their own personal judgment of things transpiring in society, whether good or bad. So they are really not following Yahweh's law in the degree to which they may imagine. The laws of Yahweh our God are not merely for personal governance, nor are they only for church. Rather, the Biblical law outlines the plan for governance of the coming Kingdom of Heaven, and Christians should seek to live by it and establish it now. As Christ had said "If you love Me, keep My commandments."

Recently, we also had done a program entitled <u>The Kingdom of Heaven</u>, or the Elections of Men? Some of our listeners did not fully appreciate this program, as some strong positions were stated concerning Christianity and national politics, and especially the current political drama unfolding here in America, assuming that Donald Trump continues to lead in the voting for the Republican party Presidential nomination. Back to the Goebbels program. While attempting to express the faith which Joseph Goebbels had that ultimately, justice would prevail in world events even if Germany lost the war, we stated

that Identity Christians should indeed have that same hope, and with even more certainty. In regard to this we quoted the apostle Peter, from his second epistle where he said that "We have also a more sure word of prophecy; whereunto ye do well that ye take heed, as unto a light that shineth in a dark place, until the day dawn, and the day star arise in your hearts."

Tonight, we shall commence with our discussion from that very point, and therefore this program is titled *Christian Expectations*.

If there is no God, then none of this matters. I do not matter, you do not matter, your listening to this is vain, and as the sinners are portrayed in Isaiah: "let us eat and drink; for to morrow we shall die." But if there is a God, He shall not be mocked, and in the end, His Creation shall indeed be preserved. Our only question is, just how it shall be preserved. Of course, all Identity Christians are fully confident that there is indeed a God, and therefore justice shall ultimately prevail.

As we have often professed over the course of the hundreds of presentations of the Scripture which have been offered here, the Biblical prophecies do not exist so that we can see the future. But rather, they exist so that when they have been fulfilled, reading the prophets it may be revealed to us that God is true and His Word is certain. But once we properly identify the parties of Scripture, the children of God and the children of the devil, and the prophecies which have thus far been clearly fulfilled, we can have a certain expectation of what is to come.



Writing in the middle of the second century, Irenaeus, the early Christian bishop of Lugdunum in Gaul, had said in chapter 26 of Book 5 of his voluminous work *Against Heresies* that, as the chapter summary goes, "John and Daniel have predicted the dissolution and desolation of the

Roman Empire, which shall precede the end of the world and the Eternal Kingdom of Christ". Looking back, we can see that Irenaeus understood the prophecies of John, probably referring to Revelation chapters 4 through 6, and Daniel, probably referring to Daniel chapter 2, and perhaps chapter 7, very well in this regard. And not only that, but he professed that understanding three hundred years before Rome actually fell, at a time when Rome was at the very near height of its power. Except for the Word of God, no man in his right mind could have predicted the end of the mighty Romans Empire at the time that Irenaeus was writing these things in his interpretation of Daniel and John. And while Irenaeus did not live to see it. he certainly had a sound Christian expectation of what was to come. We also, can have this same expectation.

But before we know what to expect, we must know

where we now stand. It takes many years of the study of history and Biblical prophecy to arrive at any serious conclusions in this regard, which is far beyond what we are able to do here for a single presentation. We already have a series of discussions of which the purpose was to exhibit our own studies in those areas, and a book which expresses the result, which we called Christreich. All we can say here, is that while Irenaeus

certainly saw the fall of Rome in Daniel and the Revelation, he did not very well see what was to follow after, which we can better see from our perspective. Taking Irenaeus' perspective and looking back, we can meet him at that point in his interpretation where he had been correct in his assessment of prophecy.

So interpreting Daniel chapters 2, 7 and 8, and Revelation chapters 7 through 17, after the fall of Rome we see the rise to world dominance of the nations of the Germanic people, and the 1,260 years of the supremacy of John's second beast described in Revelation chapter 13, which is evidently the papacy of Rome. Concurrently, we see in Revelation chapter

12 that the woman was nourished with the Gospel for 1,260 years, after which the serpent would send out a flood to drown the woman. Ostensibly, this is the same flood described in Revelation chapter 20 as the armies from the four quarters of the earth which Satan would gather against the camp of the saints.

In Revelation chapter 17 there appears a great whore, and we can identify the whore as the collective children of Israel who had previously been described as the woman of Revelation chapter 12. Then we see a depiction of the great beast that she is joined to, and something happened in the late Middle Ages whereby the woman became a whore and the kingdoms of Christendom were turned over to a system controlled by a beast. This we can see as Global Capitalism, of which Global Communism is a fully-owned subsidiary, and it belongs to Satan: the international Jew. In that chapter we see a description of seven kings, which are the seven previous Adamic world empires, and an eighth which is of the seven, which is is controlled by world Jewry and the beast of Revelation chapter 17. And at the end of Revelation chapter 17 we read, in part, of horns of the beast which hate the woman and it says of those horns: "17 For God hath put in their hearts to fulfil his will, and to agree, and give their kingdom unto the beast, until the words of God shall be fulfilled." So in Revelation chapter 18, the global system of governance and commerce which is put into place by the beast is called Mystery Babylon, and this is where we stand today.

Collectively, the children of Israel are represented in the Revelation at first as a woman, and then as a whore, because she had joined herself to this beast. Ostensibly, that joining was done voluntarily, and we have seen this unfold before our own eyes over these last couple of centuries. For this reason it is the woman who wears the name of this beast, "Mystery Babylon the Great, the Mother of Harlots and Abominations of the Earth." And while the Kingdoms of Christendom are in the hands of the beast to which the woman had joined herself, we have an assurance, found in Daniel chapter 7, "27 And the kingdom and dominion, and the greatness of the kingdom under the whole heaven, shall be given to the people of the saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve and obey him. 28 Hitherto is

the end of the matter. As for me Daniel, my cogitations much troubled me, and my countenance changed in me: but I kept the matter in my heart." This corresponds with Daniel chapter 2, where it speaks of the Germanic tribes which had destroyed Irenaeus' Rome, and it says: "44 And in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed: and the kingdom shall not be left to other people, *but* it shall break in pieces and consume all these kingdoms, and it shall stand for ever."



Revelation chapter 17 depicts a woman joined to a beast, the ten horns which belong to the beast, the hatred which the ten horns have for the woman, and the attempt by those horns to destroy the woman, where it says: "And the ten horns which thou sawest upon the beast, these shall hate the whore, and shall make her desolate and naked, and shall eat her flesh, and burn her with fire." Evidently, the way that the beast accomplishes this is through that same flood from the mouth of the serpent which is meant to persecute the woman, which are the nations from the four quarters of the earth that Satan gathers against the camp of the saints.

We belabor these things for a signal reason: because all of these poetically written visions so perfectly describe the condition of our White race as it is today. Therefore, how sure a word of prophecy do we need before we are convinced, that if all of these words of our God have unfolded so precisely, that the rest will also unfold precisely. So we should seek to stand with our God, as it is also described, speaking of those same ten horns of Revelation 17, that "These shall make war with the Lamb, and the Lamb shall overcome them: for he is Lord of lords, and King of kings: and they that are with him *are* called, and chosen, and faithful."

The Revelation represents a series of visions which do not necessarily follow one another chronologically, however there is a general chronological progression, and then every so often there is a summary vision. Again, we would need a long explanation to prove this, and we have already presented that in Christreich. Summary visions in the Revelation are given in chapter 13, and again in chapter 20, where in part we read: "7 And when the thousand years are expired, Satan shall be loosed out of his prison, 8 And shall go out to deceive the nations which are in the four quarters of the earth, Gog and Magog, to gather them together to battle: the number of whom is as the sand of the sea. 9 And they went up on the breadth of the earth, and compassed the camp of the saints about, and the beloved city: and fire came down from God out of heaven, and devoured them. 10 And the devil that deceived them was cast into the lake of fire and brimstone, where the beast and the false prophet are, and shall be tormented day and night for ever and ever."

We would assert that this vision represents the most recent stage of world history, where Satan, the Jew, was emancipated from the ghettos of Europe, and has now deceived the whole world. No doubt, it is the



same Jew who is gathering the nations against the White race as we speak.

But there is a much longer version of this same prophecy found in Ezekiel chapter 38, and, after the manner of the Hebrew literary technique called *parallelism*, another version in Ezekiel chapter 39. First, note this: Ezekiel's prophecy

is only timed with phrases such as "after many days", but the same language is repeated in Revelation chapter 20, so we are confident that this vision is for the present time. It was given while Ezekiel was in the Assyrian captivity of Israel, which we know because that is what the prophet told us in the opening of his prophecy, and it has not been fulfilled until now, except that it is absolutely manifest that at present it is beginning its fulfillment, once the parties of Scripture are properly identified.

Ezekiel 38: 1 And the word of the LORD came unto me, saying, 2 Son of man, set thy face against Gog, the land of Magog, the chief prince of Meshech and Tubal, and prophesy against him, 3 And say, Thus saith the Lord GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: 4 And I will turn thee back, and put hooks into thy jaws, and I will bring thee forth, and all thine army, horses and horsemen, all of them clothed with all sorts of armour, even a great company with bucklers and shields, all of them handling swords: 5 Persia, Ethiopia, and Libya with them; all of them with shield and helmet: 6 Gomer, and all his bands; the house of Togarmah of the north quarters, and all his bands: and many people with thee. 7 Be thou prepared, and prepare for thyself, thou, and all thy company that are assembled unto thee, and be thou a guard unto them. 8 After many days thou shalt be visited: in the latter years thou shalt come into the land that is brought back from the sword, and is gathered out of many people, against the mountains of Israel, which have been always waste: but it is brought forth out of the nations, and they shall dwell safely all of them. 9 Thou shalt ascend and come like a storm, thou shalt be like a cloud to cover the land, thou, and all thy bands, and many people with thee. 10 Thus saith the Lord GOD; It shall also come to pass, that at the same time shall things come into thy mind, and thou shalt think an evil thought: 11 And thou shalt say, I will go up to the land of unwalled villages; I will go to them that are at rest, that dwell safely, all of them dwelling without walls, and having neither bars nor gates, 12 To take a spoil, and to take a prey; to turn thine hand upon the desolate places that are now inhabited, and upon the people that are gathered out of the nations, which have gotten cattle and goods, that dwell in the midst of the land. 13 Sheba, and Dedan, and the merchants of Tarshish, with all the young lions thereof, shall say unto thee, Art thou come to take a spoil? hast thou gathered thy company to take a prey? to carry away silver and gold, to take away cattle and goods, to take a great spoil? 14 Therefore, son of man, prophesy and say unto Gog, Thus saith the Lord GOD; In that day when my people of Israel dwelleth safely, shalt thou not know it? 15 And thou shalt come from thy place out of the north parts, thou, and many people with thee, all of them riding upon horses, a great company, and a mighty army: 16 And thou shalt come up

against my people of Israel, as a cloud to cover the land; it shall be in the latter days, and I will bring thee against my land, that the nations may know me, when I shall be sanctified in thee, O Gog, before their eyes. 17 Thus saith the Lord GOD; Art thou he of whom I have spoken in old time by my servants the prophets of Israel, which prophesied in those days *many* years that I would bring thee against them? 18 And it shall come to pass at the same time when Gog shall come against the land of Israel, saith the Lord GOD, that my fury shall come up in my face. 19 For in my jealousy *and* in the fire of my wrath have I spoken, Surely in that day there shall be a great shaking in the land of Israel; 20 So that the fishes of the sea, and the fowls of the heaven, and the beasts of the field, and all creeping things that creep upon the earth, and all the men that are upon the face of the earth, shall shake at my presence, and the mountains shall be thrown down, and the steep places shall fall, and every wall shall fall to the ground. 21 And I will call for a sword against him throughout all my mountains, saith the Lord GOD: every man's sword shall be against his brother. 22 And I will plead against him with pestilence and with blood; and I will rain upon him, and upon his bands, and upon the many people that are with him, an overflowing rain, and great hailstones, fire, and brimstone. 23 Thus will I magnify myself, and sanctify myself; and I will be known in the eyes of many nations, and they shall know that I am the LORD.

Ezekiel 39:1 Therefore, thou son of man, prophesy against Gog, and say, Thus saith the Lord GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: [Now, there is contention over the translation of verse 2, which the Geneva and King James translations have gotten very wrong. Here we will supply it from the New American Standard Bible, which agrees also with the Greek Septuagint and Luther's Bible: 2 and I shall turn you around, drive you on, take you up from the remotest parts of the north, and bring you against the mountains of Israel.] 3 And I will smite thy bow out of thy left hand, and will cause thine arrows to fall out of thy right hand. 4 Thou shalt fall upon the mountains of Israel, thou, and all thy bands, and the people that is with thee: I will give thee unto the ravenous birds of every sort, and to the beasts of the field to be devoured. 5 Thou shalt fall upon the open

field: for I have spoken *it*, saith the Lord GOD. 6 And I will send a fire on Magog, and among them that dwell carelessly in the isles: and they shall know that I *am* the LORD.



7 So will I make my holy name known in the midst of my people Israel; and I will not *let them* pollute my holy name any more: and the nations shall know that I am the LORD, the Holy One in Israel. 8 Behold, it is come, and it is done, saith the Lord GOD; this is the day whereof I have spoken. 9 And they that dwell in the cities of Israel shall go forth, and shall set on fire and burn the weapons, both the shields and the bucklers, the bows and the arrows, and the handstaves, and the spears, and they shall burn them with fire seven years: 10 So that they shall take no wood out of the field, neither cut down any out of the forests; for they shall burn the weapons with fire: and they shall spoil those that spoiled them. and rob those that robbed them, saith the Lord GOD. 11 And it shall come to pass in that day, that I will give unto Gog a place there of graves in Israel, the valley of the passengers on the east of the sea: and it shall stop the *noses* of the passengers: and there shall they bury Gog and all his multitude: and they shall call it The valley of Hamongog. 12 And seven months shall the house of Israel be burying of them, that they may cleanse the land. 13 Yea, all the people of the land shall bury them; and it shall be to them a renown the day that I shall be glorified, saith the Lord GOD. 14 And they shall sever out men of continual employment, passing through the land to bury with the passengers those that remain upon the face of the earth, to cleanse it: after the end of seven months shall they search. 15 And the passengers that pass through the land, when any seeth a man's bone, then shall he set up a sign by it, till the buriers have buried it in the valley of Hamongog. 16 And also the

name of the city shall be Hamonah. Thus shall they cleanse the land. 17 And, thou son of man, thus saith the Lord GOD; Speak unto every feathered fowl, and to every beast of the field, Assemble yourselves, and come; gather yourselves on every side to my sacrifice that I do sacrifice for you, even a great sacrifice upon the mountains of Israel, that ye may eat flesh, and drink blood. 18 Ye shall eat the flesh of the mighty, and drink the blood of the princes of the earth, of rams, of lambs, and of goats, of bullocks, all of them fatlings of Bashan. 19 And ye shall eat fat till ye be full, and drink blood till ye be drunken, of my sacrifice which I have sacrificed for you. 20 Thus ye shall be filled at my table with horses and chariots, with mighty men, and with all men of war, saith the Lord GOD. 21 And I will set my glory among the nations, and all the nations shall see my judgment that I have executed, and my hand that I have laid upon them. 22 So the house of Israel shall know that I am the LORD their God from that day and forward. 23 And the nations shall know that the house of Israel went into captivity for their iniquity: because they trespassed against me, therefore hid I my face from them, and gave them into the hand of their enemies: so fell they all by the sword. 24 According to their uncleanness and according to their transgressions have I done unto them, and hid my face from them. 25 Therefore thus saith the Lord GOD; Now will I bring again the captivity of Jacob, and have mercy upon the whole house of Israel, and will be jealous for my holy name; 26 After that they have borne their shame, and all their trespasses whereby they have trespassed against me, when they dwelt safely in their land, and none made them afraid. 27 When I have brought them again from the people, and gathered them out of their enemies' lands, and am sanctified in them in the sight of many nations; 28 Then shall they know that I am the LORD their God, which caused them to be led into captivity among the nations: but I have gathered them unto their own land, and have left none of them any more there. 29 Neither will I hide my face any more from them: for I have poured out my spirit upon the house of Israel, saith the Lord GOD.

If we examine the language of Ezekiel chapter 39, and compare it to Revelation chapter 19, we see that the descriptions are in many ways identical. It then becomes evident, that the feast of sacrifice in Ezekiel 39 is indeed the Marriage Supper of the Lamb which

is described in Revelation chapter 19. But before discussing that, we shall discuss another parallel vision, found in Micah chapter 4:

Micah 4:1 But in the last days it shall come to pass, that the mountain of the house of the LORD shall be established in the top of the mountains, and it shall be exalted above the hills; and people shall flow unto it. 2 And many nations shall come, and say, Come, and let us go up to the mountain of the LORD, and to the house of the God of Jacob; and he will teach us of his ways, and we will walk in his paths: for the law shall go forth of Zion, and the word of the LORD from Jerusalem. 3 And he shall judge among many people, and rebuke strong nations afar off; and they shall beat their swords into plowshares, and their spears into pruninghooks: nation shall not lift up a sword against nation, neither shall they learn war any more. 4 But they shall sit every man under his vine and under his fig tree; and none shall make them afraid: for the mouth of the LORD of hosts hath spoken it. 5 For all people will walk every one in the name of his god, and we will walk in the name of the LORD our God for ever and ever. 6 In that day, saith the LORD, will I assemble her that halteth, and I will gather her that is driven out, and her that I have afflicted: 7 And I will make her that halted a remnant, and her that was cast far off a strong nation: and the LORD shall reign over them in mount Zion from henceforth, even for ever. 8 And thou, O tower of the flock, the strong hold of the daughter of Zion, unto thee shall it come, even the first dominion; the kingdom shall come to the daughter of Jerusalem. 9 Now why dost thou cry out aloud? is there no king in thee? is thy counsellor perished? for pangs have taken thee as a woman in travail. 10 Be in pain, and labour to bring forth, O daughter of Zion, like a woman in travail: for now shalt thou go forth out of the city, and thou shalt dwell in the field, and thou shalt go even to Babylon: there shalt thou be delivered; there the LORD shall redeem thee from the hand of thine enemies. 11 Now also many nations are gathered against thee, that say, Let her be defiled, and let our eye look upon Zion. 12 But they know not the thoughts of the LORD, neither understand they his counsel: for he shall gather them as the sheaves into the floor. 13 Arise and thresh, O daughter of Zion: for I will make thine horn iron, and I will make thy hoofs brass: and thou shalt beat in pieces many people: and I will consecrate their gain

unto the LORD, and their substance unto the Lord of the whole earth.

So there is a point where the daughter of Zion, the nations which were formed when the ancient children of Israel were cast out of Palestine by Yahweh their God, would be called to "arise and thresh" in response to those "many nations gathered against" her, who would defile her when pangs overtake her as a woman in travail. This same point is evident in another place, in Revelation chapter 18:

Revelation 18: 1 And after these things I saw another angel come down from heaven, having great power; and the earth was lightened with his glory. 2 And he cried mightily with a strong voice, saying, Babylon the great is fallen, is fallen, and is become the habitation of devils, and the hold of every foul spirit, and a cage of every unclean and hateful bird. 3 For all nations have drunk of the wine of the wrath of her fornication, and the kings of the earth have committed fornication with her, and the merchants of the earth are waxed rich through the abundance of her delicacies. 4 And I heard another voice from heaven, saying, Come out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues. 5 For her sins have reached unto heaven, and God hath remembered her iniquities. 6 Reward her even as she rewarded you, and double unto her double according to her works: in the cup which she hath filled fill to her double.

So after the fall of Mystery Babylon, the children of God are told to separate themselves, and to "reward her even as she rewarded you", and this must be that same call which we saw in Micah where it says "Arise and thresh, O daughter of Zion". In the balance of this chapter of the Revelation, we see a description of mourning by the kings and the merchants of the earth for their lost trade, and a description of the lost merchandise, and it concludes that "in her was found the blood of prophets, and of saints, and of all that were slain upon the earth." So we see the connection to World Jewry once again, as Christ had blamed the Jews of His Own time for these same crimes, in Luke chapter 11 where He said to them "that the blood of all the prophets spilled from the foundation of the Society should be required from this race, from the blood of Abel unto the blood of Zacharias who was killed between the

altar and the house. Yeah, I say to you, it shall be required from this race!"



This is the Christian expectation: to see this Global Capitalist system fail, and once it does, to be one of those who gets to do the threshing, to see the Jews who have tried to establish themselves as gods go up in flames once and for all. That should be the foremost hope in the heart of every Identity Christian. The description of the Marriage Supper of the Lamb parallels the visions of Ezekiel and Micah, where it also speaks of the aftermath of the fall of Mystery Babylon:

Revelation 19:1 And after these things I heard a great voice of much people in heaven, saying, Alleluia; Salvation, and glory, and honour, and power, unto the Lord our God: 2 For true and righteous are his judgments: for he hath judged the great whore, which did corrupt the earth with her fornication, and hath avenged the blood of his servants at her hand. 3 And again they said, Alleluia. And her smoke rose up for ever and ever. 4 And the four and twenty elders and the four beasts fell down and worshipped God that sat on the throne, saying, Amen; Alleluia. 5 And a voice came out of the throne, saying, Praise our God, all ye his servants, and ye that fear him, both small and great. 6 And I heard as it were the voice of a great multitude, and as the voice of many waters, and as the voice of mighty thunderings, saying, Alleluia: for the Lord God omnipotent reigneth. 7 Let us be glad and rejoice, and give honour to him: for the marriage of the Lamb is come, and his wife hath made herself ready. 8 And to her was granted that she should be arrayed in fine linen, clean and white: for the fine linen is the righteousness of saints. 9 And he saith unto me, Write, Blessed are they which are called unto the marriage supper of the Lamb. And he saith unto me,

These are the true sayings of God. 10 And I fell at his feet to worship him. And he said unto me, See thou do it not: I am thy fellowservant, and of thy brethren that have the testimony of Jesus: worship God: for the testimony of Jesus is the spirit of prophecy. 11 And I saw heaven opened, and behold a white horse; and he that sat upon him was called Faithful and True, and in righteousness he doth judge and make war. 12 His eyes were as a flame of fire, and on his head were many crowns; and he had a name written, that no man knew, but he himself. 13 And he was clothed with a vesture dipped in blood: and his name is called The Word of God. 14 And the armies which were in heaven followed him upon white horses, clothed in fine linen, white and clean. 15 And out of his mouth goeth a sharp sword, that with it he should smite the nations: and he shall rule them with a rod of iron: and he treadeth the winepress of the fierceness and wrath of Almighty God. 16 And he hath on his vesture and on his thigh a name written, KING OF KINGS, AND LORD OF LORDS. 17 And I saw an angel standing in the sun; and he cried with a loud voice, saving to all the fowls that fly in the midst of heaven, Come and gather yourselves together unto the supper of the great God;

18 That ye may eat the flesh of kings, and the flesh of captains, and the flesh of mighty men, and the flesh of horses, and of them that sit on them, and the flesh of all *men*, *both* free and bond, both small and



great. 19
And I saw

that sat on the horse, and against his army. 20 And the beast was taken, and with him the false prophet that wrought miracles before him, with which he deceived them that had received the mark of the beast, and them that worshipped his image. These both were cast alive into a lake of fire burning with brimstone. 21 And the remnant were slain with the sword of him that sat upon the horse, which *sword*

proceeded out of his mouth: and all the fowls were filled with their flesh.

At this point only do we see the fulfillment of what was written in Obadiah, "15 For the day of the LORD is near upon all the heathen: as thou hast done, it shall be done unto thee: thy reward shall return upon thine own head. 16 For as ye have drunk upon my holy mountain, so shall all the heathen drink continually, yea, they shall drink, and they shall swallow down, and they shall be as though they had not been. 17 But upon mount Zion shall be deliverance, and there shall be holiness; and the house of Jacob shall possess their possessions. 18 And the house of Jacob shall be a fire, and the house of Joseph a flame, and the house of Esau for stubble, and they shall kindle in them, and devour them; and there shall not be any remaining of the house of Esau; for the LORD hath spoken it."

Satan here is represented by the Edomite Jew, and all the heathen are all of those nations which Satan has gathered against the Camp of the Saints. In the end, as it is described in Ezekiel, the nations which see that the house of Israel was sanctified in the sight of Yahweh their God are those same Israelite nations, as there will be no others. As Obadiah informs us, they shall be as though they had not been. That is the purpose of the Marriage Supper of the Lamb, to fulfill the same promise which was made in Jeremiah: "11 For I *am* with thee, saith the LORD, to save thee: though I make a full end of all nations whither I have scattered thee, yet will I not make a full end of thee: but I will correct thee in measure, and will not leave thee altogether unpunished."

This is our Christian Expectation: we wait for Mystery Babylon to fall, we would help it along if we only could, and we hope that after it does, we are still around to help partake in the promised vengeance against the system, and against Satan and his minions, which are all of these non-White races currently flooding into the White nations. They are all coming here to die, and we hope to see the end of them.

But this will not happen with an election. Elections are not a promise of our Christian hope. If you put your hope in a man for salvation, you turn your back on God, and that can be likened to idolatry. Now, I would not go so far as to label someone an idolater

just for the act of voting, however if you vote because you hope a particular candidate is going to put the plan of God into effect, then you are also attesting a belief that God needs your help, or the help of a candidate, to fulfill His promises.

Every four years, well-meaning people think that they can help God, by promoting just the right Presidential candidate to "get us out of this mess". For the last couple of election cycles, it was Ron Paul, who was going to audit the Federal Reserve, as if that is actually a solution for anything. Does anyone really imagine that Mystery Babylon will fall because the Federal Reserve does not withstand the scrutiny of an audit? Who is going to do the auditing? Another Jewish-controlled accounting firm? And what can they audit when there is no standard for what there should be? The money is not real, only except that people are led to believe that it is real, which is also an element of the modern Baal religion.

Some people have posited the idea that Donald Trump might be the catalyst precipitating the fall of Babylon. But even if that is the case, we should be campaiging for Babylon's fall, rather than for Donald Trump, educating our people as to what is wrong with this system, and what we must do to be found on the right side of Justice in the end. Babylon is not going to fall with an audit, with a fence, with enforced green cards and immigration quotas, or with a renegotiation of NAFTA, or with any other trivial issue which may or may not be a part of any particular candidate's campaign promises. Babylon is sure as hell not going to fall with an election, and if Yahweh our God wanted a particular candidate to win, even the negroes would be voting for that candidate. So He would not need us. But only Yahweh is going to make Babylon fall, and Identity Christians have better be prepared for what to do when it does fall, or they too will suffer its punishments.

So here is the real issue: Do we campaign for Ron Paul? Do we campaign for Donald Trump? Or do we

campaign for Christ by informing our people of what is really going on? As Himself Christ had said, no man can serve two masters. No man can honestly serve competitive interests. Campaigning for Donald Trump, we neglect to take our God seriously, and we join in with all of the godless bastards and secular so-called white nationalists who have no faith in God, but would rather put their faith in a man like Donald Trump. Is that really where we should be found? Oh, Jesus ain't really coming, so I am going to hedge my bet with this Jew-loving casino owner, because he talks a good schtick? We cannot have that attitude and still take our faith seriously, and if we do not take our faith seriously, how can we ever expect to win over the hearts of our people?

Trump might be good comedy, but that is all he is. He might be a little better than Hillary Clinton, but

our feminized society deserves Hillary Clinton, the feminist hag. In the end, if Trump does win, he will leave White Nationalists looking either stupid or hopeless, and which one it is I cannot yet tell, but that



would also serve our God because without Him, we are stupid and hopeless.

Yahweh has promised, in 2 Chronicles chapter 7, that "14 If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land." So do we think a Presidential candidate will solve for us the Jewish question? No, only fire come down from heaven will do that. How about the negro problem? The Mestizo problem? No, only repentance and an appeal to Yahweh our God can solve those, and once we repent, perhaps He will pave the way to solving those problems and all others, but it won't be by election. We should be campaigning for one thing only: the truth of our God and His Christ.

Pictured above, Swedish women happily invite hundreds of thousands of so-called "refugees" to come and live with them, perhaps imagining that the "refugees" are nice people like themselves and share their civilized values. They seem to be absolutely impervious to the idea that the aliens are actually uncivilized, savage beasts intent upon destroying them and their culture and supplanting them in their own homes



So we see these images from Germany, taken shortly after that nation had allowed the entry of swarms of "refugees" this past winter. And indeed, they have come in swarms, the great majority of them being

men in their twenties through forties, looking for women and loot. Given the expectation of "benefits" upon reaching Europe, the hope of which they had received from the Jewish-controlled media, they have an entitlement mentality even before they cross the border, and their lusts for handouts and free sex from White women will never be satiated. When sensible women resist, they suffer brutal acts of violence at the hands of these lustful beasts. The beasts were given the impression that White European women would always be warm and welcoming, and more than willing to have sex with them.

But rather than protect Germans who complain, or who venture to stand up to these "rapefugees", the German police protect them and persecute their fellow countrymen instead. It took days for the German police to admit that 516 German women of all ages had reported being attacked, many of the attacks including unwanted sexual contact, from muslim men - and that was just on New Year's Eve in Cologne (as reported by the BBC). However even the use of the term, rapefugee, by Germans concerned for the safety of women in their native country invites harassment and arrest by police. As it has already happened in Britain and Scandinavia, police and other government agencies in Germany have also

become mercenary agents for the powers intent on destroying the European people. According to some sources, the leader of the Pegida movement in Germany is facing prosecution simply for wearing a t-shirt which contained the message "Rapefugees Not Welcome" (as reported by Breitbart.com).

So the frequency of rape has risen to epidemic proportions in <u>Sweden</u> and <u>Norway</u>, and Germany is next. Swedes are complaining that they cannot talk about the frequency of rapes there, where Islamic men, reportedly only 2% of the population, have committed 77% of the reported rapes (as reported by <u>frontpagemag.com</u>). In one particularly brutal case, a Swedish woman was recently gang-raped by Moslem Somalis while forced to the ground atop broken glass, as the Danish news website <u>10newsdk has recently reported</u>. The odds of a Swedish woman being raped during her lifetime is now one in four. The major news outlets generally ignore all of the pertinent reports, not wanting to present anything that would turn public opinion against immigration.

White Genocide: The Mass Rape and Murder of the European People

Introduction by Lasha Darkmoon

Europe is under sentence of death. The mass rape and murder of the indigenous population of Europe in their own homelands by the unstoppable hordes of the Third World is now perhaps inevitable. We in our ancestral homelands, clinging to what remains of our cherished heritage, need to prepare for a grim future of unparalleled sufferings.

Europe is dying, dying slowly.

There is no way Europe is going to survive the cataclysms ahead unless Europeans take drastic action, without delay, to reverse the menacing tide of mass immigration—if necessary by mass deportation of the invaders. It may one day be necessary, as has recently been suggested in a controversial French novel, to bomb the refugee ships and gun the invaders down on the beaches.

This is a scenario too chilling to contemplate. Heaven forbid it should ever come to this.

Whatever the outcome, we need to prepare for violence: violence by the indigenous protestors at the invasion of their homelands, violence by the conquering hordes who have come to settle these lands where they are *not* welcome, and violence by the police and the Orwellian police state as they do their best to crush the protestors and hand over our homelands to the invaders.

The conquest of Europe (and America) by these alien outsiders simply cannot be accomplished without bloodshed. Anyone who fails to see this has no concept of history; or the idea that history repeats itself. The same malignant forces that helped to unleash the French Revolution and the Russian Revolution—cataclysmic movements that swept away the remnants of the ancien regime and brought in new tyrants with uglier faces—is now planning another revolution to eclipse all the revolutions of the past: enforced mass immigration and multiculturalism with their inevitable consequences: White dispossession and mass mongrelization, leading eventually to White genocide.

Listen to the prophetic words of Enoch Powell. These were uttered in a memorable speech given in April 1968, almost 50 years ago: "We must be mad, literally mad, as a nation to be permitting the annual inflow of some 50,000 dependants, who are for the most part the material of the future growth of the immigrant descended population. It is like watching a nation busily engaged in heaping up its own funeral pyre.

As I look ahead, I am filled with foreboding. Like the Roman, I seem to see "the River Tiber foaming with much blood". That tragic and intractable phenomenon which we watch with horror on the other side of the Atlantic ... is coming upon us here by our own volition and our own neglect.

Only resolute and urgent action will avert it even now. Whether there will be the public will to demand and obtain that action, I do not know. All I know is that to see, and not to speak, would be the great betrayal."

The Camp of the Saints, 1973

Forty-two years ago, the great French author Jean Raspail wrote a deeply prescient novel. A flotilla of rusty ships packed with beggars sets sail from the Third World. They head for the French Riviera, where a million wretched, brown-skinned people hope to storm the beaches and feed on the wealthy white West. Will the French army fire on the invaders or welcome them as refugees? In the end they do neither; soldiers throw down their weapons and run away as the mob stumbles ashore. Millions more follow, and Europe is snuffed out.

The Camp of the Saints has never gone out of print, and has been translated into all major European languages—and yet the coverage of the European

"migrant" crisis goes on as if it had never been written. The masses pouring in from Syria, Afghanistan, Iraq, and a host of African countries are doing exactly what Raspail predicted.

LD: They are invading Europe in unprecedented numbers. And the Europeans, led by pathological altruists such as Angela Merkel—who is not only suspected in some quarters of having Jewish roots, but also of being mentally unbalanced—are doing nothing to keep out the incursive hordes. They are either wringing their hands impotently or displaying placards that proclaim: REFUGEES WELCOME! [LD]

The Camp of the Saints put the white man's dilemma in the harshest terms: slaughter hundreds of thousands of men, women, and children or face oblivion.

The flotilla sets sail confident that Europeans do not have the nerve to kill in order to survive. Today as well, the Third World is crossing the Mediterranean confident that whites don't have the nerve even to turn them back. Every vagabond who gets a bed in a reception center in Dortmund or Malmo tweets the good news to a hundred people back in Somalia and Syria.

They will come in endless waves until they are stopped, and if they are not stopped Europe will die, just as it does in *The Camp of the Saints*.

In 1951, the world population was 2.5 billion. It is now 7.3 billion, and the overwhelming bulk of the growth has been in those very countries that are so miserable that huge numbers of their citizens want to leave.

The supply of potential asylum seekers is essentially unlimited. Last year, the United Nations High Commissioner for Refugees (UNHCR) said there were more than 50 million displaced people around the world, of whom about 17 million were officially designated as "refugees".

LD: The interesting thing is that few other countries, apart from those in the EU, feel under any obligation to recognize these displaced persons as "refugees", nor are they under any legal constraints to offer them hospitality. China and India completely ignore any pressure to take in migrants. Their populations, at 1.3 billion and 1.2 billion respectively, are the largest in the world and they see no reason why they should add to those enormous numbers by taking in more mouths to feed. In 2014, Japan accepted only 11 out of 5,000 applications for asylum. Mexico, which sends the US millions of people, accepts even fewer. It now has a total of 1,677 refugees to Japan's 2,649. [LD]

Countries just do what they please, because the conventions have no enforcement mechanism. The only price for spurning refugees is accusations of heartlessness, and so long as a country isn't white, there isn't much of that.

News reports routinely talk about Syrians "fleeing war and turmoil in the Middle East," but it's not as though the Syrian civil war suddenly turned brutal, and shell-shocked families are fleeing war zones with only the clothes on their backs. Many have decided they are just tired of refugee camps—and the ones in Lebanon have cut back somewhat on handouts. Those coming straight from Syria just want a chance at Europe, too.

As one 35-year-old woman who brought two young children with her from Aleppo explained at the Hungarian border, "I decided to leave Syria because I want my kids to have a comfortable life, to study."

In any case, it's hardly the poor who are making the trip. Smugglers charge as much as \$2,000 per adult to ferry people just a couple of miles from Turkey to a Greek island. It takes money to travel on to Germany or Sweden—though some European countries are laying on free travel, food, and shelter.

These newcomers are not the needy; they are the greedy.

Finally, this "refugee crisis" is not just an absurdity; it's absurdity on stilts. Syrians don't qualify as refugees under the conventions. As noted above, a refugee has to have a well-founded fear of persecution. Being caught in a war zone is not persecution.

A government can choose to treat Syrians as refugees, however, and most European countries have promised them special handling. People are therefore throwing away their identity papers as soon as they get to Europe and are claiming to be Syrian. There is now a brisk market in fake Syrian passports; German authorities have confiscated hundreds of blanks. A Dutch journalist in Syria paid \$850 for a very convincing-looking custom-made fake, and they are now offered on the Internet. Syrians have been getting into fights with imposters who, they think, make it harder for real Syrians to register as refugees.

In any case, it is wrong for the press to call these people "migrants," as if they were Canada geese. Every one of them, wherever he came from, is an illegal immigrant. Israel calls such people "infiltrators." It would not be incorrect to call them "invaders," since they are an army of aliens come to occupy and transform Europe.

The rest come from South Sudan, Bangladesh, Afghanistan, Pakistan, Eritrea, and every other hell hole.

Chancellor Angela Merkel of Germany made things much worse by announcing that she expects to take in 800,000 waifs this year. Now the government says it could be more like a million. Mrs. Merkel has even been so stupid as to say that "the right to political asylum has no limits on the number of asylum seekers."

Mrs. Merkel's invitation explains why nearly a million illegals have already come to Europe, and countless more are on the way. It explains why 3,000 arrive every day on the tiny Greek Island of Lesbos. And why nearly 4,700 boat people were rescued off the coast of Libya just last Saturday (Sept. 20). And why the crush of "migrants" has so overwhelmed European transport systems that train service had to be stopped between Budapest and Vienna, and between Munich and Salzberg. It explains the mountains of rubbish, food, and feces the "migrants" have left behind wherever the gather.

"SWARMS" OF MUSLIM ILLEGALS DESCEND ON MACEDONIA



In Europe they call them "refugees" . . . in Israel they call them "infiltrators"

The spinelessness of the Europeans is perfectly matched by the arrogance and aggressiveness of the illegals.

One might think people who show up without permission in a foreign country would be grateful simply not to be turned back. Not these people. On the Greek islands they fought each other and rioted because they didn't think they were being treated well enough. On Kos, a tourist mecca, they blocked the main street of the town chanting, "We want papers! We want to eat!"

On Lesbos, with 20,000 surly young men camping in streets and squares, locals were afraid to leave their homes or send children to school. "They have stolen our lives," said one.

Africans in Italian reception centers in Belluno, Sicily, and Rome went on hunger strikes because they were tired of Italian food and wanted African food. The strikers in Belluno slashed the tires of Italians who worked at the center.

At the Serbian/Hungarian frontier, migrants massed at a border fence, chanting "open the door." They gave the Hungarians two hours to let them in, and then launched human-wave attacks on the fence to try to tear it down. When the Hungarians fired tear gas and water cannons, the illegals threw rocks and sticks at the border police. There was a running battle of several hours before the illegals finally gave up and headed for Croatia.

On all the rail routes leading to Germany, thousands of illegals have been sleeping in stations, filling the restrooms and platforms with filth, and cramming themselves onto any train that was passing through, whether they had tickets or not.

Mobs at the Keleti railroad station in central Budapest shouted "Fuck you," and "Allahu Akbar" at Hungarian authorities.

Most of these illegals are young
Muslim men who have never seen a
woman in a bikini. There have
already been reports of women and
children being raped in some of the
migrant centers, where Muslims
consider unaccompanied women "fair
game." Even when they have
segregated dormitories, women sleep
fully dressed, and are afraid to walk
around the centers. So many have
been forced into prostitution that a
social worker at a Bavarian shelter
called it "the biggest brothel in
Munich."

It's no accident that in immigranthappy Sweden the majority of rapists are immigrants—overwhelmingly Muslim. These are the people Mrs. Merkel's deputy thinks will make good Germans.

This is what Europe gets for its spinelessness. The illegals sense weakness, and they are right. They exploit that weakness, and their success inspires yet more hundreds of thousands—no doubt millions—from every wretched country. Only force will stop them, the force that any healthy people would have used immediately.



LD: This picture shows Russian vigilantes going to the rescue of their White Russian sisters who had been groped and sexually assaulted in a nightclub in Murmansk, Russia, by out-of-control asylum seekers. Fortunately, not all of Europe has gone insane.

Hungarian Foreign Minister Peter Szijjarto pointed out that if Germany is worried about the plight of Syrians it could use a tiny fraction of the money it has budgeted for "migrants" to improve conditions in the camps in Jordan, Turkey, and Lebanon.



Hungary's Prime Minister, Victor Orban has been the most consistently clear-headed European head of state throughout the crisis. He has warned that Muslims will destroy Europe's Christian identity and that Europeans have a right to refuse to become minorities on their own continent. His determination to keep illegals out has made him a hero to his people.

Slovakia said it would let in 200 Syrians but they had to be Christians. Interior Minister Ivan Netik explained that Slovakia doesn't have a single mosque and that Muslims aren't welcome.

Dutch political leader Geert Wilders has warned of an 'Islamic invasion':

> "Masses of young men in their twenties with beards singing 'Allahu Akbar' (God is greatest) across Europe—it's an invasion that threatens our prosperity, our security, our culture and identity."

He's right. Sheikh Muhammad Ayed, speaking at the Al-Aqsa Mosque in Jerusalem, encouraged the illegals to pour into Europe and mate with Europeans:

"We will breed children with them, because we shall conquer their countries," he said. "We will trample them underfoot, God willing."

Ironically, it is former Communists, who lived under an overtly anti-religious, anti-nationalist ideology, that are still able to think in terms of national and religious identity. When Mrs. Merkel said she wanted to assign mandatory "refugee" quotas to every EU member, Hungary, Latvia, Lithuania, Poland, Slovakia and the Czech Republic refused. Communism protected them from something much worse: "tolerance" and "diversity."

Perhaps the greatest irony, however, is that emasculated West Europeans are accusing East Europeans of not being European. French Foreign Minister Laurent Fabius said that Hungary's efforts to keep out illegals shows it does not "respect Europe's common values."

It is only because Europeans fought Muslim invaders for 1,000 years—from 732 at the Battle of Poitiers to 1683 at the gates of Vienna—that Europe as we know it even exists. Incredibly, Mr Fabius wants to throw it all away in the name of what he calls "Europe's common values."

Laurent Fabius could have stepped right out of the pages of *The Camp of the Saints*.

As Jean Raspail wrote in 1985: "The West is empty, even if it has not yet become really aware of it. An extraordinarily inventive civilization, surely the only one capable of meeting the challenges of the third millennium, the West has no soul left."

He put it even more pithily in *The Camp of the Saints*: "The white race was nothing more than a million sheep."

This is no idle threat.




and create an Islamic desert in the snowy north. The Guardian article continues to speak about lobsters:

20M Invaders Waiting: Macedonia

There are another twenty million non-white invaders from "Sudan and Egypt alone" waiting to enter Europe, and among them are thousands of Jihadists, the president of Macedonia has said.

Acedonia—which is in an ongoing dispute with Greece over its name, and is also known as the "Former Yugoslav Republic of Macedonia" (FYROM)—has been forced to "do the EU's dirty work in closing its border," Ivanov said.

"Our country has been forced to pay for the mistakes of the EU," he continued, adding that Macedonia's security had been severely impacted by the invasion.

"But no one has the courage to say what still lies ahead. Between Sudan and Egypt alone, twenty million migrants are waiting to come to Europe. And what about Africa? The refugee flow won't end, because everyone knows everything via Twitter and Facebook."

He went on to illustrate the security risks: "Look at these passports and papers. They are all forged or stolen. We have already seized 9,000 of them. "Some so-called refugees are travelling through the whole of Europe with false identities, and Greece is simply stamping their papers so that they continue on their journey.

"We have to assume that many of these people who were travelling with forged papers want to enter the EU via the refugee route as radical fighters."

Ivanov also charged that the EU had "completely lost sight" of security concerns. "If we had relied on Brussels rather than react ourselves, we would have been flooded with jihadists," he said.

He then got stuck into the European Union for its dithering over the issue: "And what is Europe doing? It takes more than six months to organize a summit. By that time, one million new migrants have arrived. And concerning Germany: how can it be that 130,000 refugees have simply disappeared in your country?"

His country's border closure with EU member Greece has, along with similar moves by other Balkan states, stopped all but those who have some basis to be able to claim to be Syrians from getting through—but this has left tens of thousands of invaders piling up in Greece.

"We are now paying for the EU's mistakes; we have already spent 25 million euros (\$28 million) of our taxpayers' money and had to declare a national crisis," he said.

"And what did we get from Europe in return? Nothing! Not a cent! Instead, we, as a non-EU country, are now forced to protect Europe from an EU country, namely Greece," which he said, had "been simply waving through refugees arriving from Turkey.

"We have always been the victim of EU institutions. For 25 years, we have been lied to and manipulated. A potential EU membership for Macedonia has been discussed seven times already, but there was always an obstruction, caused by Greece. There are another twenty million non-white invaders from "Sudan and Egypt alone" waiting to enter Europe, and among them are thousands of Jihadists, the president of Macedonia has said.

<u>Speaking in an interview with the German Bild</u> <u>newspaper</u>, Gjorge Ivanov said that his country had already seized over 9,000 fake Syrian passports.

Macedonia—which is in an ongoing dispute with Greece over its name, and is also known as the "Former Yugoslav Republic of Macedonia" (FYROM)—has been forced to "do the EU's dirty work in closing its border," Ivanov said.

"Our country has been forced to pay for the mistakes of the EU," he continued, adding that Macedonia's security had been severely impacted by the invasion.

"But no one has the courage to say what still lies ahead. Between Sudan and Egypt alone, twenty million migrants are waiting to come to Europe. And what about Africa? The refugee flow won't end, because everyone knows everything via Twitter and Facebook."

He went on to illustrate the security risks: "Look at these passports and papers. They are all forged or stolen. We have already seized 9,000 of them.

"Some so-called refugees are travelling through the whole of Europe with false identities, and Greece is simply stamping their papers so that they continue on their journey.

"We have to assume that many of these people who were travelling with forged papers want to enter the EU via the refugee route as radical fighters."

"No one in the EU gets along with the Greeks and we are supposed to solve this conflict on our own with this country."

The Riddle of Rotherham: "Mad Ash," White Trash and the Hostile Elite

The Yorkshire town of Rotherham, that hotspot of vibrancy, is back in the news. A gang of Pakistani Muslims (and two White women) have just been jailed for what the judge described as an "appalling catalogue" of sex-crimes against underaged White girls. The ringleader, Arshid "Mad Ash" Hussain, received 35 years; his brothers Basharat and Bannaras received 25 and 19 years respectively. According to their victims, the gang seemed to "rule Rotherham," committing brazen crimes "with impunity" for two decades. And there are lots more like them. A lawyer has said: "This trial is just the first of many and it is the tip of a very big iceberg."

The Rotherham Triangle

And there you see one of the deep mysteries about the vibrant rape-gangs of modern Britain. In smarmy liberal terminology, the Rotherham criminals are of "Pakistani heritage." Pakistan was once part of the British Raj, an empire created when India was conquered by relatively small



numbers of Whites from vast numbers of non-Whites. Whatever your opinion of British imperialism, this was an impressive military and strategic achievement. The higher intelligence, technology and organization of Whites gave them a decisive advantage over less intelligent and less organized non-Whites.

But in modern Britain that situation is reversed: a minority of non-Whites are behaving as though they rule Whites. The latest vibro-trial from Rotherham has provided stories like these:

One girl was locked up in a room above a restaurant in Blackpool for weeks and forced to have sex with a succession of men to "pay her way". A 12-year-old was forced to perform sex acts with a group of men in a car after she was picked up from a children's home. The main victim in the trial was abused by Arshid Hussain almost on a daily basis in churchyards, garages, above a pub.

. . .

Some of the girls suffered horrific violence, one had cigarettes stubbed out on her body, another was blindfolded and had petrol poured on her feet.

When one of the victims tried to find a safe house to escape, her abuser threatened to kill her brother. He also told her he had a policeman on the inside so he would always know how to find her. ... The horrendous abuse mirrors cases elsewhere in the country and is part of a suspected wider pattern of abuse in the town whose reputation

was shattered in August 2014 when Prof Alexis Jay concluded in a report that as many as 1,400 children were exploited in Rotherham over a 16-year period. (How a Rotherham gang with history of criminality abused vulnerable girls, The Guardian, 25th February 2016)

Recall the behaviour of Mohammed Karrar, a Black African Muslim who turned Oxford into another **hotspot of vibrancy**: "Karrar was brazen in his exploitation of Girl D and acted in the belief that the authorities would never challenge him — something that for years proved to be true."

Why were Whites unable to organize against and defeat a tiny minority of non-White criminals on British soil? Why is this still happening up and down the country? It's very puzzling.

Champions of the Proletariat

And it gets even more puzzling when you consider that Rotherham is a stronghold of the Labour party, which was founded, as its very name proclaims, as a passionate champion of the working-class. This is a second deep mystery about the rape-gangs. The girls who were abused in Rotherham are what the snobbish bourgeoisie would call "chavs" or "white trash," precisely the kind of vulnerable people the Labour party should have been protecting. A phrase like "white trash" would certainly never cross the lips of that dedicated socialist Denis "The Slug" MacShane. But although Denis was Labour MP for Rotherham for nearly twenty years, he failed to notice that large numbers of his young female constituents were being raped, prostituted and threatened with incineration.

Denis <u>has claimed</u> that "police kept the abuse secret from politicians." But the politician Nick Griffin, then leader of the British National Party, knew about the abuse long ago. He <u>made a speech</u> condemning it in 2004 and <u>was prosecuted</u> by the

New Labour government of which Denis formed such a shining ornament. Denis subsequently went one better than Griffin: in 2013 he was not just prosecuted but jailed for **fraud committed** on behalf of the **Jewish community**, which he served far better than he ever served his White working-class supporters.

Cherchez la Féministe

Denis is also a committed campaigner for women's rights, which raises a third deep mystery surrounding the crimes in Rotherham. Where were the feminists? The behaviour of Arshid Hussain and his brothers represented patriarchal oppression at its foulest and rape culture at its most brazen. Year after year, feminists in the Labour council and social-work departments of Rotherham knew what was going on. But it seems that they were never able to pick up a phone, write a letter or dispatch an email to alert the wider Sisterhood.

It was the *Times*, the snobbish centre-right newspaper, that exposed the horrors being committed against "white trash" girls in Rotherham, not the staunchly feminist *Guardian* or the BBC, which broadcasts a daily **Woman's Hour** overseen by the part-Jewish matriarch **Jenni Murray** and the Jewish producer **Alice Feinstein**. The *Guardian* and BBC also turned away the lesbian feminist **Julie Bindel**, who had been trying to alert her comrades to the "grooming gangs" for years. Instead, Bindel had to publish **an exposé** in a neo-conservative magazine called *Standpoint*.

For decades, abused women and girls throughout England have been in desperate need of feminist help against violent non-White rapists and pimps. They have never received that help. Instead, feminists have thrown their abundant energies into witch-hunts against elderly White scientists and the promotion of blatantly ridiculous rape-hoaxes. They've also campaigned for a tiny minority of mentally unbalanced men who claim that, while they might look like lumberjacks on the outside, they're actually ladies on the inside. In the same week that Arshid Hussain and his rape-gang were in the news, so was this heart-warming tale of trans-positive feminism:

The first "queer trans disabled lesbian woman" to run for women's officer at the National Union of Students (NUS), Anna Lee, celebrated her birthday on Tuesday by giving herself a rest from interacting with online abusers, trolls and transphobes. ... Lee says that campaigning on women's rights issues. which she has done for the past two years, has "gone beyond a passion" and taken over her life. She has worked on campaigns to improve sex and consent education in schools; bring greater gender diversity to the curriculum; tackle stigma around periods; get rid of the tampon tax; and stamp out sexual harassment at universities. ...

This isn't the first time that Lee has had to deal with transphobia. When she

came out during her first year of university, she lost almost all of her friends — they didn't want to hang out with a trans person because it was too embarrassing, she says. ... This stigma made Lee afraid to run for women's officer last year. "No one like me has run for a role like this in the past. I've never seen it before and that creates a barrier and makes it feel like it is something that you can't do."

But, encouraged by young women in the women's movement, she changed her mind this year. "I've had a huge amount of support from women, and people in the women's campaign. I felt confident putting myself forward for the role because they rallied round and supported me." Jo Gowers, women's officer for the Union of Students in Ireland, has already publically supported Lee, saying: "Anna recognises the gravity of the challenges facing Northern Ireland and Scotland in relation to abortion legislation and, importantly, how this challenge will cascade to Wales and England. I'm proudly backing Anna for NUS UK women's officer." (First trans student to run for women's officer stands up to backlash, The Guardian, 27th February 2016)

Resolving the Riddles

So we have a series of riddles about Rotherham and other hotspots of vibrancy: the impunity of non-Whites, the impotence of Whites, the indifference of feminists and the Labour party. What is the key to unlocking these riddles? I would suggest that it lies in the "community" for which Rotherham's Labour MP Denis MacShane did work successfully: British Jews.

The ideology presently dominant in the UK might be described as minority worship, or the sacralization of any group whose interests are antagonistic to those of the White majority. The martyr-cult of <u>Stephen Lawrence</u>, as overseen by the Jewish "anti-racist" <u>Dr Richard Stone</u>, has bullied the police force into giving non-Whites ever more latitude for misbehaviour. From the Jewish perspective, this is a Good Thing. If British Whites are tolerating active harm by non-Whites, is this not a <u>further guarantee</u> that British Jews are safe from another <u>inexplicable outbreak</u> of irrational <u>anti-Semitism</u>?

However, the pathology induced by **minority** worship has gone beyond passive tolerance of non-White crime to active collaboration with it. When the father of one of the many victims in Rotherham attempted to rescue his daughter, the police arrested the father for "racial harassment," not the non-White criminals who were abusing her. But when "three adult [Pakistani] men" were discovered "at 12.45am in the bedroom of a girl in a care home," guess what? The men were "not arrested." That's why it has been impossible for ordinary Whites to organize against the rape-gangs: the authorities are on the side of the criminals, not of their White victims. After all, as Richard Stone and his fellow anti-racists have told us for so long, the so-called criminals are from saintly minorities who are constantly attacked by hate-filled White racists.

"Not a Jewish place..."

The same pro-minority Jewish attitudes are apparent in feminism, which supports mass immigration from deeply misogynist Third-World nations while hysterically insisting that White males are the source of all patriarchal evil. As Labour MP for Rotherham, Denis MacShane combined feminism with pro-Jewish activism while ignoring what was happening to the White working-class in his constituency. To understand

his behaviour, examine an article published by the *Jewish Chronicle* about another New Labour politician: "How Jewish is Jack Straw?" The *Chronicle* noted that Straw has Jewish ancestry and "looks like a shul warden," but concluded that "Straw's father is from Barnsley — not a Jewish place."

Rotherham isn't a Jewish place either. Like Barnsley, it's a benighted goyish town in Yorkshire, many miles from the comfortable Judaeo-centric world of London-based socialists like **David Aaronovitch**. Denis MacShane, **Friend of Israel** and connoisseur of *haute cuisine*, chose to stand for election in Rotherham because it is a safe Labour seat, not because he wanted to help the White working-class there. White votes merely provided his *entrée* to parliament, where he could pursue his real interests: fighting "anti-Semitism," curbing free speech, and collaborating in Europe with Jews like Moshe Kantor.

Ultimate Responsibility

In short, the horrors in Rotherham are an example of what happens when Whites allow themselves to be manipulated and dispossessed by a <u>hostile</u>

Jewish elite. Remember the words of the lawyer after Arshid Hussain was jailed: "This trial is just the first of many and it is the tip of a very big iceberg." And that's just in Rotherham, which even now most British people couldn't find on a map.

But the non-White rape-gangs are only here because the hostile elite imported them. The ultimate responsibility for these crimes rests with liars, tricksters and propagandists like **Tony Blair**, **Denis MacShane**, **Sue Berelowitz**, **Richard Stone** and **David Aaronovitch**. And I don't think life in jail is a strong enough punishment for what they've inflicted on British Whites for so long.

Moslem Police and Politicians were Complicit in the Sex Abuse in Rotherham

The Times of London reports on new evidence of police complicity in a child rape ring being run by Pakistani Muslims in Rotherham, England. The ring groomed and then raped children for a decade and a half before it was broken up. The authorities were repeatedly informed, as early as 2002, but agents did not want to risk their careers in an environment of intense pressure not to seem racist or critical of Islam. There was a Home Office investigation into charges that Tony Blair's government had known of the ring as early as 2001, but did nothing because it conflicted with "his government's efforts to pacify Muslim communities." Some 1,400 children were raped over the ensuing 16 years.

Now the *Times* tells us that the police hadn't just been warned, they knew and were sometimes complicit.

Corrupt police and an influential politician fuelled a culture of impunity that allowed three brothers to "own" the town of Rotherham and abuse children until their crimes were exposed by The Times.

One officer had sex with under-age girls, passed drugs to the sex-grooming gang

and tipped them off when colleagues were searching for missing children, a court was told. Another helped to broker a deal in which one brother returned an abused girl to police after receiving an assurance that he "wouldn't get done".

The jury was told that Jahangir Akhtar, the former deputy leader of Rotherham council, also took part in the handover at a petrol station. Mr Akhtar, the former deputy chairman of South Yorkshire police and crime panel, was a relative of Arshid, Basharat and Bannaras Hussain, who behaved for years "like a pack of animals" to pursue dozens of young girls before demanding sex, often with threats of violence.

As their trial ended yesterday, it was revealed that the Independent Police Complaints Commission (IPCC) had begun 55 investigations into alleged police misconduct linked to Rotherham child sex crimes. It has received complaints against 92 named officers.

An investigation into all past sex grooming cases in the town, begun in June and led by the National Crime Agency, has identified more than 300 suspects and 9,000 lines of inquiry. Children lured into the Hussain brothers' web of alcohol, drugs, guns and cars believed that the wealthy trio, known as Ash, Bash and Bono, were above the law. It was a perception aided by the wilful blindness of child protection authorities, Sheffield crown court was told.

No criminal inquiry into the brothers' offending was launched until The Times revealed in 2013 that police and social services held, but had failed to act on, detailed intelligence that Arshid Hussain was among a small group of men suspected of sexually exploiting more than 40 under-age girls.

Less than two weeks later, Rotherham council commissioned an independent inquiry by Alexis Jay, a social services expert, which found that 1,400 girls in the South Yorkshire town were groomed and abused over 16 years. The offenders were "almost all" men of Pakistani heritage.

... One officer, said by a witness to have had sex with girls and to have passed drugs to Arshid Hussain, is under investigation by his own force and by the IPCC, the jury was told. He denies wrongdoing. The officer allegedly involved in the petrol station handover, PC Hassan Ali, died in February last year. He was fatally injured in a traffic collision on the day he was told that he was under investigation.

Between them, the two officers accessed police intelligence databases "without apparent legitimate policing purpose" on at least nine occasions between 2006 and 2011, the court was told. They searched each time for information about the Hussain brothers.


This sounds like a story of intense local corruption, and it is. It sounds like a story of the failure of the police to uphold their most basic oath, and it is that too. But it is also a story of the ways in which these criminals could rely upon protection from the highest levels of the British government. The Counter Jihad Report

Europeans are the only people who have sustainably tried to construct a civilisation on the basis of abstract standards of justice and conduct, ignoring the factor of kin preference (with an ethnic group being understood as an extended kin group), which dominates every non-European culture.

It is reasonable to suspect that some ethnic favouritism was taking place. Yet this possibility was never even mentioned in the Establishment news outlets.

It is probably long past time that we discussed the Ltopic of feminism. Not that we have avoided it. because we think that we have already addressed many aspects of the problem in the weekly Bible commentaries that we have been conducting the past seven years. But perhaps we need specific programs laying out the evils of feminism in society. Notice that I said programs, in the plural. This is a huge topic with multiple layers of abstraction, and feminism has several forms which keep society locked into a dialectic, supporting one form or another, which is right where our enemies want us to be. On the one side we have the worship of the female form and the elevation of women to the status of goddess, which is an ancient pagan ideal that leads to all sorts of perversion. On the other side we have the Jewish Golem of the ugly woman who thinks she should be a man, which was also found in the ancient world, manifested in the Greek tales of the Amazons and other myths, and which is just as pagan. In the meantime, we have the rather consistent portrayal in the Jewish media of the traditional wife and mother as a battered and abused and oppressed creature. whereby the enemies of our God and our race do their best to reduce the important role of the woman in the traditional family to the status of merely an unattractive lifestyle choice.

A few months ago, while we were traveling in Arkansas, I took the occasion to critique a couple of Bertrand Comparet's sermons. I was going to present his wife, Inez's paper, **Suppose We Are Israel, What Difference Does It Make?** Now, there is nothing

wrong with a pastor being helped in research and writing by his wife, as long as the pastor takes full responsibility for the work. If there is something wrong, he certainly cannot pass the buck to his wife! But I was taken aback when I played the recording to check the accuracy of something in the transcription, and found Bertrand Comparet introducing his wife so that she could present the paper in the regular assembly. That should be forbidden, and I am shocked that Comparet did not know better. So even the great Bertrand Comparet was influenced by what I must call feminist progressivism, as opposed to progressive feminism. Here we shall begin to examine why it is wrong for women to speak in public, although it is right for women to be of help to their husbands even if they speak in public.

Here is a digression, but it is actually quite integral to our discussion. If I wrote in a paper that "The Persians had black skin and gold teeth", people may think I was nuts, and they would demand that I back up such nonsense with historical proofs. If I refused to, I would properly be accused of lying and inventing my own history. That would make me no better than the typical modern negro with gold teeth.

A few weeks ago I encountered a discussion at a popular social media website, and a woman made a statement concerning early American history and ethnography that seemed to me to be absolutely contrary to all reality. So I asked her to document it, to provide the sources for what she was asserting. She responded by attacking me, and when she did, I treated her in kind. I treated her as she deserved to be

treated, and as I would have treated any male who tried to do the same thing. So it ended up that she never provided documentation, and a bunch of fools were insulted.

Another woman got involved in that discussion and tried to help the first one, not on the basis of the original discussion, but by immediately questioning my manhood, and accusing me of being a womanhater simply because I was caught up in a dispute with a woman. She had absolutely no care for how the dispute began, or the simple resolution that it may have had. She was obviously a feminist herself, who has adopted all the weapons of the Jewish war against White men, and she is too stupid to know how wonderful a tool she is in the hands of the Jews. She would never say such things in person, and I would deliver a very strong rebuke if she tried.

But then some emasculated idiot, a life-long clown named Jake Parsons, joined the same discussion and he also tried to reproach me for mistreating women. I asked him why he was holding the panties of the woman that he thought he was defending, and I meant it, in an allegorical sort of way, because that is exactly what he was endeavoring to do. I told them all exactly how I felt, but none of them actually understood anything that I was saying, nor could they understand. That is because all three of these individuals are feminists, including the male (who is not worthy of being called a man).

If the original woman in the discussion had merely told me from where she had obtained her information, I would have thanked her and gone off to investigate. But she was challenged by my question, and attacked me instead, responding emotionally rather than academically, and tried to hide behind the fact that she was a woman when I confronted her.

When men allow women into the public discourse, and then fail to hold women accountable for their words, women easily become the lords of society because they can say anything they want and they cannot be criticized. It is the feminization of men that has led to the masculinization of women in our society today. When you see women in khakis, it is because the men should really be wearing dresses.

When a woman speaks in public, she is behaving as a man. She deserves to be confronted as a man. In our

modern world, women think that they should be equal, so they want to wear pants. And once they are criticized, then they try to hide behind their skirts. That cannot be permitted. Women cannot have it both ways. If they want to be equal, they must be prepared to take punches like men. Men who insist upon letting women wear pants while at the same time they hide behind their skirts are weak men who, like Jake Parsons, have fallen into the worship of women. These men would be ruled over by women, reversing the natural order of God's Creation and leading to the societal breakdown which we witness today.



We read in Deuteronomy chapter 22: "5 The woman shall not wear that which pertaineth unto a man, neither shall a man put on a woman's garment: for all that do so are abomination unto Yahweh thy God." When we examine the role of clothing in the ancient world, we see that garments were used to mark a man's position and vocation in society. That is why Joseph's brethren got so upset about his manycolored coat. The Scriptures in Deuteronomy 22:5 were not necessarily describing the articles of clothing, but the roles in society that the articles of clothing represented. As an aside, I recently saw one clown abuse that same passage so as to insist that women should not wear blue jeans. He obviously did not realize that when the words were written, blue jeans did not exist, and men wore what we today may think of as dresses.

In 1 Corinthians chapter 7, Paul of Tarsus wrote "34 Let your women keep silence in the churches: for it is not permitted unto them to speak; but *they are commanded* to be under obedience, as also saith the law. 35 And if they will learn any thing, let them ask their husbands at home: for it is a shame for women to speak in the church." Where the King James Version has *church*, the correct word is *assembly* or

congregation, but Paul is referring to speaking as in questioning, answering, and teaching, since there are proper occasions where women can indeed sing psalms or offer prayers or other things while in the assembly, which we see in the context of other Scriptures.

This is not only a Christian principle, but it was also an ancient principle of Greek society, so it was the social norm of the New Testament period even among Greeks and Romans. Only men participated in the "democracy" of Athens. Only men were involved in politics in the Republic of Rome, and in the later empire. Women were excluded from politics, women did not speak publicly, and as Euripides' character Aethra in his play *Suppliant Women* says at lines 40-41 "It is proper for women, if they are wise, to do everything through their men."

Furthermore, the women of Eurpides' world were not even permitted to look upon men in public. In his play titled Hecuba at lines 974-75 the title character states that "custom ... ordains that women shall not look directly at men." The word translated "custom" in the Loeb Library edition of Euripides is vóμος, a word translated as law everywhere in the New Testament.

Of course, the Euripides method, as we shall call it here only for the purposes of our discussion, can work two ways: a good woman seeking to do good can be a positive influence on her husband, and influence him to do good. But an evil woman can find a weak husband and drive him to perpetrate evil in that same manner. Where the Euripides method fails, is when an evil woman is married to a good husband, and such a marriage may not last if the evil woman does not submit to the Godly order. Likewise, a good woman married to an indolent husband may not be able to affect good in society, but she should have more patience with her marriage. This last example reminds us of the advice which Peter had given to Christian wives where he said that such women could win their husbands over with their own good conduct.

So when a woman ventures to speak in public she is assuming the natural role of the man, and she is actually wearing "that which pertaineth to man", even if we no longer use clothing today in the stricter manner in which it was used in the ancient world.

But there are even deeper reasons why women should not speak in public.

The first reason is chivalry. Men are accustomed to treating women with the respect that a woman who is fulfilling the natural and Godly role which is assigned to women certainly deserves. But while a woman who is attempting to fulfill the role of a man does not merit any expectation of chivalry, there are weak or unsuspecting men who are easily moved to defend women simply because they are women, and in spite of the actions of the women themselves. So the notions of chivalry are easily exploited by devious women and when women are permitted to speak publicly, those notions can be used against men in order to overturn society. The manifestation of this phenomenon is readily apparent over the past 150 years of our history, and it still exists today. That is why we say that most modern men are feminists just as much as most modern women.

The second reason is lust. Men from their youth naturally compete for the attention and favor of women. So there are many weak men who would support and compliment women regardless of their actual words, simply because they are women. These same men would then defend a woman against all critics simply because they seek the favor of that woman. The bottom line is this: women shouldn't speak, because men are weak. In many men, even in most men, the lust of the eyes stops the normal function of the ears and the brain. So women speakers may get away with all kinds of things that a man would never get away with, and evil women can can be used to exploit weak men, easily corrupting the society that lets them have their way. This is how the enemies of Christ have operated ever since the Garden of Eden. This is why for the enemies of Christ, the liberation of women from the patriarchal family was the important first step in undermining Christian society.

So while we may have little choice but to continue to engage with women when we encounter them in social media, good Christians should not be offended when we treat them just as we would treat men. If women want to wear the pants and speak as men, they are asserting an equality which is unnatural, and therefore they cannot be allowed to hide behind their skirts as an attempt to deflect any criticism of their words.



With this we are going to move on to the recognition of the problem of the "liberation" of women in one specific area: that of politics. When women run for political office, societies are easily corrupted in the ways in which we have already discussed. But what is more subtle is when women are given the vote, because they are able to negate the voice of their husbands in the public arena, and very often they do just that.

The Protocols of Zion are real. We recently began a series on the Protocols, and it took us a series of seven programs just to begin establishing their legitimacy. We are soon going to begin presenting and discussing the Protocols themselves, and that will probably take much longer.

Critics of the Protocols attribute them to Maurice Joly and earlier political philosophers. But unless the protocols represent a concrete plan for the future of Europe put into place before Joly's own time, it makes no sense that the plans outlined in the Protocols concerning democracy have been fulfilled so soon after their publication. There was no democratic voting in Europe in the days of Machiavelli, and in most of Europe even in the days of Maurice Joly. Joly's Dialogue in Hell Between Machiavelli and Montesquieu, the work to which the Protocols are usually attributed, was not published until 1864, but universal voting for men was not permanently established in France until 1848, and Germany did not have universal suffrage for men until 1871. With the exception of New Zealand (1893) and Finland (1906), no other nation had

universal suffrage for women until the end of the First World War

In his own time, Joly could not have foreseen the rapid attainment of universal suffrage across all of the formerly Christian nations by men or especially by women. But the 10th Protocol informs us that those who wrote the Protocols planned to implement universal suffrage and the destruction of the family as a means of maintaining their power. There, in reference to their maintaining world power, they wrote: "To secure this we must have everybody vote without distinction of classes and qualifications, in order to establish an absolute majority, which cannot be got from the educated propertied classes. In this way, by inculcating in all a sense of self-importance, we shall destroy among the govim the importance of the family and its educational value and remove the possibility of individual minds splitting off, for the mob, handled by us, will not let them come to the front nor even give them a hearing; it is accustomed to listen to us only who pay it for obedience and attention." So the destruction of the patriachal family unit goes hand-in-hand with universal suffrage and the ability of the enemies of Christ to wield control over all White nations through the deception of what they like to call democracy.

After the First World War, universal suffrage for women came to Germany as well as the other nations of Europe, and women in Germany began participating in the political process as candidates and office-holders as well as voters. National Socialists in Germany were among the first to note the adverse effects which this new-found power on the part women brought to society, and when they came to power in 1932, they promptly removed women from politics. After the First World War, Germany fell into decadence. Weimar Germany was like Sodom and Gomorrah. Women were elevated in society. Lesbianism and drugs such as Cocaine were promoted publicly. Pornography and prostitution were common, and syphilis was epidemic. The National Socialists understood that recovery could only be had with the restoration of the family to its proper place in society, and the restoration of the family was only possible when women were restored to their proper positions within the family.

While we do not agree with it in all points, and we shall discuss those points a little later, we are going

to present a speech given by Joseph Goebbels on March 18th, 1933, titled German Women. This is just six weeks after the National Socialists had come to power, which shows how important the rehabilitation of the family was to the National Socialist plans for Germany's recovery. In his speech, Goebbels explains what the National Socialists intended to do in order to change the role of women in society back to a traditional Christian role. Goebbels also refers to a woman's exhibition, as the speech was given on the occasion of the opening of such an exposition in Berlin.

This is German Women, by Joseph Goebbels:

German women, German men!

It is a happy accident that my first speech since taking charge of the Ministry of Public Enlightenment and Propaganda is to German women. Although I agree with Treitschke that men make history, I do not forget that women raise boys to manhood. You know that the National Socialist movement is the only party that keeps women out of daily politics. This arouses bitter criticism and hostility, all of it very unjustified. We have kept women out of the parliamentary-democratic intrigues of the past fourteen years in Germany not because we do not respect them, but because we respect them too much. We do not see the woman as inferior, but rather as having a different mission, a different value, than that of the man. Therefore we believed that the German woman, who more than any other in the world is a woman in the best sense of the word, should use her strength and abilities in other areas than the man.

The woman has always been not only the man's sexual companion, but also his fellow worker. Long ago, she did heavy labor with the man in the field. She moved with him into the cities, entering the offices and factories, doing her share of the work for which she was best suited. She did this with all her abilities, her loyalty, her selfless devotion, her readiness to sacrifice.

The woman in public life today is no different than the women of the past. No one who understands the modern age would have the crazy idea of driving women from public life, from work, profession, and bread winning. But it must also be said that those things that belong to the man must remain his. That includes politics and the military. That is not to disparage women, only a recognition of how she can best use her talents and abilities.

Looking back over the past years of Germany's decline, we come to the frightening, nearly terrifying, conclusion that the less German men were willing to act as men in public life, the more women succumbed to the temptation to fill the role of the man. The feminization of men always leads to the masculinization of women. An age in which all great ideas of virtue, of steadfastness, of hardness, and determination have been forgotten should not be surprised that the man gradually loses his leading role in life and politics and government to the woman.

It may be unpopular to say this to an audience of women, but it must be said, because it is true and because it will help make clear our attitude toward women.

The modern age, with all its vast revolutionary transformations in government, politics, economics, and social relations has not left women and their role in public life untouched. Things we thought impossible several years or decades ago are now everyday reality. Some good, noble, and commendable things have happened. But also things that are contemptible and humiliating. These revolutionary transformations have largely taken from women their proper tasks. Their eyes were set in directions that were not appropriate for them. The result was a distorted public view of German womanhood that had nothing to do with former ideals.

A fundamental change is necessary. At the risk of sounding reactionary and outdated, let me say this clearly: The first, best, and most suitable place for the women is in the family, and her most glorious duty is to give children to her people and nation, children who can continue the line of generations and who

guarantee the immortality of the nation. The woman is the teacher of the youth, and therefore the builder of the foundation of the future. If the family is the nation's source of strength, the woman is its core and center. The best place for the woman to serve her people is in her marriage, in the family, in motherhood. This is her highest mission. That does not mean that those women who are employed or who have no children have no role in the motherhood of the German people. They use their strength, their abilities, their sense of responsibility for the nation, in other ways. We are convinced, however, that the first task of a socially reformed nation must be to again give the woman the possibility to fulfill her real task, her mission in the family and as a mother.

The national revolutionary government is everything but reactionary. It does not want to stop the pace of our rapidly moving age. It has no intention of lagging behind the times. It wants to be the flag bearer and pathfinder of the future. We know the demands of the modern age. But that does not stop us from seeing that every age has its roots in motherhood, that there is nothing of greater importance than the living mother of a family who gives the state children.

German women have been transformed in recent years. They are beginning to see that they are not happier as a result of being given more rights but fewer duties. They now realize that the right to be elected to public office at the expense of the right to life, motherhood, and her daily bread is not a good trade.

A characteristic of the modern era is a rapidly declining birthrate in our big cities. In 1900, two million babies were born in Germany. Now the number has fallen to one million. This drastic decline is most evident in the nation's capital. In the last fourteen years, Berlin's birthrate has become the lowest of any European city. By 1955, without emigration, it will have only about three million inhabitants. The government is determined to halt this decline of the family

and the resulting impoverishment of our blood. There must be a fundamental change. The liberal attitude toward the family and the child is responsible for Germany's rapid decline. We today must begin worrying about an aging population. In 1900 there were seven children for each elderly person, today it is only four. If current trends continue, by 1988 the ratio will be 1:1. These statistics say it all. They are the best proof that if Germany continues along its current path, it will end in an abyss with breathtaking speed. We can almost determine the decade when Germany collapses because of depopulation.

We are not willing to stand aside and watch the collapse of our national life and the destruction of the blood we have inherited. The national revolutionary government has the duty to rebuild the nation on its original foundations, to transform the life and work of the woman so that it once again best serves the national good. It intends to eliminate the social inequalities so that once again the life of our people and the future of our people and the immortality of our blood is assured.

I welcome this exhibition, whose goal is to explain and teach, and to reduce or eliminate harm to the individual and the whole people. This serves the nation and popular enlightenment, and to support it is one of the happiest duties of the new government.

Perhaps this exhibition titled "The Woman" will represent a turning point. If the goal of the exhibition is to give an impression of women in contemporary society, it does so at a time when German society is undergoing the greatest changes in generations. I am aware of how difficult this is. I know the obstacles that had to be overcome to give this exhibition a clear theme and a firm structure. It should show the significance of the woman for the family, the people, and the whole nation. Displays will give an impression of the actual life of women today, and will provide the knowledge necessary to resolve today's conflicting opinions, which were not primarily the result of the contemporary women's movement.

But that is not all. The main purpose of the exhibition "The Woman" is not only to show the way things are, but to make proposals for improvement. It aims to show new ways and new opportunities. Clear and often drastic examples will give thousands of German

women reason to think and consider. It is particularly pleasing to us men in the new government that families with many children are given particular attention, since we want to rescue the nation from decline. The importance of the family cannot be overestimated, especially in families without fathers that depend entirely upon the mother. In these families the woman has sole responsibility for the children, and she must realize the responsibility she has to her people and nation.

We do not believe that the German people is destined by fate to decline. We have blind confidence that Germany still has a great mission in the world. We have faith that we are not at the end of our

history, but rather that a new, great and honorable period of our history is now beginning. This faith gives us the strength to work and not despair. It enabled us to make great sacrifices over the past fourteen years. It gave millions of German women the strength to hope in Germany and its future, and to let their sons join in the reawakening of the nation. This faith was with the brave women who lost their husbands and breadwinners in the war, with those who gave their sons in the battle to renew their people. This faith kept us standing during the need and desperation of the past fourteen years. And this faith today fills us with new hope that Germany will again find its place in the sun.

Nothing makes one harder and more determined than struggle. Nothing gives more courage than to face resistance. During the years when Germany seemed destined to decline, a new kind of womanhood developed under the confused veneer of modern civilization. It is hard, determined, courageous, willing to sacrifice. During the four years of the great war and the fourteen years of German collapse that followed, German women and mothers proved

themselves worthy companions of their men. They have borne all the bitterness, all the privation and danger, and did not fail when hit by misfortune, worry, and trouble. As long as a nation has such a proud and noble womanhood, it cannot perish. These women are the foundation of our race, of its blood, and of its future.

This is the beginning of a new German womanhood. If the nation once again has mothers who proudly and freely choose motherhood, it cannot perish. If the woman is healthy, the people will be healthy. Woe to the nation that neglects its women and mothers. It condemns itself.

We hope that the concept of the German woman will again earn the honor and respect of the entire world. The German woman will then take her pride in her land and her people, in thinking German and feeling German. The honor of her nation and her race will be most important to her. Only a nation that does not forget its honor will be able to guarantee its daily bread. The German woman should never forget that.

I declare this exhibition open. May it reveal all the former errors and show the way to the future.

Then the world will once again respect us, and we will be able to affirm the words of Walther von der Vogelweide, who had this to say about the German woman in his famous poem:

He who seeks Virtue and proper love, Should come to our land.

Note that where Joseph Goebbels said that "the woman has always been not only the man's sexual companion, but also his fellow worker", he is also making a direct reference to the traditional role of women as it is described in the Christian Bible. We see this expressed as the intent for the creation of women in Genesis chapter 2, and we shall elaborate upon it later in this series. It is a Christian ideal, and I have not seen it expressed in those terms in pagan writings.

However while we agree wholeheartedly with nearly

everything Joseph Goebbels said in this speech, we cannot agree with Goebbels where he said that, along with the man, the woman "moved with him into the cities, entering the offices and factories, doing her share of the work for which she was best suited." Now, this is factually true, but we should not accept it as righteously inevitable. By saying this and not protesting against it, Goebbels expressed agreement that this transformation to urban life and

magnify the estate of the family. Traditionally, the family was the center of life for the man and the woman, and the estate of the family was the central focus of the economy. With the rise of Jewish Capitalism, in the Germany of Goebbels as well as throughout the entire world, the corporation has become the central focus of both the man and the woman, and the family has taken a backseat, getting attention mostly as a leisure activity. We may accept our enslavement as a fact, but we must recognize it, and we should not consider it to be good. Women belong in the home. In past times, that meant that women worked for the betterment of the home and also helped her husband in his vocation. That helped to keep the family unit together. So in the capitalist system, the family AS THE CENTER has been

replaced by the corporation, and has become secondary to the interests of those so employed.

According to the <u>Communist Manifesto</u>: "The less the skill and exertion of strength implied in manual labour, in other words, the more modern industry becomes developed, the more is the labour of men superseded by that of women. Differences of age and sex have no longer any distinctive social validity for the working class. All are instruments of labour, more or less expensive to use, according to their age and sex." Today this Jewish principle, which is both capitalist and communist, has even been taken so far as the execution of war. Women that can press buttons rather than fight in actual hand-to-hand

combat consider themselves warriors, and wear the garments of warriors. The ultimate result is the further feminization of men.

Now, we do not want women to quit their jobs. There are many women who work because the current economy has forced them to work in order to survive, or to help support their families, and we sympathize with them. Likewise, there are many older women who work or have careers because of the circumstances of their lives where modern society offered them no valid choices for fulfillment, and we sympathize with them as well. But we must understand that as a people, the children of Israel are in captivity.

Therefore we must also understand that while we are in captivity, the things which we do are not necessarily the way things should be done. It can be established, that those who control our society long ago planned to force women into the workplace, by creating inflation and oppressing the wages of men. That plan has been very effective, and has in turn helped to destroy the family unit, as well as attributing to plummeting birthrates amongst Whites. So we should see that while many women work out of necessity, it is not the model for society which we should uphold.

So if a woman is compelled to work outside of the home out of necessity, we sympathize with her. Older women, because of our fractured society, may work outside the home for a lack of anything else which is meaningful to do, and we sympathize with them. All

White Christians families should be landed, and men and women working for their own estates, but that is not the case today. But if you think that women should, or even must, work outside of the home for the sake of working, then you are a feminist just as much as women who insist on working are feminists, and you have accepted the Marxist-Capitalist dialectic.

Many Christians who have only studied the Scripture on its surface refer to Proverbs chapter 31 and assert that the Bible approves of women working outside of the household. Yet nothing can be further from the truth. In actuality, Proverbs chapter 31 describes a woman working for the advancement of her own household, and fulfilling the traditional role as mistress of the household: "10 Who can find a virtuous woman? for her price is far above rubies. 11 The heart of her husband doth safely trust in her, so that he shall have no need of spoil. 12 She will do him good and not evil all the days of her life. 13 She seeketh wool, and flax, and worketh willingly with her hands. 14 She is like the merchants' ships; she bringeth her food from afar. 15 She riseth also while it is yet night, and giveth meat to her household, and a portion to her maidens. 16 She considereth a field, and buyeth it: with the fruit of her hands she planteth a vineyard. 17 She girdeth her loins with strength, and strengtheneth her arms. 18 She perceiveth that her merchandise is good: her candle goeth not out by night. 19 She layeth her hands to the spindle, and her hands hold the distaff. 20 She stretcheth out her hand to the poor; yea, she reacheth forth her hands to the needy. 21 She is not afraid of the snow for her household: for all her household are clothed with scarlet. 22 She maketh herself coverings of tapestry; her clothing is silk and purple. 23 Her husband is known in the gates, when he sitteth among the elders of the land. 24 She maketh fine linen, and selleth it; and delivereth girdles unto the merchant. 25 Strength and honour are her clothing; and she shall rejoice in time to come. 26 She openeth her mouth with wisdom; and in her tongue is the law of kindness. 27

She looketh well to the ways of her household, and eateth not the bread of idleness. 28 Her children arise up, and call her blessed; her husband *also*, and he praiseth her. 29 Many daughters have done virtuously, but thou excellest them all. 30 Favour *is* deceitful, and beauty *is* vain: *but* a woman *that* feareth the LORD, she shall be praised. 31 Give her of the fruit of her hands; and let her own works praise her in the gates."

In Joshua chapter 2 we see the account of Rahab working as an inn-keeper, but we must note that Rahab was working in a pagan society and not a Christian one. Likewise, in Acts chapter 16 we encounter Lydia as a seller of purple, who was also a woman in a pagan society. Many Christians also mention Ruth chapter 2 in connection with women and employment, but in Ruth chapter 2 we see the young woman was sent to "glean and gather after the reapers among the sheaves" and along with the other "maidens of Boaz to glean unto the end of barley harvest and of wheat harvest". What is missed is this: that Boaz was near kin to Naomi, that Naomi, whose husband had died, had joined herself to the household of Boaz, and that Ruth along with the other young men and women of the household of Boaz were working the fields which belonged to Boaz. The women in Ruth were working for the increase of their own household and family, and not for some Jewish factory owner. So these passages cannot be used as an excuse to force women into the corporate workplace.

We do not mean to say that there are not circumstances by which women can work and own their own businesses. But young women should be married and having and raising children instead. We must distinguish what is in compliance with God's law and Word against what it is that we must do because we must exist in an evil world. Our Christian hope is, of course, that one day men and women can once again work together as families for themselves on their own estates. The current system of Jewish capitalism is not inevitable, and shall not endure.

Britain's Jewish Communist Traitors

In his plea for Britain to take in thousands more "Syrian refugees" Lord <u>Alf Dubs</u> tearfully recalls how he was brought to Britain, aged six, from Prague, as a Kindertransport Jewish refugee. His former parliamentary colleague, wealthy publisher Lord <u>George Weidenfeld</u> too, was fond of recalling how he found sanctuary in Britain after fleeing Austria just before the war. He said it was the main factor in his decision to help pay for the transport of thousands of Syrian refugees into the west.

The Kindertransport has been exposed as a **confection of distortions, myths and omissions** previously in TOO, but there is another little awkward fact about the Jewish refugees taken in by Britain before the war. And that is the remarkably high proportion of them who chose to actively betray the country which gave them sanctuary by acting as spies for Britain's deadly enemy, the Soviet Union.

They not only ensured that many British agents were sent to their <u>deaths or capture</u>, <u>torture and long</u> <u>periods of imprisonment</u>, but played a crucial part

in stealing the atomic bomb secrets that allowed the Soviet Union to catch up and have its own atomic bomb by 1949. Their treachery compromised the security of Britain and the West and probably extended the length of the Cold War and the enslavement of the subject peoples of Eastern Europe.

What is more astonishing is that in many cases the British authorities took no action against them to avoid official embarrassment. As a result some of Britain's foulest traitors were left free to enjoy their retirements in comfort and security.

It is <u>well-known</u> that Jews were prominently involved in the left throughout the twentieth century, including communism, that leftist politics was mainstream within Jewish communities during much of that period, and that leftist Jews typically continued to have a strong Jewish identity. Information on Jewish involvement in communist spying increased greatly in the last 20+ years because in 1995 the USA began to open up its Venona Soviet

code decryption archive. Another eye-opening tranche of incriminating material came via the publication of the **Mitrokhin Archive** spirited to the West by a KGB archivist defector in 1992. Finally, in a spirit of damage control, in 2001, the British intelligence services began to open up some of their older files for inspection in the National Archive. This led to the launch of something of a cottage industry for authors who found an eager audience for true-life stories about wartime espionage and derring-do.

Despite the seriousness of their crimes the media has chosen to portray these traitors as colourful romantics and their actions as the understandable acts of misguided conscience. This murderous stab in the back by many Jewish refugees towards the people who took them in, has gone completely unremarked.

Up until recently this subject has been overshadowed by the Cambridge non-Jewish spies of **Kim Philby**, **Guy Burgess and Donald MacLean** who all defected to Moscow. They lived upper-class, raffish lifestyles and their bohemian milieu lent the story a kind of perverted glamour. But they were not even the most important spies in an enormous communist network which reached into many institutions — a network of Russian and German exiles who seem to have been overwhelmingly Jewish.

One of MI5's most embarrassing lapses concerned its failure to catch Edith Tudor-Hart. She was born Edith Suschitzky in Vienna and on her first visit to Britain was deported from Britain for suspicious communist activities but she returned in 1933 as a political refugee after marrying an English doctor. From the moment she arrived she was working as a Soviet agent and set up as a professional photographer in an apartment opposite Abbey Road recording studio in north London.

She was really working for another Jewish refugee
— and Soviet spy controller — <u>Arnold Deutsch</u>, and she couriered for the Soviet Union's most successful

spy in Britain, the senior MI5 officer Kim Philby. As early as May, 1934 the three were meeting on park benches in Regents Park. By the time of the Cambridge ring defections in 1952 she was strongly under suspicion but under interrogation denied everything. Soon after she was admitted to psychiatric hospital after suffering a nervous breakdown which MI5 interrogators took as an indication of guilt.

An old MI5 file, released for view last year, said "From such evidence as is on record (letters, observations etc.) she would appear to be a rather typical, emotional, introspective and somewhat intellectual Viennese Jewess (L)ike so many leftwing intellectuals of her generation, she displayed an unhealthy interest in psychology and psychiatry". No further action was taken against her despite the

strong suspicions including her photographic equipment being found in possession of another group of Jewish communist spies. She ended her days running an antique shop in



Brighton. A major exhibition of her photography took place at the Scottish National Gallery in 2013 and a sympathetic **Guardian** article said her files not only confirmed MI5's suspicions "they also betray a degree of anti-semitism and xenophobia within the agency." (!) A **Telegraph** article described her as "the spy with a conscience."

The most important Jewish spy was <u>Melita</u>

<u>Norwood</u> who was born in England as Melita

Stedman to Latvian immigrant parents who were committed bolshevik revolutionaries and spies themselves. She joined the Party in the thirties and

got a secretarial job at the offices of the innocuoussounding British Non-Ferrous Metals Association. This was to be her gateway into the heart of the atomic bomb research establishment because she became secretary to Dr G. L. Bailey, the head of Britain's atom bomb project throughout the war, with access to both his home and office safe.

For decades she passed documents and secrets to both the KGB and the Red Army's GRU. She was identified as a security risk in 1965 but no action was taken and she retired to leafy suburbia. Her spying



was confirmed by the Mitrokhin archive in 1992 but she was never prosecuted. More recent files show she was **more** highly valued than the Cambridge spies and was secretly awarded the Order of the Red Banner by the KGB. She never hid her left-wing sympathies and when she leafleted

her neighbourhood she was tolerated as just another harmless English eccentric. Throughout her spying days she was helped by her husband Hilary Nussbaum, who was also a committed communist and who took her surname.

Because of her treachery the Soviets were able to create a copy of the British atom bomb within a year, and to catch up with the underlying technology within two years. She ended her days comfortably in a sheltered housing complex in south London while the *Mail* ran a breezy article about the "jam-making granny" spy who tended a garden allotment. Like all

the unmasked Jewish spies she expressed no regrets for spying for Stalin.


Another important Jewish refugee spy who inexplicably escaped prosecution was **Ursula** Kuczynski, also known as Ruth Werner though she had at least three other names. Born in Berlin to a wealthy Jewish family she enjoyed an expensive schooling and rich lifestyle but rejected it all to become a communist revolutionary and spy. After working for the Soviets in China and Switzerland throughout the war, she and her second husband Leonard Breurton came to live in Oxfordshire where she worked as a courier for the Atom bomb secrets of yet another Jewish refugee spy, the traitor scientist Klaus Fuchs who was caught by the Venona interceptions and jailed in 1950 for passing atomic secrets. The file on Fuchs, who had joined the Communist Party in his youth in Berlin, suggests he was helped in his endeavours by a host of Jewish women including his sister, his mistress and many others. Kuczynski also received eager help from her sister and brother who were also communists

Some Jewish communist women were married to non-Jewish traitors and acted as "handlers" for the various Soviet intelligence agencies. A good example was Kim Philby's wife <u>Litzi Friedmann</u> who was born Alice Kohlmann in Vienna. She initially fled to Britain as a refugee in 1933 and in fact married Philby to get a British passport.

Philby rose to become head of the anti-Soviet section of the Secret Intelligence Service as MI5 is formally known and until recently was thought to be the KGB's most successful agent. Because of him, probably hundreds of agents who were sent



into the Ukraine and Albania, were caught and executed. After a long career of helping Philby and betraying the country that gave her sanctuary and after Philby's defection, Friedmann was allowed to return to East Germany.



There were many other Jewish women communist spies. In 1939 one of the Cambridge spies, Donald MacLean, was working at the British embassy in Paris where the Soviet spy overseeing him was **Kitty Harris**, a Jewess from the East End of London, with whom he was having an affair. Her real NKVD courier role was not revealed until 2001 via the Venona files. (She **eventually married Earl Browder**, chairman of the CPUSA, the American Communist Party). She fled to the Soviet Union and died of alcoholism in Gorky in 1966.

Then there was <u>Hildegard Pauline Ruth Gerwig</u>, of German Jewish extraction, who married two non-Jewish scientist traitors in turn and is thought to have "run" both for the Soviets. First was <u>Engelbert</u> <u>Broda</u>, and the second was <u>Alan Nunn May</u> who worked deep within the British atomic bomb project.

Long suspected, Broda was only named as a spy in 2009.

The wartime BBC may have been a hive of communist fellow travellers but the groupthink leftism was not shared by every employee, and one in particular was patriotic and independent-minded enough to take his suspicions further. Eric Blair, who wrote under the pen name George Orwell, may have been a socialist but he detested Stalinism. Orwell listed those he thought too untrustworthy to be allowed to work in propaganda and sent it to his bosses; they included those who "in my opinion are crypto-communists, fellow-travellers or inclined that way and should not be trusted as propagandists".

When, in 2004, George Orwell's list of unreliables and potential traitors was revealed it was met with outrage in left-wing circles. The list is not perfect. But as time has passed more and more of Orwell's judgements have proved to be spot on. One of those he suspected was a Jewish political asylum seeker who became one of the most important spies in Britain. Peter Smollet was the name of a *Daily* Express correspondent who was born Hans Peter **Smolka** to a wealthy Jewish family in Vienna. He was already an NKVD agent when he hurriedly left Austria for Britain in the early thirties to escape a crackdown on communists. He arrived in Britain ostensibly working as a journalist, but MI5 already had a file on him because he was expelled from France for photographing a French armaments factory.

Nevertheless, well-connected, he soon landed plum jobs with the *Daily Express, The Times* and eventually BBC as roving European correspondent while at the same time being an agent for the Comintern (Communist International).

He covered the German entry into Prague at the behest of his boss at the BBC, Soviet mole Guy Burgess, and was also reporting to the other Soviet master spy Kim Philby. In 1961 Smollett was

interrogated but was released through lack of evidence. He eventually fled, not to the Eastern bloc, but to the family landed estate in Austria and died, wealthy and comfortable, in 1980. He was finally confirmed as a Soviet agent by the Mitrokhin archive in 2003. Smollett, incidentally, got his revenge on George Orwell by persuading several publishers not to publish his allegorical novel *Animal Farm*, a seminal work of anti-totalitarianism.

In its coverage the BBC prefers to portray these wartime **spy investigations** as hysterical "Red Scares." But in 1953 there was concern about the Jewish emigre head of the BBC's Russian service who seemed to be bending over backwards to portray the Soviet Union in a positive light. He is said to have made the BBC Russian service as left-wing as the *New Statesman* and *Nation*. The name of this man **Anatol Goldberg** was on a list of suspected fellowtravellers — or worse — submitted by a worried Conservative MP. Goldberg was initially defended but later discreetly shunted sideways and removed from this post, although he stayed as a commentator. In retirement Goldberg wrote an admiring biography of Stalin's notorious genocidal propagandist Ilya Ehrenburg which was so one-sided even the *New* York Times found it hard to take. So what was the truth about Anatol Goldberg? The answer presumably lies in the archives of the KGB or MI5.

And what of Lord Victor Rothschild who, like his friend Kim Philby, was a wartime MI5 officer. He owned an apartment at <u>5 Bentinck Street</u> in Marylebone. At various times this raucous establishment hosted soirees that included at least three of the Cambridge spies as well as the notorious Zionist traitor John Strachey who became a Labour MP.

No conclusive proof of betrayal by Nathaniel Mayer Victor Rothschild has ever emerged, but rumours continue to swirl around his name. He denied any wrongdoing to the end of his life, but an Australian author and espionage expert Roland Perry was not convinced and accused him of being a spy in a book called **The Fifth Man**. Perhaps more time will tell.

Incidentally, what was the wealthy publisher, Viennese-born Lord Weidenfeld, doing among that nest of traitors in Bentinck Street? When he died last month he was lauded for his work in flying thousands of "Syrian refugees" into Poland and said it was the least he could do, having been a wartime refugee into Britain himself. What did he have in common with Philby, Burgess and MacLean?

It would be appropriate here to mention the well-known case of George Blake, who was born in Egypt to a Jewish father and English mother. As a communist schoolboy he fled from wartime Netherlands to Britain and returned the country's generosity by spying for the Soviets. He was caught, sentenced to 42 years in prison, but then escaped and was spirited behind the Iron Curtain by British peace campaigners. He is still alive at 93 and the unusual circumstances of his escape created a mini book and **film** industry which invariably treats him and his coconspirators with **great affection**.

How sad so few of these authors and film makers sought to **spare a thought for Blake's victims.**

Britain's failure to prosecute wartime spies has become impossible to hide in recent years thanks to the opening of these archives. But there seems to be a silent consensus that there is one aspect of these failures which should not be probed too hard, and that is the ethnic dimension. As glaringly obvious as the predominant Jewishness of these spies, it is totally off limits as regards scrutiny or even comment

This is a very brief survey but there are many other cases in the archives and many more questions than answers. What is in the unpublished files on notorious Stalinist apologist **Eric Hobsbawm** who was honoured by Tony Blair but kept under close wartime surveillance by MI5? Was the friendship between this fanatical wartime communist historian and Cambridge spy Guy Burgess entirely innocent?

And what of another Cambridge friend of the gregarious Guy Burgess and an open supporter of the Soviet Union, the Marxist physicist don J. D.

Bernal? Today university buildings are named after Bernal, a pioneer of crystallography, but in 1931 he organised two trips to Moscow where Cambridge scientists were politely grilled by their Soviet counterparts, much to the alarm of many.


Mysteriously, Bernal's post-war scientific reputation has survived his espousal of the bogus Stalinist science of "Lysenkoism." It also survived his receipt of the Stalin Peace Prize and his membership in the notorious communist-front World Peace Council.


There are also worries about Churchill's chief

Former head of ZDF Bonn Dr. Wolfgang Herles made the remarks during a radio event (from minute 27) in Berlin where journalists discussed the media landscape.

Moving on to the freedom of the press, the panel chair asked Dr. Herles whether things in Germany had got "seriously out of whack". With an honesty perhaps unusual in Germany, Dr. Herles replied that ordinary Germans were totally losing faith in the media, something he called a "scandal"....

Worse than the mainstream, government controlled and poll-tax funded media in Germany just agreeing with the ruling coalition, the stations actually took orders on what was and was not to be reported on.

He said: "...the topics about which are reported are laid down by the government....

While these orders are sent to media companies from unspecified places in the government, they are communicated to individual journalists by news executives using a new-speak jargon.

Dr. Herles explains that while "there are, in fact, instructions from above", when the editor in chief of

ZDF communicated these instructions to his juniors he would merely say reporting should be framed in a way that "serves Europe and the public good".

There would be no need to add in brackets that this actually means it should be reported "to Ms. Merkel's liking", as they would be understood as the true meaning.

"Today, one is not allowed to say anything negative about the refugees" said Dr. Herles, concluding: "This is government journalism and that leads to a situation in which people no longer trust us. This is a scandal."

That the German mainstream media is not free and routinely obscures or bends the truth has been a key criticism by the Patriotic Europeans Against the Islamisation of Europe (PEGIDA) movement, which has coined phrases like Lügenpresse — the liar press — to express their frustration.

Here is a summary of astroturf tactics. Once you're aware of them, you will notice just how popular they have become:

- Creating of Wikipedia pages, monitored by corporations.
- Creating a social media presence, including Facebook and Twitter accounts, run by paid professionals.
- Secretly funding non-profit organizations to create third-party

support and web presence.

- Search engine optimizing web pages such as blogs and third-party sites that support a specific agenda.
- Financing industry research that is deceitfully presented as independent opinion.
- Funding experts working on unrelated projects, while in reality creating paid consultants.

These methods are used to give people the impression that there is widespread support for an agenda, when, in reality, no such agenda exists. Astroturf tactics are also used to discredit or criticize those who disagree with certain agendas, using stereotypical names such as "conspiracy theorist" or "quack" to make people turn away from the truth and accept lies instead.

Will South African Farmers Move to Georgia en masse?

A t least ten White South African farmers have already abandoned their home country in the face of offers of land and ultimate citizenship of the former Soviet Republic of Georgia, The Transvaal Agricultural Union of South Africa (TAU-SA) has announced....

The article goes on to explain that holding dual citizenship would circumvent any restrictions on land ownership. Earlier, one of the first Boer farmers to move to Georgia under the scheme, 66-year-old Piet Kemp, was quoted as saying that "I have a new life here," he explained.

"There is no security of land, absolutely no security of land in South Africa," he stressed. Kemp said that over the last decade he successfully helped hundreds of white farmers hold on to their farmland in face of legal challenges from black farm workers and squatters. But now, he says white farmers face threats of farm seizures.

"They have done exceptionally great job over the years in South Africa, and to give them an opportunity to do the same thing here and for Georgian farmers to learn from the experience they will receive from their new neighbors, from the South African farmers," said Georgia's Canada-educated Economy Minister, Vera Kobalia.

Kobalia praises Sandra Roelofs, the Dutch-born wife of Georgian President Mikhail Saakashvili, for promoting the program. Dutch is the mother language of Afrikaans. "It helped in terms of making them feel more secure in Georgia," Kobalia noted.

Kemp says that Georgia's Dutch-speaking first lady impressed a visiting group of Afrikaner farmers last year. Kemp believes that Afrikaners will help jump start Georgian agriculture.

Kemp adds that he does not want his new life in Georgia to be like his old life in South Africa. "I do not want to live in constant fear," the 67-year-old said emotionally as he recalled the widespread killings of other white farmers in South Africa. "We



tried to defend our rights, but we lost this war." Amid the violence, Kemp said that he felt he had no choice but to leave.

"In Georgia there is no violence, the crime rate is extremely low. So I will never go back," Kemp declared, comparing the situation here to the high violent crime rates back home, which include some 46 murders a day.

He sold his farm in South Africa's Mpumalanga province, was given Georgian citizenship in 2011 and in March that year rented 700 hectares (1,730 acres) of land in the village of Sartichala, where he now cultivates maize and wheat. "I moved to Georgia because I see tremendous opportunities here — there is a good climate, fertile soil and a good market," he said.

Georgian Diaspora Minister Mirza Davitaia, who is in charge of the scheme, said "it is a very important investment initiative." "Serious capital will be invested in Georgia's agricultural sector." South African farmers, he said, "will bring in their skills, experience and technology."

Although Georgian land is incredibly fertile, and a large proportion of its population works in agriculture, more than 80 per cent of foodstuffs are imported, fuelling drastic food-price inflation.

Georgia was once one of the larders of the Soviet Union, renowned for its citrus fruits, grapes, nuts and tea, but the amount of cultivated land has diminished by 43 per cent over the last seven years.

A hasty privatisation programme after independence in the 1990s aided the decline, when small plots of state-owned land were handed to millions of farmers, saving them from starvation but creating an inefficient subsistence farming system. TNO Staff

Widely prescribed drugs act as cellular poisons that accelerate ageing... deactivate DNA repair... promote diabetes, muscle fatigue and memory loss

Scientists have found the heart disease drug badly affects our stem cells, the internal medical system which repairs damage to our bodies and protects us from muscle and joint pain as well as memory loss. ... Professor Reza Izadpanah, a stem cell biologist and lead author of the research published in the American Journal of Physiology, said: "Our study shows statins may speed up the aging process." The study, published in the American Journal of Physiology - Cell Physiology is entitled "The Impact



of Statins on Biological
Characteristics of Stem Cells
Provides a Novel Explanation for
Their Pleotropic Beneficial and
Adverse Clinical Effects."

The study abstract states that statin drug "side effects include memory loss, myopathy, cataract formation, and increased risk of diabetes." It also warns that "Statins also impaired the expression of DNA repair genes including XRCC4, XRCC6, and Apex1."

Doctors and drug companies have

conspired for years to downplay the side effects of statin drugs, promoting the medications as "miracle" drugs that everyone should be taking. Some doctors even suggested statins should be dripped into the water supply like fluoride.

When patients experienced the devastating side effects of statin drugs -- memory loss, diabetes, muscle fatigue, etc. -- doctors simply **put them on yet more medications** for those symptoms. Statin drugs, in effect, became "gateway drugs" that led to expanding medication prescriptions for yet more high-profit drugs.

Heart industry doctors bribed to lower the limits of "high" cholesterol to push more statin drugs

To expand the scam, the medical system conspired to redefine "high cholesterol" to lower numbers, instantly thrusting tens of millions of people into a state that demanded "treatment" with high-profit medications. These decision panels of the American Heart Association and American College of Cardiology were stacked with panelists who were bribed by pharmaceutical companies to redefine high cholesterol in a way that generated the most profits.

Doctors claim the new guidelines will limit how many people with low heart risks are put on statins simply because of a cholesterol number. However, under the new advice, one-third of U.S. adults would meet the threshold to consider taking a statin, more than twice the 15 percent of adults who are recommended statins under current guidelines.

Ties between heart doctors and Big Pharma are so extensive that it is almost impossible to find a large group of doctors who have no industry ties. Just like with the vaccine industry, the statin drug industry is **far more concerned with pocketing huge profits than protecting lives**. Now, thanks to researchers at Tulane University, the science of what causes statin drugs to be so dangerous to human health is better understood.

Another nail in the coffin for statin drugs New research finds statins increase artery calcification

In yet another blow to the claimed benefits of statin drugs, newly published research has found that statin drug use leads to accelerated coronary artery and aortic artery calcification, both of which greatly contribute to cardiovascular disease and mortality. The new study comes on top of findings that led the FDA to mandate adding "diabetes risk" to the warning label of statin drugs.

Statin drugs cause problems they are marketed to solve

The latest discovery makes it clear that statin drugs not only carry a significant risk of developing type 2 diabetes, they also accelerate the cardiovascular complications associated with diabetes. This has to be particularly disconcerting to the pharmaceutical companies since they have been marketing statins to reduce cardiovascular morbidity and mortality, not accelerate it.

According to Dr. Arthur Agatston, cardiologist and author of the *South Beach* diet books, coronary calcium is the best predictor of who will have a heart attack and who will not. A recent study published in the *Journal of the American Medical Association* found that coronary calcium was six times more accurate in predicting an impending heart attack than the risk factor of a family history of coronary heart disease.

In the research, just published in the journal *Diabetes Care*, researchers looked at patients with type 2 diabetes and advanced atherosclerosis and found that coronary artery calcification "was significantly higher in more frequent statin users than in less frequent users." Further, the researchers looked at a subgroup of participants who were not initially receiving statins and found that "progression of both CAC [coronary artery calcification] and AAC [aortic artery calcification] was significantly increased in frequent statin users."

The initial premise used to market <u>statin drugs</u> was that they lowered cholesterol and cholesterol led to clogged arteries and heart attacks. That premise has been roundly discredited and the fact is that there has never been a single study which has proven that increased cholesterol levels cause <u>heart</u> attacks or other coronary problems.

Increasingly, it is being demonstrated that inflammation is the real culprit in arterial plaque. As *NaturalNews* recently reported, regardless of the amount of cholesterol in the blood, inflammation will result in the depositing of cholesterol to repair arteries damaged by inflammation. One of the worst effects of statin drugs is to lower the natural production of Coenzyme Q10 (CoQ10), a compound which is absolutely vital to optimal health and is particularly important for muscle health. The heart just happens to be the largest muscle in the body.

Overall, statin <u>drugs</u> have been linked to more than 300 side-effects, including weakening of the heart muscle. The results of this latest negative study on statin drugs may prove to ultimately be a final nail in the coffin of these dangerous drugs - though given the billions of dollars in profits the drugs rake in, we

can expect to see the pharmaceutical industry fight tooth and nail to keep the drugs on the market.

Nature offers better, safer solutions

As is usually the case, nature offers much better and safer alternatives for healing and preventing heart disease - such as proper diet and nutrition, a healthy, active lifestyle and <u>natural</u> supplements which protect and heal the cardiovascular system. (NaturalNews)

Here is a biographical note about Andreas: "Andreas Bachmair is a classical homeopath with a practice in



It falls to a courageous man like Andreas to step up to the plate.




Mum's Not Having Chemo: Cutting-edge therapies, real-life stories - a road-map to healing from cancer by Bond, Laura
